4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING PROVISIONS RELATED TO THE
5 ENFORCEMENT OF CAMPAIGN PRACTICES LAWS; REQUIRING THE POLITICAL PRACTICES
6 COMMISSION TO CONDUCT ADMINISTRATIVE CONTESTED CASE HEARINGS CONCERNING CAMPAIGN
7 PRACTICE VIOLATIONS; REVISING THE COMMISSIONER OF POLITICAL PRACTICES'S AUTHORITY,
8 DUTIES, APPOINTMENT, TERM OF OFFICE, SALARY DETERMINATION, AND QUALIFICATIONS;
9 CONFORMING PROVISIONS ON CORPORATE CONTRIBUTIONS TO CASE LAW; PROVIDING
10 NOTIFICATION REQUIREMENTS; REVISING PENALTIES; PROVIDING THAT COUNTY ATTORNEYS MAY
11 PROSECUTE ONLY CRIMINAL VIOLATIONS OF CAMPAIGN PRACTICE LAWS; REQUIRING THAT AN
12 ALLEGED CRIMINAL VIOLATION BY A COUNTY ATTORNEY BE REFERRED TO THE ATTORNEY
13 GENERAL; CLARIFYING THE STANDING REQUIREMENT FOR THE FILING OF ETHICS COMPLAINTS;
14 AMENDING SECTIONS 2-2-136, 13-35-226, 13-35-227, 13-35-403, 13-37-101, 13-37-102, 13-37-103,
15 13-37-104, 13-37-106, 13-37-107, 13-37-111, 13-37-113, 13-37-121, 13-37-124, 13-37-130, 13-37-131, AND
16 13-37-210, MCA; REPEALING SECTIONS 13-37-122, 13-37-128, AND 13-37-129, MCA; AND PROVIDING AN
17 IMMEDIATE EFFECTIVE DATE."

19 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

20

21 NEW SECTION. **Section 1. Commissioner to dismiss or refer complaint to political practices**
22 **commission.** (1) The commissioner may dismiss a complaint made pursuant to Title 13, chapter 35, or this
23 chapter if the commissioner determines that the complaint does not have merit or is insignificant.

24 (2) Any complaint that is not dismissed must be referred within 6 months to the political practices
25 commission for an administrative action under [section 3].

26

27 NEW SECTION. **Section 2. Political practices commission -- membership -- compensation.** (1)
28 There is a political practices commission that consists of three members appointed by the governor, subject to
29 confirmation by a majority of the senate, as follows:

30 (a) one member appointed from a list of three nominees submitted by the executive committee of the

1 Montana state democratic party;

2 (b) one member appointed from a list of three nominees submitted by the executive committee of the
3 Montana state republican party; and

4 (c) one member appointed from a list of three nominees submitted selected by the members appointed
5 under subsections (1)(a) and (1)(b).

6 (2) Commission members shall serve 4-year terms.

7 (3) Commission members are entitled to compensation and reimbursement for expenses as provided
8 in 2-15-122.

9

10 **NEW SECTION. Section 3. Contested case hearings -- penalties -- judicial review -- writ of**
11 **mandate.** (1) The commission shall dismiss, refer to the county attorney for possible criminal prosecution
12 pursuant to 13-37-124, or conduct an administrative contested case hearing on any matter referred to the
13 commission by the commissioner.

14 (2) All contested case hearings under this section must be conducted in accordance with the provisions
15 of Title 2, chapter 4, part 6, except as provided in this section.

16 (3) The office of the attorney general or an attorney for the commissioner of political practices hired
17 pursuant to 13-37-113 shall prosecute the matter. The person accused of a violation may be represented by
18 private counsel.

19 (4) (a) If a majority of the commission members find that the respondent is guilty of the violation, the
20 commission may impose an administrative penalty of up to \$750 for each violation, except that if the violation
21 concerned an unlawful contribution or expenditure, the administrative penalty may be up to \$750 or three times
22 the amount of the unlawful contribution or expenditure, whichever is greater.

23 (b) If the commission unanimously agrees that the violation was egregious, the commission may require
24 the respondent to pay for the cost of the hearing.

25 (5) The commission's ruling is subject to judicial review as provided in Title 2, chapter 4, part 7.

26 (6) If the commission fails to hold a contested case hearing within 6 months of the date on which the
27 commissioner referred the matter to the commission, the complainant may, within 90 days after expiration of the
28 6-month period, seek a writ of mandate from the district court in the first judicial district to compel the commission
29 to fulfill its duties under this section.

1 **SECTION 4. SECTION 2-2-136, MCA, IS AMENDED TO READ:**

2 **"2-2-136. Enforcement for state officers, legislators, and state employees -- referral of complaint**
3 **involving county attorney.** (1) (a) A person alleging a violation of this part by a state officer, legislator, or state
4 employee may file a complaint with the commissioner of political practices if the person has standing to file the
5 complaint. The commissioner does not have jurisdiction for a complaint concerning a legislator if a legislative act
6 is involved in the complaint. The commissioner also has jurisdiction over complaints against a county attorney
7 that are referred by a local government review panel pursuant to 2-2-144 or filed by a person directly with the
8 commissioner pursuant to 2-2-144(6). The commissioner may request additional information from the complainant
9 or the person who is the subject of the complaint to make an initial determination of whether the complaint states
10 a potential violation of this part.

11 (b) The commissioner may dismiss a complaint when the person who filed the complaint has failed to
12 demonstrate standing or may dismiss a complaint that is frivolous, does not state a potential violation of this part,
13 or does not contain sufficient allegations to enable the commissioner to determine whether the complaint states
14 a potential violation of this part. If the issues presented in a complaint have been addressed and decided in a prior
15 decision and the commissioner determines that no additional factual development is necessary, the commissioner
16 may issue a summary decision without holding an informal contested case hearing on the complaint.

17 (c) Except as provided in subsection (1)(b), if the commissioner determines that the complaint states a
18 potential violation of this part, the commissioner shall hold an informal contested case hearing on the complaint
19 as provided in Title 2, chapter 4, part 6. The commissioner shall issue a decision based upon the record
20 established before the commissioner.

21 (d) A person has standing to allege a violation when the person:

22 (i) alleges a past, present, or threatened injury to a property right or a civil right; and

23 (ii) alleges an injury that is distinguishable from an injury to the public generally, although the injury does
24 not need to be exclusive to the person alleging the injury.

25 (2) (a) Except as provided in subsection (2)(b), if the commissioner determines that a violation of this
26 part has occurred, the commissioner may impose an administrative penalty of not less than \$50 or more than
27 \$1,000.

28 (b) If the commissioner determines that a violation of 2-2-121(4)(b) has occurred, the commissioner may
29 impose an administrative penalty of not less than \$500 or more than \$10,000.

30 (c) If the violation was committed by a state employee, the commissioner may also recommend that the

1 employing state agency discipline the employee. The employing entity of a state employee may take disciplinary
2 action against an employee for a violation of this part, regardless of whether the commissioner makes a
3 recommendation for discipline. The commissioner may assess the costs of the proceeding against the person
4 bringing the charges if the commissioner determines that a violation did not occur or against the officer or
5 employee if the commissioner determines that a violation did occur.

6 (3) A party may seek judicial review of the commissioner's decision, as provided in chapter 4, part 7, of
7 this title, after a hearing, a dismissal, or a summary decision issued pursuant to subsection (1)(b).

8 (4) Except for records made public in the course of a hearing held under subsection (1) and records that
9 are open for public inspection pursuant to Montana law, a complaint and records obtained or prepared by the
10 commissioner in connection with an investigation or complaint are confidential documents and are not open for
11 public inspection. The complainant and the person who is the subject of the complaint shall maintain the
12 confidentiality of the complaint and any related documents released to the parties by the commissioner until the
13 commissioner issues a decision. However, the person who is the subject of a complaint may waive, in writing,
14 the right of confidentiality provided in this subsection. If a waiver is filed with the commissioner, the complaint and
15 any related documents must be open for public inspection. The commissioner's decision issued after a hearing
16 is a public record open to inspection.

17 (5) When a complaint is filed, the commissioner may issue statements or respond to inquiries to confirm
18 that a complaint has been filed, to identify against whom it has been filed, and to describe the procedural aspects
19 and status of the case.

20 (6) The commissioner may adopt rules to carry out the responsibilities and duties assigned by this part."
21

22 **Section 5.** Section 13-35-226, MCA, is amended to read:

23 **"13-35-226. Unlawful acts of employers and employees.** (1) It is unlawful for any employer, in paying
24 employees the salary or wages due them, to include with their pay the name of any candidate or any political
25 mottoes, devices, or arguments containing threats or promises, express or implied, calculated or intended to
26 influence the political opinions or actions of the employees.

27 (2) It is unlawful for an employer to exhibit in a place where the employer's workers or employees may
28 be working any handbill or placard containing:

29 (a) any threat, promise, notice, or information that, in case any particular ticket or political party,
30 organization, or candidate is elected:

1 (i) work in the employer's place or establishment will cease, in whole or in part, or will be continued or
2 increased;

3 (ii) the employer's place or establishment will be closed; or

4 (iii) the salaries or wages of the workers or employees will be reduced or increased; or

5 (b) other threats or promises, express or implied, intended or calculated to influence the political opinions
6 or actions of the employer's workers or employees.

7 (3) A person may not coerce, command, or require a public employee to support or oppose any political
8 committee, the nomination or election of any person to public office, or the passage of a ballot issue.

9 (4) A public employee may not solicit support for or opposition to any political committee, the nomination
10 or election of any person to public office, or the passage of a ballot issue while on the job or at the place of
11 employment. However, subject to 2-2-121, this section does not restrict the right of a public employee to perform
12 activities properly incidental to another activity required or authorized by law or to express personal political views.

13 (5) A person who violates this section is liable in ~~a civil~~ an administrative action ~~authorized by 13-37-128,~~
14 pursuant to [section 3] or a criminal action brought by ~~the commissioner of political practices or a county attorney~~
15 pursuant to 13-37-124 and 13-37-125."

16

17 **Section 6.** Section 13-35-227, MCA, is amended to read:

18 **"13-35-227. Prohibited contributions from corporations.** ~~(1) A corporation may not make a~~
19 ~~contribution or an expenditure in connection with to a candidate or a political committee that supports or opposes~~
20 ~~a candidate or a political party. (1) A CORPORATION MAY NOT MAKE A CONTRIBUTION TO A CANDIDATE OR CANDIDATE'S~~
21 ~~CAMPAIGN AND MAY NOT MAKE A CONTRIBUTION TO A POLITICAL COMMITTEE, INCLUDING BUT NOT LIMITED TO A POLITICAL~~
22 ~~PARTY COMMITTEE, UNLESS THE POLITICAL COMMITTEE SEGREGATES THE CONTRIBUTION IN AN ACCOUNT THAT IS~~
23 ~~SEPARATE FROM THOSE ACCOUNTS USED TO MAKE DIRECT CONTRIBUTIONS TO CANDIDATES AND CANDIDATES' CAMPAIGN~~
24 ~~COMMITTEES AND THE CONTRIBUTION IS USED AS AN INDEPENDENT EXPENDITURE.~~

25 (2) A CANDIDATE OR CANDIDATE'S COMMITTEE MAY NOT ACCEPT OR RECEIVE A CORPORATE CONTRIBUTION
26 DESCRIBED IN SUBSECTION (1).

27 ~~———— (2) A person, candidate, or political committee may not accept or receive a corporate contribution~~
28 ~~described in subsection (1).~~

29 ~~———— (3) This section does not prohibit the establishment or administration of a separate, segregated fund to~~
30 ~~be used for making political contributions or expenditures if the fund consists only of voluntary contributions~~

1 solicited from an individual who is a shareholder, employee, or member of the corporation.

2 ~~(4)(2)(3)~~ A person who violates this section is subject to the civil penalty provisions of 13-37-128 an
3 administrative action pursuant to [section 3]."

4

5 **Section 7.** Section 13-35-403, MCA, is amended to read:

6 "**13-35-403. Penalties.** A person who violates 13-35-402 is ~~liable in a civil action pursuant to 13-37-128~~
7 subject to an administrative action pursuant to [section 3]."

8

9 **Section 8.** Section 13-37-101, MCA, is amended to read:

10 "**13-37-101. Definitions.** As used in this chapter, unless the context clearly indicates otherwise, the
11 following definitions apply:

12 (1) "Commission" means the political practices commission established in [section 2].

13 ~~(1)(2)~~ "Commissioner" means the commissioner of political practices created by 13-37-102.

14 ~~(2)(3)~~ "Public office" has the meaning provided in 13-1-101.

15 ~~(3)(4)~~ "Recusal" means disqualification from a matter by reason of prejudice or conflict of interest.

16 ~~(4)(5)~~ "Relative" means a family member who is within the second degree of consanguinity or affinity to
17 the commissioner."

18

19 **Section 9.** Section 13-37-102, MCA, is amended to read:

20 "**13-37-102. Creation of office -- nomination panel -- removal.** (1) There is a commissioner of political
21 practices who is appointed by the governor, subject to confirmation by a majority of the senate, from a list of three
22 nominees submitted by the nomination panel provided for in subsection (2).

23 (2) A ~~four-member selection committee~~ five-member nomination panel composed of the speaker of the
24 house, the president of the senate, ~~and~~ the minority leaders of both houses of the legislature, and a fifth member
25 selected by a majority of the other four shall submit to the governor a list of ~~not less than two or more than five~~
26 three names of individuals for the governor's consideration. A majority of the members of the ~~selection committee~~
27 nomination panel shall agree upon each nomination.

28 ~~(2)(3)~~ The individual selected to serve as commissioner may be removed by the governor prior to the
29 expiration of the term only for incompetence, malfeasance, or neglect of duty. The governor's decision to remove
30 the commissioner must be stated in writing, and the sufficiency of the governor's stated causes for removing the

1 commissioner is subject to judicial review."

2

3 **Section 10.** Section 13-37-103, MCA, is amended to read:

4 **"13-37-103. Term of office.** Subject to the provisions of 13-37-104, the individual selected to serve as
5 commissioner is appointed for a ~~6-year~~ 4-year term and may not be reappointed to serve as commissioner."

6

7 **Section 11.** Section 13-37-104, MCA, is amended to read:

8 **"13-37-104. Vacancy.** (1) If for any reason a vacancy occurs in the position of commissioner, a
9 successor must be appointed within ~~30~~ 60 days as provided in 13-37-102(1) to serve out the unexpired term.
10 Each ~~nomination~~ appointment must be confirmed by the senate, but a nomination made while the senate is not
11 in session is effective as an appointment until the end of the next session.

12 (2) An individual who is selected to serve out the unexpired term of a preceding commissioner and who
13 has served ~~3~~ 2 years or more of an unexpired term is not eligible for reappointment.

14 (3) An individual who is selected to serve out the unexpired term of a preceding commissioner and who
15 has served less than ~~3~~ 2 years may be reappointed for a ~~6-year~~ the term as provided in 13-37-102(1)."

16

17 **Section 12.** Section 13-37-106, MCA, is amended to read:

18 **"13-37-106. Salary.** (1) The commissioner of political practices is entitled to receive a salary within the
19 pay band, as defined in 2-18-101, determined by the department of administration as provided in subsection (4).

20 (2) The commissioner is also entitled to longevity, expense reimbursement, leave, insurance, and other
21 benefits provided to classified state employees under Title 2, chapter 18.

22 (3) The salary of the commissioner may not be reduced during the term for which the commissioner is
23 appointed.

24 (4) The department of administration shall determine the appropriate occupation and pay band for the
25 commissioner of political practices in the same manner that it determines the occupation and pay band for
26 employees in state government pursuant to Title 2, chapter 18.

27 (5) The ~~governor~~ department of administration shall set the salary of the commissioner of political
28 practices within the pay band established by the department of administration.

29 (6) The commissioner of political practices must receive pay adjustments consistent with those required
30 by the legislature for state employees in 2-18-303 and 2-18-304."

2 **Section 13.** Section 13-37-107, MCA, is amended to read:

3 **"13-37-107. Commissioner of political practices -- qualifications.** The individual appointed to serve
4 as commissioner:

5 (1) must be a citizen of the United States and a resident of Montana as provided in 13-1-112; ~~and~~

6 (2) on the date of appointment, must be registered to vote in Montana; and

7 (3) may not have a relationship, association, or employment history that would cause the individual, if
8 appointed as commissioner, to have to be recused in presently identifiable instances, such as those related to
9 a currently serving elected official, a current candidate, campaign manager, or party director, or a currently active
10 political organization, that are or could be the subject of a complaint during the commissioner's term."

11

12 **Section 14.** Section 13-37-111, MCA, is amended to read:

13 **"13-37-111. Investigative Commissioner's investigative powers and duties -- recusal.** (1) Except
14 as provided in 13-35-240, the commissioner is responsible for investigating all of the alleged violations of the
15 election laws contained in Title 13, chapter 35, of this title or this chapter and ~~in conjunction with the commission~~
16 and the county attorneys ~~is~~ are responsible for enforcing these election laws.

17 (2) The commissioner may:

18 (a) investigate all statements filed pursuant to the provisions of Title 13, chapter 35, of this title or this
19 chapter and shall investigate alleged failures to file any statement or the alleged falsification of any statement filed
20 pursuant to the provisions of chapter 35 ~~of this title~~ or this chapter. ~~Upon the submission of a written complaint~~
21 ~~by any individual, the~~ The commissioner shall investigate any other alleged written complaint by an individual
22 alleging that the individual has been identifiably and specifically harmed by a violation of the provisions of Title
23 13, chapter 35, of this title, this chapter, or any rule adopted pursuant to chapter 35 of this title or this chapter.

24 (b) inspect any records, accounts, or books that must be kept pursuant to the provisions of Title 13,
25 chapter 35, of this title or this chapter that are held by any political committee or candidate, as long as the
26 inspection is made during reasonable office hours; and

27 (c) administer oaths and affirmations, subpoena witnesses, compel their attendance, take evidence, and
28 require the production of any books, papers, correspondence, memoranda, bank account statements of a political
29 committee or candidate, or other records that are relevant or material for the purpose of conducting any
30 investigation pursuant to the provisions of Title 13, chapter 35, of this title or this chapter.

1 (3) If the commissioner determines that considering a matter would give rise to the appearance of
2 impropriety or a conflict of interest, the commissioner is recused from participating in the matter.

3 (4) (a) If the commissioner is recused pursuant to this section, the commissioner shall appoint a deputy;
4 subject to subsection (4)(b).

5 (b) The deputy:

6 (i) may not be an employee of the office of the commissioner;

7 (ii) must have the same qualifications as specified for the commissioner in 13-37-107;

8 (iii) with respect to only the specific matter from which the commissioner is recused, has the same
9 authority, duties, and responsibilities as the commissioner would have absent the recusal; and

10 (iv) may not exercise any powers of the office that are not specifically related to the matter for which the
11 deputy is appointed.

12 (5) The appointment of the deputy is effectuated by a contract between the commissioner and the
13 deputy. The contract must specify the deputy's term of appointment, which must be temporary, the matter
14 assigned to the deputy, the date on which the matter assigned must be concluded by the deputy, and any other
15 items relevant to the deputy's appointment, powers, or duties."

16

17 **Section 15.** Section 13-37-113, MCA, is amended to read:

18 **"13-37-113. Hiring of attorneys --prosecutions.** The commissioner may hire or retain attorneys who
19 are properly licensed to practice before the supreme court of the state of Montana to prosecute civil violations
20 of Title 13, chapter 35, of this title or this chapter pursuant to [section 3]. ~~Any attorney retained or hired shall~~
21 ~~exercise the powers of a special attorney general, and the attorney may prosecute, subject to the control and~~
22 ~~supervision of the commissioner and the provisions of 13-35-240, 13-37-124, and 13-37-125, any criminal or civil~~
23 ~~action arising out of a violation of any provision of chapter 35 of this title or this chapter. All prosecutions must~~
24 ~~be brought in the state district court for the county in which a violation has occurred or in the district court for~~
25 ~~Lewis and Clark County. The authority to prosecute as prescribed by this section includes the authority to:~~

26 ~~—— (1) institute proceedings for the arrest of persons charged with or reasonably suspected of criminal~~
27 ~~violations of chapter 35 of this title or this chapter;~~

28 ~~—— (2) attend and give advice to a grand jury when cases involving criminal violations of chapter 35 of this~~
29 ~~title or this chapter are presented;~~

6 **Section 16.** Section 13-37-121, MCA, is amended to read:

7 **"13-37-121. Inspection of statements and reports -- issuance of orders of noncompliance --**

8 **referral to commission.** (1) Each statement and report filed with the commissioner during an election or within

9 60 days after the election must be inspected within 20 days after the statement or report is filed. Intermediate

10 Saturdays, Sundays, and holidays must be excluded in the computation of time under this section. If a person

11 has not satisfied the provisions of this chapter, the commissioner shall immediately notify the person of the

12 noncompliance. Notification by the commissioner may be accomplished by written or electronic communication

13 or by telephone. The commissioner shall also provide the person with proof of the noncompliance. If the person

14 fails to comply after the notification, the commissioner shall issue an order of noncompliance as provided in this

15 section.

16 (2) An order of noncompliance may be issued when:

17 (a) upon examination of the official ballot, it appears that the person has failed to file a statement or
 18 report as required by this chapter or that a statement or report filed by a person does not conform to law; or

19 (b) it is determined that a statement or report filed with the commissioner does not conform to the
 20 requirements of this chapter or that a person has failed to file a statement or report required by law.

21 (3) If an order of noncompliance is issued during a campaign period or within 60 days after an election,

22 a candidate or political committee shall submit the necessary information within 5 days after receiving the order

23 of noncompliance. Upon ~~a~~ the person's failure to submit the required information within the time specified, the

24 ~~appropriate county attorney or the commissioner may initiate a civil or criminal action pursuant to the procedures~~

25 ~~outlined in 13-37-124 and 13-37-125~~ commissioner shall refer the matter to the commission for an administrative

26 action under [section 3].

27 (4) If an order of noncompliance is issued during any period other than that described in subsection (3),

28 a candidate or political committee shall submit the necessary information within 10 days after receiving the order

29 of noncompliance. Upon ~~a~~ the person's failure to submit the required information within the time specified, the

30 ~~appropriate county attorney or the commissioner shall initiate a civil or criminal action pursuant to the procedures~~

1 outlined in 13-37-124 and 13-37-125 commissioner shall refer the matter to the commission for an administrative
 2 action under [section 3].

3 ~~———— (5) After a complaint is filed with the commissioner pursuant to 13-37-111, the procedure described in~~
 4 ~~this section regarding the provision of notice and issuance of orders of noncompliance is not a prerequisite to~~
 5 ~~initiation of any other administrative or judicial action authorized under chapter 35 of this title or this chapter."~~

7 **Section 17.** Section 13-37-124, MCA, is amended to read:

8 **"13-37-124. Consultation and cooperation with county attorney -- criminal prosecution.** (1) Except
 9 as provided in 13-35-240, whenever the ~~commissioner~~ commission determines that there appears to be sufficient
 10 evidence to justify a ~~civil or~~ criminal prosecution under Title 13, chapter 35, of this title or this chapter, the
 11 ~~commissioner~~ commission shall notify the county attorney of the county in which the alleged violation occurred
 12 and shall arrange to transmit to the county attorney all information relevant to the alleged violation. ~~If the county~~
 13 ~~attorney fails to initiate the appropriate civil or criminal action within 30 days after receiving notification of the~~
 14 ~~alleged violation, the commissioner may then initiate the appropriate legal action.~~

15 (2) A county attorney may, ~~at any time prior to the expiration of the 30-day time period specified in~~
 16 ~~subsection (1), waive the right to prosecute, and the waiver authorizes the commissioner to initiate the~~
 17 ~~appropriate civil or criminal action~~ shall notify the commission within 30 days of a referral under this section if the
 18 county attorney decides not to proceed with a criminal prosecution.

19 (3) The provisions of subsection (1) do not apply to a situation in which the alleged violation has been
