14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

16	NEW SECTION. Section 1. Shared-use trail pilot project. (1) The department of transportation shall
17	establish, TO THE EXTENT FUNDS ARE AVAILABLE PURSUANT TO [SECTION 2], a pilot project for the maintenance and
18	repair of shared-use trails described in this part and for educating users of shared-use trails.
19	(2) The department shall, TO THE EXTENT FUNDS ARE AVAILABLE PURSUANT TO [SECTION 2]:
20	(a) obtain or compile an inventory of all shared-use trails located in the right-of-way of each
21	STATE-MAINTAINED federal-aid highway in Montana, the estimated costs to maintain and repair the shared-use
22	trails, and other information relevant to the use and maintenance of the shared-use trails;
23	(b) contract for services to produce, disseminate, and deliver safety information and programs to
24	pedestrians, bicyclists, and other potential users of shared-use trails. The contract must be with an entity that
25	has a demonstrated ability to provide safety information on a statewide basis to pedestrians, bicyclists, and other
26	potential users of shared-use trails.
27	(c) solicit public input for shared-use trails; and
28	(d) at least annually, conduct a public forum to gather input regarding shared-use trail maintenance,
29	repair, and user education.
30	(3) The department may conduct additional public forums in the transportation commission districts

established in 2-15-2502 to gather more localized input regarding shared-use trail maintenance, repair, and user education.

- (4) The purpose of the pilot project is to:
- 4 (a) ensure that the department compiles, analyzes, and maintains and the public has access to relevant 5 information that is needed to maintain and repair shared-use trails;
 - (b) provide safety education to users of footpaths, bicycle paths or trails, or the highways of this state
 PEDESTRIANS, BICYCLISTS, AND OTHER POTENTIAL USERS OF SHARED-USE TRAILS; and
 - (c) ensure that available funding is equitably distributed within the transportation commission districts of the state and that potential users of shared-use trails in different regions of the state have an opportunity to participate in planning for and prioritizing the maintenance of shared-use trails.

- NEW SECTION. Section 2. Allocation of funds. (1) Of the total funds in the account established in 61-3-321(21)(a):
- (a) IN FISCAL YEAR 2016 ONLY, an amount not to exceed \$90,000 in fiscal year 2016 \$50,000 is allocated to the department of justice to reprogram the department's software AND EQUIPMENT OF THE DEPARTMENT AND THE DEPARTMENT'S VENDOR to accommodate the optional fee provided for in 61-3-321(21):
- (B) IN EACH FISCAL YEAR, AN AMOUNT NOT TO EXCEED \$90,000 MUST BE ALLOCATED TO THE DEPARTMENT OF JUSTICE FOR THE ADDITIONAL CONTRACT COSTS FOR THE VEHICLE RENEWAL CARD VENDOR TO COVER FORMS AND MAILING THAT RESULT FROM THE PROVISIONS OF 61-3-321(21); and

- (ii) 80% of the total must be allocated as provided in subsection (2) by the transportation commission DEPARTMENT OF TRANSPORTATION to each of the five districts established in 2-15-2502.
- (2) The amount of funds to be allocated to a district is equal to the total amount of optional registration fees provided for in 61-3-321(21)(a) collected in the district divided by the total amount of the optional registration fees provided for in 61-3-321(21)(a) collected for the entire state.
- (3) Except as provided in subsection (4), the total funds allocated to a district under subsection (1)(b)(ii) (1)(C)(II) must be used within the district for the maintenance and repair of shared-use trails described in this part.

 At least The DEPARTMENT MAY USE BUT IS NOT REQUIRED TO USE UP TO 10% of the funds allocated to a district under

subsection (1)(b)(ii) must be used (1)(C)(II) to maintain or repair shared-use trails that are not part of the federal-aid highway system.

- (4) (a) Subject to the provisions of subsection (4)(b), if all of the shared-use trails in the district are maintained and repaired at a level that meets or exceeds the standards established pursuant to 60-3-304(3)(c) or if there are no shared-use trails in the district that are not part of the federal-aid highway system, any funds remaining in a fiscal year may be used to construct new shared-use trails within the district.
- (b) Prior to the construction or extension of a shared-use trail, the department shall enter into a maintenance agreement with the county or municipality, or both, in which the trail is proposed to be constructed or extended. Based on the maintenance agreement and available funding, the department shall transfer funds from the account established in 61-3-321(21)(a) to the appropriate county or municipality as provided for in the maintenance agreement.

"60-3-302. Bicycle Shared-use trail defined. As used in this part, "bicycle "shared-use trail" means a publicly owned and maintained lane or way designated and signed for use as a bicycle route a multiuse trail or other path that is physically separated from motorized vehicular traffic by an open space or, PAVEMENT

1 MARKINGS, OR A barrier, either within a highway right-of-way or within an independent right-of-way, and THAT IS

- 2 <u>usable for transportation purposes by pedestrians, runners, bicyclists, skaters, equestrians, and other</u>
- 3 nonmotorized users. A SIDEWALK, AS DEFINED IN 61-8-102, IS NOT A SHARED-USE TRAIL."

- **Section 6.** Section 60-3-303, MCA, is amended to read:
- "60-3-303. Footpaths and bicycle Shared-use trails to be established -- funding. (1) (a) The Subject to the provisions of subsection (1)(b), the commission OR THE DEPARTMENT or a county or city, with funds received from the commission OR THE DEPARTMENT, may construct footpaths and bicycle trails. Footpaths and bicycle trails may be established and extended to the nearest city or town or termination point of the highway or road or extend a shared-use trail:
- (i) wherever a highway, road, or street is being constructed, reconstructed, or relocated. In addition, footpaths and bicycle trails may be established;
- (ii) at any time along all streets a road, street, or highway under state jurisdiction. Funds may also be expended to construct footpaths and bicycle trails along other highways, roads, and streets and in parks and recreation areas; or
- (iii) if the construction enhances traffic safety and convenience. Footpaths and bicycle trails may be constructed along all sections of the national defense interstate highway system.
- (b) Funds allocated by the commission DEPARTMENT pursuant to [section 2] may be used for the purposes described in subsection (1)(a) only as provided in [section 2(3)].
 - (2) Footpaths and trails A shared-use trail may not be established under subsection (1):

(1) Except as otherwise provided in this section, registration fees must be paid upon registration or, if applicable, renewal of registration of motor vehicles, snowmobiles, watercraft, trailers, semitrailers, and pole trailers as provided in subsections (2) through (20):.
- (2) Unless a light vehicle is permanently registered under 61-3-562, the annual registration fee for light vehicles, trucks and buses under 1 ton, and logging trucks less than 1 ton is as follows:
- (a) if the vehicle is 4 or less years old, \$217;
- 17 (b) if the vehicle is 5 through 10 years old, \$87; and
- 18 (c) if the vehicle is 11 or more years old, \$28.
- 19 (3) Except as provided in subsection (15), the one-time registration fee based on the declared weight 20 of a trailer, semitrailer, or pole trailer is as follows:
 - (a) if the declared weight is less than 6,000 pounds, \$61.25; or

- 5 (b) The owner of a motor home that is 11 years old or older and that is subject to the registration fee 6 under this section may permanently register the motor home upon payment of:
- 7 (i) a one-time registration fee of \$237.50;
- 8 (ii) unless a new set of license plates is being issued, an insurance verification fee of \$5, which must be deposited in the account established under 61-6-158;
 - (iii) if applicable, five times the renewal fees for personalized license plates under 61-3-406; and
 - (iv) if applicable, the donation fee for a generic specialty license plate under 61-3-480 or a collegiate license plate under 61-3-465.

- 4 (B) if the business reregisters the snowmobile for a second year, a fee of \$20.
- 5 (ii) If the business reregisters the snowmobile for a third year, the snowmobile must be permanently 6 registered and the business is assessed the registration fee imposed in subsection (11)(a).
 - (12) (a) The one-time registration fee for a low-speed electric vehicle is \$25.
 - (b) The one-time registration fee for a golf cart that is owned by a person who has or is applying for a low-speed restricted driver's license is \$25.
 - (c) The one-time registration fee for golf carts authorized to operate on certain public streets and highways pursuant to 61-8-391 is \$25. Upon receipt of the fee, the department shall issue the owner a decal, which must be displayed visibly on the golf cart.
 - (13) (a) Except as provided in subsection (13)(b), a fee of \$10 must be collected when a new set of standard license plates, a new single standard license plate, or a replacement set of special license plates required under 61-3-332 is issued. The \$10 fee imposed under this subsection does not apply when previously issued license plates are transferred under 61-3-335. All registration fees imposed under this section must be paid if the vehicle to which the plates are transferred is not currently registered.
 - (b) An additional fee of \$15 must be collected if a vehicle owner elects to keep the same license plate number from license plates issued before January 1, 2010, when replacement of those plates is required under 61-3-332(3).
 - (c) The fees imposed in this subsection (13) must be deposited in the account established under 61-6-158, except that \$2 of the fee imposed in subsection (13)(a) must be deposited in the state general fund.

 - (15) Whenever ownership of a trailer, semitrailer, pole trailer, off-highway vehicle, motorcycle, quadricycle, travel trailer, motor home, motorboat, sailboat, personal watercraft, motorized pontoon, snowmobile, motor vehicle owned and operated solely as a collector's item pursuant to 61-3-411, or low-speed electric vehicle

1 is transferred, the new owner shall title and register the vehicle or vessel as required by this chapter and pay the 2 fees imposed under this section.

- (16) A person eligible for a waiver under 61-3-460 is exempt from the fees required under this section.
- 4 (17) Except as otherwise provided in this section, revenue collected under this section must be deposited in the state general fund.
 - (18) The fees imposed by subsections (2) through (12) are not required to be paid by a dealer for the enumerated vehicles or vessels that constitute inventory of the dealership.
 - (19) (a) Unless a person exercises the option in either subsection (19)(b) or (19)(c), an additional fee of \$6 must be collected for each light vehicle registered under this part. This fee must be accounted for and transmitted separately from the registration fee. The fee must be deposited in an account in the state special revenue fund to be used for state parks, for fishing access sites, and for the operation of state-owned facilities. Of the \$6 fee, the department of fish, wildlife, and parks shall use \$5.37 for state parks, 25 cents for fishing access sites, and 38 cents for the operation of state-owned facilities at Virginia City and Nevada City.
 - (b) A person who registers a light vehicle may, at the time of annual registration, certify that the person does not intend to use the vehicle to visit state parks and fishing access sites and may make a written election not to pay the additional \$6 fee provided for in subsection (19)(a). If a written election is made, the fee may not be collected.
 - (c) (i) A person who registers one or more light vehicles may, at the time of annual registration, certify that the person does not intend to use any of the vehicles to visit state parks and fishing access sites and may make a written election not to pay the additional \$6 fee provided for in subsection (19)(a). If a written election is made, the fee may not be collected at any subsequent annual registration unless the person makes the written election to pay the additional fee on one or more of the light vehicles.
 - (ii) The written election not to pay the additional fee on a light vehicle expires if the vehicle is registered to a different person.
 - (20) For each light vehicle, trailer, semitrailer, pole trailer, heavy truck, motor home, motorcycle, quadricycle, and travel trailer subject to a registration fee under this section, an additional fee of \$5 must be collected and forwarded to the state for deposit in the account established in 44-1-504.
 - (21) (a) Unless a person exercises the option in subsection (21)(b), an additional fee of \$2 must be collected for each light vehicle registered under this part. This fee must be accounted for and transmitted separately from the registration fee. The fee must be deposited in an account in the state special revenue fund.

(b) A person who registers one or more light vehicles may, at the time of annual registration, certify that the person does not intend to use shared-use trails and may make a written election not to pay the additional \$2 fee provided for in subsection (21)(a). If a written election is made, the fee may not be collected at any subsequent annual registration unless the person makes the written election to pay the additional fee.

(c) The written election not to pay the additional fee on a light vehicle expires if the vehicle is registered to a different person.

(21)(22) This section does not apply to a motor vehicle, trailer, semitrailer, or pole trailer that is governed by 61-3-721."

Section 11. Section 61-3-509, MCA, is amended to read:

"61-3-509. Disposition of fees -- responsibility for dishonored payments. (1) All Except as otherwise provided in 61-3-321, all registration fees imposed by 61-3-321 on light vehicles, motor homes, motorcycles, quadricycles, buses, motor vehicles having a manufacturer's rated capacity of more than 1 ton, and truck tractors for which a license is sought and an original application for title that includes a manufacturer's statement of origin is made must be remitted to the state as provided in 15-1-504 every 30 days. The payments must be deposited in the state general fund.

- (2) (a) The department, its authorized agent, or a county treasurer is responsible for pursuing remedies available under 27-1-717 or otherwise provided by law when a check, draft, converted check, electronic funds transfer, or order for the payment of money is dishonored:
 - (i) for lack of funds or credit;
- 23 (ii) because the issuer does not have an account with the entity from which the funds are to be drawn; 24 or
 - (iii) because the issuer stops payment with the intent to defraud the payee of the check or the payee named on the issued check, draft, converted check, electronic funds transfer, or order for the payment of money.
 - (b) Once fees have been remitted to the state under this section, adjustments may be made only for dishonored instruments if less than 1 year has elapsed from the date of remittance."

NEW SECTION. Section 12. Restriction on department of justice. The department of justice may



not change to a motor registration renewal card that is a larger format or different type from the card format and
type in use prior to [the effective date of this act] solely because of the addition of language providing for the
optional fee provided for in 61-3-321(21).
