House convened at 1:00 p.m. Mr. Speaker presiding. Invocation by Representative Jerry Bennett. Pledge of Allegiance to the Flag.

Roll Call. All members present. Quorum present.

**MOTIONS**

Majority Leader Regier moved the House recess for the purpose of receiving an address by the Honorable Congressman from the State of Montana, Ryan Zinke. Upon Adjournment of the Joint Session, the House will reconvene. Motion carried.

House in Recess.

Sergeant-at-Arms Lenz notified Speaker Knudsen that the Honorable Senate of the State of Montana was awaiting entrance to the Chamber.

Speaker Knudsen requested Sergeant-at-Arms Lenz admit the Honorable Senate into the House Chambers.

Speaker Knudsen introduced Senate President Barrett.

Senate Majority Leader Rosendale moved that the body resolve itself into a joint session for the purpose of receiving an address from the Honorable Congressman from the State of Montana, Ryan Zinke. Motion carried.

Senate Majority Leader Rosendale moved that President Barrett be authorized to appoint a committee of four to notify Congressman Zinke that the body was in joint session and ready to receive his address. Motion carried.

President Barrett appointed Senator Buttrey, Senator Stewart Peregoy, Representative Smith, and Representative Olszewski to escort Congressman Zinke into the House Chambers.

Sergeant-at-Arms Spencer announced that the Honorable Congressman Ryan Zinke, was awaiting entrance to the House.

The Committee escorted Congressman Zinke into the Chambers.

Congressman Zinke gave the following remarks:

**INTRODUCTION**

1. Thank House Speaker Knudsen and Senate President Barrett.
2. Thank the members of the press.
3. Thank the People of Montana

**CONSTITUTION**

My first day as your Congressman started the same way my first days in the Navy and State Senate started: with an Oath. I took an oath to defend the constitution from enemies both foreign and domestic. And that's exactly what I'm going to do.

**LOCAL CONTROL**

The Constitution respects the sovereignty of the states and local governments. Yet, we have a President from Chicago who believes he knows how to manage Montana better than Montanans.

1. Public Lands-In Montana, our land is our way of life. That's why I fought to be on the Natural Resources Committee.
  - a. Co-sponsored the Recreational Fishing and Hunting Heritage and Opportunities Act-Protects hunting and fishing rights on federal lands
  - b. Forestry Reform-Fire vs Harvest. Economic engine local communities.
  - c. Public access to public lands: tourism, recreation, hunting, farming and grazing, energy
  - d. Sage Grouse and other wildlife
2. Energy-I am a Teddy Roosevelt Conservationist-I still drive a Prius. Protecting Montana lands and developing our energy potential are not mutually exclusive. If anything, Montana can be the engine that powers American energy independence.
  - a. On my first day in Congress, I co-sponsored legislation to build the Keystone Pipeline.
  - b. Update technology in aging pipelines and those in sensitive areas

**VETERANS**

1. We have a strong patriotic heritage in Montana: 1 in 10 of us have served in the military. During my first month in Congress, I worked on important legislation to help honor the promise we made to our veterans.
  - a. Introduced the Veterans Access to Community Care Act-Allows veterans in rural areas to seek care outside the VA if they live more than 40 miles away.

- b. Co-sponsored Hire our Heroes Act-Eliminates the penalty on small businesses who hire Veterans (ObamaCare exemption)
- c. Clay Hunt Suicide Prevention for American Veterans (SAV) Act-Strengthens suicide prevention services for veterans
- d. Today I visited the local VA facility-tell anecdote.

**INFRASTRUCTURE**

Infrastructure is a fundamental role of government and I urge Congress to approve a 5 year infrastructure plan-aging bridges, roads, pipelines

- a. Recent Oil Spill is an example of an aging pipeline that does not use latest technology
- b. Best technology available for sensitive areas
- c. Rail for ag

**CONCLUDE**

I will work with absolutely anybody who has the best interest of Montana at heart. Senators Steve Daines and Jon Tester and I have already worked together on a number of bipartisan measures for the people of Montana.

As the sole MT Rep I represent all Montanans not just those who voted for me.

**"20-20-401. Trustees' election duties -- ballot certification.** (1) The trustees are the general supervisors of school elections unless the trustees request and the county election administrator agrees to conduct a school election under 20-20-417.

(2) Not less than 25 days before an election, the clerk of the district shall prepare a certified list of the names of all candidates entitled to be on the ballot and the official wording for each ballot issue. The candidates' names must appear on the ballot in accordance with 13-12-203. The clerk

shall arrange for printing the ballots. Ballots for absentee voting must be printed and available at least 20 days before the election, except as provided in 20-9-426(2) for a bond election not held in conjunction with a school election. Names of candidates on school election ballots need not be rotated.

(3) Before the opening of the polls, the trustees shall cause each polling place to be supplied with the ballots and supplies necessary to conduct the election."
