The district court shall declare the existence of a usual and accustomed place as well as the terms and conditions of such use, and the plaintiff carries the burden of proof by a preponderance of the evidence. A declaratory judgment action in state district court brought by the Tribes does not waive the Tribes' sovereign immunity for any relief or action beyond that particular matter. No attorney fees may be awarded against any original party to such an action, except for violations of the rules of civil procedure as determined by the district court."
