(a) electronically transmitting the information in a format established by the board unless the board has granted a waiver allowing the information to be submitted in a

nonelectronic manner; and

(b) submitting the information in accordance with time limits set by the board unless the board grants an extension because:

(ii) the board is unable to receive electronic submissions.

(2) This section does not apply to:

(a) a prescriber who dispenses or administers drugs to the prescriber's patients; or

(b) a prescription drug order for a controlled substance dispensed to a person who is hospitalized.

(3) A naturopathic physician as defined in 37-26-103 shall obtain authorization in accordance with rules adopted by the board to access the registry."
