#### TIM BABCOCK

Tim Babcock was named Milford Babcock when he was born on October 27, 1919, in a humble home in Littlefork, Minnesota, to Erwin and Olive (Rinehart) Babcock. He was nicknamed "Tiny Tim" by his aunt. He soon outgrew the "Tiny" part, but the name "Tim" stuck to him for life.

He graduated from Dawson County High School in 1939 and headed for California with a cousin and a friend and found a job selling pots and pans door to door. He eventually got a job at Douglas Aircraft in Santa Monica. Tim and his high school sweetheart, Betty Lee, were married on September 21, 1941 in Las Vegas.

Six months after Pearl Harbor was attacked on December 7, 1941, Tim was called to duty. Tim shipped out on December 12, 1944 as part of the 2<sup>nd</sup> Battalion, E Company, 394<sup>th</sup> Infantry Regiment, 99<sup>th</sup> Infantry Division and fought in the "Battle of the Bulge." He captured a German officer and was awarded a Bronze Star for heroism at the Remagen Bridge. The following citation was sent home to his family.

"Private First Class Tim Babcock, 394 Infantry, United States Army, for heroic action in connection with military operations against the enemy on March 11, 1945, in Germany. Private First Class Babcock braved murderous automatic weapons fire in his determination to secure the aid of the adjacent squad in freeing his own unit, pinned down by withering fire. Upon reaching the unit, he quickly acquainted them with the situation and led them to the enemy's flank and directed the annihilation of the hard fighting group, enabling his men to proceed to the objective. By his heroic execution of duty, Private First Class Babcock reflects credit upon himself and the armed forces."

Tim was elected as a State Representative from Custer County in 1952 and then in 1956 and 1958 representing Yellowstone County. He was elected Lieutenant Governor in 1960 to serve with Governor Donald Nutter. Governor Nutter was killed in a plane crash on January 25, 1962, and Tim Babcock was constitutionally placed into the office of Governor. He won the election in 1964 and served as Governor until 1969.

Tim represented Montana at several special events during his tenure as Governor, the first being the World's Fair in Seattle in 1962. On January 1, 1964, the Montana Territorial Centennial was kicked off at the Pasadena Rose Parade. The Montana Centennial Train left Billings on April 5, 1964, and made fifteen stops on the way to its final destination in New York.

After leaving the Governor's office Tim had several business enterprises: the Babcock and Lee Truck Line with Betty's father, Occidental Petroleum, January Mining Company, Colonial Inn, KTCM-TV,

Davenport Hotel in Spokane and as a consultant. Tim purchased the famous Ox Bow Ranch in 1978 and went into the cattle business. He also raised thoroughbred horses on the ranch.

Tim and Betty's daughter Marla and his wife Betty predeceased him. He is survived by his daughter Lorna Kuney (Bill); grandchildren, Lee Ann Ruud (Monte), Tim Kuney (Tina), Ralph Kuney, Phoebe Winchester (Johnny) and Mathew Fillinger; and great grandchildren, Kate, Lizzy and Jon Ruud, Jack and Anna Kuney, Connor and Nevan Olson, Trace and Marlee Williams, Declan Winchester, and Cody, Dylan and Noemi Fillinger.

Ed graduated from Scobey schools and later from Seattle University.

In 1945 Ed married Betty Hillstrom and they farmed the family homestead and raised their family. Ed was elected to the State Senate in 1956 and re-elected in 1960. While serving in the Legislature he introduced a very important bill to Daniels County which provided for counties to receive payments "in lieu of taxes" on state lands. After his stint in the Senate, Ed remained active in politics.

In 1969 Ed and Betty moved to Helena, where he worked for the Department of State Lands, implementing the Resource Development Program. In 1972 he was appointed Director of the Department of Professional and Occupational Licensing, serving until his retirement in 1981. Ed and Betty moved back to Scobey three years later, and Ed served on many boards, including the Hospital Foundation and local co-ops. In his later years he especially enjoyed photography and following the activities of his grandchildren. Ed believed in accomplishing at least one thing every day.

Ed is survived by daughter Mary Vollertsen of Choteau; sons Steve of Scobey and Jack of Peerless; "daughter" Honey Richardson of Missoula; and seven grandchildren. In addition to his parents, Ed was preceded in death by his wife Betty in 1997.

George Darrow was born in Osage, Wyoming on Friday the 13<sup>th</sup> of August, 1924 to George and Marjorie (Ord) Darrow. During George's early life the family lived in New York and spent summers in Wyoming. He earned degrees in geology and economics from the University of Michigan where he played football and wrestled. He served in the Navy and worked in oil and groundwater exploration in Billings. In 1953 George married Eileen Riedl, and they had four children: Roy, Karen, Reed and John. The couple later divorced, and George married Elna Eshom in Bigfork in 1976. George and Elna were married for 32 years. Elna passed away in 2009 and his son John in 2010.

The Darrows were consummate volunteers for decades in the Bigfork community where they owned and operated Kootenai Galleries for many years. He was a driving force behind the Bigfork Center for the Performing Arts and led an effort to raise nearly \$1 million for the center in the mid-1980s. George served on a committee to conserve Cougar Canyon, a tract of state land on the mountainside above Woods Bay, as accessible public property.

As a Republican state legislator in both the House and Senate from 1967 to 1974, George wrote and led the passage of the Montana Environmental Policy Act, landmark legislation that still guides the planning of development projects with a focus on environmental impacts. George was known as the father of MEPA. He was the chief sponsor of the Montana Water Policy Act in the 1967 Legislature.

George is survived by his children, Roy Darrow, Reed Darrow and Karen Darrow.

Bob Depratu was born in 1939 in Eureka, Montana. He learned early on in life that hard work was the gateway to a better life. Bob got his first job at age nine when his father bought him a rototiller and Bob worked neighbors' gardens for \$5 apiece. During his seventh and eighth grade years at the Rexford school, he would line up prospective customers to buy vehicles from Rygg Ford. He sold cars for Rygg after graduating from Lincoln County High School in Eureka in 1957 and during the summer between his two years at Kinman Business University in Spokane, where he earned an associate degree in accounting. He got his driver's license at age 12 and delivered groceries after school for several years. By 15 he was foreman of the hay crew for the Sam Leighty farm at Rexford. At 16 he was working with a crew at Valcor Logging, driving the trucks and operating a skid cat.

After he married Bea in 1959, the couple settled into Whitefish and he went right to work at the Ford dealership selling cars for Rygg until he bought the business five years later. He was President of the Montana Auto Dealers Association and was named to the Ford Motor Co. National Dealer Council in 1981, where he served on the new products and political affairs committees. He served on Ford's customer resolution board for six years.

He was proud of the work ethic he and Bea instilled in their own three children, Bret, Bart and Brenda. All three worked at the dealership during their youth. Bart joined the business as a partner in 1985 and remains a primary owner. Brenda is the parts and service director.

Bob's community service ranged from being a yeti in the Winter Carnival to faithful involvement with the Jaycees, Rotary and Chamber of Commerce. He was very generous with his time and in making contributions to worthwhile organizations.

Bob served in the state Senate from 1997 to 2005 and became chairman of the Senate Taxation Committee. Bob said in 2012 that his work to pass legislation to lower the state's income and capital gains taxes was his most noteworthy accomplishment as a legislator. DePratu "was a great man, a great gentleman who was willing to work with anyone and everyone," former state Representative Bob Lawson of Whitefish said in Bob's obituary.

Bob is survived by his wife of 54 years, Bea DePratu; sons Bret and Bart; and daughter, Brenda DePratu.

Harold was born in Great Falls, Montana, on November 11, 1925, the oldest son of Ole and Effie Gunderson. He was raised in Power, Montana, graduating from Power High School in 1943. After graduation he enlisted in the Air Force and served as a flight engineer on a B29 bomber in the Pacific Theater, surviving a major plane crash. After he returned from the war he attended Montana State University earning a BS in Economics.

Edna and Harold married in 1947, and they had five children. Edna attended MSU, majoring in journalism before moving to the farm in Power where the couple started their family. In 1960, she and Harold moved their family to Havre, where together they established the Hi-Line Herald newspaper and she pursued her career in journalism. He actively supported the State Hail Insurance program and fought to increase its coverage from \$12 to \$24 per acre in the 1967 Legislature. Jack's father, Ole, and his older brother, Harold, were also members of the House of Representatives.

After Jack retired from farming in 1980, he and Corkey moved to Helena. In his early years in Helena, Jack was the administrator of the State Hail Department for four and a half years. Jack and Corkey loved to travel with their friends. Jack visited 48 of the 50 states and also Japan, Taiwan, Australia, New Zealand and the British Isles. Jack later married Bernice Winters. Jack and Bernice also lived in Helena and traveled extensively. They divorced in 1997.

He was an Eagle Scout and a recipient of the Boy Scouts Order of the Arrow.

From 1988 to 1993, he served as a member of the Montana Board Of Regents. He was Chairman of the Board of Regents from 1990 to 1993.

In 1994, Bill was the recipient of the Montana State University Blue and Gold Award for his widespread impact on agriculture. Bill was an ordained elder in the Presbyterian Church and a member of the Presbyterian Church of Miles City for more than 50 years. He was a founding member of the Miles City Town & Country Club and a member and president of the Miles City Club. If Bill were asked to name hobbies, he would say over the course of his life he enjoyed golfing, bridge, travel and piloting his private aircraft. His true joy came from time spent with his wife of 55 years and his family.

He was a strong advocate for the state hospitals at Galen and Warm Springs and the Montana State Prison. He worked on wildlife conservation and access issues. He served on many legislative committees, but was best known as the chair of the powerful Appropriations Subcommittee on Institutions.

After retiring from politics in 2000, Red's public service continued. He was a member and chair of the boards of trustees for Shodair Hospital in Helena as well as the Southwest Montana Area Agency on Aging and the Metcalf Senior Citizen's Center in Anaconda. He was a member of the Holy Family parish in Anaconda, the Sportsmen's Club and a life member of the Ancient Order of Hibernians. Red's sometimes acerbic and always entertaining wit was a well-known highlight of debates during his legislative years and was very much a part of his private life. Red had a talent for telling a story and shared the gift of laughter liberally. As his daughter, Kara, has said, "Being with Red was like being at a party. You just don't want the party to end."

His proud parents, Clark E. and Muriel (Thornton) Simon, expected a girl to go along with his older brother, Ronald. They sent a telegram that relayed the surprise to Bruce's grandparents that read, "We named Helen 'Bruce.""

Bruce was raised and attended school in Billings. He attended Montana State University in Bozeman, earning two Bachelor degrees and a Master's degree. In 1961, Bruce and then-wife Colleen Cahill welcomed their son, Tod Thornton Simon. Three years later, in 1964, their daughter Rebecca Jill Simon was born.

Bruce served as President of the Montana Retail Association for two and a half years. His appointment to the Governor's Council on Management and his work on the Industry Council led him to run for public office. He won election to the Montana House of Representatives in 1984. During his seven sessions in the Legislature, Bruce became one of the most respected Representatives, earning a reputation as a fair, thorough and well-prepared lawmaker. He had a reputation as an outstanding and effective committee chairman. He served as a member of various committees, including Business and Labor and the Legislative Audit Committee. He was named State Official of the Year by the National Association of Home Builders in 1998 and the Montana Legislator of the Year by numerous groups, including the Montana Optometric Association and the Montana Building Industry Association. He is the only non-attorney to argue a case before the Montana Supreme Court.

Bruce met his wife Sharon on a ski vacation, and they were married for 42 years. Their son, David Dean Simon, was born in 1974. Bruce was a volunteer baseball and hockey coach and followed his sons and their athletic teams. Bruce loved the outdoors and his hobby was fishing on Montana's rivers and streams.

Bruce is survived by his wife, Sharon, sons Tod (Catherine), and Dave (Amy), daughter Becky (King), brother Ron (Myrna), cousin Tom Frisby (Kathy), nephews and nieces, grandchildren and great grandchildren.

Chet served as two-term Mayor of the city of Scobey, was a member and council of Scobey Lutheran Church, became a 50-year honoree member of the Scobey Lions Club, a 69-year member of the Scobey Masonic Lodge, served on the Scobey Fire Department, Daniels County Fair Board, Daniels Memorial Hospital Board, Daniels Memorial Hospital Foundation, helped found the Daniels County Museum and served on its board. Chet was a director of the Montana Auto Dealers' Association and served as a Montana State Representative from Daniels County in the 1983 legislative session.

In 1938 Chet married Marjorie Miner, a country school teacher who boarded with the Solberg family. They continued to reside in the Opheim-Richland area and engaged in farming. Wilbur Spring was born on January 6, 1921 four miles northeast of Belgrade on the farm that has been in his family for 111 years and where he lived for the first 75 years of his life. He was the son of Sophie (Vaught) and Wilbur P. Spring. At the age of 10, he knew what it was to hitch a single horse to a buggy to take himself and his two younger sisters 2 ½ miles to a rural school. Wilbur graduated from Belgrade High School in1939, where he was a charter member and the first president of the Belgrade Future Farmers of America chapter. He attended Montana State College for two years, majoring in general agriculture. He farmed with his father and following his father's accident in 1953, Wilbur took over management of the family farm. Over the years he turned swampy pasture land into a thriving hay and grain operation and bought the family farm from his parents in 1965.

Wilbur married Helen Sitzman, a nurse from Billings, on Thanksgiving Day in 1952, which was also his parents' 34<sup>th</sup> wedding anniversary. From this union, five children were born: Susan Jean, twins Barbara June and Beverly Jane, Thomas Wilbur and Robert Paul. Wilbur had a passion for statistics and loved analyzing all sorts of information, he also was a stickler for accuracy. At one time he had his granddaughter, Laura, write to the World Almanac to correct their mistaken assertion that the confluence of the Missouri River was in Madison County instead of Gallatin. He was very pleased with the next edition of the Almanac, as the change he had requested had been made.

Helen passed away on May 18, 1988. That November, Wilbur was elected to represent northeastern Gallatin County in the Montana House of Representatives. He served three terms from 1989 until 1994. During that time he met and married Jeanne Amsberry of Helena on her 71<sup>st</sup> birthday, July 17, 1992. Jeanne passed away less than five months later. In Wilbur's retirement years he spent many pleasant hours visiting and playing pinochle with his buddies at the Elks Club. His main form of exercising was dancing and, for a time, he was a member of the formal dance club with his friend and dance partner, Anita Iverson.

Wilbur is survived by his brother-in-law, Joe Taylor; his five children and their spouses, Susan (Chuck) Noble, Barbara (Kerry) Bickle, Beverly (Dick) Marlow, Tom (Kathleen) Spring, and Bob (Megan) Spring; 10 grandchildren and 12 great-grandchildren.

### EDMUND "NEIL" TAYLOR

**WHEREAS**, IT IS WITH DEEP, SINCERE SORROW THAT THE MEMBERS OF THE SIXTY-FOURTH LEGISLATIVE ASSEMBLY OF THE STATE OF MONTANA RECORD THE PASSING OF EDMUND "NEIL" TAYLOR ON MAY 2, 1964 IN SCOBEY MONTANA.

# **WHEREAS**, IT IS FITTING AND PROPER THAT THE RECORD AND ACCOMPLISHMENTS OF THE LATE EDMUND "NEIL" TAYLOR BE FILED ON THE OFFICIAL RECORDS OF THIS ASSEMBLY, AND THE FOLLOWING FACTS RELATIVE TO HIS CAREER ARE HEREBY NOTED:

Edmund "Neil" Taylor was born September 7, 1897 at Mount Moriah, Missouri. He was the third son of Charles Denver "CD" and Essie Louise (Schooler) Taylor. CD decided to explore the possibilities of claiming a homestead in Montana. In the spring of 1914 when Neil was 16, CD and his sons Neil and Reid traveled by train to northeastern Montana. They came as far as Culbertson on the train bringing only the bare necessities to establish a place to live, including a couple of milk cows and a team of horses. The remainder of the Taylor family stayed in Missouri until CD was ready to move them north.

During this time, CD and the boys filed a homestead claim on the western edge of the Fort Peck Indian Reservation. The two brothers and their dad began working to fulfill the requirements of the U.S. Government's "Homestead Act" to "stake their claim" on the land. While in Saskatchewan, to supplement the family income in winter, Neil and his brother kept busy using their many horses freighting for the Hudson's Bay Company. Neil recorded some of his favorite memories including the Reservation Roundup: "It was the spring of 1919 when I was privileged to ride on that big Indian horse roundup for the first time. It is hard to believe now, but at that time we would handle 20,000 to 40,000 horses during the roundup."

Neil married Florence Kennedy on June 26, 1923 in Saskatoon. The honeymoon was a train trip to Scobey, the county seat of Daniels County. In early 1925 Neil and Florence rented a place in the Line Coulee community. In 1925 their first daughter Margaret Louise (Taylor) Gebhardt was born and in 1927 their second daughter Florence "Fae" (Taylor) Phillips (a 2013 Montana Cowboy Hall of Fame & Western Heritage Center inductee) was born.

Neil believed in giving to his community. He was a member of many organizations such as the Montana Stock Grower's Association and the Farm Bureau. He helped organize the Big Muddy Hereford Association and the Scobey Saddle Club. In 1955 Neil began the Taylor Calf Chain in Daniels County. He gave away two heifer calves to 4-H members with the understanding they in turn would give their first heifer calf to another member. This chain ran for over 50 years.

In 1945 Neil ran for and was elected to the Montana Legislature. Neil served in the House for six sessions from 1945 to 1955. His House colleagues called him the "Iron Duke" for standing on his convictions that expenses be cut and the budget balanced. As a joke, they presented Neil with a meat cleaver to help him cut the budget.

Neil is survived by his wife Florence; two daughters, Margaret Louise Gebhardt, Roundup, Montana; Florence Fae Phillips, Lewistown, Montana, and 10 grandchildren.
