 - (c) A contract for milking must state that a person other than the owner of the animal or

animals will manage the animal or animals, including providing housing, pasture, feed, and milking services. The person contracting to manage the animal or animals and provide the milking service may not own an interest in the animal or animals.

(d) The contract must contain a conspicuous notification that raw milk is not pasturized."
