"NEW SECTION. Section 1. Adjustments to federal taxable income to determine Montana taxable income. (1) The items in subsection (2) are added to and the items in subsection (3) are subtracted from federal taxable income to determine Montana taxable income.

- (2) The following are added to federal taxable income:
- (a) to the extent that it is not exempt from taxation by Montana under federal law, interest from obligations of a territory or another state or any political subdivision of a territory or another state and exempt-interest dividends attributable to that interest except to the extent already included in federal taxable income;
- (b) a withdrawal from a medical care savings account provided for in Title 15, chapter 61, used for a purpose other than an eligible medical expense or long-term care of the employee or account holder or a dependent of the employee or account holder;
- (c) a nonqualified withdrawal from a family education savings account provided for in Title 15, chapter 62, to the extent that it was deducted from income in calculating Montana individual income taxes:
- (d) a withdrawal from a first-time home buyer savings account provided for in Title 15, chapter 63, used for a purpose other than for eligible costs for the purchase of a single-family

residence;

- (e) an item of income, deduction, or expense to the extent that it was used to calculate federal taxable income if the item was also used to calculate a credit against a Montana income tax liability:
- (f) a deduction or expense upon which a state tax credit is computed under 33-22-2006 to the extent that it was included as a deduction or expense in determining federal taxable income;
- (g) a deduction for an income distribution from an estate or trust to a beneficiary that was included in the federal taxable income of an estate or trust in accordance with sections 651 and 661 of the Internal Revenue Code, 26 U.S.C. 651 and 661; and
- (h) for a taxpayer that deducts state income taxes pursuant to section 164(a)(3) of the Internal Revenue Code, 26 U.S.C. 164(a)(3), an additional amount equal to the state income tax deduction claimed, not to exceed the amount required to reduce the federal itemized amount computed under section 161 of the Internal Revenue Code, 26 U.S.C. 161, to the amount of the federal standard deduction allowable under section 63(c) of the Internal Revenue Code, 26 U.S.C. 63(c).
- (3) To the extent they are included as income or gain or not already excluded as a deduction or expense in determining federal taxable income, the following are subtracted from federal taxable income:
 - (a) if exempt from taxation by Montana under federal law:
- (i) interest from obligations of the United States government and exempt-interest dividends attributable to that interest; and
 - (ii) railroad retirement benefits:
- (b) salary received from the armed forces by residents who entered into active duty from Montana and are serving on active duty in the regular armed forces;
- (c) interest and other income related to contributions that were made prior to January 1, 2016, that are retained in a medical care savings account provided for in Title 15, chapter 61, and any withdrawal for payment of eligible medical expenses or for the long-term care of the employee or account holder or a dependent of the employee or account holder;
- (d) interest and other income related to contributions that were made prior to January 1, 2016, that are retained in a family education savings account provided for in Title 15, chapter 62, and any qualified withdrawal for payment of qualified higher education expenses;
- (e) interest and other income related to contributions that were made prior to January 1, 2016, that are retained in a first-time home buyer savings account provided for in Title 15, chapter 63, and any withdrawal for payment of eligible costs for the first-time purchase of a single-family residence:
- (f) a deduction for an income distribution from an estate or trust to a beneficiary in accordance with sections 651 and 661 of the Internal Revenue Code, 26 U.S.C. 651 and 661, recalculated according to the additions and subtractions in subsections (2), and (3)(a) through (3)(e), and (3)(g), and (3)(h); and
- (g) for each taxpayer that has attained the age of 65, an additional subtraction of \$6,400; and
- (h) the amount of a scholarship to an eligible student by a student scholarship organization pursuant to [section 10 of Senate Bill No. 410].
- (4) By November 1 of each year, the department shall multiply the subtraction from federal taxable income for a taxpayer that has attained the age of 65 contained in subsection (3)(g) by the inflation factor for that tax year, rounding the result to the nearest \$10. The resulting amount is

effective for that tax year and must be used as the basis for the subtraction from federal taxable income determined under subsection (3)(g).""

Dear President Barrett:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments Senate Bill 336 (SB 336), "AN ACT GENERALLY REVISING RULEMAKING PROCEDURES; REQUIRING THAT THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES INCLUDE CERTAIN INFORMATION IN RULEMAKING NOTICES PERTAINING TO THE DELIVERY OF MEDICAID SERVICES: REQUIRING THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES TO PREPARE AND ELECTRONICALLY SEND A STATEMENT OF FINDINGS TO INTERESTED PERSONS CONCERNING THE RULE'S INTENDED OUTCOMES WITHIN A YEAR AFTER THE RULE'S EFFECTIVE DATE IF THE RULE PERTAINS TO THE DELIVERY OF MEDICAID SERVICES: PROVIDING EXCEPTIONS; ALLOWING AN IMPACTED BUSINESS, IMPACTED CONTRACTOR, OR ELECTED OFFICIAL TO REQUEST AND RECEIVE AN ECONOMIC IMPACT STATEMENT FOR RULES PROPOSED BY THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES: AMENDING PAYMENTS THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES IS ENTITLED TO COLLECT FROM CERTAIN PROVIDERS: AMENDING SECTIONS 2-4-405 AND 53-6-111, MCA; AND PROVIDING AN EFFECTIVE DATE AND AN APPLICABILITY DATE."

SB 336 contains two, unrelated subjects. Sections 1 and 2 would revise the administrative rulemaking for the Department of Public Health and Human Services (DPHHS). Section 3 amends MCA Section 53-6-11, which addresses Medicaid overpayment recovery process.

Section 1 demands that DPHHS provide, measure, and report on the intended outcomes of "a proposed substantive rule concerning the delivery of Medicaid services." Although I am supportive of efforts to provide performance-based metrics within the Medicaid program, many DPHHS rules regarding Medicaid services simply do not lend themselves to performance-based measurement, such as rules which merely implement federal requirements as a condition of continued federal funding. My proposed amendment to SB 336 would limit this new rule-making requirement to those rules whose reasons and rationale can be assessed by performance-based measures, and explicitly exempts rules implementing rate increases or federal law or regulation.

Section 2 of SB 336 is not acceptable. Section 2 amends MCA section 2-4-405 to grant any impacted business, contractor, or elected official the right to demand that DPHHS prepare and provide a completed economic impact statement for any proposed rule. Preparing an economic impact statement is not a trivial undertaking. The request for such a statement properly should remain within the purview of an administrative rule committee or legislators, as is the case under current law. Existing law also requires that every agency, including DPHHS, afford persons the ability to comment on and to submit information regarding effects (including economic effects) proposed rule action might have on them and their businesses. Simply put, current law adequately satisfies the needs addressed in Section 2. Allowing individuals, businesses and any and all elected officials to request an economic impact statement for any rule promulgated under Medicaid will create inefficiencies and inappropriately interfere with effective government. My amendment to SB 336 strikes Section 2 in its entirety.

Section 3's amendments to MCA section 53-6-111 are, in large part, acceptable. My proposed amendment reinserts the phrase "provider error" into subsection 2(a)(i) to make it clear that the Department continues to be entitled to recover overpayments that are the result of provider error. Although I agree that a provider should not be held liable for overpayments based on reasonable interpretation of billing codes, my proposed amendment clarifies that the burden of proving the reasonableness of the interpretation falls on the provider. By comparison, current law puts the burden on a provider to show that the Department's interpretation of the relevant rule is unreasonable.

With my proposed amendments, I support the additional accountability measures contained in SB 336.

I respectfully ask for your support of these amendments.
