4 A BILL FOR AN ACT ENTITLED: "AN ACT CLARIFYING LAWS PERTAINING TO THE ASSIGNMENT OF
5 ROAD AND STREET ADDRESSES; SPECIFYING THAT COUNTIES MAY DESIGNATE STREET NAMES AND
6 ADDRESSES IN UNINCORPORATED AREAS; AMENDING SECTION 7-14-2101, MCA; AND PROVIDING AN
7 IMMEDIATE EFFECTIVE DATE."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11 **Section 1.** Section 7-14-2101, MCA, is amended to read:

12 **"7-14-2101. General powers of county relating to roads and bridges -- definitions.** (1) The board
13 of county commissioners, under the limitations and restrictions that are prescribed by law, may:

- 14 (a) (i) lay out, maintain, control, and manage county roads and bridges within the county;
15 (ii) subject to 15-10-420, levy taxes for the laying out, maintenance, control, and management of the
16 county roads and bridges within the county as provided by law;

- 17 (b) (i) in the exercise of sound discretion, jointly with other counties, lay out, maintain, control, manage,
18 and improve county roads and bridges in adjacent counties, wholly or in part as agreed upon between the boards
19 of the counties concerned;

- 20 (ii) subject to 15-10-420, levy taxes for the laying out, maintenance, control, management, and
21 improvement of county roads and bridges in adjacent counties or shared jointly with other counties, as agreed
22 upon between the boards of the counties concerned and as provided by law;

- 23 (c) (i) enter into agreements for adjusted annual contributions over not more than 6 years toward the cost
24 of joint highway or bridge construction projects entered into in cooperation with other counties, the state, or the
25 United States;

- 26 (ii) subject to 15-10-420, place a joint project in the budget and levy taxes for a joint project as provided
27 by law.

11 ~~(3)(2)~~ (a) Following a public hearing, a board of county commissioners may accept by resolution a road
12 that has not previously been considered a county road but that has been laid out, constructed, and maintained
13 with state department of transportation or county funds.

14 (b) A survey is not required of an existing county road that is accepted by resolution by a board of county
15 commissioners.

16 (c) A road that is abandoned by the state may be designated as a county road upon the acceptance and
17 approval by resolution of a board of county commissioners.

18 (3) The board of county commissioners may adopt regulations for unincorporated areas within a county
19 governing:

20 (a) the assignment of numerical physical addresses except for roads under the jurisdiction of a federal,
21 state, or tribal entity if that entity objects to the assignment; and

22 (b) the naming of roads except roads under the jurisdiction of a federal, state, or tribal entity unless that
23 entity consents to the naming.

24 (4) Unless the context requires otherwise, for the purposes of this chapter, the following definitions apply:

25 (a) "Bridge" includes rights-of-way or other interest in land, abutments, superstructures, piers, and
26 approaches except dirt fills.

27 (b) "County road" means:

8 NEW SECTION. Section 2. Notification to tribal governments. The secretary of state shall send a
9 copy of [this act] to each tribal government located on the seven Montana reservations and to the Little Shell
10 Chippewa tribe.

12 NEW SECTION. Section 3. Effective date. [This act] is effective on passage and approval.
