4	A BILL FOR AN ACT ENTITLED: "AN ACT REVISING PRETRIAL DIVERSION LAWS TO ALLOW DEFERRAI
5	OF PROSECUTION TO BE ENTERED INTO UPON NOTICE BY THE PROSECUTOR; AMENDING SECTION
6	46-16-130, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
9	
10	Section 1. Section 46-16-130, MCA, is amended to read:
11	"46-16-130. Pretrial diversion. (1) (a) Prior to the filing of a charge, the prosecutor and a defendant whe
12	has counsel or who has voluntarily waived counsel may agree to the deferral of a prosecution for a specified
13	period of time based on one or more of the following conditions:
14	(i) that the defendant may not commit any offense;
15	(ii) that the defendant may not engage in specified activities, conduct, and associations bearing a
16	relationship to the conduct upon which the charge against the defendant is based;
17	(iii) that the defendant shall participate in a supervised rehabilitation program, which may include
18	treatment, counseling, training, or education;
19	(iv) that the defendant shall make restitution in a specified manner for harm or loss caused by the offense
20	or
21	(v) any other reasonable conditions.
22	(b) The agreement must be in writing, must be signed by the parties, and must state that the defendan
23	waives the right to speedy trial for the period of deferral. The agreement may include stipulations concerning the
24	admissibility of evidence, specified testimony, or dispositions if the deferral of the prosecution is terminated and
25	there is a trial on the charge.
26	(c) The prosecution must be deferred for the period specified in the agreement unless there has been
27	a violation of its terms.
28	(d) The agreement must be terminated and the prosecution automatically dismissed with prejudice upor
29	expiration and compliance with the terms of the agreement.
30	(2) A condition of pretrial diversion may be for the court to refer a defendant for evaluation to determine

1 the appropriateness of proceedings pursuant to Title 53, chapter 21.

2 (3) After Except as provided in 46-1-1104 and 46-1-1204, after a charge has been filed, a deferral of
3 prosecution may be entered into only with the approval of the court after the prosecutor provides notice to the
4 court.
5 (4) A prosecution for a violation of 61-8-401, 61-8-406, 61-8-410, or 61-8-411 may not be deferred."
