8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	Section 1. Section 76-16-112, MCA, is amended to read:
11	"76-16-112. Creation of Montana grass conservation commission membership meetings
12	compensation. (1) There is a Montana grass conservation commission. The commission is composed of five
13	members appointed by the governor to serve staggered 3-year terms.
14	(2) (a) The governor, after giving full consideration to representation by both large and small operators,
15	shall appoint:
16	(i) two members who are either officers of or who serve on the board of directors of a state district;
17	(ii) two members who hold active grazing preference rights within a state district; and
18	(iii) one member of the public who possesses a general understanding of the livestock industry and the
19	proper use of rangelands within state districts for the purpose of livestock production.
20	(b) Ex officio members may be appointed by the commission as needed.
21	(3) Members may not be appointed for more than three consecutive terms. The commission shall
22	annually elect from among its members a presiding officer and a vice presiding officer. The presiding officer shall
23	preside over all meetings of the commission, except that the vice presiding officer shall assume the duties of the
24	presiding officer in the absence of the presiding officer.
25	(4) (a) The commission shall meet annually at the main offices of the department in Helena at a place
26	determined by the presiding officer.
27	(b) The commission may hold other meetings at times and places as necessary upon the call of the
28	presiding officer or the request of a majority of commission members and upon at least 7 days' written notice to
29	the commission members of the time and place of the meeting.
30	(c) A majority of commission members constitutes a quorum for the transaction of business. The

1 commission shall keep accurate records of all business that is considered, and the presiding officer shall sign all 2 orders, minutes, and other documents of the commission.

- (5) Commission members may receive no compensation for their services, but members are entitled to compensation for actual expenses incurred in carrying out their duties, including travel and per diem.
- 5 (6) The commission is allocated to the department for administrative purposes only as provided in 2-15-121. The commission shall, if it determines that personnel services are required, hire its own personnel, and 2-15-121(2)(d) does not apply. The secretary must be employed at the discretion of the commission."
