4	A BILL FOR AN ACT ENTITLED: "AN ACT EXPANDING THE DUTIES OF THE TOURISM ADVISORY
5	COUNCIL TO INCLUDE PROMOTION OF REGIONAL HISTORY MUSEUMS; AMENDING SECTION 2-15-1816,
6	MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
9	
10	Section 1. Section 2-15-1816, MCA, is amended to read:
11	"2-15-1816. Tourism advisory council. (1) There is created a tourism advisory council.
12	(2) The council is composed of not less than 12 members appointed by the governor from Montana's
13	private sector travel industry and includes at least one member from Indian tribal governments, with
14	representation from each tourism region initially established by executive order of the governor and as may be
15	modified by the council under subsection (5).
16	(3) Members of the council shall serve staggered 3-year terms, subject to replacement at the discretion
17	of the governor. The governor shall designate four of the initial members to serve 1-year terms and four of the
18	initial members to serve 2-year terms.
19	(4) The council shall:
20	(a) oversee distribution of funds to regional nonprofit tourism corporations for tourism promotion and to
21	nonprofit convention and visitors bureaus in accordance with Title 15, chapter 65, part 1, and this section;
22	(b) advise the department of commerce relative to tourism promotion;
23	(c) advise the governor on significant matters relative to Montana's travel industry;
24	(d) prescribe allowable administrative expenses for which accommodation tax proceeds may be used
25	by regional nonprofit tourism corporations and nonprofit convention and visitors bureaus;
26	(e) direct the university system regarding Montana travel research;
27	(f) approve all travel research programs prior to their being undertaken; and
28	(g) encourage regional nonprofit tourism corporations to promote tourist activities on Indian reservations
29	in their regions; and
30	(h) require ENCOURAGE regional nonprofit tourism corporations and nonprofit convention and visitors

bureaus receiving money under subsection (4)(a) to promote public and nonprofit history museums in their
regions.

- (5) The council may modify the tourism regions established by executive order of the governor.
- 4 (6) The department of commerce shall adopt such rules as may be necessary to implement and administer Title 15, chapter 65, part 1, and this section."

<u>NEW SECTION.</u> **Section 2. Notification to tribal governments.** The secretary of state shall send a copy of [this act] to each tribal government located on the seven Montana reservations and to the Little Shell Chippewa tribe.
