4	A BILL FOR AN ACT ENTITLED: "AN ACT FACILITATING PURCHASE OF HEALTH INSURANCE COVERAGE

10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12	NEW SECTION. Section 1. Enrollment and outreach program enrollment facilitation board
13	coordinator. (1) There is a federal health benefit exchange enrollment facilitation board that shall undertake
14	activities to increase public awareness of, knowledge about, and enrollment in health insurance coverage by
15	individuals with incomes of 100% to 138% of the federal poverty level.
16	(2) The board shall undertake its activities in conjunction with the commissioner of insurance designated
17	in 2-15-1903 and is attached to the commissioner's office for administrative purposes.
18	(3) The board consists of 13 members as follows:
19	(a) two members representing health insurance issuers on the federal health benefit exchange created
20	pursuant to 42 U.S.C. 18041;
21	(b) two individuals who are licensed in Montana to sell health insurance policies and are selling qualified
22	health plans, as defined in 42 U.S.C. 18021, on the federal health benefit exchange;
23	(c) two health care providers;
24	(d) one representative of a federally qualified health center established pursuant to 42 U.S.C. 254b;
25	(e) one certified application counselor provided for in federal rule;
26	(f) one representative of a group that advocates for low-income individuals; and
27	(g) four legislators, two from the Montana house of representatives and two from the Montana senate
28	appointed as follows:
29	(i) one senator of the majority party appointed by the senate president and one senator of the minority
30	party appointed by the senate minority leader; and

(ii) one representative of the majority party appointed by the speaker of the house and one representative of the minority party appointed by the house minority leader.

- (4) The commissioner shall appoint the nonlegislative members of the board and determine the frequency with which the board meets.
  - (5) The board shall work with the commissioner on ways to:
- (a) establish relationships with parties interested in publicizing the availability of qualified health plans on the federal health benefit exchange;
- 8 (b) effectively distribute information on the availability of federal premium assistance credits under 26
  9 U.S.C. 36B for the purchase of qualified health plans and the federal penalties for failure to purchase a qualified
  10 health plan; and
  - (c) maximize enrollment in a qualified health plan through the federal health benefit exchange by individuals with incomes of 100% to 138% of the federal poverty level.
  - (6) The commissioner shall report to the board on efforts undertaken to increase the enrollment of low-income individuals in a qualified health plan. The report must include:
  - (a) an evaluation of the effectiveness of each education and information effort undertaken under this section;
  - (b) the number of individuals with an income of 100% to 138% of the federal poverty level who have purchased a qualified health plan through the federal health benefit exchange; and
  - (c) an analysis of the demographics of the individuals who purchased insurance, to the extent the information is available.
  - (7) Board members are entitled to compensation and reimbursement of expenses as provided in 2-15-122.

<u>NEW SECTION.</u> **Section 2. Appropriation.** (1) There is appropriated \$100,000 from the general fund to the state auditor's office for the biennium beginning July 1, 2015. The money must be used for the education and outreach activities required under [section 1], including expenses related to operation of the federal health benefit exchange enrollment facilitation board.
