- (3) (a) If the a vacancy in the office of United States representative occurs between the federal primary and the federal general election in even-numbered years, the candidate elected to the office for the succeeding full term shall immediately take office to fill the unexpired term.
- (b) If a vacancy in the office of United States senator occurs in the last year of the office's term, an election for the remainder of the term may not be held if the vacancy occurs between 85 days before the federal primary election and the end of the term. The term of office for a candidate elected to the senate seat at the regularly scheduled general election must commence with the new term.
- (4) (a) (l) The governor may make a temporary appointment to fill a vacancy until the election to fill the vacancy is held.
- (II) (A) If the vacancy is subject to the provisions of subsection (3)(b), the governor may make a temporary appointment until the new term of office commences RESULTS OF THE REGULARLY SCHEDULED GENERAL ELECTION ARE CERTIFIED.
- (B) When the results are certified, the governor shall appoint the candidate who won the election for the senate seat to fill the remainder of the vacancy.
- (b) The governor may appoint only an individual from the same political party as the individual vacating the office. Unless the appointment is made pursuant to subsection (4)(a)(ii)(B), when a vacancy occurs, if the vacating officeholder represented a political party eligible for primary election under 13-10-601, the person appointed by the governor pursuant to subsection (4)(a)(i) or (4)(a)(ii) must be of the same political party affiliations after taking office, the individual who is appointed to fill the vacancy must be of the same political party that the vacating officeholder was when the vacating officeholder was elected or appointed to that office.
- (5) WITHIN 3 DAYS AFTER BEING NOTIFIED OF A VACANCY, THE GOVERNOR SHALL NOTIFY THE POLITICAL PARTY

  THAT WAS REPRESENTED BY THE VACATING OFFICEHOLDER.
- (6) (A) WITHIN 15 DAYS AFTER BEING NOTIFIED OF A VACANCY, THE STATE PARTY CENTRAL COMMITTEE SHALL FORWARD TO THE GOVERNOR A LIST OF THREE PROSPECTIVE APPOINTEES.
