17	of agriculture within 3 months of [the effective date of this act] in order to establish limits on food and beverage
18	items purchased by recipients of supplemental nutrition assistance program benefits. The waiver must, at a
19	minimum, prohibit the purchase of the food and beverage items that are listed as prohibited items on the
20	approved food list published by the department on October 1, 2014, for the special supplemental nutrition
21	program for women, infants, and children.
22	(b) If the waiver request is approved, the department shall apply for continuation of the waiver in a timely
23	manner.
24	(c) If the waiver request is denied, the department shall submit the request annually until it is approved.
25	(2) The department may request other limitations on food or beverage items that are low in nutrients and
26	that may contribute to chronic diseases such as diabetes and heart disease.

29	nutrition assistance program. (1) The department may seek a waiver of the work requirements established

section. 1 2 (2) The department may seek a waiver of the work requirements for individuals living in a county when 3 that county's unemployment rate for the previous 12-month period exceeds 10%. 4 (3) The department may seek a waiver of the work requirements for individuals living on an Indian 5 reservation if: 6 (a) the unemployment rate for the previous 12-month period exceeds 10% for the reservation, when the 7 reservation is located entirely within one county; or 8 (b) for a reservation located in more than one county, the unemployment rate for the previous 12-month 9 period exceeds 10% in any single-county portion of the reservation. 10 (4) Except as provided in subsection (3), the department may not seek a waiver for an area made up 11 of more than one county unless the unemployment rate for the previous 12-month period exceeds 10% in each 12 county in the multicounty area. 13 (5) The department may not seek renewal of an existing waiver that does not meet the requirements of 14 this section. 15 16 NEW SECTION. Section 3. Limitations on eligibility. Section 4. Photo identification. (1) An individual using supplemental nutrition assistance program benefits shall present one of the following forms of photo identification at the time of 23 24 purchase: 25 (a) a valid current Montana driver's license; 26 (b) a valid school district or postsecondary education photo identification; 27 (c) a current tribal photo identification card; or 28 (d) a current Montana identification card issued pursuant to Title 61, chapter 12, part 5. 29 (2) A person who does not have a form of identification listed in subsection (1) at the time the person 30 is determined eligible for supplemental nutrition assistance program benefits may obtain a Montana identification Legislative Services - 2 -Authorized Print Version - SB 206

Section 5. Section 39-51-403, MCA, is amended to read:

4 "39-51-403. Money to be requisitioned from unemployment trust fund solely for payment of 5 benefits. (1) Money may be requisitioned from this state's account in the unemployment trust fund solely for the 6 payment of benefits and in accordance with section 904 of the Social Security Act, 42 U.S.C. 1104, and with 7 regulations prescribed by the department. Money withheld by the department from a benefits payment at the 8 request of an individual, in accordance with the department's rules pertaining to deductions and withholding for 9 federal income tax purposes pursuant to 39-51-2207, for repayment of an overissuance of food stamp 10 supplemental nutrition assistance program benefits pursuant to 39-51-2208, or for repayment of child support 11 obligations pursuant to 39-51-3106 must be considered benefits for the purposes of this subsection.

12 (2) The department shall from time to time requisition from the unemployment trust fund amounts, not 13 exceeding the amounts in this state in the fund, that it considers necessary for the payment of benefits for a 14 reasonable future period. Upon receipt of a requisition, the secretary of the treasury of the United States shall 15 deposit the money in the benefit account. Upon receipt of the deposit, the department shall issue warrants for 16 the payment of benefits solely from the benefit account.

(3) Expenditures of money in the benefit account and refunds from the clearing account are not subject
 to any provisions of law requiring specific appropriations or other formal release by state officers of money in their
 custody.

(4) Any balance of money requisitioned from the unemployment trust fund that remains unclaimed or unpaid in the benefit account after the expiration of the period for which the sums were requisitioned must be deducted from estimates for and may be used for the payment of benefits during succeeding periods or, in the discretion of the department, must be redeposited with the secretary of the treasury of the United States to the credit of this state's account in the unemployment trust fund, as provided in 39-51-402."

3 (c) serving as a foster parent, licensed as a foster care provider in accordance with 52-2-621, and

For premium ratemaking and for the determination of the weekly wage for weekly compensation benefits, the

(1) If a parent or a court-appointed third party requests, or if 18 the court finds that a parenting proceeding is contested, the court may order an investigation and report 19 concerning parenting arrangements for the child. The investigator may be the child's guardian ad litem or other professional considered appropriate by the court. The department of public health and human services may not 20 21 be ordered to conduct the investigation or draft a report unless the person requesting the investigation is a 22 recipient of financial assistance, as defined in 53-4-201, or a participant in the food stamp supplemental nutrition 23 assistance program, as defined in 53-2-902, and all reasonable options for payment of the investigation, if 24 conducted by a person not employed by the department, are exhausted. Except as required for children 16 years of age or older, 7 the investigator may consult with and obtain information from medical, psychiatric, or other expert persons who 8 have served the child in the past without obtaining the consent of the persons or entities authorized by law to 9 grant or withhold access to the records. The child's consent must be obtained if the child is 16 years of age or 10 older unless the court finds that the child lacks mental capacity to consent. If the requirements of subsection (4) 11 are fulfilled, the investigator's report may be received in evidence at the hearing.
