4	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
5	MONTANA PROCLAIMING THE MONTH OF MAY 2015 AS AMYOTROPHIC LATERAL SCLEROSIS (ALS)
6	AWARENESS MONTH AND URGING THE PRESIDENT AND CONGRESS OF THE UNITED STATES TO
7	ENACT LEGISLATION TO PROVIDE ADDITIONAL FUNDING FOR RESEARCH IN ORDER TO FIND A
8	TREATMENT AND A CURE FOR AMYOTROPHIC LATERAL SCLEROSIS.

10	WHEREAS, amyotrophic lateral sclerosis or ALS is better known as Lou Gehrig's disease; and
11	WHEREAS, ALS is a fatal neurodegenerative disease characterized by degeneration of cell bodies of
12	the lower motor neurons in the gray matter of the anterior horns of the spinal cord; and
13	WHEREAS, the initial symptom of ALS is weakness of the skeletal muscles, especially those of the
14	extremities; and
15	WHEREAS, as ALS progresses the patient experiences difficulty in swallowing, talking, and breathing;
16	and
17	WHEREAS, ALS eventually causes muscles to atrophy, and the patient becomes a functional
18	quadriplegic; and
19	WHEREAS, ALS does not affect a patient's mental capacity, and the patient remains alert and aware of
20	the loss of motor functions and the inevitable outcome of continued deterioration and death; and
21	WHEREAS, on average, patients diagnosed with ALS only survive 2 to 5 years from the time of
22	diagnosis; and
23	WHEREAS, ALS has no known cause, means of prevention, or cure; and
24	WHEREAS, research indicates that military veterans are approximately twice as likely to develop ALS
25	as those who have not served in the military; and
26	WHEREAS, the Department of Veterans Affairs implemented regulations to establish a presumption of
27	service connection for ALS, thereby presuming that the development of ALS was incurred or aggravated by a
28	veteran's service in the military; and
29	WHEREAS, a national ALS patient registry, administered by the Centers for Disease Control and
30	Prevention, is currently identifying cases of ALS in the United States and may become the single largest ALS

1 research project ever created; and

2 WHEREAS, Amyotrophic Lateral Sclerosis Awareness Month increases the public's awareness of ALS

3 patients' circumstances and acknowledges the terrible impact this disease has not only on the patient but on his

- 4 or her family and the community and recognizes the research being done to eradicate this horrible disease.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
STATE OF MONTANA:

8 That the Legislature hereby proclaims the month of May, 2015, as Amyotrophic Lateral Sclerosis 9 Awareness Month in Montana.

BE IT FURTHER RESOLVED, that the Legislature urges the President and Congress of the United States to enact legislation to provide additional funding for research in order to find a treatment and eventually a cure for amyotrophic lateral sclerosis.
