 5 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING ELECTION LAWS; CLARIFYING WHEN
 6 AN ELECTION REQUESTED BY PETITION CONCERNING A LOCAL GOVERNMENT ORDINANCE MUST BE
 7 HELD; REVISING NOTICE REQUIREMENTS RELATED TO RESORT TAX ELECTIONS; REVISING THE
 8 DEADLINE FOR WRITE-IN CANDIDATES IN SPECIAL DISTRICT AND LOCAL GOVERNMENT ELECTIONS;
 9 REVISING THE DEADLINES BY WHICH ABSENTEE AND MAIL BALLOTS MUST BE AVAILABLE;
 10 CLARIFYING THE DEADLINE FOR THE CANCELLATION OF A CONSERVATION DISTRICT ELECTION;

 12 VOTER REGISTRATION DUTIES FOR SCHOOL ELECTIONS; REVISING NOTICE REQUIREMENTS
 13 RELATED TO SCHOOL ELECTIONS; CLARIFYING VOTER QUALIFICATIONS FOR WATER AND SEWER
 14 DISTRICT ELECTIONS; REVISING CERTAIN ELECTION PROVISIONS RELATED TO IRRIGATION DISTRICTS;

 17 13-3-213, 13-10-211, 13-13-205, 13-13-222, 20-3-313, AND 20-20-204, AND 85-7-1702, MCA; AND PROVIDING
 18 AN IMMEDIATE EFFECTIVE DATE AND A RETROACTIVE APPLICABILITY DATE."

20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

21

22 **SECTION 1. SECTION 7-3-103, MCA, IS AMENDED TO READ:**23 **"7-3-103. Amendment of self-government charter or adopted alternative form of government --**24 **election.** (1) An amendment to a self-government charter or an adopted alternative form of government may only
 25 be made by submitting the question of amendment to the electors of the local government as provided in 7-3-149.26 An amendment approved by the electors becomes effective on the first day of the local government fiscal year
 27 following the fiscal year of approval unless the question submitted to the electors provides otherwise.28 (2) An amendment to a self-government charter or an adopted alternative form of government may be
 29 proposed by:

30 (a) petition as provided in 7-3-125;

1 (b) the local government by ordinance; or

2 (c) a study commission recommendation pursuant to 7-3-192.

3 (3) The local government, by ordinance, may provide procedures for the submission and verification of
4 initiative petitions."

5

6 **SECTION 2.** SECTION 7-3-149, MCA, IS AMENDED TO READ:

7 **"7-3-149. Election on alteration of form of government.** (1) ~~Upon the election administrator's~~
8 ~~verification that a petition filed pursuant to sections 7-3-121 through 7-3-123, 7-3-125, and 7-3-141 through~~
9 ~~7-3-148 meets all the necessary requirements, the~~ The governing body shall call an election on the question of
10 an alteration of the form of government or a change in a plan of government proposed by the petition upon:

11 (a) the election administrator's verification that a petition filed pursuant to sections 7-3-121 through
12 7-3-123, 7-3-125, and 7-3-141 through 7-3-148 meets all the necessary requirements;

13 (b) adoption of a local government ordinance pursuant to 7-3-103(2)(b); or

14 (c) a recommendation by a study commission pursuant to 7-3-192.

15 (2) The election must be conducted in accordance with Title 13, chapter 1, part 4.

16 ~~(2)(3)~~ (3) The cost of the election must be paid for by the local government.

17 ~~(3)(4)~~ (a) The affirmative vote of a simple majority of those voting on the question is required for
18 adoption.

19 (b) In any election involving the question of consolidation, each question must be submitted to the
20 electors in the county and requires an affirmative vote of a simple majority of the votes cast in the county on the
21 question for adoption. There is no requirement for separate majorities in local governments voting on
22 consolidation.

23 (c) In any election involving the question of county merger, the questions must be submitted to the
24 electors in the counties affected and require a majority of the votes cast on the questions in each affected county
25 for adoption.

26 (d) If the electors disapprove the proposed new form of local government, amendments, or consolidation
27 plan, the local government retains its existing form."

28

29 **Section 3.** Section 7-5-132, MCA, is amended to read:

30 **"7-5-132. Procedure for initiative or referendum election.** (1) The electors of a local government may,

1 by petition, request an election on whether to enact, repeal, or amend an ordinance. The form of the petition must
2 be approved by the county election administrator. A petition signed by at least 15% of the local government's
3 qualified electors is sufficient to require an election.

4 (2) (a) If an approved petition containing sufficient signatures is filed prior to the ordinance's effective
5 date or within 60 days after the passage of the ordinance, whichever is later, a petition requesting an election on
6 whether to amend or repeal the ordinance delays the ordinance's effective date until the ordinance is ratified by
7 the electors.

8 (b) If an approved petition containing sufficient signatures is filed within 60 days after the effective date
9 of an emergency ordinance, the emergency ordinance is suspended until it is ratified by the electors.

10 (3) The governing body may refer an existing or proposed ordinance to a vote of the people by
11 resolution.

12 (4) A petition or resolution for an election must:

13 (a) embrace only a single comprehensive subject;

14 (b) set out fully the ordinance sought, the ordinance to be amended and the proposed amendment, or
15 the ordinance to be repealed;

16 (c) be in the form prescribed in Title 13, chapter 27, except as specifically provided in this part; and

17 (d) contain transition provisions if the measure changes terms of office or forms of government.

18 (5) An election held pursuant to this section must be conducted in conjunction with the next local
19 government election held in accordance with Title 13, chapter 1, part 4, except that if the petition asks for a
20 special election, specifies an election date that complies with 13-1-405, and is signed by at least 25% of the
21 qualified electors, a special election must be held on the date specified in the petition.

22 (6) If a majority of those voting on the question approve the proposal, it becomes effective when the
23 election results are officially declared, unless otherwise stated in the proposal."
24

25 **Section 4.** Section 7-6-1504, MCA, is amended to read:

26 **"7-6-1504. Resort tax -- election required -- procedure -- notice.** (1) A resort community or area may
27 not impose or, except as provided in 7-6-1505, amend or repeal a resort tax unless the resort tax question has
28 been approved by a majority of the qualified electors voting on the question.

29 (2) The resort tax question may be presented to the qualified electors of:

30 (a) a resort community by a petition of the electors as provided by 7-5-131, 7-5-132, 7-5-134, 7-5-135,

1 and 7-5-137 or by a resolution of the governing body of the resort community; or

2 (b) a resort area by a resolution of the board of county commissioners, following receipt of a petition of
3 electors as provided in 7-6-1508.

4 (3) If a resort area is in more than one county, the resort tax question must be presented to and approved
5 by the qualified electors in the resort area of each county.

6 (4) The petition or resolution referring the taxing question must state:

7 (a) the rate of the resort tax;

8 (b) the duration of the resort tax;

9 (c) the date when the tax becomes effective, which date may not be earlier than 35 days after the
10 election; and

11 (d) the purposes that may be funded by the resort tax revenue.

12 (5) On receipt of an adequate petition, the governing body shall hold an election in accordance with Title
13 13, chapter 1, part 5.

14 (6) (a) Before the resort tax question is submitted to the electorate of a resort community or area, the
15 governing body of the resort community or the board of county commissioners in the county in which the resort
16 area is located shall provide notice of the goods and services subject to the resort tax by a method described in
17 13-1-108.

18 (b) The notice must be given two times, with at least 6 days separating the notices. The first notice must
19 be no more than 45 days prior to the election, and the last notice must be no less than 30 days prior to the
20 election.

21 ~~(6)(7)~~ Notice of the election must be ~~accomplished~~ given as provided in 13-1-108 and include the
22 information listed in subsection (4) of this section.

23 ~~(7)(8)~~ The question of the imposition of a resort tax may not be placed before the qualified electors more
24 than once in any fiscal year."
25

26 **SECTION 5. SECTION 7-13-2212, MCA, IS AMENDED TO READ:**

27 **"7-13-2212. Qualifications to vote. (1) Except as provided in subsection (2), an individual is not entitled**
28 **to vote at any election under the provisions of part 23 and this part unless the individual possesses all the**
29 **qualifications required of electors under the general election laws of the state and is a resident of the proposed**
30 **district or the owner of taxable real property located within the county in which the individual proposes to vote and**

1 ~~situated within the boundaries of the proposed district.~~

2 ~~———(2) An individual who is the owner of the real property described in subsection (1) need not possess the~~
 3 ~~qualifications required of an elector in 13-1-111(1)(c), provided that the elector is qualified if registered to vote~~
 4 ~~in any state of the United States and files proof of registration with the election administrator at least 40 days prior~~
 5 ~~to the election in which the individual intends to vote: (1) An individual is qualified to vote in any election under~~
 6 ~~the provisions of part 23 and this part if the individual is a qualified voter pursuant to 13-1-111, not including~~
 7 ~~13-1-111(1)(a) and (1)(c), and is:~~

8 (a) a resident of the proposed or existing district;

9 (b) an owner of taxable real property within the boundaries of the proposed or existing district or, if the
 10 property is owned by more than one person, an agent designated by the owners;

11 (c) an individual listed in 13-1-506 representing a corporation or company that owns taxable real property
 12 within the boundaries of the proposed or existing district; or

13 (d) a designated agent for a property held in trust within the boundaries of the proposed or existing
 14 district.

15 (2) An individual qualified to vote pursuant to subsections (1)(b) through (1)(d) shall provide written proof
 16 of the individual's qualifications to the election administrator at least 25 days before the election."

18 **Section 6.** Section 13-1-101, MCA, is amended to read:

19 **"13-1-101. Definitions.** As used in this title, unless the context clearly indicates otherwise, the following
 20 definitions apply:

21 (1) "Active elector" means an elector whose name has not been placed on the inactive list due to failure
 22 to respond to confirmation notices pursuant to 13-2-220 or 13-19-313.

23 (2) "Active list" means a list of active electors maintained pursuant to 13-2-220.

24 (3) "Anything of value" means any goods that have a certain utility to the recipient that is real and that
 25 is ordinarily not given away free but is purchased.

26 (4) "Application for voter registration" means a voter registration form prescribed by the secretary of state
 27 that is completed and signed by an elector, is submitted to the election administrator, and contains voter
 28 registration information subject to verification as provided by law.

29 (5) "Ballot" means a paper ballot counted manually or a paper ballot counted by a machine, such as an
 30 optical scan system or other technology that automatically tabulates votes cast by processing the paper ballots.

1 (6) (a) "Ballot issue" or "issue" means a proposal submitted to the people at an election for their approval
2 or rejection, including but not limited to an initiative, referendum, proposed constitutional amendment, recall
3 question, school levy question, bond issue question, or ballot question.

4 (b) For the purposes of chapters 35 and 37, an issue becomes a "ballot issue" upon certification by the
5 proper official that the legal procedure necessary for its qualification and placement on the ballot has been
6 completed, except that a statewide issue becomes a "ballot issue" upon preparation and transmission by the
7 secretary of state of the form of the petition or referral to the person who submitted the proposed issue.

8 (7) "Ballot issue committee" means a political committee specifically organized to support or oppose a
9 ballot issue.

10 (8) "Candidate" means:

11 (a) an individual who has filed a declaration or petition for nomination, acceptance of nomination, or
12 appointment as a candidate for public office as required by law;

13 (b) for the purposes of chapter 35, 36, or 37, an individual who has solicited or received and retained
14 contributions, made expenditures, or given consent to an individual, organization, political party, or committee
15 to solicit or receive and retain contributions or make expenditures on the individual's behalf to secure nomination
16 or election to any office at any time, whether or not the office for which the individual will seek nomination or
17 election is known when the:

18 (i) solicitation is made;

19 (ii) contribution is received and retained; or

20 (iii) expenditure is made; or

21 (c) an officeholder who is the subject of a recall election.

22 (9) (a) "Contribution" means:

23 (i) the receipt by a candidate or a political committee of an advance, gift, loan, conveyance, deposit,
24 payment, or distribution of money or anything of value to support or oppose a candidate or a ballot issue;

25 (ii) an expenditure, including an in-kind expenditure, that is made in coordination with a candidate or ballot
26 issue committee and is reportable by the candidate or ballot issue committee as a contribution;

27 (iii) the receipt by a political committee of funds transferred from another political committee; or

28 (iv) the payment by a person other than a candidate or political committee of compensation for the
29 personal services of another person that are rendered to a candidate or political committee.

30 (b) "Contribution" does not mean services provided without compensation by individuals volunteering

1 a portion or all of their time on behalf of a candidate or political committee or meals and lodging provided by
2 individuals in their private residences for a candidate or other individual.

3 (10) "Coordinated", including any variations of the term, means made in cooperation with, in consultation
4 with, at the request of, or with the express prior consent of a candidate or political committee or an agent of a
5 candidate or political committee.

6 (11) "De minimis act" means an action, contribution, or expenditure that is so small that it does not trigger
7 registration, reporting, disclaimer, or disclosure obligations under Title 13, chapter 35 or 37, or warrant
8 enforcement as a campaign practices violation under Title 13, chapter 37.

9 (12) "Election" means a general, special, or primary election held pursuant to the requirements of state
10 law, regardless of the time or purpose.

11 (13) (a) "Election administrator" means, except as provided in subsection (13)(b), the county clerk and
12 recorder or the individual designated by a county governing body to be responsible for all election administration
13 duties, except that with regard to school elections not administered by the county, the term means the school
14 district clerk.

15 (b) As used in chapter 2 regarding voter registration, the term means the county clerk and recorder or
16 the individual designated by a county governing body to be responsible for all election administration duties even
17 if the school election is administered by the school district clerk.

18 (14) (a) "Election communication" means the following forms of communication to support or oppose a
19 candidate or ballot issue:

- 20 (i) a paid advertisement broadcast over radio, television, cable, or satellite;
21 (ii) paid placement of content on the internet or other electronic communication network;
22 (iii) a paid advertisement published in a newspaper or periodical or on a billboard;
23 (iv) a mailing; or
24 (v) printed materials.

25 (b) The term does not mean:

26 (i) an activity or communication for the purpose of encouraging individuals to register to vote or to vote,
27 if that activity or communication does not mention or depict a clearly identified candidate or ballot issue;

28 (ii) a communication that does not support or oppose a candidate or ballot issue;

29 (iii) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
30 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general circulation;

1 (iv) a communication by any membership organization or corporation to its members, stockholders, or
2 employees; or

3 (v) a communication that the commissioner determines by rule is not an election communication.

4 (15) (a) "Electioneering communication" means a paid communication that is publicly distributed by radio,
5 television, cable, satellite, internet website, newspaper, periodical, billboard, mail, or any other distribution of
6 printed materials, that is made within 60 days of the initiation of voting in an election, that does not support or
7 oppose a candidate or ballot issue, that can be received by more than 100 recipients in the district voting on the
8 candidate or ballot issue, and that:

9 (i) refers to one or more clearly identified candidates in that election;

10 (ii) depicts the name, image, likeness, or voice of one or more clearly identified candidates in that
11 election; or

12 (iii) refers to a political party, ballot issue, or other question submitted to the voters in that election.

13 (b) The term does not mean:

14 (i) a bona fide news story, commentary, blog, or editorial distributed through the facilities of any
15 broadcasting station, newspaper, magazine, internet website, or other periodical publication of general circulation
16 unless the facilities are owned or controlled by a candidate or political committee;

17 (ii) a communication by any membership organization or corporation to its members, stockholders, or
18 employees;

19 (iii) a commercial communication that depicts a candidate's name, image, likeness, or voice only in the
20 candidate's capacity as owner, operator, or employee of a business that existed prior to the candidacy;

21 (iv) a communication that constitutes a candidate debate or forum or that solely promotes a candidate
22 debate or forum and is made by or on behalf of the person sponsoring the debate or forum; or

23 (v) a communication that the commissioner determines by rule is not an electioneering communication.

24 (16) "Elector" means an individual qualified to vote under state law.

25 (17) (a) "Expenditure" means a purchase, payment, distribution, loan, advance, promise, pledge, or gift
26 of money or anything of value:

27 (i) made by a candidate or political committee to support or oppose a candidate or a ballot issue; or

28 (ii) used or intended for use in making independent expenditures or in producing electioneering
29 communications.

30 (b) "Expenditure" does not mean:

- 1 (i) services, food, or lodging provided in a manner that they are not contributions under subsection (9);
2 (ii) payments by a candidate for a filing fee or for personal travel expenses, food, clothing, lodging, or
3 personal necessities for the candidate and the candidate's family;
4 (iii) the cost of any bona fide news story, commentary, blog, or editorial distributed through the facilities
5 of any broadcasting station, newspaper, magazine, or other periodical publication of general circulation; or
6 (iv) the cost of any communication by any membership organization or corporation to its members or
7 stockholders or employees.
- 8 (18) "Federal election" means an election in even-numbered years in which an elector may vote for
9 individuals for the office of president of the United States or for the United States congress.
- 10 (19) "General election" means an election that is held for offices that first appear on a primary election
11 ballot, unless the primary is canceled as authorized by law, and that is held on a date specified in 13-1-104.
- 12 (20) "Inactive elector" means an individual who failed to respond to confirmation notices and whose name
13 was placed on the inactive list pursuant to 13-2-220 or 13-19-313.
- 14 (21) "Inactive list" means a list of inactive electors maintained pursuant to 13-2-220 or 13-19-313.
- 15 (22) (a) "Incidental committee" means a political committee that is not specifically organized or operating
16 for the primary purpose of supporting or opposing candidates or ballot issues but that may incidentally become
17 a political committee by receiving a contribution or making an expenditure.
- 18 (b) For the purpose of this subsection (22), the primary purpose is determined by the commissioner by
19 rule and includes criteria such as the allocation of budget, staff, or members' activity or the statement of purpose
20 or goal of the person or individuals that form the committee.
- 21 (23) "Independent committee" means a political committee organized for the primary purpose of receiving
22 contributions and making expenditures that is not controlled either directly or indirectly by a candidate and that
23 does not coordinate with a candidate in conjunction with the making of expenditures except pursuant to the limits
24 set forth in 13-37-216(1).
- 25 (24) "Independent expenditure" means an expenditure for an election communication to support or
26 oppose a candidate or ballot issue made at any time that is not coordinated with a candidate or ballot issue
27 committee.
- 28 (25) "Individual" means a human being.
- 29 (26) "Legally registered elector" means an individual whose application for voter registration was
30 accepted, processed, and verified as provided by law.

1 (27) "Mail ballot election" means any election that is conducted under Title 13, chapter 19, by mailing
2 ballots to all active electors.

3 (28) "Person" means an individual, corporation, association, firm, partnership, cooperative, committee,
4 including a political committee, club, union, or other organization or group of individuals or a candidate as defined
5 in subsection (8).

6 (29) "Place of deposit" means a location designated by the election administrator pursuant to 13-19-307
7 for a mail ballot election conducted under Title 13, chapter 19.

8 (30) (a) "Political committee" means a combination of two or more individuals or a person other than an
9 individual who receives a contribution or makes an expenditure:

10 (i) to support or oppose a candidate or a committee organized to support or oppose a candidate or a
11 petition for nomination;

12 (ii) to support or oppose a ballot issue or a committee organized to support or oppose a ballot issue; or

13 (iii) to prepare or disseminate an election communication, an electioneering communication, or an
14 independent expenditure.

15 (b) Political committees include ballot issue committees, incidental committees, independent committees,
16 and political party committees.

17 (c) A candidate and the candidate's treasurer do not constitute a political committee.

18 (d) A political committee is not formed when a combination of two or more individuals or a person other
19 than an individual makes an election communication, an electioneering communication, or an independent
20 expenditure of \$250 or less.

21 (31) "Political party committee" means a political committee formed by a political party organization and
22 includes all county and city central committees.

23 (32) "Political party organization" means a political organization that:

24 (a) was represented on the official ballot in either of the two most recent statewide general elections; or

25 (b) has met the petition requirements provided in Title 13, chapter 10, part 5.

26 (33) "Political subdivision" means a county, consolidated municipal-county government, municipality,
27 special purpose district, or any other unit of government, except school districts, having authority to hold an
28 election.

29 (34) "Polling place election" means an election primarily conducted at polling places rather than by mail
30 under the provisions of Title 13, chapter 19.

1 (35) "Primary" or "primary election" means an election held on a date specified in 13-1-107 to nominate
2 candidates for offices filled at a general election.

3 (36) "Provisional ballot" means a ballot cast by an elector whose identity or eligibility to vote has not been
4 verified as provided by law.

5 (37) "Provisionally registered elector" means an individual whose application for voter registration was
6 accepted but whose identity or eligibility has not yet been verified as provided by law.

7 (38) "Public office" means a state, county, municipal, school, or other district office that is filled by the
8 people at an election.

9 (39) "Random-sample audit" means an audit involving a manual count of ballots from designated races
10 and ballot issues in precincts selected through a random process as provided in 13-17-503.

11 (40) "Registrar" means the county election administrator and any regularly appointed deputy or assistant
12 election administrator.

13 (41) "Regular school election" means the school trustee election provided for in 20-20-105(1).

14 (42) "School election" has the meaning provided in 20-1-101.

15 (43) "School election filing officer" means the filing officer with whom the declarations for nomination for
16 school district office were filed or with whom the school ballot issue was filed.

17 (44) "School recount board" means the board authorized pursuant to 20-20-420 to perform recount duties
18 in school elections.

19 (45) "Signature envelope" means an envelope that contains a secrecy envelope and ballot and that is
20 designed to:

21 (a) allow election officials, upon examination of the outside of the envelope, to determine that the ballot
22 is being submitted by someone who is in fact a qualified elector and who has not already voted; and

23 (b) allow it to be used in the United States mail.

24 (46) "Special election" means an election held on a day other than the day specified for a primary
25 election, general election, or regular school election.

26 (47) "Special purpose district" means an area with special boundaries created as authorized by law for
27 a specialized and limited purpose.

28 (48) "Statewide voter registration list" means the voter registration list established and maintained
29 pursuant to 13-2-107 and 13-2-108.

30 (49) "Support or oppose", including any variations of the term, means:

1 (a) using express words, including but not limited to "vote", "oppose", "support", "elect", "defeat", or
 2 "reject", that call for the nomination, election, or defeat of one or more clearly identified candidates, the election
 3 or defeat of one or more political parties, or the passage or defeat of one or more ballot issues submitted to voters
 4 in an election; or

5 (b) otherwise referring to or depicting one or more clearly identified candidates, political parties, or ballot
 6 issues in a manner that is susceptible of no reasonable interpretation other than as a call for the nomination,
 7 election, or defeat of the candidate in an election, the election or defeat of the political party, or the passage or
 8 defeat of the ballot issue or other question submitted to the voters in an election.

9 (50) "Transfer form" means a form prescribed by the secretary of state that may be filled out by an elector
 10 to transfer the elector's registration when the elector's residence address has changed within the county.

11 (51) "Valid vote" means a vote that has been counted as valid or determined to be valid as provided in
 12 13-15-206.

13 (52) "Voted ballot" means a ballot that is:

- 14 (a) deposited in the ballot box at a polling place;
- 15 (b) received at the election administrator's office; or
- 16 (c) returned to a place of deposit.

17 (53) "Voting system" or "system" means any machine, device, technology, or equipment used to
 18 automatically record, tabulate, or process the vote of an elector cast on a paper ballot."

19

20 **Section 7.** Section 13-1-403, MCA, is amended to read:

21 **"13-1-403. Election deadlines for candidate filing, write-in candidacy, and withdrawal -- election**
 22 **cancellation -- election by acclamation.** (1) Consistent with the candidate filing deadline in 13-10-201(7) for
 23 primary elections and except as provided in subsection (2) for a write-in candidate, the candidate filing deadline
 24 for election to a local government office is no sooner than 145 days and no later than 85 days before the election.

25 (2) ~~Consistent with the deadline for write-in candidates under 13-10-211 for primary elections, a~~ A

28 the expiration of the officer's term shall serve until the election or appointment of a successor under the laws

29 effective on and after November 4, 2015, that provide for the special purpose district election to be held on the
