18 ~~Section 1. Section 10-3-1307, MCA, is amended to read:~~

19 ~~"10-3-1307. Responsibilities of department of transportation-- assessment and collection of fees~~
20 ~~--issuance of permits-- inspection of motor carriers. (1) After receiving notification from the person or entity~~
21 ~~that plans to ship high-level radioactive waste or transuranic waste through the state, the department of~~
22 ~~transportation shall assess fees according to the following schedule:~~

23 ~~(a) a fee of \$2,500 must be assessed for each cask designed for transport by truck; and~~

24 ~~(b) a fee of \$4,500 must be assessed for the first cask designed for transport by rail and a fee of \$3,000~~
25 ~~for each additional cask designed for transport by rail that is shipped by the same person or entity in the same~~
26 ~~shipment.~~

27 ~~(2) Payment of the fees provided in subsection (1) is the responsibility of the person or entity who owns~~
28 ~~the waste.~~

12 **Section 1.** Section 15-30-2131, MCA, is amended to read:

13 **"15-30-2131. Deductions allowed in computing net income.** (1) In computing net income, there are
 14 allowed as deductions:

15 (a) the items referred to in sections 161, including the contributions referred to in 33-15-201(5)(b), and
 16 211 of the Internal Revenue Code, 26 U.S.C. 161 and 211, subject to the following exceptions, which are not
 17 deductible:

18 (i) items provided for in 15-30-2133;

19 (ii) state income tax paid;

20 (iii) premium payments for medical care as provided in subsection (1)(g)(i);

21 (iv) long-term care insurance premium payments as provided in subsection (1)(g)(ii); and

22 (v) a charitable contribution using a charitable gift annuity unless the annuity is a qualified charitable gift
 23 annuity as defined in 33-20-701;

24 (b) federal income tax paid within the tax year, not to exceed \$5,000 for each taxpayer filing singly, head
 25 of household, or married filing separately or \$10,000 if married and filing jointly;

26 (c) expenses of household and dependent care services as outlined in subsections (1)(c)(i) through
 27 (1)(c)(iii) and (2) and subject to the limitations and rules as set out in subsections (1)(c)(iv) through (1)(c)(vi), as
 28 follows:

29 (i) expenses for household and dependent care services necessary for gainful employment incurred for:

30 (A) a dependent under 15 years of age for whom an exemption can be claimed;

1 (B) a dependent as allowable under 15-30-2114(5), except that the limitations for age and gross income
2 do not apply, who is unable to provide self-care because of physical or mental illness; and
3 (C) a spouse who is unable to provide self-care because of physical or mental illness;
4 (ii) employment-related expenses incurred for the following services, but only if the expenses are incurred
5 to enable the taxpayer to be gainfully employed:
6 (A) household services that are attributable to the care of the qualifying individual; and
7 (B) care of an individual who qualifies under subsection (1)(c)(i);
8 (iii) expenses incurred in maintaining a household if over half of the cost of maintaining the household
9 is furnished by an individual or, if the individual is married during the applicable period, is furnished by the
10 individual and the individual's spouse;
11 (iv) the amounts deductible in subsections (1)(c)(i) through (1)(c)(iii), subject to the following limitations:
12 (A) a deduction is allowed under subsection (1)(c)(i) for employment-related expenses incurred during
13 the year only to the extent that the expenses do not exceed \$4,800;
14 (B) expenses for services in the household are deductible under subsection (1)(c)(i) for
15 employment-related expenses only if they are incurred for services in the taxpayer's household, except that
16 employment-related expenses incurred for services outside the taxpayer's household are deductible, but only if
17 incurred for the care of a qualifying individual described in subsection (1)(c)(i)(A) and only to the extent that the
18 expenses incurred during the year do not exceed:
19 (I) \$2,400 in the case of one qualifying individual;
20 (II) \$3,600 in the case of two qualifying individuals; and
21 (III) \$4,800 in the case of three or more qualifying individuals;
22 (v) if the combined adjusted gross income of the taxpayers exceeds \$18,000 for the tax year during
23 which the expenses are incurred, the amount of the employment-related expenses incurred, to be reduced by
24 one-half of the excess of the combined adjusted gross income over \$18,000;
25 (vi) for purposes of this subsection (1)(c):
26 (A) married couples shall file a joint return or file separately on the same form;
27 (B) if the taxpayer is married during any period of the tax year, employment-related expenses incurred
28 are deductible only if:
29 (I) both spouses are gainfully employed, in which case the expenses are deductible only to the extent
30 that they are a direct result of the employment; or

- 1 (II) the spouse is a qualifying individual described in subsection (1)(c)(i)(C);
- 2 (C) an individual legally separated from the individual's spouse under a decree of divorce or of separate
3 maintenance may not be considered as married;
- 4 (D) the deduction for employment-related expenses must be divided equally between the spouses when
5 filing separately on the same form;
- 6 (E) payment made to a child of the taxpayer who is under 19 years of age at the close of the tax year
7 and payments made to an individual with respect to whom a deduction is allowable under 15-30-2114(5) are not
8 deductible as employment-related expenses;
- 9 (d) in the case of an individual, political contributions determined in accordance with the provisions of
10 section 218(a) and (b) of the Internal Revenue Code of 1954 (now repealed) that were in effect for the tax year
11 that ended December 31, 1978;
- 12 (e) that portion of expenses for organic fertilizer and inorganic fertilizer produced as a byproduct allowed
13 as a deduction under 15-32-303 that was not otherwise deducted in computing taxable income;
- 14 (f) contributions to the child abuse and neglect prevention program provided for in 52-7-101, subject to
15 the conditions set forth in 15-30-2143;
- 16 (g) the entire amount of premium payments made by the taxpayer, except premiums deducted in
17 determining Montana adjusted gross income, or for which a credit was claimed under 15-30-2366, for:
- 18 (i) insurance for medical care, as defined in 26 U.S.C. 213(d), for coverage of the taxpayer, the
19 taxpayer's dependents, and the parents and grandparents of the taxpayer; and
- 20 (ii) long-term care insurance policies or certificates that provide coverage primarily for any qualified
21 long-term care services, as defined in 26 U.S.C. 7702B(c), for:
- 22 (A) the benefit of the taxpayer for tax years beginning after December 31, 1994; or
- 23 (B) the benefit of the taxpayer, the taxpayer's dependents, and the parents and grandparents of the
24 taxpayer for tax years beginning after December 31, 1996;
- 25 (h) light vehicle registration fees, as provided for in 61-3-321(2)(a) and 61-3-562, paid during the tax
26 year; and
- 27 (i) per capita livestock fees imposed pursuant to 15-24-921, 15-24-922, 81-6-104, 81-6-204, 81-6-209,
28 81-7-118, or 81-7-201.
- 29 (2) (a) Subject to the conditions of subsection (1)(c), a taxpayer who operates a family day-care home
30 or a group day-care home, as these terms are defined in 52-2-703, and who cares for the taxpayer's own child

1 and at least one unrelated child in the ordinary course of business may deduct employment-related expenses
2 considered to have been paid for the care of the child.

3 (b) The amount of employment-related expenses considered to have been paid by the taxpayer is equal
4 to the amount that the taxpayer charges for the care of a child of the same age for the same number of hours of
5 care. The employment-related expenses apply regardless of whether any expenses actually have been paid.
6 Employment-related expenses may not exceed the amounts specified in subsection (1)(c)(iv)(B).

7 (c) Only a day-care operator who is licensed and registered as required in 52-2-721 is allowed the
8 deduction under this subsection (2)."

10 **Section 2.** Section 15-50-207, MCA, is amended to read:

11 **"15-50-207. Credit against other taxes -- credit for personal property taxes and certain fees.** (1) (a)

12 The additional license fees withheld or otherwise paid as provided in this chapter may be used as a credit on the
13 contractor's corporate income tax provided for in chapter 31 of this title or on the contractor's income tax provided
14 for in chapter 30, depending upon the type of tax the contractor is required to pay under the laws of the state.

15 (b) The credit allowed under this subsection (1) may be used as a carryforward against taxes imposed
16 by chapter 30 or 31 for the 5 succeeding tax years. The entire amount of the credit not used in the year earned
17 must be carried first to the earliest tax year in which the credit may be applied and then to each succeeding tax
18 year.

19 (2) Personal property taxes and the fee in lieu of tax on buses, trucks having a manufacturer's rated
20 capacity of more than 1 ton, or truck tractors, as provided in 61-3-529, and the registration fee on light vehicles,
21 as provided in 61-3-321(2)(a) and 61-3-562, paid in Montana on any personal property or vehicle of the contractor
22 that is used in the business of the contractor and is located within this state may be credited against the license
23 fees required under this chapter. However, in computing the tax credit allowed by this section against the
24 contractor's income tax or corporate income tax, the tax credit against the license fees required under this chapter
25 may not be considered as license fees paid for the purpose of the income tax or corporate income tax credit."

27 **Section 3.** Section 15-70-401, MCA, is amended to read:

28 **"15-70-401. Definitions.** As used in this part, the following definitions apply:

29 (1) "Agricultural use" means use of gasoline or special fuel by a person who earns income while
30 engaging in the business of farming or ranching and who files farm or income reports for tax purposes as required

1 by the United States internal revenue service.

2 (2) "Aviation fuel" means gasoline or any other liquid fuel by whatever name the liquid fuel may be known
3 or sold, compounded for use in and sold for use in aircraft, including but not limited to any and all gasoline or
4 liquid fuel meeting or exceeding the minimum specifications prescribed by the United States for use by its military
5 forces in aircraft.

6 (3) (a) "Biodiesel" means a fuel produced from monoalkyl esters of long-chain fatty acids derived from
7 vegetable oils, renewable lipids, animal fats, or any combination of those ingredients. The fuel must meet the
8 requirements of ASTM D6751, also known as the Standard Specification for Biodiesel Fuel (B100) Blend Stock
9 for Distillate Fuels, as adopted by the American society for testing and materials.

10 (b) Biodiesel is also known as "B-100".

11 (4) "Bulk delivery" means placing gasoline or special fuel not intended for resale in storage or containers.
12 The term does not mean gasoline or special fuel delivered into the supply tank of a motor vehicle.

13 (5) "Cardtrol" or "keylock" means a unique device intended to allow access to a fuel dealer's unattended
14 pump or dispensing unit for the purpose of delivery of gasoline or special fuel to an authorized user of the unique
15 device.

16 (6) "Department" means the department of transportation.

17 (7) (a) "Distributed" means the withdrawal of gasoline or special fuel from a refinery or terminal storage,
18 other than by pipeline, by a licensed distributor for sale or use in this state, including:

19 (i) gasoline or special fuel refined, produced, manufactured, or compounded in this state and placed in
20 storage tanks in this state;

21 (ii) gasoline or special fuel transferred from a refinery or pipeline terminal in this state and placed in tanks
22 at the refinery or terminal; or

23 (iii) gasoline or special fuel imported into this state and placed in storage at a refinery or pipeline terminal.

24 (b) Gasoline or special fuel imported into this state, other than gasoline or special fuel placed in storage
25 at a refinery or pipeline terminal, is considered to be distributed after it has arrived in and is brought to rest in this
26 state.

27 (8) (a) "Distributor" means:

28 (i) a person who engages in the business in this state of producing, refining, manufacturing, or
29 compounding gasoline or special fuel for sale, use, or distribution;

30 (ii) an importer who imports gasoline or special fuel for sale, use, or distribution;

1 (iii) a person who engages in the wholesale distribution of gasoline or special fuel in this state and
2 chooses to become licensed to assume the Montana state gasoline tax or special fuel tax liability;

3 (iv) an exporter;

4 (v) a dealer licensed as of January 1, 1969, except a dealer at an established airport; or

5 (vi) a person in Montana who blends ethanol with gasoline.

6 (b) The term does not include a special biodiesel fuel producer who produces biodiesel from waste
7 vegetable oil feedstock in this state for the operation of motor vehicles owned or controlled by the person on the
8 public roads and highways of the state.

9 (9) "Ethanol" means nominally anhydrous ethyl alcohol that has been denatured as specified in 27 CFR,
10 parts 20 and 21, and that meets the standards for ethanol adopted pursuant to 82-15-103.

11 (10) "Ethanol-blended gasoline" means gasoline blended with ethanol. The percentage of ethanol in the
12 blend is identified by the letter "E" followed by the percentage number. A blend that is 10% denatured ethanol
13 and 90% gasoline would be reflected as E-10. A blend that is 85% denatured ethanol and 15% gasoline would
14 be reflected as E-85.

15 (11) "Export" means to transport out of Montana, by any means other than in the fuel supply tank of a
16 motor vehicle, gasoline or special fuel received from a refinery or pipeline terminal within Montana.

17 (12) "Exporter" means a person who transports, other than in the fuel supply tank of a motor vehicle,
18 gasoline or special fuel received from a refinery or pipeline terminal in Montana to a destination outside Montana
19 for sale, use, or consumption outside Montana.

20 (13) (a) "Gasoline" includes:

21 (i) all petroleum products commonly or commercially known or sold as gasolines, including casinghead
22 gasoline, natural gasoline, aviation fuel, and all flammable liquids composed of a mixture of selected
23 hydrocarbons expressly manufactured and blended for the purpose of effectively and efficiently operating internal
24 combustion engines; and

25 (ii) any other type of additive when the additive is mixed or blended into gasoline, regardless of the
26 additive's classifications or uses.

27 (b) "Gasoline" does not include special fuels as defined in this section or compressed natural gas,
28 liquefied natural gas, or liquefied petroleum gas as defined in 15-70-701.

29 (14) "Import" means to first receive gasoline or special fuel into possession or custody after its arrival and
30 coming to rest at a destination within the state or to first receive any gasoline or special fuel shipped or

1 transported into this state from a point of origin outside this state other than in the fuel supply tank of a motor
2 vehicle.

3 (15) "Importer" means a person who transports or arranges for the transportation of gasoline or special
4 fuel into Montana for sale, use, or distribution.

5 (16) "Improperly imported fuel" means gasoline or special fuel that is:

6 (a) consigned to a Montana destination and imported into the state without the distributor first having
7 obtained a Montana distributor license as required in 15-70-402; or

8 (b) delivered, possessed, sold, or transferred in the state in any manner not authorized under Title 15,
9 chapter 70.

10 (17) "Motor vehicle" means all vehicles that are operated on the public roads and highways of this state
11 and that are operated in whole or in part by the combustion of gasoline or special fuel.

12 (18) "Person" includes any person, firm, association, joint-stock company, syndicate, partnership, or
13 corporation. Whenever the term is used in any clause prescribing and imposing a fine or imprisonment, or both,
14 as applied to a firm, association, syndicate, or partnership, it includes the partners or members and, as applied
15 to joint-stock companies and corporations, the officers.

16 (19) "Public roads and highways of this state" means all streets, roads, highways, and related structures:

17 (a) built and maintained with appropriated funds of the United States, the state of Montana, or any
18 political subdivision of the state;

19 (b) dedicated to public use;

20 (c) acquired by eminent domain, as provided in Title 60, chapter 4, or Title 70, chapter 30; or

21 (d) acquired by adverse use by the public, with jurisdiction having been assumed by the state or any
22 political subdivision of the state.

23 (20) "Special biodiesel fuel producer" means a person who produces less than 2,500 gallons annually
24 of biodiesel fuel from waste vegetable oil feedstock for the operation of motor vehicles owned or controlled by
25 the person on the public roads and highways of the state.

26 (21) (a) "Special fuel" means those combustible gases and liquids commonly referred to as diesel fuel
27 or any other volatile liquid of less than 46 degrees A.P.I. (American petroleum institute) gravity test, ~~except liquid~~
28 ~~petroleum gas~~, when actually sold for use in motor vehicles operating on the public roads and highways of this
29 state. The term "special fuel" includes biodiesel and additives of all types when the additive is mixed or blended
30 into special fuel, regardless of the additive's classifications or uses.

1 **(b) The term does not include compressed natural gas, liquefied natural gas, or liquefied petroleum gas**
2 **as defined in 15-70-701.**

3 (22) (a) "Special fuel user" means a person who consumes special fuel for the operation of motor vehicles
4 owned or controlled by the person on the public roads and highways of this state.

5 (b) The term does not include:

6 (i) the U.S. government, a state, a county, an incorporated city or town, or a school district of this state;
7 or

8 (ii) a special biodiesel fuel producer who produces biodiesel from waste vegetable oil feedstock for the
9 operation of motor vehicles owned or controlled by the person on the public roads and highways of this state.

10 (23) "Use" means the operation of a motor vehicle on the public roads and highways of this state or of
11 any political subdivision of this state.

12 (24) "Waste vegetable oil" means used cooking oil gathered from restaurants or commercial food
13 processors."
14

15 **Section 4.** Section 15-70-701, MCA, is amended to read:

16 **"15-70-701. Definitions.** As used in this part, the following definitions apply:

17 (1) "Bond" means:

18 (a) a bond executed by a compressed natural gas dealer, a liquefied natural gas dealer, or a liquefied
19 petroleum gas dealer as principal with a corporate surety qualified under the laws of Montana, payable to the
20 state of Montana, conditioned upon performance of all requirements of this part, including the payment of all
21 taxes, penalties, and other obligations of the compressed natural gas dealer, the liquefied natural gas dealer, or
22 the liquefied petroleum gas dealer arising out of this part; or

23 (b) a deposit with the department by the compressed natural gas dealer, the liquefied natural gas dealer,
24 or the liquefied petroleum gas dealer, under terms and conditions that the department may prescribe, of
25 certificates of deposit or irrevocable letters of credit issued by a bank and insured by the federal deposit insurance
26 corporation.

27 (2) "Compressed natural gas" means a product that is used as a fuel and that contains carbon or
28 hydrogen, or both, and is compressed to greater than 24 pounds per square inch absolute base pressure and
29 up to 3,600 pounds per square inch absolute base pressure when sold for use in motor vehicles operated on the
30 public roads and highways of this state.

1 (3) "Compressed natural gas dealer" or "dealer" means a person who delivers any part of compressed
2 natural gas into the fuel supply tank or tanks of a motor vehicle.

3 (4) "Department" means the department of transportation.

4 (5) "Liquefied natural gas" means natural gas sold for use in motor vehicles that has been cooled to -259
5 degrees F and, when condensed into liquid, is colorless, odorless, noncorrosive, and nontoxic.

6 (6) "Liquefied natural gas dealer" or "dealer" means a person who delivers any part of liquefied natural
7 gas into the fuel supply tank or tanks of a motor vehicle.

8 ~~(5)(7)~~ "Liquefied petroleum gas" means any petroleum product that is sold for use in motor vehicles and
9 that is composed predominantly of any of the following hydrocarbons or mixtures of hydrocarbons:

10 (a) propane;

11 (b) propylene;

12 (c) butane, including normal butane or isobutane; or

13 (d) butylene.

14 ~~(6)(8)~~ "Liquefied petroleum gas dealer" or "dealer" means a person who delivers any part of liquefied
15 petroleum gas into the fuel supply tank or tanks of a motor vehicle.

16 ~~(7)(9)~~ "Motor vehicle" means any vehicle that is self-propelled by compressed natural gas, by liquefied
17 natural gas, or by liquefied petroleum gas and that is driven upon the public roads and highways of this state.

18 ~~(8)(10)~~ (a) "Person" means a person, firm, association, joint-stock company, syndicate, partnership, or
19 corporation.

20 (b) When used in any clause prescribing and imposing a fine or imprisonment, or both, as applied to a
21 firm, association, syndicate, or partnership, person means the partners or members of a firm, association,
22 syndicate, or partnership. As applied to a joint-stock company or corporation, the term means the officers of the
23 joint-stock company or corporation.

24 ~~(9)(11)~~ "Public roads and highways of this state" means all streets, roads, highways, and related
25 structures that are:

26 (a) built and maintained with appropriated funds of the United States, the state of Montana, or any
27 political subdivision of the state;

28 (b) dedicated to public use;

29 (c) acquired by eminent domain, as provided in Title 60, chapter 4, or Title 70, chapter 30; or

30 (d) acquired by adverse use by the public, with jurisdiction having been assumed by the state or any

1 political subdivision of the state."
2

3 **Section 5.** Section 15-70-702, MCA, is amended to read:

4 **"15-70-702. Compressed natural gas dealer's, liquefied natural gas dealer's, or liquefied**
5 **petroleum gas dealer's license.** A person may not act as a compressed natural gas dealer, as a liquefied
6 natural gas dealer, or as a liquefied petroleum gas dealer in this state unless the person holds a valid compressed
7 natural gas dealer's license, a valid liquefied natural gas dealer's license, or a valid liquefied petroleum gas
8 dealer's license issued by the department."
9

10 **Section 6.** Section 15-70-703, MCA, is amended to read:

11 **"15-70-703. Application for license.** An application for a compressed natural gas dealer's license, a
12 liquefied natural gas dealer's license, or a liquefied petroleum gas dealer's license must be filed on a form
13 prescribed by the department. The application must contain information that the department considers
14 necessary."
15

16 **Section 7.** Section 15-70-704, MCA, is amended to read:

17 **"15-70-704. Bonding, release of surety, and additional bond.** (1) Except as provided in this section,
18 a compressed natural gas dealer's license, a liquefied natural gas dealer's license, or a liquefied petroleum gas
19 dealer's license may not be issued to a person and may not be continued in force unless the person has furnished
20 a bond, in a form prescribed by the department, to secure the dealer's compliance with this part and has paid all
21 taxes, interest, and penalties due under this part. The department shall waive the bond requirement of a
22 compressed natural gas dealer, a liquefied natural gas dealer, or a liquefied petroleum gas dealer who is not
23 subject to the provisions of subsection (2)(a) or (2)(b).

24 (2) The total amount of the bond or bonds required must be equivalent to twice the compressed natural
25 gas dealer's, the liquefied natural gas dealer's, or the liquefied petroleum gas dealer's estimated quarterly tax
26 payments but may not be less than \$1,000 for any compressed natural gas dealer, liquefied natural gas dealer,
27 or liquefied petroleum gas dealer who:

28 (a) requests a compressed natural gas dealer's license, a liquefied natural gas dealer's license, or a
