11	Section 1. Section 70-24-204, MCA, is amended to read:
12	"70-24-204. Effect of unsigned or undelivered rental agreement. (1) If the landlord does not sign and
13	deliver a written rental agreement that has already been signed by the tenant and delivered to the landlord by the
14	$\textcolor{red}{\textbf{tenant}}, \textbf{acceptance of rent } \textcolor{red}{\textbf{without reservation}} \textcolor{red}{\underline{\textbf{WITHOUT RESERVATION}}} \ \textbf{by the landlord gives the rental agreement}$
15	the same effect as if it had been signed and delivered by the landlord to the tenant.
16	(2) If the tenant does not sign and deliver to the landlord a written rental agreement that has already
17	been signed by the landlord and delivered to the tenant by the landlord, acceptance of possession of the
18	$\underline{\text{premises}} \text{ and payment of rent } \underline{\text{without reservation}} \underline{\text{WITHOUT RESERVATION}} \underline{\text{by the tenant}} \underline{\text{gives the rental agreement}}$
19	the same effect as if it had been signed and delivered by the tenant to the landlord.
20	(3) If a rental agreement given effect by the operation of this section provides for a term longer than 1
21	year, it is effective for only 1 year."

23	Section 2. Section 70-33-203, MCA, is amended to read:
24	"70-33-203. Effect of unsigned or undelivered rental agreement. (1) If the landlord does not sign and
25	deliver a written rental agreement that has already been signed by the tenant and delivered to the landlord by the
26	tenant, acceptance of rent without reservation WITHOUT RESERVATION by the landlord gives the rental agreement
27	the same effect as if it had been signed and delivered by the landlord to the tenant.
28	(2) If the tenant does not sign and deliver to the landlord a written rental agreement that has already
29	been signed by the landlord and delivered to the tenant by the landlord, acceptance of possession of the
30	premises and payment of rent without reservation WITHOUT RESERVATION by the tenant gives the rental agreement

1	the same effect as if it had been signed and delivered by the tenant to the landlord.
2	(3) If a rental agreement given effect by the operation of this section provides for a term longer than
3	year, it is effective for only 1 year."

7	NEW SECTION. Section 4. Applicability. [This act] applies to rental agreements entered into
