Section 1. General rate cases. (1) If 2 years have elapsed since the commission 13 issued an order approving the rates and schedules of a public utility following a general rate case, the public utility 14 must file an application for a general rate case or some part of a general rate case, as determined by the 15 commission. The commission may require that any application made pursuant to this section conform to its rules 16 on practice, procedure, and minimum filing requirements. A public utility filing an application pursuant to this 17 section has the burden of persuading the commission that the rates, schedules, and service proposals contained 18 in the application are reasonable and just. 19 (2) For purposes of this section: 20 (a) (i) "general rate case" means a contested case review of all necessary components of the revenue 21 requirement, allocated cost of service, and rate design of a public utility, followed by a commission order 22 establishing rates and schedules. 23 (ii) The term does not mean: 24 (A) a commission proceeding on an application from a public utility to reflect in its rates changes in the 25 commodity cost of natural gas or electricity; 26 (B) a proceeding on an application from a public utility for an automatic rate adjustment pursuant to 69-3-308; or 27 28 (C) any other proceeding allowed by the commission on an application from a public utility to change 29 rates and schedules based on a review of a single or a limited number of public utility cost components. 30 (b) "public utility" means any public utility regulated by the commission pursuant to Title 69, chapter 3,
