4 A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING THE DEPARTMENT OF PUBLIC HEALTH AND
5 HUMAN SERVICES TO CREATE A STRATEGIC PLAN TO REDUCE THE INCIDENCE OF CHILD ABUSE AND
6 NEGLECT."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10 **NEW SECTION. Section 1. Strategic plan for child abuse and neglect prevention -- report to**
11 **legislature.** (1) (a) By August 15, 2018, the department shall develop a strategic plan that sets out measurable
12 goals and strategies for reducing child abuse and neglect in Montana over a 5-year period. The plan must
13 address ways to:

14 (i) increase family stability;

15 (ii) enhance child development for all families; and

16 (iii) mitigate the factors known to lead to child abuse and neglect.

17 (b) The plan must review factors and propose strategies specific to Montana's urban and rural areas,
18 as well as the state's Indian communities and reservations.

19 (2) The strategic plan must:

20 (a) outline the degree to which child abuse and neglect is occurring in Montana and the projections for
21 the occurrence of child abuse and neglect in future years;

22 (b) discuss the effects that child abuse and neglect have on children, families, and society as a whole,
23 including the effects on the physical, psychological, cognitive, and behavioral development of children;

24 (c) examine the risk factors that lead to child abuse and neglect and the protective factors that reduce
25 the potential for child abuse and neglect to occur, using the social-ecological model that takes into account
26 individual, family, community, and societal factors, including factors specific to Indian communities and
27 reservations;

28 (d) review research related to risk and protective factors to evaluate the effectiveness of various
29 prevention efforts and identify the characteristics of successful prevention responses;

30 (e) inventory the prevention responses currently being used in Montana at the state and local levels; and

- 1 (f) propose additional prevention strategies.
- 2 (3) The department shall, at a minimum, include the following entities in development of the strategic
3 plan:
- 4 (a) the interagency coordinating council for state prevention programs provided for in 2-15-225;
5 (b) the Montana children's trust fund board provided for in 2-15-2214;
6 (c) the state advisory council for the child and family services division of the department;
7 (d) former members of the protect Montana kids commission established by the governor by executive
8 order on September 21, 2015;
9 (e) representatives of Montana's tribal communities; and
10 (f) representatives of other state and local agencies and organizations that work to reduce or prevent
11 child abuse and neglect, including juvenile courts and health, education, social services, and law enforcement
12 agencies.
- 13 (4) The department shall provide a copy of the strategic plan to the children, families, health, and human
14 services interim committee and the legislative finance committee.

16 **NEW SECTION. Section 2. Codification instruction.** [Section 1] is intended to be codified as an
17 integral part of Title 41, chapter 3, part 1, and the provisions of Title 41, chapter 3, part 1, apply to [section 1].
