Helena, Montana February 3, 2017 House Chambers State Capitol

House convened at 1:00 p.m. Mr. Speaker presiding. Invocation by Representative Noland. Pledge of Allegiance to the Flag.

Roll Call. All members present, except Representatives Peppers, excused. Quorum present.

# SPECIAL ORDERS OF THE DAY

Speaker Knudsen moved that the House revert to Order of Business # 11, Special Orders Of The Day, the purpose of receiving entertainment by Jason DeShaw.

Majority Leader Ehli introduced Jason DeShaw, an award-winning mental health advocate and country singer/songwriter from Eastern Montana. Diagnosed with bipolar disorder and alcoholism, Jason speaks and sings across North America, striving to bring people hope. Jason DeShaw has performed, across the country from the forensic unit at Warm Springs to the lecture halls of Harvard.

Speaker Knudsen thanked Jason DeShaw for his performance.

Majority Leader Ehli moved that the House Recess for the purpose of receiving the State of Education Address by the Superintendent of Public Instruction, Elsie Arntzen. Motion carried.

Majority Leader Ehli moved that Speaker Knudsen be authorized to appoint a committee of two to escort the Superintendent of Public Instruction Elsie Arntzen into the House Chamber. Motion carried.

Speaker Knudsen appointed Representative Berglee and Representative Hamilton. The Committee was discharged.

Sergeant-at-Arms Murfitt notified Speaker Knudsen that the Superintendent of Public Instruction, Elsie Arntzen, was awaiting entrance into the House Chamber.

The Committee escorted Superintendent Arntzen into the Chamber.

Speaker Knudsen introduced the Honorable Elsie Arntzen Superintendent of Public Instruction.

Thank you for sharing your talent and your story with us, Jason. It is truly inspiring. We need to spread your message of hope to students across Montana. You truly make Montana proud.

Thank you, Speaker Knudsen, and Members of the Montana House of Representatives for hosting me today. For twelve years I have been honored to serve shoulder to shoulder with you in these chambers, as well as with our esteemed colleagues in the Senate, but I have to tell you, sometimes

you have reminded me of my class of ten year olds.

A Montana thank you today for the members of the tribal nations, representatives of our statewide elected officials, and other guests here today.

Most importantly, I want to thank my family, who continue to support me as they always have. I am a proud mother of two daughters, grandmother of four beautiful grandchildren, and have been married to my high school sweetheart, Steven, for over forty years.

I have a degree in Economics from the University of Montana. Go Griz! I also have my Education degree from MSU. Go Cats! For twenty-three years I was privileged to teach in Billings Public Schools. In fact, I am currently in the certificate renewal process for my teaching license. As State Superintendent I'll even get to sign my own teaching certificate.

My purpose is to strengthen our public schools by ensuring a seamless system that reflects our community values, our culture, and our historic journey in a way that will make Montana proud and a leader in the West.

As the Superintendent of the Office of Public Instruction, I am responsible for leading one of the largest agencies of our state government. About forty percent of the state's general fund is dedicated to our public schools. This funds about sixty-four percent of your local school district's budget. Last week I presented our budget request to the Joint Subcommittee on Education. This request respects local taxpayers and, most importantly, our students.

The budget that I have offered is fiscally responsible and funds Montana's obligation to our schools. That is why my priority this session is to make sure that you do right by our students, and our taxpayers, and pass my budget. The Natural Resource Development payment that was removed by the Governor must be restored because it supports our Montana treasures, our students, in an equitable manner. If it is not reinstated, then a roughly \$11.4 million tax shift will be placed on local property taxpayers. Our budget resists that tax burden to local taxpayers. The State of Montana and the Governor must recognize your responsibility to public education and not further burden our local communities.

I have also asked that a formula component of the definition of quality public education be returned as stated in statute; that is the \$6.3 million Data for Achievement payment. The direct effect is that school districts will lose budget authority to best support our students and, as you know, money closest to the student is money well spent.

Thank you to this body for unanimously supporting House Bill 191, championed by the House Education Chair, Representative Berglee. I have strongly advocated for this bill. This is the statutorily mandated inflationary increase to K-12 Base Aid. By prioritizing the passage of this most important legislation early in these tight fiscal times, all of you are putting our Montana public schools and our students first. Thank you! This provides stability as next year's school budgets are being crafted for our future students. Thank you for helping me keep Montana's promise to fund our public schools and place this on the Governor's desk before the end of February.

My office has been carefully monitoring education-related bills and offering informational testimony

on fiscal implications. This is evidence of my sincere commitment to depoliticize this office and to honor the legislature, as you are the lawmakers.

I want to recognize the admirable work for education emphasized by many of you. A thank you to those of you who have joined the Bipartisan Education Caucus. The meaningful conversations that we have over hot coffee and apple fritters encourage us all to be mindful of education throughout our day. I hope to see even more of you join us in the coming weeks. Set your alarm to be there at 7:00am.

To our Montana Native American leaders: I am listening. The valuable conversations we have had in our combined Education Council highlights the interconnectedness of culture, community, and education. Indian Education for All is in our constitutional framework. That is why, on day two of this legislature, the Office of Public Instruction hosted an Indian Education for All event in the Rotunda. It is my priority to have all Montana students learn about, and be proud of, Montana.

While speaking at the Assessment and Data Conference this week in Billings I reiterated that assessment must be purposeful and meaningful to student success. This data must be governed with integrity and respect for student privacy. We need to ensure progress monitoring for continued growth for all students. Our gifted students must have the opportunity to advance and our special needs students must be encouraged to perform at the best of their ability, and then celebrate their success.

Along with family support, a strong indicator for student success is a qualified teacher. Critical to retention of quality teachers are mentoring and professional development. A great resource provided by the Office of Public Instruction is the Teacher's Learning Hub, which offers online courses to professionals in the field of education all across Montana.

As a proud fourth generation Montanan, I invite all of you who humbly serve our great state to embrace Montana Proud. Montana Proud is my vision for achieving student success. It must be about the students.

I am excited to announce that the Ag Literacy program will now be an inter-agency collaboration between the Montana Department of Agriculture and the Office of Public Instruction. The Ag Literacy program will enhance the knowledge of, and pride in, Montana's number one industry.

I want to increase the value of a high school diploma. Let's begin this work by inspiring our middle school students. Raising math achievement will be a priority in Montana. Students who are not proficient in math when they enter college only have a ten percent chance of completing their degree. Now, more than ever, young people need the skills to thrive in a fast-changing economy. I am proud to strengthen our partnership with the Office of the Commissioner of Higher Education to ensure that our students are college, career, and community ready to make Montana proud.

Being Montana proud includes hope. Our school counselors are on the front lines of protecting our students. They educate the whole mind, body, and spirit. Join me in recognizing these individuals in our schools, as next week is National School Counselor week. I appreciate the Montana School Counselor's Association, under the direction of Renee Schoening of Deer Lodge, for their

partnership in bringing Montana Hope to all of our students.

Many of you here in this body are champions of mental health awareness. You are joined by our passionate community partners. Montana consistently ranks as one of the highest states in the country for youth suicide.

Our university system at MSU-Bozeman, houses a renowned international program, Youth Aware of Mental Health. I am thankful for the leadership of Dr. Byerly. Also, NAMI, The National Alliance on Mental Illness, under the direction of Matt Kuntz, provides positive resources for our Montana families; Montana hope to make Montana proud.

My efforts to make Montana proud don't stop at our borders. I was elected to be the gatekeeper for Montana's public schools against federal overreach. In this effort, I am in communication with Montana's entire congressional delegation and we will all be working together to advance Montana's educational interests. Local control and flexibility are Montana values that I will be advocating for. Flexibility for parents, teachers, and local public schools creates the environment of opportunity that each unique Montana student needs to succeed and be proud of.

Thank you again for the opportunity to address you this afternoon. I will let you get back to the People's business. May God Bless Montana and God Bless our students. Thank you for putting Montana students first.
