I am writing to express my unequivocal **support** for Senate Bill No. 97, **"AN ACT ESTABLISHING THE PRIMACY OF MONTANA LAW BY PROHIBITING THE APPLICATION OF FOREIGN LAW WHEN IT VIOLATES A FUNDAMENTAL RIGHT GUARANTEED BY THE MONTANA OR UNITED STATES CONSTITUTION; PROVIDING EXCEPTIONS; AND PROVIDING AN APPLICABILITY DATE."**

As a retired federal law enforcement officer, with considerable overseas experience, I am viscerally offended when elements of our judicial system are compelled, by political correctness, to throw off the protections of U.S. Constitutional law in favor of foreign legal precepts. Though it has not yet happened in the Great State of Montana, the application of Shariah law has been successfully applied in approximately 23 jurisdictions across the nation. These countries subordinate their laws to Islamic Law. Among the Islamic countries mentioned, it should be noted that no other legal standards are recognized. These national constitutions remain true to the Islamic legal requirement to recognize Islamic law as the pre-eminent basis of all law. The central issue is that the constitution of these countries is subordinate to the "**absolute rule of Islam.**"

Recognition of the constitutions (and legislation derived therefrom) of these countries in American courts is recognition of Shari'a law in American courts.
