Section 20-26-1503, MCA, is amended to read: 11 "20-26-1503. Use of incentive for physicians practicing in rural areas or medically underserved 12 areas or for underserved populations state special revenue account. (1) The state special revenue account 13 established in 20-26-1501 is statutorily appropriated, as provided in 17-7-502, to the board of regents to be used 14 to pay: 15 (a) the educational debts of physicians who practice in rural areas or medically underserved areas or 16 for medically underserved populations of the state that demonstrate a need for assistance in physician 17 recruitment; and 18 (b) the expenses of administering the incentive program. The expenses of administering the program 19 may not exceed 10% of the annual fees assessed pursuant to 20-26-1502. 20 (2) The board of regents shall establish procedures for determining rural areas and medically 21 underserved areas or populations of the state that qualify for assistance in physician recruitment. An eligible area 22 or eligible population must demonstrate that a physician shortage exists or that the area or population has been 23 unsuccessful in recruiting physicians in other ways. 24 (3) A physician from an area or serving a population determined to be eligible under subsection (2) may 25 apply to the board of regents for payment of an educational debt directly related to a professional school, as 26 provided in subsection (4). Physicians who have paid the fee authorized in 20-26-1502 must be given a 27 preference over other applicants. To receive the educational debt payments, the physician shall sign an annual 28 contract with the board of regents. medically underserved area or for a medically underserved population may receive is \$100,000 \$125,000

2 \$150,000 over a 5-year period or a proportionally reduced amount for a shorter period.

(5) The amount contractually committed in a year may not exceed the annual amount deposited in the state special revenue account established in 20-26-1501."
