6	A BILL FOR AN ACT ENTITLED: "AN ACT PROHIBITING A STATE AGENCY OR LOCAL GOVERNMENT
7	FROM PROHIBITING AN INDIVIDUAL FROM WEARING TRADITIONAL TRIBAL REGALIA OR OBJECTS OF
8	CULTURAL SIGNIFICANCE AT CERTAIN PUBLIC EVENTS; PROVIDING AN EXCEPTION; PROVIDING
9	DEFINITIONS; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

11	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
12	
13	NEW SECTION. Section 1. Tribal regalia and objects of cultural significance allowed at public
14	events. (1) The purpose of this section is to help further the state's recognition of the distinct and unique cultural
15	heritage of the American Indians and the state's commitment to preserving the American Indians' cultural integrity
16	as provided in Article X, section 1(2), of the Montana constitution.
17	(2) A (A) EXCEPT AS PROVIDED IN SUBSECTION (2)(B), A A state agency or a local government may not
18	prohibit an individual from wearing traditional tribal regalia or objects of cultural significance at a public event.
19	(B) A STATE AGENCY OR LOCAL GOVERNMENT MAY PROHIBIT AN INDIVIDUAL FROM WEARING TRADITIONAL TRIBAL
20	REGALIA OR OBJECTS OF CULTURAL SIGNIFICANCE AT A PUBLIC EVENT WHEN IT IS NECESSARY TO PREVENT OR MITIGATE
21	IMMINENT OR EXISTING DANGER TO THE INDIVIDUAL'S OR ANOTHER PERSON'S HEALTH OR SAFETY.
22	(3) For purposes of this section, the following definitions apply:
23	(a) "Individual" means a human being regardless of age.
24	(b) "Local government" has the meaning provided in 2-2-102.
25	(c) "Public event" means an event held or sponsored by a state agency or a local government, including
26	but not limited to an award ceremony, a graduation ceremony, or a public meeting.
27	(d) "State agency" has the meaning provided in 1-2-116.
28	
29	NEW SECTION. Section 2. Notification to tribal governments. The secretary of state shall send a
30	copy of [this act] to each tribal government located on the seven Montana reservations and to the Little Shell
