Section 1. Section 7-13-4502, MCA, is amended to read:

"7-13-4502. Definitions. As used in this part, unless the context indicates otherwise, the following definitions apply:

(1) "Board of directors" means the board of directors provided for in 7-13-4516 or a joint board of directors provided for in 7-13-4527.

~~(2) "Board of environmental review" means the board of environmental review as provided in 2-15-3502.~~

~~(3)~~(2) "Commissioners" means the board of county commissioners or the governing body of a city-county consolidated government.

(3) "Department" means the department of environmental quality provided for in 2-15-3501.

(4) "Family residential unit" means a single-family dwelling.

(5) "Fee-assessed units" means all real property with improvements, including taxable and tax-exempt property as shown on the property assessment records maintained by the county, and mobile homes and manufactured homes as defined in 15-24-201.

(6) "Local water quality district" means an area established with definite boundaries for the purpose of protecting, preserving, and improving the quality of surface water and ground water in the district as authorized by this part."

Section 2. Section 7-13-4513, MCA, is amended to read:

"7-13-4513. Insufficient protest to bar proceedings -- resolution creating district -- power to implement local water quality program. (1) The commissioners may create a local water quality district, establish fees, and appoint a board of directors if the commissioners find that insufficient protests have been made in accordance with 7-13-4511 or if the registered voters who reside in the proposed district have approved a referendum as provided in 7-13-4512.

(2) To create a local water quality district, the commissioners shall pass a resolution in accordance with the resolution of intention introduced and passed by the commissioners or in accordance with the terms of the referendum.

(3) The commissioners and board of directors may implement a local water quality program after the program is approved by the ~~board of environmental review~~ department pursuant to 75-5-311."

1 **Section 3.** Section 7-13-4517, MCA, is amended to read:

2 **"7-13-4517. Powers and duties of board of directors.** The board of directors of a local water quality
3 district, with the approval of the commissioners, may:

4 (1) develop a local water quality program, to be submitted to the ~~board of environmental review~~
5 department, for the protection, preservation, and improvement of the quality of surface water and ground water
6 in the district. In developing the program, the board of directors shall consult with the board or boards of
7 supervisors of conservation districts, established as provided in 76-15-201, whose geographical area of
8 jurisdiction is included within the boundaries of the local water quality district.

9 (2) implement a local water quality program;

10 (3) administer the budget of the local water quality district;

11 (4) employ personnel;

12 (5) purchase, rent, or lease equipment and material necessary to develop and implement an effective
13 program;

14 (6) cooperate or contract with any corporation, association, individual, or group of individuals, including
15 any agency of the federal, state, or local government, in order to develop and implement an effective program;

16 (7) receive gifts, grants, or donations for the purpose of advancing the program and acquire, by gift,
17 deed, or purchase, land necessary to implement the local water quality program;

18 (8) administer local ordinances that are adopted by the commissioners and governing bodies of the
19 participating cities and towns and that pertain to the protection, preservation, and improvement of the quality of
20 surface water and ground water;

21 (9) apply for and receive from the federal government or the state government, on behalf of the local
22 water quality district, money to aid the local water quality program;

23 (10) borrow money for assistance in planning or refinancing a local water quality district and repay loans
24 with the money received from the established fees; and

25 (11) construct facilities that cost not more than \$5,000 and maintain facilities necessary to accomplish
26 the purposes of the district, including but not limited to facilities for removal of water-borne contaminants; water
27 quality improvement; sanitary sewage collection, disposal, and treatment; and storm water or surface water
28 drainage collection, disposal, and treatment."

29

30 **Section 4.** Section 15-24-3001, MCA, is amended to read:

1 **"15-24-3001. Electrical generation and transmission facility exemption -- definitions.** (1) (a) Except
2 as provided in subsections (1)(b) and (3), an electrical generation facility and related delivery facilities constructed
3 in the state of Montana after May 5, 2001, and before January 1, 2006, may be exempt from property taxation
4 for a 10-year period beginning on the date that an owner or operator of an electrical generation facility and related
5 delivery facilities commences to construct the facility as defined in ~~75-20-104(6)(a) and (6)(b)~~ 75-20-104(5)(a)
6 and (5)(b). In order to be exempt from property taxation, an owner and operator of an electrical generation facility
7 and related delivery facilities shall offer contracts to sell 50% of that facility's net generating output at a cost-based
8 rate, which includes a rate of return not to exceed 12%, to customers for a 20-year period from the date of the
9 facility's completion.

10 (b) The property tax exemption allowed under subsection (1)(a) is limited to a 5-year period for
11 generation facilities powered by oil or gas turbines.

12 (2) To the extent that 50% of the net generating output of the facility is not contracted for delivery to
13 consumers for a contract term extending 5 years to 20 years from the completion of the facility, as determined
14 by the owner, surplus capacity must be offered on a declining contract term basis for the remainder of the contract
15 period at a cost-based rate that includes a rate of return not to exceed 12%. Surplus capacity that is not
16 contracted for in this fashion may be sold at market rates.

17 (3) (a) Except as provided in subsection (3)(c), if an owner or operator of property exempt from taxation
18 under subsection (1)(a) signs a contract to sell power as required in subsection (1) and then fails to perform the
19 contract during the first 10-year period, the 10-year property tax exemption in subsection (1) is void and the
20 property is subject to a rollback tax as provided in 15-24-3002.

21 (b) Except as provided in subsection (3)(c), if an owner or operator of property exempt from taxation
22 under subsection (1)(b) signs a contract to sell power as required in subsection (1) and then fails to perform the
23 contract during the first 5-year period, the 5-year property tax exemption in subsection (1) is void and the property
24 is subject to a rollback tax as provided in 15-24-3002.

25 (c) If an owner or operator fails to perform the contract due to earthquakes or other acts of God, theft,
26 sabotage, acts of war, other social instabilities, or equipment failure, the property tax exemption in subsection
27 (1)(a) or (1)(b) is not void and the owner or operator is not subject to the rollback tax as provided in 15-24-3002.

28 (4) For the purposes of this section, the following definitions apply:

29 (a) (i) "Electrical generation facility" means any combination of a physically connected generator or
30 generators, associated prime movers, and other associated property, including appurtenant land and

1 improvements and personal property, that are normally operated together to produce 20 average megawatts or
 2 more of electric power. The term is limited to generating facilities that produce electricity from coal-fired steam
 3 turbines, oil or gas turbines, or turbine generators that are driven by falling water.

4 (ii) The term does not include:

5 (A) electrical generation facilities used for noncommercial purposes or exclusively for agricultural
 6 purposes; or

7 (B) a qualifying small power production facility, as that term is defined in 16 U.S.C. 796(17), that is owned
 8 and operated by a person not primarily engaged in the generation or sale of electricity other than electric power
 9 from a small power production facility and that is classified under 15-6-134 and 15-6-138.

10 (b) "Related delivery facilities" means transmission facilities necessary to deliver the energy from the
 11 electrical generation facility to the existing network transmission system.

12 (c) "Surplus capacity" means that portion of the 50% of net generating output not contracted for use.

13 (5) The department shall appraise exempt electrical generation facilities for each year that the property
 14 is exempt and determine the taxable value of the property as if it were subject to property taxation."

16 **Section 5.** Section 37-42-102, MCA, is amended to read:

17 **"37-42-102. Definitions.** Unless the context requires otherwise, in this chapter, the following definitions
 18 apply:

19 ~~(1) "Board" means the board of environmental review provided for in 2-15-3502.~~

20 ~~(2)~~(1) "Certificate" means a certificate of competency issued by the department, stating that the operator
 21 holding the certificate has met the requirements for the specified operator classification of the certification
 22 program.

23 ~~(3)~~(2) "Community water system" means a public water supply system that serves at least 15 service
 24 connections used by year-round residents or that regularly serves at least 25 year-round residents.

25 ~~(4)~~(3) "Council" means the water and wastewater operators' advisory council provided for in 2-15-2105.

26 ~~(5)~~(4) "Department" means the department of environmental quality provided for in 2-15-3501.

27 ~~(6)~~(5) "Industrial waste" means any waste substance from the processes of business or industry or from
 28 the development of a natural resource, together with any sewage that may be present.

29 ~~(7)~~(6) "Industrial waste discharge system" means a system that discharges industrial waste into state
 30 waters.

1 ~~(6)~~(7) "Nontransient noncommunity water system" means a public water system, as defined in 75-6-202,
2 that is not a community system and that regularly serves at least 25 of the same persons for at least 6 months
3 a year.

4 ~~(9)~~(8) "Operator" means the person in direct responsible charge of the operation of a water treatment
5 plant, water distribution system, or wastewater treatment plant.

6 ~~(10)~~(9) "State waters" means the term as defined in 75-6-102.

7 ~~(11)~~(10) "Wastewater treatment plant" means a facility that:

8 (a) is designed to remove solids, bacteria, or other harmful constituents of sewage, industrial waste, or
9 other wastes; and

10 (b) is part of either an industrial waste discharge system or a public sewage system as defined in
11 75-6-102.

12 ~~(12)~~(11) "Water distribution system" means that portion of the water supply system that conveys water
13 from the water treatment plant or other supply source to the premises of the consumer and that is part of a
14 community water system or a nontransient noncommunity water system.

15 ~~(13)~~(12) "Water supply system" means a system of pipes, structures, and facilities through which water
16 is obtained, treated, sold, distributed, or otherwise offered to the public for household use or use by humans and
17 that is part of a community water system or a nontransient noncommunity water system.

18 ~~(14)~~(13) "Water treatment plant" means that portion of the water supply system that alters either the
19 physical, chemical, or bacteriological quality of the water and renders it safe and palatable for human use."
20

21 **Section 6.** Section 37-42-321, MCA, is amended to read:

22 **"37-42-321. Revocation of operator's certificate -- disciplinary action by department.** (1) The
23 department may issue an order revoking the certificate of an operator when the department finds that:

24 (a) the operator has practiced fraud or deception;

25 (b) reasonable care, judgment, or the application of the operator's knowledge or ability was not used in
26 the performance of the operator's duties; or

27 (c) the operator is incompetent or unable to properly perform the operator's duties.

28 (2) The department may issue an order taking any disciplinary action listed in 37-1-136.

29 (3) A person aggrieved by an order of the department under this section may request a hearing before
30 the ~~board~~ department by submitting a written request stating the reason for the request within 30 days after

1 receipt of the department's decision.

2 (4) The contested case provisions of the Montana Administrative Procedure Act, Title 2, chapter 4, part
3 6, apply to a hearing held under this section."

4

5 **Section 7.** Section 50-2-116, MCA, is amended to read:

6 **"50-2-116. Powers and duties of local boards of health.** (1) In order to carry out the purposes of the
7 public health system, in collaboration with federal, state, and local partners, each local board of health shall:

8 (a) appoint and fix the salary of a local health officer who is:

9 (i) a physician;

10 (ii) a person with a master's degree in public health; or

11 (iii) a person with equivalent education and experience, as determined by the department;

12 (b) elect a presiding officer and other necessary officers;

13 (c) employ qualified staff;

14 (d) adopt bylaws to govern meetings;

15 (e) hold regular meetings at least quarterly and hold special meetings as necessary;

16 (f) identify, assess, prevent, and ameliorate conditions of public health importance through:

17 (i) epidemiological tracking and investigation;

18 (ii) screening and testing;

19 (iii) isolation and quarantine measures;

20 (iv) diagnosis, treatment, and case management;

21 (v) abatement of public health nuisances;

22 (vi) inspections;

23 (vii) collecting and maintaining health information;

24 (viii) education and training of health professionals; or

25 (ix) other public health measures as allowed by law;

26 (g) protect the public from the introduction and spread of communicable disease or other conditions of
27 public health importance, including through actions to ensure the removal of filth or other contaminants that might
28 cause disease or adversely affect public health;

29 (h) supervise or make inspections for conditions of public health importance and issue written orders for
30 compliance or for correction, destruction, or removal of the conditions;

1 (i) bring and pursue actions and issue orders necessary to abate, restrain, or prosecute the violation of
2 public health laws, rules, and local regulations;

3 (j) identify to the department an administrative liaison for public health. The liaison must be the local
4 health officer in jurisdictions that employ a full-time local health officer. In jurisdictions that do not employ a
5 full-time local health officer, the liaison must be the highest ranking public health professional employed by the
6 jurisdiction.

7 (k) subject to the provisions of 50-2-130, adopt necessary regulations that are not less stringent than
8 state standards for the control and disposal of sewage from private and public buildings and facilities that are not
9 regulated by Title 75, chapter 6, or Title 76, chapter 4. The regulations must describe standards for granting
10 variances from the minimum requirements that are identical to standards promulgated by the ~~board of~~
11 ~~environmental review~~ department of environmental quality and must provide for appeal of variance decisions to
12 the department of environmental quality as required by 75-5-305. If the local board of health regulates or permits
13 water well drilling, the regulations must prohibit the drilling of a well if the well isolation zone, as defined in
14 76-4-102, encroaches onto adjacent private property without the authorization of the private property owner.

15 (2) Local boards of health may:

16 (a) accept and spend funds received from a federal agency, the state, a school district, or other persons
17 or entities;

18 (b) adopt necessary fees to administer regulations for the control and disposal of sewage from private
19 and public buildings and facilities;

20 (c) adopt regulations that do not conflict with rules adopted by the department:

21 (i) for the control of communicable diseases;

22 (ii) for the removal of filth that might cause disease or adversely affect public health;

23 (iii) subject to the provisions of 50-2-130, for sanitation in public and private buildings and facilities that
24 affects public health and for the maintenance of sewage treatment systems that do not discharge effluent directly
25 into state water and that are not required to have an operating permit as required by rules adopted under
26 75-5-401;

27 (iv) subject to the provisions of 50-2-130 and Title 50, chapter 48, for tattooing and body-piercing
28 establishments and that are not less stringent than state standards for tattooing and body-piercing
29 establishments;

30 (v) for the establishment of institutional controls that have been selected or approved by the:

1 (A) United States environmental protection agency as part of a remedy for a facility under the federal
2 Comprehensive Environmental Response, Compensation, and Liability Act of 1980, 42 U.S.C. 9601, et seq.; or

3 (B) department of environmental quality as part of a remedy for a facility under the Montana
4 Comprehensive Environmental Cleanup and Responsibility Act, Title 75, chapter 10, part 7; and

5 (vi) to implement the public health laws; and

6 (d) promote cooperation and formal collaborative agreements between the local board of health and
7 tribes, tribal organizations, and the Indian health service regarding public health planning, priority setting,
8 information and data sharing, reporting, resource allocation, service delivery, jurisdiction, and other matters
9 addressed in this title.

10 (3) A local board of health may provide, implement, facilitate, or encourage other public health services
11 and functions as considered reasonable and necessary."

12

13 **Section 8.** Section 50-79-401, MCA, is amended to read:

14 **"50-79-401. Administrative hearings.** In a proceeding under this chapter for granting, suspending,
15 revoking, or amending a license or for determining compliance with or granting exceptions from rules adopted
16 under this chapter, the ~~board of environmental review~~ department of environmental quality shall first afford an
17 opportunity for a hearing on the record upon the request of a person whose interest may be affected by the
18 proceeding and shall admit the person as a party to the proceeding."

19

20 **Section 9.** Section 50-79-403, MCA, is amended to read:

21 **"50-79-403. Emergency orders and rules.** When the department finds that an emergency exists
22 requiring immediate action to protect the public health and safety, the department may, without notice or hearing,
23 issue a rule or order reciting the existence of the emergency and requiring that ~~such~~ action be taken as
24 considered necessary to meet the emergency. Notwithstanding any provision of this chapter to the contrary, the
25 rule or order is effective immediately. A person to whom the rule or order is directed shall comply with it
26 immediately but on application to the ~~board~~ department of environmental quality ~~shall~~ must be afforded a prompt
27 hearing. On the basis of the hearing the emergency rule or order ~~shall~~ must be continued, modified, or revoked
28 by the ~~board~~ department of environmental quality within 30 days after the hearing or when the emergency no
29 longer exists."

30

1 **Section 10.** Section 75-1-220, MCA, is amended to read:

2 **"75-1-220. Definitions.** For the purposes of this part, the following definitions apply:

3 (1) "Alternatives analysis" means an evaluation of different parameters, mitigation measures, or control
4 measures that would accomplish the same objectives as those included in the proposed action by the applicant.
5 For a project that is not a state-sponsored project, it does not include an alternative facility or an alternative to
6 the proposed project itself. The term includes alternatives required pursuant to Title 75, chapter 20.

7 (2) "Appropriate board" means, for administrative actions taken under this part by the:

8 (a) department of environmental quality, the ~~board of environmental review~~ department of environmental
9 quality, as provided for in ~~2-15-3502~~ 2-15-3501;

10 (b) department of fish, wildlife, and parks, the fish and wildlife commission, as provided for in 2-15-3402,
11 and the state parks and recreation board, as provided for in 2-15-3406;

12 (c) department of transportation, the transportation commission, as provided for in 2-15-2502;

13 (d) department of natural resources and conservation for state trust land issues, the board of land
14 commissioners, as provided for in Article X, section 4, of the Montana constitution;

15 (e) department of natural resources and conservation for oil and gas issues, the board of oil and gas
16 conservation, as provided for in 2-15-3303; and

17 (f) department of livestock, the board of livestock, as provided for in 2-15-3102.

18 (3) "Complete application" means, for the purpose of complying with this part, an application for a permit,
19 license, or other authorization that contains all data, studies, plans, information, forms, fees, and signatures
20 required to be included with the application sufficient for the agency to approve the application under the
21 applicable statutes and rules.

22 (4) "Cumulative impacts" means the collective impacts on the human environment within the borders of
23 Montana of the proposed action when considered in conjunction with other past, present, and future actions
24 related to the proposed action by location or generic type.

25 (5) "Environmental review" means any environmental assessment, environmental impact statement, or
26 other written analysis required under this part by a state agency of a proposed action to determine, examine, or
27 document the effects and impacts of the proposed action on the quality of the human and physical environment
28 within the borders of Montana as required under this part.

29 (6) "Project sponsor" means any applicant, owner, operator, agency, or other entity that is proposing an
30 action that requires an environmental review. If the action involves state agency-initiated actions on state trust

1 lands, the term also includes each institutional beneficiary of any trust as described in The Enabling Act of
 2 Congress, approved February 22, 1899, 25 Stat. 676, as amended, the Morrill Act of 1862, 7 U.S.C. 301 through
 3 308, and the Morrill Act of 1890, 7 U.S.C. 321 through 329.

4 (7) "Public scoping process" means any process to determine the scope of an environmental review.

5 (8) (a) "State-sponsored project" means:

6 (i) a project, program, or activity initiated and directly undertaken by a state agency;

7 (ii) except as provided in subsection (8)(b)(i), a project or activity supported through a contract, grant,
 8 subsidy, loan, or other form of funding assistance from a state agency, either singly or in combination with one
 9 or more other state agencies; or

10 (iii) except as provided in subsection (8)(b)(i), a project or activity authorized by a state agency acting in
 11 a land management capacity for a lease, easement, license, or other authorization to act.

12 (b) The term does not include:

13 (i) a project or activity undertaken by a private entity that is made possible by the issuance of permits,
 14 licenses, leases, easements, grants, loans, or other authorizations to act by the:

15 (A) department of environmental quality pursuant to Titles 75, 76, or 82;

16 (B) department of fish, wildlife, and parks pursuant to Title 87, chapter 4, part 4;

17 (C) board of oil and gas conservation pursuant to Title 82, chapter 11; or

18 (D) department of natural resources and conservation or the board of land commissioners pursuant to
 19 Titles 76, 77, 82, and 85; or

20 (ii) a project or activity involving the issuance of a permit, license, certificate, or other entitlement for
 21 permission to act by another agency acting in a regulatory capacity, either singly or in combination with other
 22 state agencies."

23

24 **Section 11.** Section 75-1-1001, MCA, is amended to read:

25 **"75-1-1001. Penalty factors.** (1) In determining the amount of an administrative or civil penalty to which
 26 subsection (4) applies, the department of environmental quality or the district court, as appropriate, shall take into
 27 account the following factors:

28 (a) the nature, extent, and gravity of the violation;

29 (b) the circumstances of the violation;

30 (c) the violator's prior history of any violation, which:

1 (i) must be a violation of a requirement under the authority of the same chapter and part as the violation
2 for which the penalty is being assessed;

27 (e) requirements for inspection, monitoring, recordkeeping, and reporting;

28 (f) procedures for the transfer of permits;

29 (g) requirements and procedures for suspension, modification, and revocation of permits by the
30 department;

1 (h) requirements and procedures for appropriate emission limitations and other requirements, including
2 enforceable measures necessary to ensure compliance with those limitations and requirements;

3 (i) requirements and procedures for permit modification and amendment; and

4 (j) requirements and procedures for issuing a single permit authorizing emissions from similar operations
5 at multiple temporary locations, which permit may include conditions necessary to ensure compliance with the
6 requirements of this chapter at all authorized locations and a requirement that the owner or operator notify the
7 department in advance of each change in location.

8 (4) This section does not restrict the ~~board's~~ department's authority to adopt regulations providing for
9 a single air quality permit system.

10 (5) Department approval of an application to transfer a portable emission source from one location to
11 another is exempt from the provisions of 75-1-201(1).

12 (6) The department may, for good cause shown, waive or shorten the time required for filing the
13 appropriate applications.

14 (7) The department shall require that applications for permits be accompanied by any plans,
15 specifications, and other information that it considers necessary.

16 (8) An application is not considered filed until the applicant has submitted all fees required under
17 75-2-220 and all information and completed application forms required pursuant to subsections (2), (3), and (7)
18 of this section. If the department fails to notify the applicant in writing within 30 days after the purported filing of
19 an application that the application is incomplete and fails to list the reasons why the application is considered
20 incomplete, the application is considered filed as of the date of the purported filing.

21 (9) (a) Except as provided in 75-1-205(4) and 75-1-208(4)(b), if an application for a permit requires the
22 preparation of an environmental impact statement under the Montana Environmental Policy Act, Title 75, chapter
23 1, parts 1 through 3, the department shall notify the applicant in writing of the approval or denial of the application:

24 (i) within 180 days after the department's receipt of a filed application, as provided in subsection (8), if
25 the department prepares the environmental impact statement;

26 (ii) within 30 days after issuance of the final environmental impact statement by the lead agency if a state
27 agency other than the department has been designated by the governor as lead agency for preparation of the
28 environmental impact statement; or

29 (iii) if the application is for a machine, equipment, a device, or a facility at an operation that requires a
30 permit under Title 82, chapter 4, part 1, 2, or 3, within 30 days of issuance of the final environmental impact

1 statement in accordance with time requirements of Title 82, chapter 4, part 1, 2, or 3.

2 (b) If an application does not require the preparation of an environmental impact statement, is not subject
3 to the provisions of 75-2-215, and is not subject to the federal air quality permitting provisions of 42 U.S.C. 7475,
4 7503, or 7661a, the department shall notify the applicant in writing within 60 days after its receipt of a filed
5 application, as provided in subsection (8), of its approval or denial of the application, except as provided in
6 subsection (14).

7 (c) If an application does not require the preparation of an environmental impact statement and is subject
8 to the federal air permitting provisions of 42 U.S.C. 7475, 7503, or 7661a, the department shall notify the
9 applicant, in writing, within 75 days after its receipt of a filed application, as provided in subsection (8), of its
10 approval or denial of the application.

11 (d) Except as provided in subsection (9)(e), if an application does not require the preparation of an
12 environmental impact statement and is subject to the provisions of 75-2-215, the department shall notify the
13 applicant of its approval or denial of the application, in writing, within 75 days after its receipt of a filed application,
14 as provided in subsection (8).

15 (e) If an application for a permit is for the construction, installation, alteration, or use of a source that is
16 also required to obtain a license pursuant to 75-10-221 or a permit pursuant to 75-10-406, the department shall
17 prepare a single environmental review document pursuant to Title 75, chapter 1, for the permit required under
18 this section and the license or permit required under 75-10-221 or 75-10-406 and act on the applications within
19 the time period provided for in 75-2-215(3)(e).

20 (f) The time for notification may be extended for 30 days by written agreement of the department and
21 the applicant. Additional 30-day extensions may be granted by the department upon the request of the applicant.
22 Notification of approval or denial may be served personally or by certified mail on the applicant or the applicant's
23 agent.

24 (g) Failure by the department to act in a timely manner does not constitute approval or denial of the
25 application. This does not limit or abridge the right of any person to seek available judicial remedies to require
26 the department to act in a timely manner.

27 (10) Except as provided in 75-2-213, when the department approves or denies the application for a permit
28 under this section, a person who is directly and adversely affected by the department's decision may request a
29 hearing before the ~~board~~ department. The request for hearing must be filed within 15 days after the department
30 renders its decision. An affidavit setting forth the grounds for the request must be filed within 30 days after the

1 department renders its decision. The contested case provisions of the Montana Administrative Procedure Act,
2 Title 2, chapter 4, part 6, apply to a hearing before the ~~board~~ department under this subsection.

3 (11) Except as provided in 75-2-213:

4 (a) the department's decision on the application is not final until 15 days have elapsed from the date of
5 the decision;

6 (b) the filing of a request for hearing does not stay the department's decision. However, the ~~board~~
7 department may order a stay upon receipt of a petition and a finding, after notice and opportunity for hearing, that:

8 (i) the person requesting the stay is entitled to the relief demanded in the request for a hearing; or

9 (ii) continuation of the permit during the appeal would produce great or irreparable injury to the person
10 requesting the stay.

11 (c) upon granting a stay, the ~~board~~ department may require a written undertaking to be given by the party
12 requesting the stay for the payment of costs and damages incurred by the permit applicant and its employees
13 if the ~~board~~ department determines that the permit was properly issued. When requiring an undertaking, the ~~board~~
14 department shall use the same procedures and limitations as are provided in 27-19-306(2) through (4) for
15 undertakings on injunctions.

16 (12) The ~~board~~ department shall provide, by rule, a period of 30 days in which the public may submit
17 comments on draft air quality permits for applications that:

18 (a) are subject to the federal air quality permitting provisions of 42 U.S.C. 7475, 7503, or 7661a;

19 (b) are subject to the requirements of 75-2-215; or

20 (c) require the preparation of an environmental impact statement.

21 (13) The ~~board~~ department shall provide, by rule, a period of 15 days in which the public may submit
22 comments on draft air quality permits not subject to subsection (12).

23 (14) The ~~board~~ department shall provide, by rule, the basis upon which the department may extend by
24 15 days:

25 (a) the period as provided in subsection (13) in which the public may submit comments on draft air quality
26 permits not subject to subsection (12); and

27 (b) the period for notifying an applicant of its final decision on approval or denial of an application, as
28 provided in subsection (9)(b).

29 (15) (a) The ~~board~~ department may adopt rules for issuance, modification, suspension, revocation,
30 renewal, or creation of:

- 1 (i) general permits covering multiple similar sources; or
2 (ii) other permits covering multiple similar sources.
3 (b) Rules adopted pursuant to subsection (15)(a) may provide for construction and operation under the
4 permit upon authorization by the department or upon notice to the department."
5

6 **Section 23.** Section 75-2-212, MCA, is amended to read:

7 **"75-2-212. Variances -- renewals -- filing fees.** (1) A person who owns or is in control of a plant,
8 building, structure, process, or equipment may apply to the ~~board~~ department for an exemption or partial
9 exemption from rules governing the quality, nature, duration, or extent of emissions of air pollutants. The
10 application must be accompanied by information and data that the ~~board~~ department may require. The ~~board~~
11 department may grant an exemption or partial exemption if it finds that:

12 (a) the emissions occurring or proposed to occur do not constitute a danger to public health or safety;
13 and

14 (b) compliance with the rules from which an exemption is sought would produce hardship without equal
15 or greater benefits to the public.

16 (2) An exemption or partial exemption may not be granted pursuant to this section except after public
17 hearing on due notice and until the ~~board~~ department has considered the relative interests of the applicant, other
18 owners or property likely to be affected by the emissions, and the general public.

19 (3) The exemption or partial exemption may be renewed if a complaint is not made to the ~~board~~
20 department because of it or if, after the complaint has been made and duly considered at a public hearing held
21 by the ~~board~~ department on due notice, the ~~board~~ department finds that renewal is justified. A renewal may not
22 be granted except on application. An application must be made at least 60 days before the expiration of the
23 exemption or partial exemption. Immediately before application for renewal, the applicant shall give public notice
24 of the application in accordance with rules of the ~~board~~ department. A renewal pursuant to this subsection must
25 be on the same grounds and subject to the same limitations and requirements as provided in subsection (1).

26 (4) An exemption, partial exemption, or renewal is not a right of the applicant or holder but may be
27 granted at the discretion of the ~~board~~ department. However, a person adversely affected by an exemption, partial
28 exemption, or renewal granted by the ~~board~~ department may obtain judicial review as provided by 75-2-411.

29 (5) This section and an exemption, partial exemption, or renewal granted pursuant to this section may
30 not be construed to prevent or limit the application of the emergency provisions and procedures of 75-2-402 to

1 a person or the person's property.

2 (6) A person who owns or is in control of a plant, building, structure, process, or equipment, which are
 3 called facilities, who applies to the ~~board~~ department for an exemption or partial exemption or a renewal of an
 4 exemption or partial exemption from a rule governing the quality, nature, duration, or extent of emissions of air
 5 pollutants shall submit with the application for variance a sum of not less than \$500 or 2% of the cost of the
 6 equipment to bring the facility into compliance with the rule for which a variance is sought, whichever is greater,
 7 but not to exceed \$80,000. The department shall prepare a statement of actual costs, and funds in excess of this
 8 must be returned to the applicant. The person requesting the variance shall describe the facility in sufficient detail,
 9 with accompanying estimates of cost and verifying materials, to permit the department to determine with
 10 reasonable accuracy the sum of the fee. For a renewal of an exemption or partial exemption, if a public hearing,
 11 environmental impact statement, or appreciable investigation by the department is not necessary, the minimum
 12 filing fee applies or the fee may be waived by the department. The filing fee must be deposited in the state special
 13 revenue fund provided for in 17-2-102. It is the intent of the legislature that the revenue derived from the filing fees
 14 must be used by the department to:

- 15 (a) compile the information required for rendering a decision on the request;
- 16 (b) compile the information necessary for any environmental impact statements;
- 17 (c) offset the costs of a public hearing, printing, or mailing; and
- 18 (d) carry out its other responsibilities under this chapter."

20 **Section 24.** Section 75-2-213, MCA, is amended to read:

21 **"75-2-213. Energy development project -- hearing and procedures.** (1) (a) When the department
 22 approves or denies the application for a permit under 75-2-211 for an energy development project, the applicant
 23 or a person who has provided the department with formal comments and who is directly and adversely affected
 24 by the department's decision may request a hearing before the ~~board~~ department. If the department provided an
 25 opportunity for public comment on the application, the request for a hearing must be limited to those issues raised
 26 in comments made to the department during the comment period unless the issues are related to a material
 27 change in federal or state law made during the comment period, to a judicial decision issued after the comment
 28 period, or to a material change to the draft permit, which was submitted for public comment, made by the
 29 department in the final permit decision and upon which the public did not have a meaningful opportunity to
 30 comment. The request for hearing must be filed within 30 days after the department renders its decision. An

1 affidavit setting forth the grounds for the request must be filed with the request for a hearing.

2 (b) (i) If a hearing is requested by a person other than the applicant for or permittee of an energy
3 development project, the applicant or permittee may, by filing a written election with the board department within
4 15 days of receipt of the request for hearing, elect to have the matter proceed to hearing before the board
5 department or to have the matter submitted directly to the district court for judicial review of the agency decision.
6 The party who requests the hearing may elect to have the matter submitted either to the board department for
7 a hearing or to the district court for judicial review by submitting a written election to the board department with
8 the request for hearing. If there are conflicting elections between the parties, the matter must proceed to district
9 court.

10 (ii) If the applicant or permittee is not the person who requested the hearing and has elected to have the
11 matter submitted to the district court, the person who submitted the request for a hearing shall file a petition for
12 review of the permit decision within 15 days of receipt of notice from the permittee. If the person who requested
13 the hearing has elected to have the matter proceed to district court, that person shall file a petition in district court
14 within 15 days of filing the request.

15 (iii) The petition must be limited to matters raised in the request for hearing and must be filed in the county
16 in which the facility is located.

17 (iv) If a party does not elect to submit the matter directly to district court, the matter must proceed through
18 the contested case process before the board department pursuant to the Montana Administrative Procedure Act.

19 (v) The board department or the district court shall apply the laws and rules in place when the
20 department issued its decision, and the board department or the district court may not consider any issue that
21 was not presented to the department for the department's consideration during the formal comment period unless
22 the issue is related to a material change in federal or state law made during the comment period, to a judicial
23 decision issued after the comment period, or to a material change to the draft permit, which was submitted for
24 public comment, made by the department in the final permit decision and upon which the public did not have a
25 meaningful opportunity to comment.

26 (c) (i) Except as provided in subsection (1)(c)(ii), if the person requesting the hearing is not the applicant
27 or permittee of an energy development project, the board department or the district court shall require a written
28 undertaking to be given by the party requesting the hearing for the payment of costs and damages incurred by
29 the permit applicant and its employees if the request for a hearing or judicial review was for an improper purpose
30 designed to harass, cause unnecessary delay, or improperly interfere with the issuance of the permit without a

1 reasonable basis in law or fact.

2 (ii) The board department or the district court may not require a written undertaking if the party requesting
3 the hearing is an indigent person.

4 (d) If grounds for requesting the hearing are based on alleged error in applying best available control
5 technology requirements, the board department or the district court shall give deference to the best available
6 control technology determination made by the department. The board department or the district court may not
7 reject the best available control technology determination unless the determination was incorrect as a matter of
8 law or the factual basis for the determination was clearly erroneous.

9 (2) The board department shall issue a final decision within 4 months from the close of the hearing on
10 the merits or, if no hearing is held, within 3 months from the date that briefing by the parties is complete unless
11 the applicant or permittee and the party other than the applicant or permittee agree in writing to an extension of
12 time. The board department shall require the parties to prepare the case for hearing without unreasonable delay.

13 (3) (a) Any requirement in a permit to commence construction, installation, or alteration within a certain
14 time period is tolled during a contested case or judicial review proceeding, but not by more than 12 months,
15 unless the applicant or permittee in its discretion waives the tolling in writing.

16 (b) If there are multiple appeals of one permit, tolling under this subsection (3) may not exceed a total
17 of 12 months for all appeals.

18 (c) The applicant may not engage in construction during the period that the time period is tolled under
19 subsection (3)(a).

20 (4) The department shall, for good cause shown, waive for up to 1 year any requirement that construction
21 of an energy development project must proceed with due diligence. During the period that a waiver is in effect,
22 an air quality permit does not expire because construction of an energy development project failed to proceed
23 with due diligence."

25 **Section 25.** Section 75-2-215, MCA, is amended to read:

26 **"75-2-215. Solid or hazardous waste incineration -- additional permit requirements.** (1) Until the
27 department has issued an air quality permit pursuant to 75-2-211 that includes the conditions required by this
28 section, a person may not construct, install, alter, or use a solid or hazardous waste incinerator or a boiler or
29 industrial furnace subject to the provisions of 75-10-406, except as provided in subsection (2).

30 (2) An existing or permitted solid or hazardous waste incinerator or a boiler or industrial furnace subject

1 to the provisions of 75-10-406 is subject to the provisions of subsection (1) only if it incinerates or uses as fuel
2 or would incinerate or use as fuel solid or hazardous waste in an amount, form, kind, or content that changes the
3 nature, character, or composition of its emissions from its design or permitted operation.

4 (3) The department may not issue a permit to a facility described in subsection (1) until:

5 (a) the owner or operator has provided to the department's satisfaction:

6 (i) a characterization of emissions and ambient concentrations of air pollutants, including hazardous air
7 pollutants, from any existing emission source at the facility; and

8 (ii) an estimate of emissions and ambient concentrations of air pollutants, including hazardous air
9 pollutants, from the incineration of solid or hazardous waste or the use of hazardous waste as fuel for a boiler
10 or industrial furnace, as proposed in the permit application or modification;

11 (b) if a license is required pursuant to 75-10-221 or a permit is required pursuant to 75-10-406, the
12 applicant has published, in the county where the project is proposed, at least three notices, in accordance with
13 the procedures identified in 7-1-4127, describing the proposed project;

14 (c) if a license is required pursuant to 75-10-221 or a permit is required pursuant to 75-10-406, the
15 department has conducted a public hearing on an environmental review prepared pursuant to Title 75, chapter
16 1, and, as appropriate, provided additional opportunities for the public to review and comment on the permit
17 application or modification;

18 (d) the department has reached a determination that the projected emissions and ambient concentrations
19 will constitute a negligible risk to the public health, safety, and welfare and to the environment; and

20 (e) the department has issued a license pursuant to 75-10-221 or a permit pursuant to 75-10-406, if a
21 license or permit is required. The decision to issue, deny, or alter a permit pursuant to 75-2-211 and this section
22 must be made within 30 days from when the department issues a license pursuant to 75-10-221 or a permit
23 pursuant to 75-10-406 or within 90 days after the receipt of a complete application for a permit or a permit
24 alteration under 75-2-211 and this section, whichever is later.

25 (4) The department shall require the application of air pollution control equipment, engineering, or other
26 operating procedures as necessary to provide reductions of air pollutants, including hazardous air pollutants,
27 equivalent to or more stringent than those achieved through the best available control technology.

28 (5) The ~~board~~ department may by rule provide for general air quality permits under the provisions of
29 75-2-211 and this section. The rules must cover numerous similar classes or categories of incinerators and
30 boilers or industrial furnaces.

1 (6) This section does not relieve an owner or operator of a solid or hazardous waste incinerator or a
2 boiler or industrial furnace that is not included under subsection (1) from the obligation to obtain any permit
3 otherwise required under this chapter or rules implementing this chapter."

5 **Section 26.** Section 75-2-217, MCA, is amended to read:

6 **"75-2-217. Operating permit program -- exemptions -- general requirements -- duration.** (1) The
7 ~~board~~ department shall provide by rule for the issuance, expiration, modification, amendment, suspension,
8 revocation, and renewal of operating permits as part of an operating permit program to be administered by the
9 department under this chapter. The ~~board~~ department shall promulgate rules that are consistent with the
10 operating permit framework and guidelines outlined in Subchapter V of the federal Clean Air Act and
11 implementing regulations.

12 (2) This section applies to all sources of air pollutants that are subject to the provisions of Subchapter
13 V of the federal Clean Air Act, 42 U.S.C. 7661, et seq.

14 (3) A person may not violate any requirement of an operating permit issued under 75-2-218 and this
15 section or operate any source required to have a permit under this section without having complied with the
16 requirements of the operating permit program administered by the department pursuant to 75-2-218, 75-2-219,
17 and this section.

18 (4) The ~~board~~ department may by rule provide for the exemption of one or more source categories, in
19 whole or in part, from all or part of the requirements of this section if the ~~board~~ department determines that
20 compliance with the requirements of this section is impracticable, infeasible, or unnecessarily burdensome for
21 the sources. The ~~board~~ department may premise this determination upon a similar determination by the
22 appropriate federal agency acting pursuant to the federal Clean Air Act, 42 U.S.C. 7401, et seq.

23 (5) The ~~board~~ department may by rule provide for general operating permits covering numerous similar
24 sources.

25 (6) An operating permit issued by the department under 75-2-218 and this section is effective for a period
26 not to exceed 5 years and may be renewed.

27 (7) The operating permit program administered by the department pursuant to this section must include
28 the following:

29 (a) adequate procedures that are streamlined and reasonable for:

30 (i) expeditiously determining when applications are complete;

- 1 (ii) processing applications; and
- 2 (iii) expeditiously reviewing permit actions, including application renewals or revisions;
- 3 (b) requirements and procedures for submittal of information necessary to determine the location,
- 4 quantity, and type of emissions;
- 5 (c) procedures for public notice and opportunity for comment or public hearing, as appropriate;
- 6 (d) procedures for providing notice and an opportunity for comment to contiguous states and federal
- 7 agencies, as appropriate;
- 8 (e) requirements for inspection, monitoring, recordkeeping, compliance certification, and reporting;
- 9 (f) deadlines for submitting permit applications and compliance plans that are not later than 12 months
- 10 after the source becomes subject to the operating permit requirement;
- 11 (g) deadlines for submitting permit renewal applications that are not later than 6 months before expiration
- 12 of the existing operating permit;
- 13 (h) requirements for compliance plans that must be submitted with permit and renewal applications,
- 14 including schedules of compliance and progress reports;
- 15 (i) requirements and procedures for periodic certification of source compliance with permit requirements,
- 16 including the prompt reporting of any deviations from permit requirements;
- 17 (j) requirements for submission of any plans, specifications, or other information that the department
- 18 considers necessary under this section;
- 19 (k) conditions and procedures for the transfer of operating permits;
- 20 (l) requirements and procedures for suspension, modification, amendment, and revocation of permits
- 21 by the department for cause, including the modification or amendment of permits before renewal or termination
- 22 to incorporate applicable limitations or requirements effective after permit issuance;
- 23 (m) requirements and procedures for incorporating into permits and permit renewals all applicable
- 24 emission limitations and other requirements, including enforceable measures necessary to ensure compliance
- 25 with those limitations and requirements;
- 26 (n) requirements and procedures for permit modification and amendment;
- 27 (o) procedures for tracking activities conducted under general permits;
- 28 (p) requirements and procedures for issuing a single operating permit authorizing emissions from similar
- 29 operations at multiple temporary locations, which permit may include conditions necessary to ensure compliance
- 30 with the requirements of this chapter at all authorized locations and a requirement that the owner or operator

1 notify the department in advance of each change in location;

2 (q) requirements and procedures for allowing changes within a permitted facility without requiring a
3 permit amendment if the changes are not prohibited under this chapter and do not exceed the emissions
4 allowable under the permit; and

5 (r) other requirements necessary for the department to obtain the authorization to administer an
6 operating permit program under the provisions of Subchapter V of the federal Clean Air Act."

8 **Section 27.** Section 75-2-218, MCA, is amended to read:

9 **"75-2-218. Permits for operation -- application completeness -- action by department -- application**
10 **shield -- review by ~~board~~ department.** (1) An application for an operating permit or renewal is not considered
11 filed until the department has determined that it is complete. An application is complete if all fees required under
12 75-2-220 and all information and completed application forms required under 75-2-217 have been submitted. A
13 complete application must contain all of the information required for the department to begin processing the
14 application. If the department fails to notify the applicant in writing within 60 days after submittal of an application
15 that the application is incomplete and fails to list the reasons why the application is considered incomplete, the
16 application is considered filed on the date of the department's receipt of the application. The department may
17 request additional information after a completeness determination has been made. The ~~board~~ department shall
18 adopt rules that contain criteria for use in determining both when an application is complete and when additional
19 information is required after a completeness determination has been made.

23 Failure of the department to act in a timely manner does not constitute approval or denial of the application. This
24 does not limit or abridge the right of any person to seek available judicial remedies to require the department to
25 act in a timely manner.

26 (3) The ~~board~~ department may by rule provide for a transition schedule for both the submittal to the
27 department of initial applications for operating permits by existing sources and action by the department on these
28 initial permit applications. The ~~board~~ department may require that one-third of all operating permit applications
29 required for existing sources be submitted within the first calendar year after the adoption of rules implementing
30 an operating permit program under 75-2-217.

1 (4) If an applicant submits a timely and complete application for an operating permit, the applicant's
2 failure to hold a valid operating permit is not a violation of 75-2-217. If an applicant submits a timely and complete
3 application for an operating permit renewal, the expiration of the applicant's existing operating permit is not a
4 violation of 75-2-217. The applicant shall continue to be subject to the terms and conditions of the expired
5 operating permit until the operating permit is renewed and is subject to the application of 75-2-217. The applicant
6 is not entitled to the protection of this subsection if the delay in final action by the department on the application
7 results from the applicant's failure to submit in a timely manner information requested by the department to
8 process the application.

9 (5) Except as provided in subsection (8), if the department approves or denies an application for an
10 operating permit or the renewal, modification, or amendment of a permit under 75-2-217 and this section, any
11 person that participated in the public comment process required under 75-2-217(7) may request a hearing before
12 the ~~board~~ department. The request for a hearing must be filed within 30 days after the department renders its
13 decision and must include an affidavit setting forth the grounds for the request. The contested case provisions
14 of the Montana Administrative Procedure Act, Title 2, chapter 4, part 6, apply to a hearing before the ~~board~~
15 department under this subsection.

16 (6) (a) Except as provided in subsection (8), the department's decision on any application is not final until
17 30 days have elapsed from the date of the decision.

19 decision. However, the ~~board~~ department may order a stay upon receipt of a petition and a finding, after notice
20 and opportunity for an informal hearing, that:

21 (i) the person requesting the hearing is entitled to the relief demanded in the request for a hearing; or
22 (ii) continuation of the permit during the appeal would produce great or irreparable injury to the person
23 requesting the hearing.

24 (c) Upon granting a stay, the ~~board~~ department may require a written undertaking to be given by the
25 party requesting the stay for the payment of costs and damages incurred by the permit applicant and its
26 employees if the ~~board~~ department determines that the permit was properly issued. When requiring an
27 undertaking, the ~~board~~ department shall use the same procedures and limitations as are provided in 27-19-306(2)
28 through (4) for undertakings on injunctions.

29 (7) The requirements of subsections (5) and (6) also apply to any action initiated by the department to

1 (8) The denial by the department of an application under 75-2-217 and this section is not subject to
 2 review by the ~~board~~ department or judicial review if the basis for denial is the written objection of the appropriate

4 (9) Compliance with an operating permit granted or renewed under 75-2-217 and this section is

8 (2) For a permit or registration fee based on emissions, the fee must be based on emissions of air

10 regulated under section 7411 or 7412 of the federal Clean Air Act, 42 U.S.C. 7401, et seq., and each air pollutant
11 subject to a national primary ambient air quality standard.

7 precursors to the formation of chlorinated dioxins, furans, and carcinogens;

9 (iii) emissions, including continuous emission monitoring and air pollution control devices; and

10 (e) are necessary to implement the provisions of this section and to coordinate the requirements under
11 this section with the requirements contained in 75-2-211 and 75-2-215.

12 (2) A person who applies for an air quality permit or alteration pursuant to 75-2-211 and 75-2-215 for a
13 commercial medical waste incinerator or commercial hazardous waste incinerator shall provide, to the satisfaction
14 of the department, the following information:

15 (a) a dispersion model of emissions, using approved methods, and those studies that are necessary to
16 identify the potential community exposure;

17 (b) an analysis of the potential pathways for human exposure to air contaminants, particularly chlorinated
18 dioxins, furans, heavy metals, and other carcinogens, including the potential for inhalation, ingestion, and physical
19 contact by the affected communities; and

20 (c) a quantitative analysis of the estimated total possible human exposure to chlorinated dioxins, furans,
21 heavy metals, and carcinogens for the affected communities.

22 (3) The department may not issue or alter an air quality permit pursuant to this chapter until the
23 department has determined, based upon an analysis of the information provided by the applicant pursuant to
24 subsection (2) and other necessary and relevant data, that the public health risk from air emissions or ambient
25 concentrations of chlorinated dioxins, furans, heavy metals, and other hazardous air pollutants will not exceed
26 the negligible risk standard required by 75-2-215 and any applicable federal standards for allowable intake, as
27 determined by the department after a review of established and relevant federal standards and guidelines.

29 (a) require the ~~board~~ department to promulgate standards for the allowable intake of any substances
30 for which the federal government has not established standards;

2 which the federal government has established standards that are more stringent than the federal standards; or

3 (c) limit or otherwise impair the duty of the department under 75-2-215 to determine that emissions and
4 ambient concentrations will constitute a negligible risk as required by 75-2-215(3)(d), including emissions and
5 ambient concentrations of dioxins, furans, heavy metals, and carcinogens, before issuing an air quality permit
6 pursuant to 75-2-211 and 75-2-215."

21 federal regulations or guidelines may petition the ~~board~~ department or the local air pollution control program to
22 review the rule, ordinance, or local law.

23 (ii) If the ~~board~~ department or local air pollution control program determines that the rule, ordinance, or
24 local law is more stringent than state or federal regulations or guidelines, the ~~board~~ department or local air
25 pollution control program shall either revise the rule, ordinance, or local law to conform to the state or federal
26 regulations or guidelines or follow the process provided in subsections (4)(a) and (4)(b) within a reasonable
27 period of time, not to exceed 6 months after receiving the petition.

28 (5) Except for those emergency powers provided for in 75-2-402, the ~~board~~ department may not delegate
29 to a local air pollution control program the authority to control any air pollutant source that:

30 (a) requires the preparation of an environmental impact statement in accordance with Title 75, chapter

1 1, part 2;

2 (b) is subject to regulation under the Montana Major Facility Siting Act, as provided in Title 75, chapter

7 (6) If the ~~board~~ department finds that the location, character, or extent of particular concentrations of
8 population, air pollutant sources, or geographic, topographic, or meteorological considerations or any combination
9 of these makes impracticable the maintenance of appropriate levels of air quality without an areawide air pollution
10 control program, the ~~board~~ department may determine the boundaries within which the program is necessary and
11 require it as the only acceptable alternative to direct state administration.

12 (7) If the ~~board~~ department has reason to believe that any part of an air pollution control program in force
13 under this section is either inadequate to prevent and control air pollution in the jurisdiction to which the program
14 relates or is being administered in a manner inconsistent with this chapter, the ~~board~~ department shall, on notice,
15 conduct a hearing on the matter.

16 (8) If, after the hearing, the ~~board~~ department determines that any part of the program is inadequate to
17 prevent and control air pollution in the jurisdiction to which it relates or that it is not accomplishing the purposes
18 of this chapter, it shall require that necessary corrective measures be taken within a reasonable time, not to
19 exceed 60 days.

20 (9) If the jurisdiction fails to take these measures within the time required, the department shall
21 administer within that jurisdiction all of the provisions of this chapter, including the terms contained in any
22 applicable ~~board~~ department order, that are necessary to correct the deficiencies found by the ~~board~~ department.
23 The department's control program supersedes all municipal or county air pollution laws, rules, ordinances, and
24 requirements in the affected jurisdiction. The cost of the department's action is a charge on the jurisdiction.

25 (10) If the ~~board~~ department finds that the control of a particular air pollutant source because of its
26 complexity or magnitude is beyond the reasonable capability of the local jurisdiction or may be more efficiently
27 and economically performed at the state level, it may direct the department to assume and retain control over that
28 air pollutant source. A charge may not be assessed against the jurisdiction. Findings made under this subsection
29 may be either on the basis of the nature of the sources involved or on the basis of their relationship to the size
30 of the communities in which they are located.

1 (11) A jurisdiction in which the department administers all or part of its air pollution control program under
2 subsection (9) may, ~~with the approval of the board,~~ establish or resume an air pollution control program that
3 meets the requirements of subsection (3).

4 (12) A municipality or county may administer all or part of its air pollution control program in cooperation
5 with one or more municipalities or counties of this state or of other states.

6 (13) Local air pollution control programs established under this section shall provide procedures for public
7 notice, public hearing, public comment, and appeal for any proposed new or revised rules, ordinances, or local
8 laws adopted pursuant to this section. The procedures must comply with the following requirements:

9 (a) The local air pollution control program shall create and maintain a list of interested persons who wish
10 to be informed of actions related to rules, ordinances, or local laws adopted by the local air pollution control
11 program.

12 (b) At least 30 days prior to the adoption, revision, or repeal of a rule, ordinance, or law, the local air
13 pollution control program shall give written notice of its intended action.

14 (c) The notice required under subsection (13)(b) must include:

17 (ii) an explanation of the procedure for a person to be included on the list of interested persons

19 (iii) an explanation of the procedures and deadlines for presentation of oral or written comments related
20 to the intended action;

21 (iv) an explanation of the process for requesting a public hearing as provided in subsection (13)(f); and

22 (v) the rationale for the intended action. The rationale must:

23 (A) include an explanation of why the intended action is reasonably necessary to implement the goals
24 and purposes of the local air pollution control program;

25 (B) specifically address those intended actions for which there are no similar state or federal regulations
26 or guidelines; and

27 (C) be written in plain, easily understood language.

28 (d) For the purposes of subsection (13)(c)(v), a statement of authority to adopt a rule, ordinance, or local
29 law does not, standing alone, constitute a showing of reasonable necessity for the intended action.

30 (e) The local air pollution control program shall mail a copy of the proposed rule, ordinance, or local law

1 to all interested persons on the list established pursuant to subsection (13)(a) who have made timely requests
2 to be included on the list.

3 (f) If at least 10 of the persons who will be directly affected by the proposed rule, ordinance, or local law
4 request a public hearing, the local air pollution control program shall hold a hearing to hear comments from the
5 public on the intended action.

6 (g) The local air pollution control program shall prepare a written response to all comments submitted
7 in writing or presented at the public hearing for consideration prior to adoption, revision, or repeal of the proposed
8 rule, ordinance, or local law.

9 (h) A person who submits a written comment on a proposed action or who attends a public hearing in
10 regard to a proposed action must be informed of the final action."

13 **"75-2-302. State and federal aid.** (1) Any local air pollution control program meeting the requirements

26 served personally or by certified mail on the alleged violator or the violator's agent. The notice must specify the

29 period of time stated in the order or an order to pay an administrative penalty, or both. The order becomes final

2 (2) If, after a hearing held under subsection (1), the ~~board~~ department finds that violations have occurred,
3 it shall issue an appropriate order for the prevention, abatement, or control of the emissions involved or for the
4 taking of other corrective action or assess an administrative penalty, or both. As appropriate, an order issued as
5 part of a notice or after a hearing may prescribe the date by which the violation must cease; time limits for
6 particular action in preventing, abating, or controlling the emissions; or the date by which the administrative
7 penalty must be paid. If, after a hearing on an order contained in a notice, the ~~board~~ department finds that a
8 violation has not occurred or is not occurring, it shall rescind the order.

9 (3) (a) An action initiated under this section may include an administrative civil penalty of not more than
10 \$10,000 for each day of each violation, not to exceed a total of \$80,000. If an order issued by the ~~board~~
11 department under this section requires the payment of an administrative civil penalty, the ~~board~~ department shall
12 state findings and conclusions describing the basis for its penalty assessment.

8 (2) In taking action under subsection (1), the ~~board~~ department shall ensure that the standards are
9 cost-effective and economically, environmentally, and technologically feasible."

11 **Section 55.** Section 75-5-305, MCA, is amended to read:

12 **"75-5-305. Adoption of requirements for treatment of wastes -- variance procedure -- appeals. (1)**

13 The ~~board~~ department may establish minimum requirements for the treatment of wastes. For cases in which the
14 federal government has adopted technology-based treatment requirements for a particular industry or activity in
15 40 CFR, chapter I, subchapter N, the ~~board~~ department shall adopt those requirements by reference. To the
16 extent that the federal government has not adopted minimum treatment requirements for a particular industry or
17 activity, the ~~board~~ department may do so, through rulemaking, for parameters likely to affect beneficial uses,

22 (2) (a) The ~~board~~ department shall establish minimum requirements for the control and disposal of
23 sewage from private and public buildings, including standards and procedures for variances from the
24 requirements.

25 (b) For gray water reuse systems, the ~~board~~ department shall establish rules that:

26 (i) allow the diversion of gray water from wastewater treatment systems and limit the amount of gray
27 water flow allowed by permit;

28 (ii) address the uses of gray water, including when and how gray water may be applied to land; and

29 (iii) include any other provisions that the ~~board~~ department considers necessary to ensure that gray water
30 reuse systems comply with laws and regulations and protect public health and the environment.

1 (3) An applicant for a variance from minimum requirements adopted by a local board of health pursuant
 2 to 50-2-116 may appeal the local board of health's final decision to the department by submitting a written request
 3 for a hearing within 30 days after the decision. The written request must describe the activity for which the
 4 variance is requested, include copies of all documents submitted to the local board of health in support of the

5 (2) An authorization must include conditions that minimize, to the extent practicable, the magnitude of

8 and that ensure that existing and designated uses of state water are protected and maintained upon completion
9 of the activity. Authorizations issued under this section may include conditions that require water quality or

12 duplication in review of activities eligible for authorizations under this section.

13 (3) An authorization to use a pesticide does not relieve a person from the duty to comply with Title 80,
14 chapters 8 and 15. The department may not authorize an exemption from water quality standards for an activity
15 that requires a discharge permit under rules adopted by the board pursuant to 75-5-401."

18 **"75-5-310. Site-specific standards of water quality for aquatic life.** (1) Notwithstanding any other

6 **"75-5-311. Local water quality districts -- ~~board~~ department approval -- local water quality**
7 **programs.** (1) A county that establishes a local water quality district according to the procedures specified in Title
8 7, chapter 13, part 45, shall, in consultation with the department, undertake planning and information-gathering
9 activities necessary to develop a proposed local water quality program.

10 (2) A county may implement a local water quality program in a local water quality district if the program
11 is approved by the ~~board~~ department after a hearing conducted under 75-5-202.

12 (3) In approving a local water quality program, the ~~board~~ department shall determine that the program

26 (5) (a) For the facilities and sources of pollution included in subsection (4) and consistent with the

- 28 (i) be compatible with or more stringent or more extensive than the requirements imposed by 75-5-304,
29 75-5-305, and 75-5-401 through 75-5-404 and rules adopted under those sections to protect water quality,
30 establish waste discharge permit requirements, and establish best management practices for substances that

1 have the potential to pollute state waters;

2 (ii) provide for administrative procedures, administrative orders and actions, and civil enforcement actions
3 that are consistent with 75-5-601 through 75-5-604, 75-5-611 through 75-5-616, 75-5-621, and 75-5-622 and

13 (b) regulate any facility or source of pollution to the extent that the facility or source is:

14 (i) required to obtain a permit or other approval from the department or federal government or is the
15 subject of an administrative order, a consent decree, or an enforcement action pursuant to Title 75, chapter 5,
16 part 4; Title 75, chapter 6; Title 75, chapter 10; the federal Comprehensive Environmental Response,
17 Compensation, and Liability Act of 1980, 42 U.S.C. 9601 through 9675, as amended; or federal environmental,
18 safety, or health statutes and regulations;

19 (ii) exempted from obtaining a permit or other approval from the department because the facility or
20 source is required to obtain a permit or other approval from another state agency or is the subject of an
21 enforcement action by another state agency; or

22 (iii) subject to the provisions of Title 80, chapter 8 or chapter 15.

23 (7) If the boundaries of a district are changed after the ~~board~~ department has approved the local water
24 quality program for the district, the board of directors of the local water quality district shall submit a program
25 amendment to the ~~board~~ department and obtain ~~the board's~~ department approval of the program amendment
26 before implementing the local water quality program in areas that have been added to the district.

27 (8) The department shall monitor the implementation of local water quality programs to ensure that the
28 programs are adequate to protect, preserve, and improve the quality of the surface water and ground water and
29 are being administered in a manner consistent with the purposes and requirements of Title 75, chapter 5. If the
30 department finds that a local water quality program is not adequate to protect, preserve, and improve the quality

1 of the surface water and ground water or is not being administered in a manner consistent with the purposes and
2 requirements of Title 75, chapter 5, the department shall prepare a report to the board.

3 (9) If the ~~board~~ department determines that a local water quality program is inadequate to protect,
4 preserve, and improve the quality of the surface water and ground water in the local water quality district or that
5 the program is being administered in a manner inconsistent with Title 75, chapter 5, the ~~board~~ department shall
6 give notice and conduct a hearing on the matter.

7 (10) If after the hearing the ~~board~~ department determines that the program is inadequate to protect,
8 preserve, and improve the quality of the surface water and ground water in the local water quality district or that

17 district for that source. Findings made under this subsection may be based on the nature of the source involved
18 or on the source's relationship to the size of the community in which it is located."

21 **"75-5-312. Temporary water quality standards.** (1) The ~~board~~ department may on its own accord;
22 ~~upon recommendation of the department~~ or upon a petition for rulemaking, as provided in 2-4-315, by a person,
23 including a permit applicant or permittee, temporarily modify a water quality standard for a specific water body
24 or segment on a parameter-by-parameter basis in those instances in which substantive information indicates that

5 (a) the chemical, biological, and physical condition of the water body or segment;

8 (d) the temporary modifications to the existing water quality standards being requested;

9 (e) existing beneficial uses; and

10 (f) the designated uses considered attainable in the absence of the water quality limiting factors.

11 (4) The preliminary implementation plan prepared by the department or the petitioner, as applicable,

13 (a) a description of the proposed actions that will eliminate the water quality limiting factors identified in
14 subsection (3)(b) to the extent considered achievable; and

15 (b) a schedule for implementing the proposed actions that ensures that the existing water quality

7 (9) If a state water is designated as having temporary standards, the department shall report ~~to the board~~
8 at least every 3 years ~~or upon request of the board~~ regarding whether adequate efforts have been made to
9 implement the plans submitted as the basis for the temporary standards.

10 (10) The ~~board~~ department shall review the temporary standards and implementation plan at least every
11 3 years at a public hearing for which notice and an opportunity for comment have been provided. During this
12 review, the ~~board~~ department shall consider the progress made in restoring water quality to a level that achieves
13 the goal of the temporary water quality standards. The ~~board~~ department may terminate or modify the temporary
14 standards based on information submitted at the time of review.

15 (11) The ~~board~~ department shall terminate a temporary standard for a parameter if:

16 (a) values for the modified parameter or parameters improve to conditions that support all designated
17 uses for that classification;

18 (b) the state water for which the temporary standard is adopted is reclassified as provided for in
19 75-5-302; or

20 (c) the plan submitted in support of the temporary water quality standard is not being implemented
21 according to the plan's schedule or modifications to that plan or schedule made by the ~~board~~ department.

22 (12) The ~~board~~ department may modify the implementation plan if there is convincing evidence
23 that the plan needs modification.

24 (13) If a temporary standard for a parameter in a particular state water is terminated because the plan
25 submitted in support of the temporary water quality standard is not being implemented according to the plan's
26 schedule or modifications to that schedule made by the ~~board~~ department, a person may request a new
27 temporary standard by submitting both a petition for rulemaking and an implementation plan that meet the
28 requirements of subsection (4). However, the ~~board~~ department may not adopt another temporary standard for
29 the parameter in the state water that would cumulatively be in effect for a total period longer than 20 years for the
30 parameter in the state water."

2 **Section 61.** Section 75-5-313, MCA, is amended to read:

3 **"75-5-313. Nutrient standards variances -- individual, general, and alternative.** (1) The department
4 shall, on a case-by-case basis, approve the use of an individual nutrient standards variance in a discharge permit
5 based upon adequate justification pursuant to subsection (2) that attainment of the base numeric nutrient
6 standards is precluded due to economic impacts, limits of technology, or both.

7 (2) (a) The department, in consultation with the nutrient work group, shall develop guidelines for
8 individual nutrient standards variances to ensure that the economic impacts from base numeric nutrient standards
9 on public and private systems are equally and adequately addressed. In developing those guidelines, the
10 department and the nutrient work group shall consider economic impacts appropriate for application within
11 Montana, acknowledging that advanced treatment technologies for removing nutrients will result in significant and
12 widespread economic impacts.

13 (b) The department shall consult with the nutrient work group prior to recommending base numeric

27 wastewater treatment facilities that discharge to surface water:

28 (i) in an amount greater than or equal to 1 million gallons per day of effluent if the permittee treats the
29 discharge to, at a minimum, 1 milligram total phosphorus per liter and 10 milligrams total nitrogen per liter,
30 calculated as a monthly average during the period in which the base numeric nutrient standards apply;

1 (ii) in an amount less than 1 million gallons per day of effluent if the permittee treats the discharge to, at
2 a minimum, 2 milligrams total phosphorus per liter and 15 milligrams total nitrogen per liter, calculated as a
3 monthly average during the period in which the base numeric nutrient standards apply; or

4 (iii) from lagoons that were not designed to actively remove nutrients if the permittee maintains the
5 performance of the lagoon at a level equal to the performance of the lagoon on October 1, 2011.

6 (6) (a) The monthly average concentrations for total nitrogen and total phosphorus in subsection (5)(b)
7 are the highest concentrations allowed in each category and remain in effect until May 31, 2016.

8 (b) Categories and concentrations in subsection (5)(b) must be adopted by rule by May 31, 2016.

9 (7) (a) Immediately after May 31, 2016, and every 3 years thereafter, the department, in consultation with
10 the nutrient work group, shall revisit and update the concentration levels provided in subsection (5)(b).

11 (b) If more cost-effective and efficient treatment technologies are available, the concentration levels
12 provided in subsection (5)(b) must be updated pursuant to subsection (7)(c) to reflect those changes.

13 (c) The updates become effective and may be incorporated into a permit only after a public hearing and
14 adoption by the department under the rulemaking procedures of Title 2, chapter 4, part 3.

15 (8) An individual, general, or alternative nutrient standards variance may be established for a period not
16 to exceed 20 years and must be reviewed by the department every 3 years from the date of adoption to ensure
17 that the justification for its adoption remains valid.

18 (9) (a) Permittees receiving an individual, general, or alternative nutrient standards variance shall
19 evaluate current facility operations to optimize nutrient reduction with existing infrastructure and shall analyze
20 cost-effective methods of reducing nutrient loading, including but not limited to nutrient trading without substantial
21 investment in new infrastructure.

22 (b) The department may request that a permittee provide the results of an optimization study and nutrient

29 of subsections (8) and (9) and shall demonstrate that the permittee's contribution to nutrient concentrations in the

1 (11) The department shall encourage the use of alternative effluent management methods to reduce
2 instream nutrient loading, including reuse, recharge, land application, and trading.

3 (12) On or before July 1 of each year, the department, in consultation with the nutrient work group, shall
4 report to the water policy committee established in 5-5-231 by providing a summary of the status of the base
5 numeric nutrient standards, the nutrient standards variances, and the implementation of those standards and
6 variances, including estimated economic impacts.

7 (13) On or before September 1 of each year preceding the convening of a regular session of the
8 legislature, the department, in consultation with the nutrient work group, shall summarize the two most recent
9 reports provided under subsection (12) and submit to the water policy committee established in 5-5-231 this final
10 summary in accordance with 5-11-210."

21 (3) (a) The owner or operator shall file a declaratory judgment action to establish the existence of a trade
22 secret if the owner or operator wishes the information to remain confidential.

24 (c) Information not intended to be public when submitted to the ~~board or~~ department must be submitted
25 in writing and clearly marked as confidential."

28 **"75-5-315. Outstanding resource waters -- statement of purpose.** (1) The legislature, understanding
29 the requirements of applicable federal law and the uniqueness of Montana's water resource, recognizes that
30 certain state waters are of such environmental, ecological, or economic value that the state should, upon a

1 showing of necessity, prohibit, to the greatest extent practicable, changes to the existing water quality of those
2 waters. Outstanding resource waters must be afforded the greatest protection feasible under state law, after
3 thorough examination.

4 (2) The purpose of 75-5-316 and this section is to provide this protection, when necessary, and to
5 provide guidance to the ~~board~~ department in establishing rules to accomplish that level of protection."

7 **Section 64.** Section 75-5-316, MCA, is amended to read:

8 **"75-5-316. Outstanding resource water classification -- rules -- criteria -- limitations -- procedure**

9 **-- definition.** (1) As provided under the provisions of 75-5-301 and this section, the ~~board~~ department may adopt
10 rules regarding the classification of waters as outstanding resource waters.

11 (2) The department may not:

12 (a) grant an authorization to degrade under 75-5-303 in outstanding resource waters; or

13 (b) allow a new or increased point source discharge that would result in a permanent change in the water
14 quality of an outstanding resource water.

15 (3) (a) A person may petition the ~~board~~ department for rulemaking to classify state waters as outstanding

10 a written finding is made that the interests of the public and the landowners affected will be protected.

11 (8) Strip-mining or underground-mining may not be conducted within 500 feet of active or abandoned
12 underground mines in order to prevent breakthroughs and to protect health or safety of miners. However, the
13 department shall permit an operator to mine near, through, or partially through an abandoned underground mine
14 or closer to an active underground mine if:

15 (a) the nature, timing, and sequencing of specific strip-mine activities and specific underground-mine
16 activities are jointly approved by the department and the regulatory authority concerned with the health and safety
17 of underground miners; and

18 (b) the operations will result in improved resource recovery, abatement of water pollution, or elimination
19 of hazards to the health and safety of the public.

20 (9) The department may not approve an application for a strip- or underground-coal-mining operation
21 if the area proposed to be mined is included:

22 (a) within an area designated unsuitable for strip or underground coal mining; or

23 (b) within an area under review for this designation under an administrative proceeding, unless in an area
24 as to which an administrative proceeding has commenced pursuant to this part, the operator making the permit
25 application demonstrates that prior to January 1, 1977, the operator made substantial legal and financial
26 commitments in relation to the operation for which the operator is applying for a permit.

27 (10) A permit or major permit revision for a strip- or underground-coal-mining operation may not be issued
28 unless the applicant has affirmatively demonstrated by its coal conservation plan that failure to conserve coal will
29 not occur. The department may require the applicant to submit any information it considers necessary for review
30 of the coal conservation plan.

1 (11) Whenever information available to the department indicates that a strip- or underground-coal-mining
2 operation that is owned or controlled by the applicant or by any person who owns or controls the applicant is
3 currently in violation of Public Law 95-87, as amended, any state law required by Public Law 95-87, as amended,
4 or any law, rule, or regulation of the United States or of any department or agency in the United States pertaining
5 to air or water environmental protection, the department may not issue a strip- or underground-coal-mining permit
6 or amendment, other than an incidental boundary revision, until the applicant submits proof that the violation has
7 been corrected or is in the process of being corrected to the satisfaction of the administering agency.

8 (12) The department may not issue a strip- or underground-coal-mining permit or amendment, other than
9 an incidental boundary revision, to any applicant that it finds, after an opportunity for hearing, owns or controls
10 any strip- or underground-coal-mining operation that has demonstrated a pattern of willful violations of Public Law
11 95-87, as amended, or any state law required by Public Law 95-87, as amended, when the nature and duration
12 of the violations and resulting irreparable damage to the environment indicate an intent not to comply with the
13 provisions of this part.

14 (13) Subject to valid existing rights, no strip- or underground-coal-mining operations except those that
15 existed as of August 3, 1977, may be conducted:

16 (a) on lands within the boundaries of units of the national park system, the national wildlife refuge
17 system, the national wilderness preservation system, the national system of trails, the wild and scenic rivers
18 system, including study rivers designated under section 5(a) of the Wild and Scenic Rivers Act or study rivers or
19 study river corridors established in any guidelines issued under that act, or national recreation areas designated
20 by an act of congress; or

21 (b) on any federal lands within national forests, subject to the exceptions and limitations of 30 CFR
22 761.11(b) and the procedures of 30 CFR 761.13.

23 (14) (a) A person who is listed by the department in the applicant violator system maintained by the office
24 of surface mining reclamation and enforcement of the U.S. department of the interior pursuant to the Surface
25 Mining Control and Reclamation Act of 1977, 30 U.S.C. 1201, et seq., as owning or controlling a strip-mining or
26 underground-mining operation may challenge the ownership or control listing by filing a written request with the
27 department for review of the listing. In the request, the person must include a written explanation of the basis for
28 the challenge and any evidence the person wishes the department to consider. The department shall provide a
29 written response within 60 days of receipt of the request for review.

30 (b) Within 30 days of receipt of the response pursuant to subsection (14)(a), the person who is listed may

1 request a hearing before the ~~board~~ department by submitting to the ~~board~~ department a written request for
2 hearing that states the reason for the request. The contested case provisions of the Montana Administrative
3 Procedure Act, Title 2, chapter 4, part 6, apply to the hearing."
4

5 **Section 179.** Section 82-4-231, MCA, is amended to read:

6 **"82-4-231. Submission of and action on reclamation plan.** (1) As rapidly, completely, and effectively
7 as the most modern technology and the most advanced state of the art will allow, each operator granted a permit
8 under this part shall reclaim and revegetate the land affected by the operation, except that underground tunnels,
9 shafts, or other subsurface excavations need not be revegetated. Under the provisions of this part and rules
10 adopted by the ~~board~~ department, an operator shall prepare and carry out a method of operation, a plan of
11 grading, backfilling, highwall reduction, subsidence stabilization, water control, and topsoiling and a reclamation
12 plan for the area of land affected by the operation. In developing a method of operation and plans of grading,
13 backfilling, highwall reduction, subsidence stabilization, water control, topsoiling, and reclamation, all measures
14 must be taken to eliminate damages to landowners and members of the public, their real and personal property,
15 public roads, streams, and all other public property from soil erosion, subsidence, landslides, water pollution, and
16 hazards dangerous to life and property.

17 (2) The reclamation plan must set forth in detail the manner in which the applicant intends to comply with
18 82-4-232 through 82-4-234 and this section and the steps to be taken to comply with applicable air and water
19 quality laws and rules and any applicable health and safety standards.

20 (3) The application for a permit or major revision of a permit, which must contain the reclamation plan,
21 must be submitted to the department.

22 (4) The department shall determine whether the application is administratively complete. An application
23 is administratively complete if it contains information addressing each application requirement in 82-4-222 and
24 the rules implementing that section and all information necessary to initiate processing and public review. The
25 department shall notify the applicant in writing of its determination no later than 90 days after submittal of the
26 application. If the department determines that the application is not administratively complete, it shall specify in
27 the notice those items that the application must address. The application is presumed administratively complete
28 as to those requirements not specified in the notice.

29 (5) If the department determines that an environmental impact statement on the application is required,
30 it shall notify the applicant in writing at the same time it gives the applicant notice pursuant to subsection (4).

1 (6) After the applicant receives notice that the application is administratively complete, the applicant shall
2 publish notice of filing of the application once a week for 4 consecutive weeks in a newspaper of general
3 circulation in the locality of the proposed operation. The department shall notify various local governmental
4 bodies, planning agencies, sewage and water treatment authorities, and water companies in the locality in which
5 the proposed mining will take place of the application and provide a reasonable time for them to submit written
6 comments. Any person having an interest that is or may be adversely affected or the officer or head of any
7 federal, state, or local governmental agency or authority may file written objections to the proposed initial or
8 revised application for permit or major revision within 30 days of the applicant's published notice. If written
9 objections are filed and an objector requests an informal conference, the department shall hold an informal
10 conference in the locality of the proposed operation within 30 days of receipt of the request. The department shall
11 notify the applicant and all parties to the informal conference of its decision and the reasons for its decision within
12 60 days of the informal conference. The department may arrange with the applicant upon request by any party
13 to the administrative proceeding for access to the proposed mining area for the purpose of gathering information
14 relevant to the proceeding.

15 (7) The filing of written objections or a request for an informal conference may not preclude the
16 department from proceeding with its review of the application as specified in subsection (8).

17 (8) (a) The department shall review each administratively complete application and determine the
18 acceptability of the application. During the review, the department may propose modifications to the application
19 or delete areas from the application in accordance with the requirements of 82-4-227. A complete application is
20 considered acceptable when the application is in compliance with all of the applicable requirements of this part
21 and the regulatory program pursuant to this part.

22 (b) If the applicant significantly modifies the application after the application has been determined
23 administratively complete in accordance with subsection (4), the department shall under this section either deny
24 the application or conduct a new review, including an administrative completeness determination, public notice,
25 and objection period.

26 (c) If an environmental impact statement is determined to be necessary prior to making a permit decision,
27 the department shall complete and publish the final environmental impact statement at least 15 days prior to the
28 date of issuance of the written findings pursuant to subsection (8)(f).

29 (d) Except as provided in 75-1-205(4) and 75-1-208(4)(b), within 120 days after it determines that an
30 application is administratively complete, the department shall notify the applicant in writing whether the application

1 is or is not acceptable. If the application is not acceptable, the department shall set forth the reasons why it is not
2 acceptable, and it may propose modifications, delete areas, or reject the entire application. All items not specified
3 as unacceptable in the department's notification are presumed to be acceptable. Except as provided in
4 75-1-208(4)(b), if the applicant revises the application in response to a notice of unacceptability, the department
5 shall review the revised application and notify the applicant in writing within 120 days of the date of receipt
6 whether the revised application is acceptable. If the revision constitutes a significant modification under
7 subsection (8)(b), the department shall conduct a new review, beginning with an administrative completeness
8 determination.

9 (e) When the application is determined to be acceptable, the department shall publish notice of its
10 determination once a week for 2 consecutive weeks in a newspaper of general circulation in the locality of the
11 proposed operation. Any person having an interest that is or may be adversely affected may file a written
12 objection to the determination within 10 days of the department's last published notice. If a written objection is
13 filed and an objector requests an informal conference, the department shall hold an informal conference in the
14 locality of the proposed operation within 20 days of receipt of the request. The department shall notify the
15 applicant and all parties to the informal conference of its decision and the reasons for the decision within 10 days
16 of the informal conference.

17 (f) Except as provided in 75-1-205(4) and 75-1-208(4)(b), the department shall prepare written findings
18 granting or denying the permit or major revision application in whole or in part not later than 45 days from the date
19 the application is determined acceptable. However, if lands subject to the federal lands program are included in
20 the application for permit or major revision, the department shall prepare and submit written findings to the federal
21 regulatory authority. If the department's decision is to grant the permit, the department shall issue the permit on
22 the date of its written finding or, if any federal concurrence is necessary, on the date when the concurrence is
23 obtained. If the application is denied, specific reasons for the denial must be set forth in the written notification
24 to the applicant.

25 (g) If the department fails to act within the times specified in this subsection (8), it shall immediately ~~notify~~
26 ~~the board in writing of~~ record in writing its failure to comply and the reasons for the failure to comply.

27 (9) The applicant, a landowner, or any person with an interest that is or may be adversely affected by
28 the department's permit decision may within 30 days of that decision submit a written notice requesting a hearing.
29 The notice must contain the grounds upon which the requester contends that the decision is in error. The hearing
30 must be started within 30 days of the request. For purposes of a hearing, the ~~board~~ department or its hearings

1 officer may order site inspections of the area pertinent to the application. The ~~board~~ department shall within 20
2 days of the hearing notify the person who requested the hearing, by certified mail, and all other persons, by
3 regular mail, of the findings and decisions. A person who presided at the informal conference may not preside
4 at the hearing or participate in the decision.

5 (10) In addition to the method of operation, grading, backfilling, highwall reduction, subsidence
6 stabilization, water control, topsoiling, and reclamation requirements of this part and rules adopted under this part,
7 the operator, consistent with the directives of subsection (1), shall:

8 (a) bury under adequate fill all toxic materials, shale, mineral, or any other material determined by the
9 department to be acid-producing, toxic, undesirable, or creating a hazard;

10 (b) as directed by rules, seal off tunnels, shafts, or other openings or any breakthrough of water creating
11 a hazard;

12 (c) impound, drain, or treat all runoff or underground mine waters so as to reduce soil erosion, damage
13 to grazing and agricultural lands, and pollution of surface and subsurface waters;

14 (d) remove or bury all metal, lumber, and other refuse resulting from the operation;

15 (e) use explosives in connection with the operation only in accordance with department regulations
16 designed to minimize noise, damage to adjacent lands, and water pollution and ensure public safety and for other
17 purposes;

18 (f) adopt measures to prevent land subsidence unless the department approves a plan for inducing
19 subsidence into an abandoned operation in a predictable and controlled manner, with measures for grading,
20 topsoiling, and revegetating the subsided land surface. In order for a controlled subsidence plan to be approved,
21 the applicant is required to show that subsidence will not cause a direct or indirect hazard to any public or private
22 buildings, roads, facilities, or use areas, constitute a hazard to human life or health or to domestic livestock or
23 a viable agricultural operation, or violate any other restrictions the department may consider necessary.

24 (g) stockpile and protect from erosion all mining and processing wastes until these wastes can be
25 disposed of according to the provisions of this part;

26 (h) deposit as much stockpiled waste material as possible back into the mine voids upon abandonment
27 in a manner that will prevent or minimize land subsidence. The remaining waste material must be disposed of
28 as provided by this part and the rules of the ~~board~~ department.

29 (i) seal all portals, entryways, drifts, shafts, or other openings between the surface and underground
30 mine workings when no longer needed;

1 (j) to the extent possible using the best technology currently available, minimize disturbances and
2 adverse impacts of the operation on fish, wildlife, and related environmental values and achieve enhancement
3 of those resources when practicable;

4 (k) minimize the disturbances to the prevailing hydrologic balance at the mine site and in adjacent areas
5 and to the quality and quantity of water in surface water and ground water systems both during and after strip-
6 or underground-coal-mining operations and during reclamation by:

7 (i) avoiding acid or other toxic mine drainage by measures including but not limited to:

8 (A) preventing or removing water from contact with toxic-producing deposits;

9 (B) treating drainage to reduce toxic content that adversely affects downstream water upon being
10 released to watercourses;

11 (C) casing, sealing, or otherwise managing boreholes, shafts, and wells and keeping acid or other toxic
12 drainage from entering ground and surface waters;

13 (ii) (A) conducting strip- or underground-mining operations so as to prevent, to the extent possible using
14 the best technology currently available, additional contributions of suspended solids to streamflow or runoff
15 outside the permit area, but the contributions may not be in excess of requirements set by applicable state or
16 federal law;

17 (B) constructing any siltation structures pursuant to subsection (10)(k)(ii)(A) prior to commencement of
18 strip- or underground-mining operations, with the structures to be certified by a qualified registered engineer and
19 to be constructed as designed and as approved in the reclamation plan;

20 (iii) cleaning out and removing temporary or large settling ponds or other siltation structures from
21 drainways after disturbed areas are revegetated and stabilized and depositing the silt and debris at a site and
22 in a manner approved by the department;

23 (iv) restoring recharge capacity of the mined area to approximate premining conditions;

24 (v) avoiding channel deepening or enlargement in operations that requires the discharge of water from
25 mines;

26 (vi) preserving throughout the mining and reclamation process the essential hydrologic functions of
27 alluvial valley floors in the arid and semiarid areas of the country;

28 (vii) designing and constructing reclaimed channels of intermittent streams and perennial streams to
29 ensure long-term stability; and

30 (viii) any other actions that the department may prescribe;

- 1 (l) conduct strip- or underground-mine operations in accordance with the approved coal conservation
2 plan;
- 3 (m) stabilize and protect all surface areas, including spoil piles, to effectively control air pollution;
- 4 (n) seal all auger holes with an impervious and noncombustible material in order to prevent drainage
5 except when the department determines that the resulting impoundment of water in the auger holes may create
6 a hazard to the environment or the public health and safety;
- 7 (o) develop contingency plans to prevent sustained combustion;
- 8 (p) refrain from construction of roads or other access ways up a streambed or drainage channel or in
9 proximity to the channel so as to seriously alter the normal flow of water;
- 10 (q) meet other criteria that are necessary to achieve reclamation in accordance with the purposes of this
11 part, taking into consideration the physical, climatological, and other characteristics of the site;
- 12 (r) with regard to underground mines, eliminate fire hazards and otherwise eliminate conditions that
13 constitute a hazard to health and safety of the public;
- 14 (s) locate openings for all new drift mines working acid-producing or iron-producing coal seams in a
15 manner that prevents a gravity discharge of water from the mine.
- 16 (11) An operator may not throw, dump, pile, or permit the throwing, dumping, or piling or otherwise
17 placing of any overburden, stones, rocks, mineral, earth, soil, dirt, debris, trees, wood, logs, or any other materials
18 or substances of any kind or nature beyond or outside of the area of land that is under permit and for which a
19 bond has been posted under 82-4-223 or place the materials described in this section in a way that normal
20 erosion or slides brought about by natural physical causes will permit the materials to go beyond or outside of
21 that area of land. An operator shall conduct the strip- or underground-mining operation in a manner that protects
22 areas outside the permit area."

23

24 **Section 180.** Section 82-4-232, MCA, is amended to read:

25 **"82-4-232. Area mining required -- bond -- alternative plan.** (1) (a) Area strip mining, a method of
26 operation that does not produce a bench or fill bench, is required where strip mining is proposed. The area of land
27 affected must be backfilled and graded to the approximate original contour of the land. However:

- 28 (i) consistent with the adjacent unmined landscape elements, the operator may propose and the
29 department may approve regraded topography gentler than premining topography in order to enhance the
30 postmining land use and develop a postmining landscape that will provide greater moisture retention, greater

1 stability, and reduced soil losses from runoff and erosion;

2 (ii) postmining slopes may not exceed the angle of repose or lesser slope as is necessary to achieve a
3 long-term static safety factor of 1.3 or greater and to prevent slides;

4 (iii) permanent impoundments may be approved if they are suitable for the postmining land use and
5 otherwise meet the requirements of this part, as provided by ~~board~~ department rules; and

6 (iv) reclaimed topography must be suitable for the approved postmining land use.

7 (b) Spoil from the first cut is not required to be transported to the last cut if highwalls are eliminated, box
8 cut spoils are graded to blend in with the surrounding terrain, and the approximate original contour of the land
9 is achieved.

10 (c) When directed by the department, the operator shall construct in the final grading diversion ditches,
11 depressions, or terraces that will accumulate or control the water runoff.

12 (2) In addition to the backfilling and grading requirements, the operator's method of operation on steep
13 slopes may be regulated and controlled according to rules adopted by the ~~board~~ department. These rules may
14 require any measure to accomplish the purpose of this part.

15 (3) For coal mining on prime farmlands, the ~~board~~ department shall establish by rule specifications for
16 soil removal, storage, replacement, and reconstruction, and the operator must as a minimum be required to:

17 (a) (i) segregate the A horizon of the natural soil, except when it can be shown that other available soil
18 materials will create a final soil having a greater productive capacity; and

19 (ii) if not used immediately, stockpile this material separately from other spoil and provide needed
20 protection from wind and water erosion or contamination by other acid or toxic material;

21 (b) (i) segregate the B horizon of the natural soil, or underlying C horizon or other strata, or a combination
22 of the horizons or other strata that are shown to be both texturally and chemically suitable for plant growth and
23 that can be shown to be equally or more favorable for plant growth than the B horizon in sufficient quantities to
24 create in the regraded final soil a root zone of comparable depth and quality to that that existed in the natural soil;
25 and

26 (ii) if not used immediately, stockpile this material separately from other spoil and provide needed
27 protection from wind and water erosion or contamination by acid or toxic material;

28 (c) replace and regrade the root zone material described in subsection (3)(b) with proper compaction
29 and uniform depth over the regraded spoil material; and

30 (d) redistribute and grade in a uniform manner the surface soil horizon described in subsection (3)(a).

1 (4) All available topsoil must be removed in a separate layer, guarded from erosion and pollution, and
2 kept in a condition so that it can sustain vegetation of at least the quality and variety it sustained prior to removal.
3 However, the operator shall accord substantially the same treatment to any subsurface deposit of material that
4 is capable, as determined by the department, of supporting surface vegetation virtually as well as the present
5 topsoil. After the operation has been backfilled and graded, the topsoil or the best available subsurface deposit
6 of material that is best able to support vegetation must be returned as the top layer.

7 (5) As determined by rules of the ~~board~~ department, time limits must be established requiring backfilling,
8 grading, subsidence stabilization, water control, highwall reduction, topsoiling, planting, and revegetation to be
9 kept current. All backfilling, subsidence stabilization, sealing, grading, and topsoiling must be completed before
10 necessary equipment is moved from the operation.

11 (6) (a) The permittee may file an application with the department for the release of all or part of a
12 performance bond. The application must contain a proposed public notice of the precise location of the land
13 affected, the number of acres for which bond release is sought, the permit and the date approved, the amount
14 of the bond filed and the portion sought to be released, the type and appropriate dates of reclamation work
15 performed, and a description of the results achieved as they relate to the permittee's approved reclamation plan.
16 In addition, as part of any bond release application, the permittee shall submit copies of letters that the permittee
17 has sent to adjoining property owners, local governmental bodies, planning agencies, and sewage and water
18 treatment authorities or water companies in the locality of the operation, notifying them of the permittee's intention
19 to seek release from the bond.

20 (b) The department shall determine whether the application is administratively complete. An application
21 is administratively complete if it includes:

- 22 (i) the location and acreage of the land for which bond release is sought;
23 (ii) the amount of bond release sought;
24 (iii) a description of the completed reclamation, including the date of performance;
25 (iv) a discussion of how the results of the completed reclamation satisfy the requirements of the approved
26 reclamation plan; and
27 (v) information required by rules implementing this part.

28 (c) The department shall notify the applicant in writing of its determination no later than 60 days after
29 submittal of the application. If the department determines that the application is not administratively complete,
30 it shall specify in the notice those items that the application must address. After an application for bond release

1 has been determined to be administratively complete by the department, the permittee shall publish a public
2 notice that has been approved as to form and content by the department at least once a week for 4 successive
3 weeks in a newspaper of general circulation in the locality of the mining operation.

4 (d) Any person with a valid legal interest that might be adversely affected by the release of a bond or the
5 responsible officer or head of any federal, state, or local governmental agency that has jurisdiction by law or
6 special expertise with respect to any environmental, social, or economic impact involved in the operation or is
7 authorized to develop and enforce environmental standards with respect to the operation may file written
8 objections to the proposed release of bond to the department within 30 days after the last publication of the
9 notice. If written objections are filed and a hearing is requested, the department shall hold a public hearing in the
10 locality of the operation proposed for bond release or in Helena, at the option of the objector, within 30 days of
11 the request for hearing. The department shall inform the interested parties of the time and place of the hearing.
12 The date, time, and location of the public hearing must be advertised by the department in a newspaper of
13 general circulation in the locality for 2 consecutive weeks. Within 30 days after the hearing, the department shall
14 notify the permittee and the objector of its final decision.

15 (e) Without prejudice to the rights of the objector or the permittee or the responsibilities of the department
16 pursuant to this section, the department may establish an informal conference to resolve written objections.

17 (f) For the purpose of the hearing under subsection (6)(d), the department may administer oaths,
18 subpoena witnesses or written or printed materials, compel the attendance of witnesses or the production of
19 materials, and take evidence, including but not limited to conducting inspections of the land affected and other
20 operations carried on by the permittee in the general vicinity. A verbatim record of each public hearing required
21 by this section must be made, and a transcript must be made available on the motion of any party or by order of
22 the department.

23 (g) If the applicant significantly modifies the application after the application has been determined to be
24 administratively complete, the department shall conduct a new review, including an administrative completeness
25 determination. A significant modification includes but is not limited to:

26 (i) the notification of an additional property owner, local governmental body, planning agency, or sewage
27 and water treatment authority of the permittee's intention to seek a bond release;

28 (ii) a material increase in the acreage for which a bond release is sought or in the amount of bond release
29 sought; or

30 (iii) a material change in the reclamation for which a bond release is sought or the information used to

1 evaluate the results of that reclamation.

2 (h) The department shall, within 30 days of determining that the application is administratively complete
3 or as soon as weather permits, conduct an inspection and evaluation of the reclamation work involved. In the
4 evaluation, the department shall consider, among other things, the degree of difficulty in completing any remaining
5 reclamation, whether pollution of surface and subsurface water is occurring, the probability of continuance or
6 future occurrence of the pollution, and the estimated cost of abating the pollution.

7 (i) The department shall review each administratively complete application to determine the acceptability
8 of the application. A complete application is acceptable if the application is in compliance with all of the applicable
9 requirements of this part, the rules adopted under this part, and the permit.

10 (j) (i) The department shall notify the applicant in writing regarding the acceptability of the application no
11 later than 60 days from the date of the inspection.

12 (ii) If the department determines that the application is not acceptable, it shall specify in the notice those
13 items that the application must address.

14 (iii) If the applicant revises the application in response to a notice of unacceptability, the department shall
15 review the revised application and notify the applicant in writing within 60 days of the date of receipt as to whether
16 the revised application is acceptable.

17 (iv) If the revision constitutes a significant modification, the department shall conduct a new review,
18 beginning with an administrative completeness determination.

19 (v) A significant modification includes but is not limited to:

20 (A) the notification of an additional property owner, local governmental body, planning agency, or sewage
21 and water treatment authority of the permittee's intention to seek a bond release;

22 (B) a material increase in the acreage for which a bond release is sought or the amount of bond release
23 sought; or

24 (C) a material change in the reclamation for which a bond release is sought or the information used to
25 evaluate the results of that reclamation.

26 (k) The department shall release the bond in whole or in part if it is satisfied the reclamation covered by
27 the bond or portion of the bond has been accomplished as required by this part according to the following
28 schedule:

29 (i) When the permittee completes the plugging, backfilling, regrading, and drainage control of a bonded
30 area in accordance with the approved reclamation plan, the department shall release 60% of the bond or

1 collateral for the applicable permit area.

2 (ii) After revegetation has been established on the regraded lands in accordance with the approved
3 reclamation plan, the department shall, for the period specified for operator responsibility of reestablishing
4 revegetation, retain that amount of bond for the revegetated area that would be sufficient for a third party to cover
5 the cost of reestablishing revegetation. Whenever a silt dam is to be retained as a permanent impoundment, the
6 portion of bond may be released under this subsection (6)(k)(ii) if provisions for sound future maintenance by the
7 operator or the landowner have been made with the department. Any part of the bond may not be released under
8 this subsection (6)(k)(ii):

9 (A) as long as the lands to which the release would be applicable are contributing suspended solids to
10 streamflow or runoff outside the permit area in excess of the requirements of 82-4-231(10)(k); or

11 (B) before soil productivity for prime farm lands to which the release would be applicable has returned
12 to equivalent levels of yield as nonmined land of the same soil type in the surrounding area under equivalent
13 management practices, as determined from the soil survey.

14 (iii) When the permittee has successfully completed all prospecting, mining, and reclamation activities,
15 the department shall release the remaining portion of the bond, but not before the expiration of the period
16 specified for responsibility and not until all reclamation requirements of this part are fully met.

17 (l) If the department disapproves the application for release of the bond or a portion of the bond, it shall:

18 (i) provide to the permittee detailed written findings demonstrating that the reclamation covered by the
19 bond or a portion of the bond has not been accomplished as required by this part; and

20 (ii) recommend corrective actions necessary to secure the release and allowing opportunity for a public
21 hearing.

22 (m) When an application for total or partial bond release is filed with the department, it shall notify the
23 municipality or county in which a prospecting or mining operation is located by certified mail at least 30 days prior
24 to the release of all or a portion of the bond.

25 (7) All disturbed areas must be reclaimed in a timely manner to conditions that are capable of supporting
26 the land uses that they were capable of supporting prior to any mining or to higher or better uses as approved
27 pursuant to subsection (8).

28 (8) (a) An operator may propose a higher or better use as an alternative postmining land use. If the
29 landowner is not the operator, the operator shall submit written documentation of the concurrence of the
30 landowner or the land management agency with jurisdiction over the land. The department may approve the

1 proposed alternative postmining land use only if it meets all of the following criteria:

2 (i) There is a reasonable likelihood for achievement of the alternative land use.

3 (ii) The alternative land use does not present any actual or probable hazard to the public health or safety

4 or any threat of water diminution or pollution.

5 (iii) The alternative land use will not:

6 (A) be impractical or unreasonable;

7 (B) be inconsistent with applicable land use policies or plans;

8 (C) involve unreasonable delay in implementation; or

9 (D) cause or contribute to violation of federal, state, or local law.

10 (b) As used in this section, the term "landowner" includes a person who has sold the surface estate to
11 the operator with an option to repurchase the surface estate after mining and reclamation are complete.

12 (9) The reclamation plan must incorporate appropriate wildlife habitat enhancement features that are
13 integrated with cropland, grazing land, pastureland, land occasionally cut for hay, or other uses in order to
14 enhance habitat diversity, with emphasis on big game animals, game birds, and threatened and endangered
15 species that have been documented to live in the area of land affected, and to enhance wetlands and riparian
16 areas along rivers and streams and bordering ponds and lakes. Incorporation of wildlife habitat enhancement
17 features does not constitute a change in land use to fish and wildlife habitat and may not interfere with the
18 designated land use.

19 (10) Facilities existing prior to mining, including but not limited to public roads, utility lines, railroads, or
20 pipelines, may be replaced as part of the reclamation plan."

21

22 **Section 181.** Section 82-4-234, MCA, is amended to read:

23 **"82-4-234. Commencement of reclamation.** The operator shall commence the reclamation of the area
24 of land affected by the operator's operation as soon as possible after the beginning of strip mining or underground
25 mining of that area in accordance with plans previously approved by the department. Those grading, backfilling,
26 subsidence stabilization, topsoiling, and water management practices that are approved in the plans must be kept
27 current with the operation as defined by rules of the ~~board~~ department, and a permit or supplement to a permit
28 may not be issued if, in the discretion of the department, these practices are not current."

29

30 **Section 182.** Section 82-4-235, MCA, is amended to read:

1 **"82-4-235. Determination of successful revegetation -- final bond release.** (1) Success of
2 revegetation must be judged on the effectiveness of the vegetation for the approved postmining land use, the
3 extent of cover compared to the cover occurring in the natural vegetation, and the requirements of 82-4-233.

4 Standards for success are:

5 (a) for areas reclaimed for use as cropland, crop production must be at least equal to that achieved prior
6 to mining based on comparison with historical data, comparable reference areas, or United States department
7 of agriculture publications applicable to the area of the operation, as referenced in rules adopted by the ~~board~~
8 department;

9 (b) for areas reclaimed for use as pastureland or grazing land, the ground cover and production of living
10 plants on the revegetated area must be at least equal to that of a reference area or other standard approved by
11 the department as appropriate for the postmining land use;

12 (c) for areas reclaimed for use as fish and wildlife habitat, forestry, or recreation, success of revegetation
13 must be determined on the basis of approved tree density standards or shrub density standards, or both, and
14 vegetative ground cover required to achieve the postmining land use;

15 (d) reestablished vegetation is considered effective if the postmining land use is achieved and erosion
16 is controlled;

17 (e) reestablished vegetation is considered permanent if it is diverse and effective at the end of the
18 10-year responsibility period specified under subsection (2); and

19 (f) plant species composing the reestablished vegetation are considered to have the same seasonal
20 characteristics of growth as the original vegetation, to be capable of regeneration and plant succession, and to
21 be compatible with the plant and animal species of the area if those plant species are native to the area or are
22 introduced species approved by the department as desirable and necessary to achieve the postmining land use.

23 (2) Inspection and evaluation of reclaimed vegetative cover must be made as soon as possible following
24 an application for final bond release to determine if a satisfactory stand has been established. If the department
25 determines that a satisfactory vegetative cover has been established, it shall release the remaining bond held
26 on the area reclaimed after public notice and an opportunity for hearing as provided in 82-4-232(6). Except as
27 provided in subsection (3), the remaining bond may not be released prior to a period of 10 years after the last
28 year of augmented seeding, fertilizing, irrigation, or other work required under this part for those operations or
29 portions of operations that were seeded after May 2, 1978, or prior to a period of 5 years after initial planting for
30 all exploration activities and all other operations.

1 (3) (a) Vegetative cover of water management facilities and other support facilities composing no more
2 than 10% of the area for which bond release is sought is not subject to the 10-year responsibility period. Water
3 management facilities and other support facilities include sedimentation ponds, diversions, other water
4 management structures, soils stockpiles, and access roads.

5 (b) Vegetative cover of water management facilities and other support facilities composing no more than
6 10% of the area for which bond release is sought is eligible for bond release if the vegetative cover otherwise
7 meets the reclamation standards in subsection (1).

8 (4) (a) Notwithstanding the provisions of subsections (2) and (3), on land from which coal was removed
9 prior to May 3, 1978, and on land from which coal was not removed and that was not used, disturbed, or
10 redisturbed in connection with this part after May 2, 1978, pursuant to a permit issued by the department under
11 this part, the department may approve for release a bond on an area of reclaimed vegetation that meets the
12 following criteria:

13 (i) it was seeded using a seed mixture that was approved by the department under the criteria
14 established pursuant to 82-4-233 and that included introduced species; and

15 (ii) at least one of the following conditions exists:

16 (A) the standards of 82-4-233(1) are otherwise achieved;

17 (B) the operator has demonstrated substantial usefulness of the reclaimed vegetation for grazing of
18 livestock;

19 (C) the operator demonstrates that the reclaimed vegetation has substantial value as a habitat
20 component for wildlife present in the area; or

21 (D) the topography and soils are suitable for conversion to cropland or hayland consistent with the
22 standards of 82-4-232 and the department approves and the operator completes that conversion.

23 (b) On lands that meet the criteria described in subsection (4)(a), interseeding or supplemental planting
24 may be performed without reinitiating the liability period provided in subsection (2)."

25

26 **Section 183.** Section 82-4-239, MCA, is amended to read:

27 **"82-4-239. Reclamation.** (1) The department may have reclamation work done by its employees, by
28 employees of other governmental agencies, by soil conservation districts, or through contracts with qualified
29 persons. The ~~board~~ department may construct, operate, and maintain plants for the control and treatment of water
30 pollution resulting from mine drainage.

1 (2) Any funds or any public works programs available to the department must be used and expended
2 to reclaim and rehabilitate lands that have been subjected to strip mining or underground mining and that have
3 not been reclaimed and rehabilitated in accordance with the standards of this part. The department shall
4 cooperate with federal, state, and private agencies to engage in cooperative projects under this section.

5 (3) Agents, employees, or contractors of the department may enter upon any land for the purpose of
6 conducting studies or exploratory work to determine whether the land has been strip- or underground-mined and
7 not reclaimed and rehabilitated in accordance with the requirements of this part and to determine the feasibility
8 of restoration, reclamation, abatement, control, or prevention of any adverse effects of past coal-mining practices.
9 Upon request of the director of the department, the attorney general shall bring an injunctive action to restrain
10 any interference with the exercise of the right to enter and inspect granted in this subsection. The action must
11 be brought in the county in which the mine is located.

12 (4) (a) The department shall take the actions described in subsection (4)(b) when it makes a finding of
13 fact that:

14 (i) land or water resources have been adversely affected by past coal-mining practices;

15 (ii) the adverse effects are at a stage at which, in the public interest, action to restore, reclaim, abate,
16 control, or prevent should be taken; and

17 (iii) the owners of the land or water resources where entry must be made to restore, reclaim, abate,
18 control, or prevent the adverse effects of past coal-mining practices are not known or readily available or the
19 owners will not give permission for the department or its agents, employees, or contractors to enter upon the
20 property to restore, reclaim, abate, control, or prevent the adverse effects of past coal-mining practices.

21 (b) After giving notice by mail to the owner, if known, and any purchaser under contract for deed, if
22 known, or, if neither is known, by posting notice on the premises and advertising in a newspaper of general
23 circulation in the county in which the land lies, the agents, employees, or contractors of the department may enter
24 on the property adversely affected by past coal-mining practices and on any other property necessary for access
25 to the mineral property to do all things necessary or expedient to restore, reclaim, abate, control, or prevent the
26 adverse effects of past coal-mining practices.

27 (c) Action taken under subsection (4)(b) is not an act of condemnation of property or of trespass, but
28 rather is an exercise of the power granted by Article IX, sections 1 and 2, of the Montana constitution.

29 (5) (a) Within 6 months after the completion of projects to restore, reclaim, abate, control, or prevent
30 adverse effects of past coal-mining practices on privately owned land, the department shall itemize the money

1 expended and may file a statement of those expenses in the office of the clerk and recorder of the county in which
2 the land lies, together with a notarized appraisal by an independent appraiser of the value of the land before the
3 restoration, reclamation, abatement, control, or prevention of adverse effects of past coal-mining practices if the
4 money expended resulted in a significant increase in property value. The statement constitutes a lien upon the
5 land. The lien may not exceed the amount determined by the appraisal to be the increase in the market value of
6 the land as a result of the restoration, reclamation, abatement, control, or prevention of the adverse effects of past
7 coal-mining practices. A lien under this subsection (5)(a) may not be filed against the property of a person who
8 owned the surface prior to May 2, 1977, and who did not consent to, participate in, or exercise control over the
9 mining operation that necessitated the reclamation performed under this part.

10 (b) The landowner may petition within 60 days of the filing of the lien to determine the increase in the
11 market value of the land as a result of the restoration, reclamation, abatement, control, or prevention of the
12 adverse effects of past coal-mining practices. The amount reported to be the increase in value of the premises
13 constitutes the amount of the lien and must be recorded with the statement provided for in this section. Any party
14 aggrieved by the decision may appeal as provided by law.

15 (c) The lien provided in this section must be recorded at the office of the county clerk and recorder. The
16 statement constitutes a lien upon the land as of the date of the expenditure of the money and has priority as a
17 lien second only to the lien of real estate taxes imposed upon the land.

18 (6) The department may acquire the necessary property by gift or purchase. A gift or purchase must be
19 approved by the board of land commissioners. If the property cannot be acquired by gift or purchase at a
20 reasonable cost, proceedings may be instituted in the manner provided in Title 70, chapter 30, against all
21 nonaccepting landholders if:

22 (a) the property is necessary for successful reclamation;

23 (b) the acquired land after restoration, reclamation, abatement, control, or prevention of the adverse
24 effects of past coal-mining practices will serve recreation and historic purposes or conservation and reclamation
25 purposes or provide open space benefits; and

26 (c) (i) permanent facilities, such as treatment plants or relocated stream channels, will be constructed
27 on the land for the restoration, reclamation, abatement, control, or prevention of the adverse effects of past strip-
28 or underground-coal-mining practices; or

29 (ii) acquisition of coal refuse disposal sites and all coal refuse on the land will serve the purposes of this
30 part because public ownership is desirable to meet emergency situations and prevent recurrences of the adverse

1 effects of past coal-mining practices."
2

3 **Section 184.** Section 82-4-251, MCA, is amended to read:

4 **"82-4-251. Noncompliance -- suspension of permits.** (1) If it is determined on the basis of an
5 inspection that the permittee is or that any condition or practice exists in violation of any requirement of this part
6 or any permit condition required by this part that creates an imminent danger to the health or safety of the public
7 or is causing or can reasonably be expected to cause significant and imminent environmental harm to land, air,
8 or water resources, the director of the department or an authorized representative shall immediately order
9 cessation of the operation or the portion of the operation relevant to the condition, practice, or violation. The
10 cessation order remains in effect until the director or an authorized representative determines that the condition,
11 practice, or violation has been abated or until modified, vacated, or terminated by the director or an authorized
12 representative pursuant to subsection (5). If the director or an authorized representative finds that the ordered
13 cessation of the operation or any portion of the operation will not completely abate the imminent danger to the
14 health or safety of the public or the significant and imminent environmental harm to land, air, or water resources,
15 the director or the authorized representative shall, in addition to the cessation order, impose affirmative
16 obligations requiring any steps that the director or the authorized representative considers necessary to abate
17 the imminent danger or the significant environmental harm.

18 (2) When, on the basis of an inspection, the department determines that any permittee is in violation of
19 any requirement of this part or any permit condition required by this part that does not create an imminent danger
20 to the health or safety of the public or cannot be reasonably expected to cause significant and imminent
21 environmental harm to land, air, or water resources, the director or an authorized representative shall issue a
22 notice to the permittee or the permittee's agent fixing a reasonable time, not exceeding 90 days, for the
23 abatement of the violation and providing opportunity for public hearing. If, upon expiration of the period of time
24 as originally fixed or subsequently extended, for good cause shown and upon the written finding of the director
25 or an authorized representative, the director or an authorized representative finds that the violation has not been
26 abated, the director or an authorized representative shall immediately order a cessation of the operation or the
27 portion of the operation relevant to the violation. The cessation order remains in effect until the director or an
28 authorized representative determines that the violation has been abated or until modified, vacated, or terminated
29 by the director or an authorized representative pursuant to subsection (5). In the order of cessation issued under
30 this subsection, the director shall determine the steps necessary to abate the violation in the most expeditious

1 manner possible and shall include the necessary measures in the order.

2 (3) When, on the basis of an inspection, the director or an authorized representative determines that a
3 pattern of violations of any requirements of this part or any permit conditions required by this part exists or has
4 existed and if the director or an authorized representative also finds that the violations are caused by the
5 unwarranted failure of the permittee to comply with any requirements of this part or any permit conditions or that
6 the violations are willfully caused by the permittee, the director or an authorized representative shall issue an
7 order to the permittee to show cause as to why the permit should not be suspended or revoked and shall provide
8 opportunity for a public hearing. If a hearing is requested, the director shall inform all interested parties of the time
9 and place of the hearing. Upon the permittee's failure to show cause as to why the permit should not be
10 suspended or revoked, the director or an authorized representative shall suspend or revoke the permit. A
11 permittee may request a contested case hearing on a permit suspension or revocation by filing a request for
12 hearing, specifying the grounds for the request, within 30 days of receipt of the order of suspension or revocation.
13 The order is effective upon expiration of the period for requesting a hearing or, if a hearing is requested, upon
14 issuance of a final order by the ~~board~~ department. The hearing must be conducted in accordance with the
15 requirements of Title 2, chapter 4, part 6. When a permit has been revoked, the department may order the
16 performance bond forfeited.

17 (4) Any additional permits held by an operator whose mining permit has been revoked must be
18 suspended, and the operator is not eligible to receive another permit or to have the suspended permits reinstated
19 until the operator has complied with all the requirements of this part with respect to former permits issued to the
20 operator. An operator who has forfeited a bond is not eligible to receive another permit unless the land for which
21 the bond was forfeited has been reclaimed without cost to the state or the operator has paid into the reclamation
22 account a sum together with the value of the bond the department finds adequate to reclaim the lands.

23 (5) Notices and orders issued pursuant to this section must set forth with reasonable specificity the
24 nature of the violation and the remedial action required, the period of time established for abatement, and a
25 reasonable description of the portion of the operation to which the notice or order applies. Each notice or order
26 issued under this section must be given promptly to the permittee or the permittee's agent by the department, by
27 the director, or by the authorized representative who issued the notice or order. All notices and orders must be
28 in writing and be signed by the authorized representatives. Any notice or order issued pursuant to this section
29 may be modified, vacated, or terminated by the director or an authorized representative. However, any notice or
30 order issued pursuant to this section that requires cessation of mining by the operator expires within 30 days of

1 actual notice to the operator unless an informal public hearing, if requested by the person to whom the notice or
 2 order was issued, is held at the site or within such reasonable proximity to the site that any viewings of the site
 3 can be conducted during the course of the hearing. If the department receives a request for an informal public
 4 hearing 21 days after service of the notice or order, the period for holding the informal public hearing is extended
 5 by the number of days after the 21st day that the request was received.

6 (6) A person who has been issued a notice or an order of cessation pursuant to subsection (1) or (2) or
 7 a person who has an interest that is or may be adversely affected by an order issued pursuant to subsection (1)
 8 or (2) or by modification, vacation, or termination of that order may request a hearing before the ~~board~~ department
 9 on that order within 30 days of its issuance or within 30 days of its modification, vacation, or termination. The filing
 10 of an application for review under this subsection may not operate as a stay of any order or notice. The ~~board~~
 11 department shall make findings of fact and issue a written decision incorporating an order vacating, affirming,
 12 modifying, or terminating the order.

13 (7) Whenever an order is issued under this section or as the result of any administrative proceeding
 14 under this part, at the request of any person, a sum equal to the aggregate amount of all costs, expenses, and
 15 attorney fees as determined by the department to have been reasonably incurred by the person for or in
 16 connection with the person's participation in the proceedings, including any judicial review of agency actions, may
 17 be assessed against either party as the court, resulting from judicial review, or the department, resulting from
 18 administrative proceedings, considers proper.

19 (8) In order to protect the stability of the land, the director or an authorized representative shall order
 20 cessation of underground coal mining under urbanized areas, cities, towns, and communities and adjacent to
 21 industrial or commercial buildings, major impoundments, or permanent streams if the director or the authorized
 22 agent finds imminent danger to inhabitants of the urbanized areas, cities, towns, and communities."
 23

24 **Section 185.** Section 82-4-254, MCA, is amended to read:

25 **"82-4-254. Violation -- penalty -- waiver.** (1) (a) Except as provided in subsection (2), a person or
 26 operator who violates any of the provisions of this part, rules adopted or orders issued under this part, or term
 27 or condition of a permit and any director, officer, or agent of a corporation who purposely or knowingly authorizes,
 28 orders, or carries out a violation shall pay an administrative penalty of not less than \$100 or more than \$5,000
 29 for the violation and an additional administrative penalty of not less than \$100 or more than \$5,000 for each day
 30 during which a violation continues and may be enjoined from continuing the violations as provided in this section.

1 A person or operator who fails to correct a violation within the period permitted by law, rule of the board, or order
2 of the department must be assessed a penalty of not less than \$750 for each day, up to 30 days, during which
3 the failure or violation continues.

4 (b) Penalties assessed under this section must be determined in accordance with the penalty factors
5 in 82-4-1001.

6 (c) The period permitted for correction of a violation does not, in the case of any review proceeding under
7 82-4-251(6), end until entry of a final order suspending the abatement requirements or until entry of an order of
8 court ordering suspension of the abatement requirements. If the failure to abate continues for more than 30 days,
9 the department shall, within 30 days after the 30-day period, take appropriate action pursuant to 82-4-251(3) or
10 request action under subsection (4) or (6) of this section.

11 (2) The department may waive the penalty for a minor violation of this part, a rule adopted or an order
12 issued under this part, or a term or condition of a permit if the department determines that the violation is not of
13 potential harm to public health, public safety, or the environment and does not impair the administration of this
14 part. The department may not waive a penalty assessed under this section if the person or operator fails to abate
15 the violation as directed under 82-4-251. The ~~board~~ department shall adopt rules to implement and administer
16 a procedure for waiver of a penalty under this subsection.

17 (3) (a) To assess an administrative penalty under this section, the department shall issue a notice of
18 violation and penalty order to the person or operator, unless the penalty is waived pursuant to subsection (2). The
19 notice and order must specify the provision of this part, rule adopted or order issued under this part, or term or
20 condition of a permit that is violated and must contain findings of fact, conclusions of law, and a statement of the
21 proposed administrative penalty. The notice and order must be served personally or by certified mail. Service by
22 mail is complete 3 business days after the date of mailing. The notice and order become final unless, within 30
23 days after the order is served, the person or operator to whom the order was issued requests a hearing before
24 the ~~board~~ department. By submitting to the ~~board~~ department a written request within 30 days of service of the
25 notice of violation, stating the reason for the request, the person or operator is entitled to a hearing before the
26 ~~board~~ department under 82-4-206 on the issues of whether the alleged violation has occurred and whether the
27 penalty proposed to be assessed is proper. On receipt of a request, the ~~board~~ department shall schedule a
28 hearing. After a hearing, the ~~board~~ department shall make findings of fact and issue a written decision as to the
29 occurrence of the violation and the amount of penalty warranted. If the ~~board~~ department finds that the violation
30 occurred and a penalty is warranted, it shall order the payment of the penalty. If the time for requesting a hearing

1 expires without a hearing request, the person or operator shall remit the amount of the penalty within 30 days of
2 the expiration of the period for requesting a hearing.

3 (b) If the person or operator to whom a final order is issued under subsection (3)(a) wishes to obtain
4 judicial review of the order, the person or operator shall submit with any assessed penalty a statement that the
5 penalty is being paid under protest and the department shall hold the payment in escrow until judicial review is
6 complete. Any person or operator who fails to request and submit testimony at the hearing provided for in
7 subsection (3)(a) or who fails to pay any assessed penalty under protest within 30 days of the order assessing
8 the penalty forfeits the right to seek judicial review of the violation and penalty determinations.

9 (c) Penalties provided for in this section are recoverable in an action brought by the department. The
10 action must be filed in the district court of the first judicial district, Lewis and Clark County, if mutually agreed on
11 by the parties in the action, or in the district court having jurisdiction over the defendant.

12 (4) The department may bring an action for a restraining order or temporary or permanent injunction
13 against an operator or other person who:

14 (a) violates, threatens to violate, or fails or refuses to comply with any order or decision issued under this
15 part;

16 (b) interferes with, hinders, or delays the department in carrying out the provisions of this part;

17 (c) refuses to admit an authorized representative of the department to the permit area;

18 (d) refuses to permit inspection of the permit area by an authorized representative of the department;

19 (e) refuses to furnish any information or report requested by the department in furtherance of the
20 provisions of this part; or

21 (f) refuses to permit access to and copying of records that the department determines to be necessary
22 in carrying out the provisions of this part.

23 (5) Any relief granted by a court under subsection (4)(a) continues in effect until the completion or final
24 termination of all proceedings for review of relief granted under this part unless, prior to the final determination,
25 the district court granting the relief sets it aside or modifies it.

26 (6) A person who violates any of the provisions of this part or any determination or order issued under
27 this part or who purposely or knowingly violates any permit condition issued under this part is guilty of a
28 misdemeanor and shall be fined an amount not less than \$500 and not more than \$10,000 or be imprisoned for
29 not more than 1 year, or both. Each day on which the violation occurs constitutes a separate offense.

30 (7) A person who knowingly makes any false statement, representation, or certification or knowingly fails

1 to make any statement, representation, or certification in any application, record, report, plan, or other document
2 filed or required to be maintained pursuant to this part shall upon conviction be punished by a fine of not more

11 to engage in the mining of rock products from the landowner's land may obtain an operating permit for multiple
12 sites if each of the multiple sites does not:

13 (i) operate within 100 feet of surface water or in ground water or impact any wetland, surface water, or
14 ground water;

15 (ii) have any water impounding structures other than for storm water control;

16 (iii) have the potential to produce acid, toxic, or otherwise pollutive solutions;

17 (iv) adversely impact a member of or the critical habitat of a member of a wildlife species that is listed as
18 threatened or endangered under the Endangered Species Act of 1973; or

19 (v) impact significant historic or archaeological features.

20 (b) A landowner who is a permittee and who allows another person to mine on the landowner's land
21 remains responsible for compliance with this part, the rules adopted pursuant to this part, and the permit for all
22 mining activities conducted on sites permitted pursuant to this subsection (2) with the landowner's permission.
23 The performance bond required under this part is and must be conditioned upon compliance with this part, the
24 rules adopted pursuant to this part, and the permit of the landowner and any person who mines with the
25 landowner's consent.

26 (3) A small miner who intends to use a cyanide ore-processing reagent or other metal leaching solvents
27 or reagents shall obtain an operating permit for that part of the small miner's operation where the cyanide
28 ore-processing reagent or other metal leaching solvents or reagents will be used or disposed of.

29 (4) (a) Prior to receiving an operating permit from the department, a person shall pay the basic permit
30 fee of \$500. The department may require a person who is applying for a permit pursuant to subsection (1) to pay

1 an additional fee not to exceed the actual amount of contractor and employee expenses beyond the normal
2 operating expenses of the department whenever those expenses are reasonably necessary to provide for timely
3 and adequate review of the application, including any environmental review conducted under Title 75, chapter
4 1, parts 1 and 2. The ~~board~~ department may further define these expenses by rule. Whenever the department
5 determines that an additional fee is necessary and the additional fee will exceed \$5,000, the department shall
6 notify the applicant that a fee must be paid and submit to the applicant an itemized estimate of the proposed
7 expenses. The department shall provide the applicant an opportunity to review the department's estimated
8 expenses. The applicant may indicate which proposed expenses the applicant considers duplicative or excessive,
9 if any.

10 (b) (i) Subject to subsection (4)(b)(ii), a contractor shall, at the request of the applicant, directly submit
11 invoices of contractor expenses to the applicant.

12 (ii) A contractor's work is assigned, reviewed, accepted, or rejected by the department pursuant to this
13 section.

14 (5) The person shall submit an application on a form provided by the department, which must contain
15 the following information and any other pertinent data required by rule:

16 (a) the name and address of the operator, the engineer of record if applicable, and, if a corporation or
17 other business entity, the name and address of its officers, directors, owners of 10% or more of any class of
18 voting stock, partners, and the like and its resident agent for service of process, if required by law;

19 (b) the minerals expected to be mined;

20 (c) a proposed reclamation plan;

21 (d) the expected starting date of operations;

22 (e) a map showing the specific area to be mined and the boundaries of the land that will be disturbed,
23 the topographic detail, the location and names of all streams, roads, railroads, and utility lines on or immediately
24 adjacent to the area, and the location of proposed access roads to be built;

25 (f) the names and addresses of the owners of record and any purchasers under contracts for deed of
26 the surface of the land within the permit area and the owners of record and any purchasers under contracts for
27 deed of all surface area within one-half mile of any part of the permit area, provided that the department is not
28 required to verify this information;

29 (g) the names and addresses of the present owners of record and any purchasers under contracts for
30 deed of all minerals in the land within the permit area, provided that the department is not required to verify this

1 information;

2 (h) the source of the applicant's legal right to mine the mineral on the land affected by the permit,
3 provided that the department is not required to verify this information;

4 (i) the types of access roads to be built and manner of reclamation of road sites on abandonment;

5 (j) a plan that will provide, within limits of normal operating procedures of the industry, for completion of
6 the operation;

7 (k) ground water and surface water hydrologic data gathered from a sufficient number of sources and
8 length of time to characterize the hydrologic regime;

9 (l) a plan detailing the design, operation, and monitoring of impounding structures, including but not
10 limited to tailings impoundments and water reservoirs, sufficient to ensure that the structures are safe and stable.
11 For a tailings storage facility, this requirement is met by submission of a design document pursuant to 82-4-376,
12 a panel report pursuant to 82-4-377, and a tailings operation, maintenance, and surveillance manual pursuant
13 to 82-4-379 prior to issuance of a draft permit.

14 (m) a plan identifying methods to be used to monitor for the accidental discharge of objectionable
15 materials and remedial action plans to be used to control and mitigate discharges to surface or ground water;

16 (n) an evaluation of the expected life of any tailings impoundment or waste area and the potential for
17 expansion of the tailings impoundment or waste site. For a tailings storage facility, this requirement is met by
18 submission of a design document pursuant to 82-4-376, a panel report pursuant to 82-4-377, and a tailings
19 operation, maintenance, and surveillance manual pursuant to 82-4-379 prior to issuance of a draft permit.

20 (o) an assessment of the potential for the postmining use of mine-related facilities for other industrial
21 purposes, including evidence of consultation with the county commission of the county or counties where the
22 mine or mine-related facilities will be located.

23 (6) Except as provided in subsection (8), the permit provided for in subsection (1) for a large-scale
24 mineral development, as defined in 90-6-302, must be conditioned to provide that activities under the permit may
25 not commence until the impact plan is approved under 90-6-307 and until the permittee has provided a written
26 guarantee to the department and to the hard-rock mining impact board of compliance within the time schedule
27 with the commitment made in the approved impact plan, as provided in 90-6-307. If the permittee does not comply
28 with that commitment within the time scheduled, the department, upon receipt of written notice from the hard-rock
29 mining impact board, shall suspend the permit until it receives written notice from the hard-rock mining impact
30 board that the permittee is in compliance.

1 (7) When the department determines that a permittee has become or will become a large-scale mineral
2 developer pursuant to 82-4-339 and 90-6-302 and provides notice as required under 82-4-339, within 6 months
3 of receiving the notice, the permittee shall provide the department with proof that the permittee has obtained a
4 waiver of the impact plan requirement from the hard-rock mining impact board or that the permittee has filed an
5 impact plan with the hard-rock mining impact board and the appropriate county or counties. If the permittee does
6 not file the required proof or if the hard-rock mining impact board certifies to the department that the permittee
7 has failed to comply with the hard-rock mining impact review and implementation requirements in Title 90, chapter
8 6, parts 3 and 4, the department shall suspend the permit until the permittee files the required proof or until the
9 hard-rock mining impact board certifies that the permittee has complied with the hard-rock mining impact review
10 and implementation requirements.

11 (8) Compliance with 90-6-307 is not required for exploration and bulk sampling for metallurgical testing
12 when the aggregate samples are less than 10,000 tons.

13 (9) A person may not be issued an operating permit if:

14 (a) that person's failure, or the failure of any firm or business association of which that person was a
15 principal or controlling member, to comply with the provisions of this part, the rules adopted under this part, or
16 a permit or license issued under this part has resulted in either the receipt of bond proceeds by the department
17 or the completion of reclamation by the person's surety or by the department, unless that person meets the
18 conditions described in 82-4-360;

19 (b) that person has not paid a penalty for which the department has obtained a judgment pursuant to
20 82-4-361;

21 (c) that person has failed to post a reclamation bond required by 82-4-305; or

22 (d) that person has failed to comply with an abatement order issued pursuant to 82-4-362, unless the
23 department has completed the abatement and the person has reimbursed the department for the cost of
24 abatement.

25 (10) A person may not be issued a permit under this part unless, at the time of submission of a bond, the
26 person provides the current information required in subsection (5)(a) and:

27 (a) (i) certifies that the person is not currently in violation in this state of any law, rule, or regulation of
28 this state or of the United States pertaining to air quality, water quality, or mined land reclamation; or

29 (ii) presents a certification by the administering agency that the violation is in the process of being
30 corrected to the agency's satisfaction or is the subject of a bona fide administrative or judicial appeal; and

1 (b) if the person is a partnership, corporation, or other business association, provides the certification
2 required by subsection (10)(a)(i) or (10)(a)(ii), as applicable, for any partners, officers, directors, owners of 10%
3 or more of any class of voting stock, and business association members."
4

5 **Section 193.** Section 82-4-338, MCA, is amended to read:

6 **"82-4-338. Performance bond.** (1) (a) An applicant for an exploration license or operating permit shall
7 file with the department a bond payable to the state of Montana with surety satisfactory to the department in the
8 sum to be determined by the department of not less than \$200 for each acre or fraction of an acre of the disturbed
9 land, conditioned upon the faithful performance of the requirements of this part, the rules of the ~~board~~ department,
10 and the permit. In lieu of a bond, the applicant may file with the department a cash deposit, an assignment of a
11 certificate of deposit, an irrevocable letter of credit, or other surety acceptable to the department. The bond may
12 not be less than the estimated cost to the state to ensure compliance with Title 75, chapters 2 and 5, this part,
13 the rules, and the permit, including the potential cost of department management, operation, and maintenance
14 of the site upon temporary or permanent operator insolvency or abandonment, until full bond liquidation can be
15 effected.

16 (b) A public or governmental agency may not be required to post a bond under the provisions of this part.

17 (c) A blanket performance bond covering two or more operations may be accepted by the department.
18 A blanket bond must adequately secure the estimated total number of acres of disturbed land.

19 (d) (i) For an exploration license or operating permit authorizing activities on federal land within the state,
20 the department may accept a bond payable to the state of Montana and the federal agency administering the
21 land. The bond must provide at least the same amount of financial guarantee as required by this part.

22 (ii) The bond must provide that the department may forfeit the bond without the concurrence of the federal
23 land management agency. The bond may provide that the federal land management agency may forfeit the bond
24 without the concurrence of the department. Upon forfeiture by either agency, the bond must be payable to the
25 department and may also be payable to the federal land management agency. If the bond is payable to the
26 department and the federal land management agency, the department, before accepting the bond, shall enter
27 into an agreement or memorandum of understanding with the federal land management agency providing for
28 administration of the bond funds in a manner that will allow the department to provide for compliance with the
29 requirements of this part, the rules adopted under this part, and the permit.

30 (iii) The department may not enter into an agreement or memorandum of understanding with a federal

1 land management agency that would require the department to impose requirements on an operator that are
2 more stringent than state law and rules.

3 (2) (a) The department may calculate one or more reclamation plan components within its jurisdiction
4 with the assistance of one or more third-party contractors selected jointly by the department and the applicant
5 and compensated by the applicant when, based on relevant past experience, the department determines that
6 additional expertise is necessary to calculate the bond amount for reclamation plan components. The department
7 may contract for assistance pursuant to this subsection in determining bond amounts for the initial bond and for
8 any subsequent bond review and adjustment. The mine owner is responsible for the first \$5,000 in contractor
9 services provided under this subsection. The mine owner and the department are each responsible for 50% of
10 any amount over \$5,000.

11 (b) To select a third-party contractor as authorized in subsection (2)(a), the department shall prepare
12 a list of no fewer than four contractors acceptable to the department and shall provide the applicant with a copy
13 of the list. The applicant shall provide the department with a list of at least 50% of the contractors from the
14 department's list. The department shall select its contractor from the list provided by the applicant.

15 (3) (a) The department shall conduct an overview of the amount of each bond annually and shall conduct
16 a comprehensive bond review at least every 5 years. The department may conduct additional comprehensive
17 bond reviews if, after modification of a reclamation or operation plan, an annual overview, or an inspection of the
18 permit area, the department determines that an increase of the bond level may be necessary. The department
19 shall consult with the licensee or permittee if a review indicates that the bond level should be adjusted. When
20 determined by the department that the set bonding level of a permit or license does not represent the present
21 costs of compliance with this part, the rules, and the permit, the department shall modify the bonding
22 requirements of that permit or license. The licensee or permittee must have 60 days to negotiate the preliminary
23 bond determination with the department, at the end of which time period the department shall issue the proposed
24 bond determination. The department shall give the licensee or permittee a copy of the bond calculations that form
25 the basis for the proposed bond determination and, for operating permits, publish notice of the proposed bond
26 determination in a newspaper of general circulation in the county in which the operation is located. The
27 department shall issue a final bond determination in 30 days. Unless the licensee or permittee requests a hearing
28 under subsection (3)(b), the licensee or permittee shall post bond with the department in the amount represented
29 by the final bond determination no later than 30 days after issuance of the final bond determination. If the licensee
30 or permittee demonstrates that, through the exercise of reasonable diligence, the licensee or permittee will not

1 be able to post the bond within 30 days, the department shall grant a 30-day extension of the deadline.

2 (b) The permittee or any person with an interest that may be adversely affected may obtain a contested
3 case hearing before the ~~board~~ department under the provisions of the Montana Administrative Procedure Act,
4 Title 2, chapter 4, part 6, on the final bond determination by filing with the department, within 30 days of the
5 issuance of the final bond determination, a written request for hearing stating the reason for the request. The
6 request for hearing must specify the amount of bond increase, if any, that the licensee or permittee considers
7 appropriate and state the reasons that the licensee or permittee considers the department's final bond
8 determination to be excessive. As a condition precedent to any right to request a hearing, the licensee or
9 permittee shall post bond with the department in the amount of the bond increase that the licensee or permittee
10 has stated is appropriate in the request for hearing or the amount that is one-half of the increase contained in the
11 department's final bond determination, whichever amount is greater. If the ~~board~~ department determines that
12 additional bond is necessary, the licensee or permittee shall post bond in the amount determined by the ~~board~~
13 department within 30 days of receipt of the ~~board's~~ department's decision. If the licensee or permittee
14 demonstrates that, through the exercise of reasonable diligence, the licensee or permittee will not be able to post
15 the bond within 30 days, the department shall grant a reasonable extension of the deadline.

16 (c) If a licensee or permittee fails to post bond in accordance with subsection (3)(a) or (3)(b) in the
17 required amounts by the required deadlines, the license or permit is suspended by operation of law and the
18 licensee or permittee shall immediately cease mining and exploration operations until the required bond is posted
19 with and approved by the department.

20 (4) A bond filed in accordance with the provisions of this part may not be released by the department
21 until the provisions of this part, the rules adopted pursuant to this part, and the permit have been fulfilled.

22 (5) A bond filed for an operating permit obtained under 82-4-335 may not be released or decreased until
23 the public has been provided an opportunity for a hearing and a hearing has been held if requested. The
24 department shall provide reasonable statewide and local notice of the opportunity for a hearing, including but not
25 limited to publishing the notice in newspapers of general daily circulation.

26 (6) Except as provided in subsection (7), all bonds required in accordance with the provisions of this
27 section must be based upon reasonably foreseeable activities that the applicant may conduct in order to comply
28 with conditions of an operating permit or license. Bonds may be required only for anticipated activities as
29 described in subsection (1). Only those activities that themselves or in conjunction with other activities have a
30 reasonable possibility of occurring may be bonded. Bond calculations, including calculations for the initial bond

1 or for subsequent bond reviews and adjustments, may not include amounts for any occurrence or contingency
2 that is not a reasonably foreseeable result of any activity conducted by the applicant.

3 (7) (a) If the department determines, based on unanticipated circumstances that are discovered following
4 the issuance of a mining permit, that a substantial and imminent danger to public health, public safety, or the
5 environment exists or that there is a reasonable probability that a violation of water quality standards will occur,
6 the department may require an operator to submit an amended reclamation plan to address the danger and to
7 post a temporary bond to guarantee the performance of the amended portion of the reclamation plan. The
8 temporary bond may only be required if the anticipated costs associated with the plan amendment would increase
9 the total bond amount for the current plan by more than 10%, as determined in subsection (7)(b).

10 (b) (i) In determining the need for the temporary bond and the amount of the temporary bond under
11 subsection (7)(a), the department shall select a third-party contractor in consultation with the operator pursuant
12 to subsection (7)(b)(ii) to provide:

13 (A) a technical engineering analysis and report on the substantial and imminent danger to public health,
14 public safety, or the environment identified in subsection (7)(a); and

15 (B) the estimated costs of addressing the potential danger in order to establish the amount of the
16 temporary bond.

17 (ii) The department shall provide the operator with a list of at least four qualified third-party contractors.
18 The operator shall select two qualified third-party contractors from that list. The department shall select its
19 contractor from the list provided by the operator. The operator shall reimburse the department for the reasonable
20 costs of the third-party contractor.

21 (c) An approved interim amended reclamation plan and interim bond must remain in effect until the
22 earlier of:

23 (i) the date that a revised reclamation plan is approved pursuant to 82-4-337 and a permanent bond for
24 the revised reclamation plan is submitted and accepted pursuant to this section; or

25 (ii) 2 years following the date of submission of a complete application pursuant to 82-4-337 to modify the
26 reclamation plan provision or remedy the conditions that created the need to amend the reclamation plan unless
27 the department approves or denies the complete application within 2 years of submission. The applicant may
28 agree to an extension of this deadline.

29 (d) Except as provided in subsection (8), the process provided for in this subsection (7) is not subject
30 to the provisions of Title 75, chapter 1.

1 (8) (a) In determining whether to require amendment of a reclamation plan under subsection (7)(a), the
2 department shall prepare or require the permittee to prepare a written analysis of changes in the reclamation plan
3 that may eliminate or mitigate to an acceptable level the environmental condition. The analysis must include an
4 assessment of the effectiveness of the changes and any potential negative environmental impacts of the
5 changes. The department shall prepare an environmental impact statement pursuant to Title 75, chapter 1, only
6 if the department determines that the changes would not mitigate the condition to an acceptable level or may have
7 potentially significant negative environmental impacts.

8 (b) If the department determines that preparation of an environmental impact statement is necessary,
9 the permittee shall pay the department's costs pursuant to 75-1-205.

10 (9) At the applicant's discretion, bonding in addition to that required by this section may be posted. These
11 unobligated bonds may, on the applicant's request, be applied to future bonds required by this section.

12 (10) (a) If the department determines that there exists at an area permitted or licensed under this part
13 an imminent danger to public health, public safety, or the environment caused by a violation of this part, the rules
14 adopted pursuant to this part, or the permit or license and if the permittee or licensee fails or refuses to
15 expeditiously abate the danger, the department may immediately suspend the permit or license, enter the site,
16 and abate the danger. The department may thereafter institute proceedings to revoke the license or permit,
17 declare the permittee or licensee in default, and forfeit a portion of the bond, not to exceed \$150,000 or 10% of
18 the bond, whichever is less, to be used to abate the danger. The department shall notify the surety of the
19 forfeiture and the forfeiture amount by certified mail, and the surety shall pay the forfeiture amount to the
20 department within 30 days of receipt of the notice. The department shall, as a condition of any termination of the
21 suspension and revocation proceedings, require that the permittee or licensee reimburse the surety, with interest,
22 for any amount paid to and expended by the department pursuant to this subsection (10) and for the actual cost
23 of the surety's expenses in responding to the department's forfeiture demand.

24 (b) If the department is unable to permanently abate the imminent danger using the amount forfeited
25 under subsection (10)(a), the department may forfeit additional amounts under the procedure provided in
26 subsection (10)(a).

27 (c) The department shall return to the surety any money received from the surety pursuant to this
28 subsection (10) and not used by the department to abate the imminent danger. The amount not returned to the
29 surety must be credited to the surety and reduces the penal amount of the bond on a dollar-for-dollar basis.

30 (d) Any interest accrued on bond proceeds that is not required to abate the imminent danger determined

1 in subsection (10)(a) must be returned to the surety, unless otherwise agreed to in writing by the surety.

2 (11) If a bond is terminated as a result of the action or inaction of a licensee or permittee or is canceled
3 or otherwise terminated by the surety issuing the bond and the licensee or permittee fails to post a new bond for
4 the entire amount of the terminated bond within 30 days following the notice of termination provided to the
5 department, then the license or permit must be immediately suspended without further action by the department."

7 **Section 194.** Section 82-4-339, MCA, is amended to read:

8 **"82-4-339. Annual report of activities by permittee -- fee -- notice of large-scale mineral developer**

9 **status.** (1) Within 30 days after completion or abandonment of operations on an area under permit or within 30
10 days after each anniversary date of the permit, whichever is earlier, or at a later date that may be provided by
11 ~~rules of the board~~ rule and each year after that date until reclamation is completed and approved, the permittee
12 shall pay the annual fee of \$100 and shall file a report of activities completed during the preceding year on a form
13 prescribed by the department. The report must:

14 (a) identify the permittee and the permit number;

15 (b) locate the operation by subdivision, section, township, and range and with relation to the nearest town
16 or other well-known geographic feature;

17 (c) estimate acreage to be newly disturbed by operation in the next 12-month period;

18 (d) include the number of persons on the payroll for the previous permit year and for the next permit year
19 at intervals that the department considers sufficient to enable a determination of the permittee's status under
20 90-6-302(4);

21 (e) update the information required in 82-4-335(5)(a); and

22 (f) update any maps previously submitted or specifically requested by the department. The maps must
23 show:

24 (i) the permit area;

25 (ii) the unit of disturbed land;

26 (iii) the area to be disturbed during the next 12-month period;

27 (iv) if completed, the date of completion of operations;

28 (v) if not completed, the additional area estimated to be further disturbed by the operation within the
29 following permit year; and

30 (vi) the date of beginning, amount, and current status of reclamation performed during the previous 12

1 months.

2 (2) Whenever the department determines that the permittee has become or will, during the next permit
3 year, become a large-scale mineral developer, it shall immediately serve written notice of that fact on the
4 permittee, the hard-rock mining impact board, and the county or counties in which the operation is located."

5

6 **Section 195.** Section 82-4-342, MCA, is amended to read:

7 **"82-4-342. Amendment to operating permits.** (1) During the term of an operating permit issued under
8 this part, an operator may apply for a permit revision as described in subsections (5)(g) through (5)(j) or an
9 amendment to the permit. The operator may not apply for an amendment to delete disturbed acreage except
10 following reclamation, as required under 82-4-336, and bond release for the disturbance, as required under
11 82-4-338.

12 (2) (a) The board department may by rule establish criteria for the classification of amendments as major
13 or minor. The board department shall adopt rules establishing requirements for the content of applications for
14 revisions and major and minor amendments and the procedures for processing revisions and minor amendments.

15 (b) An amendment must be considered minor if:

16 (i) it is for the purpose of retention of mine-related facilities that are valuable for postmining use;

17 (ii) evidence is submitted showing that a local government has requested retention of the mine- related
18 facilities for a postmining use; and

19 (iii) the postmining use of the mine-related facilities meets the requirements provided for in 82-4-336.

20 (3) Applications for major amendments must be processed pursuant to 82-4-337.

21 (4) The department shall review an application for a revision or a minor amendment and provide a notice
22 of decision on the adequacy of the application within 30 days. If the department does not respond within 30 days,
23 then the permit is revised or amended in accordance with the application.

24 (5) The department is not required to prepare an environmental assessment or an environmental impact
25 statement for the following categories of action and permit revisions:

26 (a) actions that qualify for a categorical exclusion as defined by rule or justified by a programmatic review
27 pursuant to Title 75, chapter 1;

28 (b) administrative actions, such as routine, clerical, or similar functions of a department, including but
29 not limited to administrative procurement, contracts for consulting services, and personnel actions;

30 (c) repair or maintenance of the permittee's equipment or facilities;

1 (d) investigation and enforcement actions, such as data collection, inspection of facilities, or enforcement
2 of environmental standards;

3 (e) ministerial actions, such as actions in which the agency does not exercise discretion, but acts upon
4 a given state of facts in a prescribed manner;

5 (f) approval of actions that are primarily social or economic in nature and that do not otherwise affect the
6 human environment;

7 (g) changes in a permit boundary that increase disturbed acres that are insignificant in impact relative
8 to the entire operation, provided that the increase is less than 25 acres or 10% of the permitted area, whichever
9 is less;

10 (h) changes to an approved reclamation plan if the changes are consistent with this part and rules
11 adopted pursuant to this part;

12 (i) changes in an approved operating plan for an activity that was previously permitted if the changes will
13 be insignificant relative to the entire operation and the changes are consistent with subsection (5)(g);

14 (j) changes in a permit for the purpose of retention of mine-related facilities that are valuable for
15 postmining use; and

16 (k) modifications to a tailings storage facility that result in a minor expansion to the facility if:

17 (i) the proposed modification is certified by the seal of the engineer of record;

18 (ii) the capacity increase resulting from the expansion is no greater than 15% of the capacity of the
19 existing tailings storage facility; and

20 (iii) the modification complies with 82-4-376(2)(l) and (2)(dd) and is exempt under subsection (5)(g),
21 (5)(h), or (5)(i) of this section."

22

23 **Section 196.** Section 82-4-353, MCA, is amended to read:

24 **"82-4-353. Administrative remedies -- notice -- appeals -- parties.** (1) Upon receipt of an application
25 for an operating permit, the department shall provide notice of the application by publication in a newspaper of

12 (3) The ~~board~~ department may acquire the necessary property by gift or purchase, or if the property
13 cannot be acquired by gift or purchase at a reasonable cost, proceedings may be instituted in the manner
14 provided in Title 70, chapter 30, against all nonaccepting landholders if:

15 (a) acquisition of the property is necessary for successful reclamation;

16 (b) the acquired property after restoration or reclamation or after abatement, control, or prevention of the
17 adverse effects of past mining practices will serve recreation and historic purposes or conservation and
18 reclamation purposes or provide open space benefits; and

19 (c) (i) permanent facilities, such as treatment plants or relocated stream channels, will be constructed
20 on the property for the restoration or reclamation of the property or for abatement, control, or prevention of the
21 adverse effects of past mining practices; or

22 (ii) acquisition of refuse disposal sites and all refuse on the sites will serve the purposes of this part in
23 that public ownership is desirable to meet emergency situations and prevent recurrences of the adverse effects
24 of past mining practices.

25 (4) The department may record in the office of the clerk and recorder in the county in which property that
26 has been reclaimed pursuant to 82-4-424 or this section is located a notice that the property has been mined and
27 reclaimed. The notice must include the date and a brief description of the reclamation."

29 **Section 208.** Section 82-4-1001, MCA, is amended to read:

30 **"82-4-1001. Penalty factors.** (1) In determining the amount of an administrative or civil penalty assessed

1 under the statutes listed in subsection (4), the department of environmental quality or the district court, as
2 appropriate, shall take into account the following factors:

3 (a) the nature, extent, and gravity of the violation;

4 (b) the circumstances of the violation;

5 (c) the violator's prior history of any violation, which:

6 (i) must be a violation of a requirement under the authority of the same chapter and part as the violation
7 for which the penalty is being assessed;

8 (ii) must be documented in an administrative order or a judicial order or judgment issued within 3 years
9 prior to the date of the occurrence of the violation for which the penalty is being assessed; and

10 (iii) may not, at the time that the penalty is being assessed, be undergoing or subject to administrative
11 appeal or judicial review;

12 (d) the economic benefit or savings resulting from the violator's action;

13 (e) the violator's good faith and cooperation;

15 or mitigate the violation or impacts of the violation; and

16 (g) other matters that justice may require.

17 (2) Except for penalties assessed under 82-4-254, after the amount of a penalty is determined under (1),
18 the department of environmental quality or the district court, as appropriate, may consider the violator's financial
19 ability to pay the penalty and may institute a payment schedule or suspend all or a portion of the penalty.

20 (3) Except for penalties assessed under 82-4-254, the department of environmental quality may accept
21 a supplemental environmental project as mitigation for a portion of the penalty. For purposes of this section, a
22 "supplemental environmental project" is an environmentally beneficial project that a violator agrees to undertake

24 (4) This section applies to penalties assessed by the department of environmental quality or the district

29 **Section 209.** Section 82-15-102, MCA, is amended to read:

30 **"82-15-102. Enforcement of part -- rules.** (1) Except as provided in subsection (2), this part must be

1 enforced by the department. It may adopt necessary and reasonable rules for the implementation of the
2 provisions and intent of this part, and those rules have the effect of law.

3 (2) Section 82-15-110(8) must be enforced by the department of environmental quality.

4 (3) The ~~board of environmental review~~ department of environmental quality shall adopt rules for the
5 regulation of methyl tertiary butyl ether in accordance with this part. The rules must establish:

6 (a) a trace level or trace levels of methyl tertiary butyl ether that may be contained in gasoline that is
7 imported into the state, stored, distributed, sold, offered or exposed for sale, or dispensed in the state of Montana.

8 The ~~board~~ department of environmental quality shall establish trace levels in a manner that prevents the

15 **Section 210.** Section 82-15-120, MCA, is amended to read:

16 **"82-15-120. Department of environmental quality to enforce prohibition on methyl tertiary butyl**
17 **ether -- notice requirements -- hearing -- penalties.** (1) (a) Whenever the department of environmental quality
18 believes that a violation of 82-15-110(8) or of the rules adopted pursuant to 82-15-102(3) has occurred, it may
19 serve written notice of the violation on the alleged violator or an agent of the alleged violator.

20 (b) The notice must specify the facts alleged to constitute a violation and may include an order assessing
21 an administrative penalty pursuant to subsection (3), an order to take necessary corrective action within a
22 reasonable period of time stated in the order, or both.

23 (c) The order becomes final unless, within 30 days after the notice is served, the person named in the
24 order requests in writing a hearing before the ~~board of environmental review~~ department of environmental quality.
25 Service by mail is complete on the date of mailing.

26 (d) Upon receipt of the request, the ~~board of environmental review~~ department of environmental quality
27 shall schedule a hearing. The contested case provisions of the Montana Administrative Procedure Act provided

 8 under this section is subject to a civil penalty not to exceed \$5,000 for each violation. Each day of violation

 11 relief, including temporary and permanent injunctions and penalties under subsection (4) of this section, for a

 13 section. The action must be brought in the district court of the first judicial district, Lewis and Clark County, or in
