**Insert:** "(c)(i) The practice of dental hygiene also includes prescriptive authority limited to fluoride agents, topical oral anesthetic agents, and nonsystemic oral antimicrobials that:

- (A) are not controlled substances;
- (B) do not require a license by the federal drug enforcement agency; and
- (C) are identified in a drug formulary approved by the board through rule in consultation with the board of pharmacy. For purposes of this section, the board's consultation with the board of pharmacy must be done when necessary.
  - (ii) Prescriptive authority under this section must be:
  - (A) done under the general supervision of a licensed dentist;
  - (B) pursuant to rules adopted by the board; and
- (C) in compliance with applicable laws concerning prescription packaging, labeling, and recordkeeping requirements. (iii) The board shall determine by rule the education and competency requirements required for dental hygiene prescriptive authority.
- (iv) The board shall determine by rule the percentage of fluoride, chlorhexidine gluconate, or any other active ingredients in any medication that may be prescribed by a dental hygienist under this section."
