### **MESSAGES FROM THE GOVERNOR**

March 31, 2017

The Honorable Scott Sales President of the Senate State Capitol Helena, MT 59620

Dear President Sales:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby **return with amendments Senate Bill 189** (SB 189), "AN ACT REVISING PROTEST PROCEDURES FOR CREATION OF A SPECIAL PURPOSE DISTRICT; REMOVING THE REQUIREMENT THAT A SPECIAL PURPOSE DISTRICT FORM SPECIFY THAT A PROPERTY OWNER'S LACK OF ACTION BE CONSTRUED AS SUPPORT FOR CREATION OF THE DISTRICT; CLARIFYING THAT ONLY FORMS RETURNED WITH SUPPORT FOR OR OPPOSITION AGAINST CREATION OF THE DISTRICT MAY BE USED IN DETERMINING SUFFICIENCY OF PROTEST; AND AMENDING SECTION 7-11-1008, MCA."

SB 189 changes the procedures used by local governments to create special purpose districts. Under current law, prior to a special district being created, property owners that will be assessed to pay for the proposed district must be given an opportunity to protest the creation of the special district. Local governments must send protest forms to all of the property owners in the district. If between 10 percent and 50 percent of the total number of property owners in the district protest the proposed special district, then the issue must be put to a referendum. If 50 percent or more of the property owners of the district protest, then the local government must cease action on the

proposed special district for at least 12 months. § 7-11-1008, MCA. The law as it now exists states that not returning a protest form is construed as consent to the formation of the special district. Further, protest forms that are returned that are not marked as either supporting or opposing the district, are counted as opposing the district.

SB 189 would change current law so that only protest forms filled out and returned as opposing the district would count as protest votes. This makes sense. However, the bill also changes the mechanics of how to measure the 10 percent and 50 percent thresholds for a referendum or a 12-month delay of activity. Under existing law, the 10 percent and 50 percent thresholds are calculated as a percentage of the *entire number* of assessed property owners in the district. Under SB 189, the percentage thresholds would be calculated as a percentage of just the *protest forms returned*. This means that a very small minority of protesting property holders could block the formation of a district. In my view, SB 189 upsets the careful balance in existing law between the views of the property holders that pay for such districts, and the needs of the district as a whole.

My amendments preserve the goal of SB 189 in counting only returned protest forms opposing a district as "protest votes," while maintaining the entire number of assessed property owners in the district as the basis for the 10 percent and 50 percent triggers for a referendum or to delay action.

I respectfully ask for your support of these amendments.
