10	WHEREAS, when individuals with Alzheimer's disease or other dementias have the opportunity to
11	maintain their dignity and self-esteem by living at home or in community residential settings their quality of life
12	is increased; and
13	WHEREAS, many individuals with Alzheimer's disease or other dementias deplete their resources and
14	turn to Medicaid to help them stay in their homes or in assisted living; and
15	WHEREAS, 504 Montanans who are entitled to nursing home care were on the waiting list for Medicaid
16	home and community-based waiver services on August 1, 2016; and
17	WHEREAS, the average cost to the Montana Medicaid program for nursing home care is significantly
18	more than the cost for care in assisted living or in the home; and
19	WHEREAS, 92% of Montanans want for themselves or their loved ones to live at home with assistance
20	or in an assisted living or group home in their community if life becomes difficult due to illness; and
21	WHEREAS, there is a need to expand Medicaid home and community-based waiver services and to
22	incentivize providers to offer care to Medicaid members in their homes or in assisted living settings to ensure that
23	Medicaid members can choose the most appropriate setting in which to receive care and avoid unnecessary
24	nursing home placement.

26	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

28	NEW SECTION. Section 1. Appropriation report. (1) (a) The following amounts are appropriated
29	to the department of public health and human services to increase the number of basic and adult residential
30	service slots under the home and community-based medicaid services waiver administered by the senior and

(b) The department shall increase the number of basic and adult residential services slots by 200 slots over the biennium, phasing in 50 slots every 6 months of the biennium.

(2) (a) The following amounts are appropriated to the department of public health and human services to increase the reimbursement rate for adult residential service slots in the home and community-based services waiver administered by the senior and long-term care division for elderly and physically disabled individuals:

- (b) The appropriation provided for in this subsection (2) must be used to:
- (i) increase the base daily reimbursement rate for 85% of the adult residential slots by \$5.80 <u>STARTING</u>

 JULY 1, 2017, AND THEN every 6 months THEREAFTER of the 2019 biennium; and
- (ii) increase the base daily reimbursement rate for up to 15% of the adult residential slots by \$44.90 effective July 1, 2017, to pay for memory care for individuals with Alzheimer's disease or other dementias.
- (3) The department shall report to the children, families, health, and human services interim committee by September 15, 2018, and to the 66th legislature, as provided in 5-11-210, on the effectiveness of the increased waiver slots and enhanced reimbursement rates. The report must include information on:
 - (a) the use of the new waiver slots;
- (b) whether the increased reimbursement rates led to an increase in the number of providers accepting medicaid clients;
- (c) whether the percentage of slots designated for memory care was adequate to address the need forthat care; and
 - (d) whether fewer patients with Alzheimer's disease or other dementias were admitted to state facilities, including the Montana state hospital and the Montana mental health nursing care center. If fewer patients were admitted to state facilities, the department must estimate the amount of money saved by placing fewer individuals
