2 INTRODUCED BY J. TREBAS

4 A BILL FOR AN ACT ENTITLED: "AN ACT REDUCING VEHICLE REGISTRATION FEES FOR SENIORS OVER
5 65; PROVIDING RULEMAKING AUTHORITY; AND AMENDING SECTION 61-3-321, MCA."

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

8

9 NEW SECTION. **Section 1. Reduced registration fee.** (1) For a person who is 65 years of age or
10 older, the registration fee for a light vehicle is 15% less than the corresponding amount listed in 61-3-321(2).

11 (2) A person who is 65 years or age or older may only register one light vehicle under this section.

12 (3) The department shall determine verification of age requirements by rule.

14 **Section 2.** Section 61-3-321, MCA, is amended to read:15 **"61-3-321. Registration fees of vehicles and vessels -- certain vehicles exempt from registration**
16 **fees -- disposition of fees.** (1) Except as otherwise provided in this section, registration fees must be paid upon
17 registration or, if applicable, renewal of registration of motor vehicles, snowmobiles, watercraft, trailers,
18 semitrailers, and pole trailers as provided in subsections (2) through (20).19 (2) ~~Unless~~ Subject to [section 1] and unless a light vehicle is permanently registered under 61-3-562,
20 the annual registration fee for light vehicles, trucks and buses under 1 ton, and logging trucks less than 1 ton is
21 as follows:

22 (a) if the vehicle is 4 or less years old, \$217;

23 (b) if the vehicle is 5 through 10 years old, \$87; and

24 (c) if the vehicle is 11 or more years old, \$28.

25 (3) Except as provided in subsection (15), the one-time registration fee based on the declared weight
26 of a trailer, semitrailer, or pole trailer is as follows:

27 (a) if the declared weight is less than 6,000 pounds, \$61.25; or

28 (b) if the declared weight is 6,000 pounds or more, \$148.25.

29 (4) Except as provided in subsection (15), the one-time registration fee for motor vehicles owned and
30 operated solely as collector's items pursuant to 61-3-411, based on the weight of the vehicle, is as follows:

- 1 (a) 2,850 pounds and over, \$10; and
2 (b) under 2,850 pounds, \$5.
- 3 (5) Except as provided in subsection (15), the one-time registration fee for off-highway vehicles other
4 than a quadricycle or motorcycle is \$61.25.
- 5 (6) The annual registration fee for heavy trucks, buses, and logging trucks in excess of 1 ton is \$22.75.
- 6 (7) (a) The annual registration fee for a motor home, based on the age of the motor home, is as follows:
7 (i) less than 2 years old, \$282.50;
8 (ii) 2 years old and less than 5 years old, \$224.25;
9 (iii) 5 years old and less than 8 years old, \$132.50; and
10 (iv) 8 years old and older, \$97.50.
- 11 (b) The owner of a motor home that is 11 years old or older and that is subject to the registration fee
12 under this section may permanently register the motor home upon payment of:
13 (i) a one-time registration fee of \$237.50;
14 (ii) unless a new set of license plates is being issued, an insurance verification fee of \$5, which must be
15 deposited in the account established under 61-6-158;
16 (iii) if applicable, five times the renewal fees for personalized license plates under 61-3-406; and
17 (iv) if applicable, the donation fee for a generic specialty license plate under 61-3-480 or a collegiate
18 license plate under 61-3-465.
- 19 (8) (a) Except as provided in subsection (15), the one-time registration fee for motorcycles and
20 quadricycles registered for use on public highways is \$53.25, and the one-time registration fee for motorcycles
21 and quadricycles registered for both off-road use and for use on the public highways is \$114.50.
- 22 (b) An additional fee of \$16 must be collected for the registration of each motorcycle or quadricycle as
23 a safety fee, which must be deposited in the state motorcycle safety account provided for in 20-25-1002.
- 24 (9) Except as provided in subsection (15), the one-time registration fee for travel trailers, based on the
25 length of the travel trailer, is as follows:
26 (a) under 16 feet in length, \$72; and
27 (b) 16 feet in length or longer, \$152.
- 28 (10) Except as provided in subsection (15), the one-time registration fee for a motorboat, sailboat,
29 personal watercraft, or motorized pontoon required to be numbered under 23-2-512 is as follows:
30 (a) for a personal watercraft or a motorboat, sailboat, or motorized pontoon less than 16 feet in length,

1 \$65.50;

2 (b) for a motorboat, sailboat, or motorized pontoon at least 16 feet in length but less than 19 feet in
3 length, \$125.50; and

4 (c) for a motorboat, sailboat, or motorized pontoon 19 feet in length or longer, \$295.50.

5 (11) (a) Except as provided in subsections (11)(b) and (15), the one-time registration fee for a
6 snowmobile is \$60.50.

7 (b) (i) A snowmobile that is licensed by a Montana business and is owned exclusively for the purpose
8 of daily rental to customers is assessed:

9 (A) a fee of \$40.50 in the first year of registration; and

10 (B) if the business reregisters the snowmobile for a second year, a fee of \$20.

11 (ii) If the business reregisters the snowmobile for a third year, the snowmobile must be permanently
12 registered and the business is assessed the registration fee imposed in subsection (11)(a).

13 (12) (a) The one-time registration fee for a low-speed electric vehicle is \$25.

14 (b) The one-time registration fee for a golf cart that is owned by a person who has or is applying for a
15 low-speed restricted driver's license is \$25.

16 (c) The one-time registration fee for golf carts authorized to operate on certain public streets and
17 highways pursuant to 61-8-391 is \$25. Upon receipt of the fee, the department shall issue the owner a decal,
18 which must be displayed visibly on the golf cart.

19 (13) (a) Except as provided in subsection (13)(b), a fee of \$10 must be collected when a new set of
20 standard license plates, a new single standard license plate, or a replacement set of special license plates
21 required under 61-3-332 is issued. The \$10 fee imposed under this subsection does not apply when previously
22 issued license plates are transferred under 61-3-335. All registration fees imposed under this section must be
23 paid if the vehicle to which the plates are transferred is not currently registered.

24 (b) An additional fee of \$15 must be collected if a vehicle owner elects to keep the same license plate
25 number from license plates issued before January 1, 2010, when replacement of those plates is required under
26 61-3-332(3).

27 (c) The fees imposed in this subsection (13) must be deposited in the account established under
28 61-6-158, except that \$2 of the fee imposed in subsection (13)(a) must be deposited in the state general fund.

29 (14) The provisions of this part with respect to the payment of registration fees do not apply to and are
30 not binding upon motor vehicles, trailers, semitrailers, snowmobiles, watercraft, or tractors owned or controlled

1 by the United States of America or any state, county, city, or special district, as defined in 18-8-202, or to a vehicle
2 or vessel that meets the description of property exempt from taxation under 15-6-201(1)(a), (1)(d), (1)(e), (1)(g),
3 (1)(h), (1)(i), (1)(k), (1)(l), (1)(n), or (1)(o), 15-6-203, or 15-6-215, except as provided in 61-3-520.

4 (15) Whenever ownership of a trailer, semitrailer, pole trailer, off-highway vehicle, motorcycle,
5 quadricycle, travel trailer, motor home, motorboat, sailboat, personal watercraft, motorized pontoon, snowmobile,
6 motor vehicle owned and operated solely as a collector's item pursuant to 61-3-411, or low-speed electric vehicle
7 is transferred, the new owner shall title and register the vehicle or vessel as required by this chapter and pay the
8 fees imposed under this section.

9 (16) A person eligible for a waiver under 61-3-460 is exempt from the fees required under this section.

10 (17) Except as otherwise provided in this section, revenue collected under this section must be deposited
11 in the state general fund.

12 (18) The fees imposed by subsections (2) through (12) are not required to be paid by a dealer for the
13 enumerated vehicles or vessels that constitute inventory of the dealership.

14 (19) (a) Unless a person exercises the option in either subsection (19)(b) or (19)(c), an additional fee of
15 \$6 must be collected for each light vehicle registered under this part. This fee must be accounted for and
16 transmitted separately from the registration fee. The fee must be deposited in an account in the state special
17 revenue fund to be used for state parks, for fishing access sites, and for the operation of state-owned facilities.
18 Of the \$6 fee, the department of fish, wildlife, and parks shall use \$5.37 for state parks, 25 cents for fishing
19 access sites, and 38 cents for the operation of state-owned facilities at Virginia City and Nevada City.

20 (b) A person who registers a light vehicle may, at the time of annual registration, certify that the person
21 does not intend to use the vehicle to visit state parks and fishing access sites and may make a written election
22 not to pay the additional \$6 fee provided for in subsection (19)(a). If a written election is made, the fee may not
23 be collected.

24 (c) (i) A person who registers one or more light vehicles may, at the time of annual registration, certify
25 that the person does not intend to use any of the vehicles to visit state parks and fishing access sites and may
26 make a written election not to pay the additional \$6 fee provided for in subsection (19)(a). If a written election is
27 made, the fee may not be collected at any subsequent annual registration unless the person makes the written
28 election to pay the additional fee on one or more of the light vehicles.

29 (ii) The written election not to pay the additional fee on a light vehicle expires if the vehicle is registered
30 to a different person.

1 (20) For each light vehicle, trailer, semitrailer, pole trailer, heavy truck, motor home, motorcycle,
2 quadricycle, and travel trailer subject to a registration fee under this section, an additional fee of \$5 must be
3 collected and forwarded to the state for deposit in the account established in 44-1-504.

4 (21) This section does not apply to a motor vehicle, trailer, semitrailer, or pole trailer that is governed by
5 61-3-721."

7 NEW SECTION. **Section 3. Codification instruction.** [Section 1] is intended to be codified as an
8 integral part of Title 61, chapter 3, and the provisions of Title 61, chapter 3, apply to [section 1].
