14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

16	NEW SECTION. Section 1. Definitions. As used in [sections 1 through 5], unless the context requires
17	otherwise, the following definitions apply:
18	(1) "Board" means the board of environmental review provided for in 2-15-3502.
19	(2) "Decommission" or "decommissioning" means removal of wind turbines, buildings, cabling, electrical
20	components, road, and any other associated facilities. The term includes reclamation of surface lands to previous
21	grade and comparable productivity and to prevent adverse hydrologic effects, unless a property owner and the
22	owner of a wind generation facility have reached an agreement concerning alternative restoration of the land
23	surface area and a copy of the agreement is provided to the department.
24	(2) "DECOMMISSION" OR "DECOMMISSIONING" MEANS:
25	(A) THE REMOVAL OF AN ABOVEGROUND WIND TURBINE TOWER AFTER THE END OF A WIND GENERATION
26	FACILITY'S USEFUL LIFE OR ABANDONMENT;
27	(B) EXCEPT AS PROVIDED IN [SECTION 2(2)], THE REMOVAL OF BUILDINGS, CABLING, ELECTRICAL COMPONENTS,
28	ROADS, OR ANY OTHER ASSOCIATED FACILITIES; AND
29	(C) EXCEPT AS PROVIDED IN [SECTION 2(2)], RECLAMATION OF SURFACE LANDS TO THE PREVIOUS GRADE AND
30	TO COMPARABLE PRODUCTIVITY IN ORDER TO PREVENT ADVERSE HYDROLOGIC EFFECTS.

1 (3) "Department" means the department of environmental quality provided for in 2-15-3501. 2 (4) "Owner" means a person who owns a wind generation facility used for the generation of electricity. 3 (5) "Person" means any individual, firm, partnership, company, association, corporation, city, town, or 4 local governmental entity or any other state, federal, or private entity, whether organized for profit or not. 5 (6) "REPURPOSED" MEANS HAVING MADE A SIGNIFICANT INVESTMENT IN AN EXISTING WIND GENERATION FACILITY 6 TO EXTEND THE USEFUL LIFE OF THE FACILITY BY MORE THAN 5 YEARS. 7 (6)(7) "Wind generation facility" means any combination of a physically connected wind turbine or 8 turbines, associated prime movers, and other associated property, including appurtenant land and improvements 9 and personal property, that are normally operated together to produce electric power from wind that have a 10 nameplate capacity greater than or equal to 50 25 megawatts. 11 12 NEW SECTION. Section 2. Bond -- penalty for failure to submit. (1) On or before July 1, 2017, the 13 owner of a wind generation facility operating in Montana shall: 14 (a) notify the department in writing as to the date that the facility began commercial operation; and 15 (b) provide the department with the necessary information in accordance with [sections 1 through 5] and 16 rules adopted pursuant to [sections 1 through 5] in order for the department to determine bond requirements. 17 (2) The owner of a wind generation facility shall submit to the department a bond payable to the state 18 of Montana in a form acceptable by the department and in the sum determined by the department, conditioned 19 upon the faithful decommissioning of the wind generation facility. 20 (3) (a) If a wind generation facility commenced commercial operation on or before January 1, 2017, the 21 operator shall submit the decommissioning bond to the department prior to the conclusion of the 15th year of 22 operation of the wind generation facility. 23 (b) If a wind generation facility commenced commercial operation after January 1, 2017, the operator 24 shall submit the decommissioning bond to the department prior to the conclusion of the 5th year of operation of 25 the wind generation facility. 26 (4) In determining the amount of the bond, the department shall take into consideration the character 27 and nature of the site where the wind generation facility is located. 28 (5) (a) If the owner of a wind generation facility fails to submit a decommissioning bond acceptable to 29 the department within the timeframe required by this section, the department may assess an administrative 30 penalty of not more than \$1,500 and an additional administrative penalty of not more than \$1,500 for each day Legislative - 2 -

1 the failure to submit the decommissioning bond continues. 2 (b) The owner of a wind generation facility may appeal the department's penalty assessment to the board 3 within 20 days after receipt of written notice of the penalty. The contested case provisions of the Montana 4 Administrative Procedures Act, Title 2, chapter 4, part 6, apply to a hearing before the board under this subsection 5 <del>(5).</del> 6 (6) If the owner of a wind generation facility transfers ownership of the facility to a successor owner, the 7 first owner remains responsible for decommissioning the wind generation facility, and the department may not 8 release the bond submitted by the first owner until the successor owner submits a bond acceptable to the 9 department. 10 (7) Submitting a bond in accordance with this section does not absolve the owner of a wind generation 11 facility from complying with applicable regulations and requirements for: 12 (a) areas subject to local zoning adopted under Title 76, chapter 2; 13 (b) military affected areas under Title 10, chapter 1, part 15; or 14 (c) airport affected areas under Title 67, chapter 7. 15 NEW SECTION. Section 2. Bond -- PENALTY FOR FAILURE TO SUBMIT. (1) ON OR BEFORE JULY 1, 2018, 16 17 THE OWNER OF A WIND GENERATION FACILITY OPERATING IN MONTANA SHALL: 18 (A) NOTIFY THE DEPARTMENT IN WRITING OF THE DATE THAT THE FACILITY BEGAN COMMERCIAL OPERATION; 19 (B) SUBJECT TO SUBSECTION (2), SUBMIT A PLAN FOR DECOMMISSIONING THE FACILITY TO THE DEPARTMENT, 20 INCLUDING THE SCOPE OF WORK TO BE COMPLETED AND COST ESTIMATES FOR COMPLETION; AND 21 (C) PROVIDE THE DEPARTMENT WITH ANY OTHER NECESSARY INFORMATION IN ACCORDANCE WITH [SECTIONS] 22 1 THROUGH 5] AND RULES ADOPTED PURSUANT TO [SECTIONS 1 THROUGH 5] IN ORDER FOR THE DEPARTMENT TO 23 DETERMINE BOND REQUIREMENTS IN ACCORDANCE WITH THIS SECTION. 24 (2) IF A PROPERTY OWNER AND THE OWNER OF A WIND GENERATION FACILITY REACH AN AGREEMENT 25 CONCERNING ALTERNATIVE RESTORATION OF BUILDINGS, CABLING, ELECTRICAL COMPONENTS, ROADS, OR ANY OTHER 26 ASSOCIATED FACILITIES, INSTEAD OF REMOVAL; ALTERNATIVE PLANS FOR RECLAMATION OF SURFACE LANDS; OR BOTH 27 ALTERNATIVE RESTORATION AND ALTERNATIVE PLANS FOR RECLAMATION, DECOMMISSIONING DOES NOT INCLUDE 28 REMOVAL, PLANS FOR RECLAMATION, OR BOTH, AS LONG AS A COPY OF THE AGREEMENT IS PROVIDED TO THE 29 DEPARTMENT. 30 (3) IF NECESSARY, THE DEPARTMENT MAY MODIFY A PLAN FOR DECOMMISSIONING TO DETERMINE BOND Legislative - 3 -

12	COMMERCIAL OPERATION ON OR BEFORE JANUARY 1, 2007, THE OPERATOR SHALL SUBMIT THE DECOMMISSIONING BOND
13	TO THE DEPARTMENT PRIOR TO THE CONCLUSION OF THE 16TH YEAR OF OPERATION OF THE WIND GENERATION FACILITY.
14	(B) EXCEPT AS PROVIDED IN SUBSECTIONS (7) AND (8), IF A WIND GENERATION FACILITY COMMENCED
15	COMMERCIAL OPERATION AFTER JANUARY 1, 2007, THE OPERATOR SHALL SUBMIT THE DECOMMISSIONING BOND TO THE
16	DEPARTMENT PRIOR TO THE CONCLUSION OF THE 15TH YEAR OF OPERATION OF THE WIND GENERATION FACILITY.
17	(7) IF A WIND GENERATION FACILITY IS REPURPOSED, AS DETERMINED BY THE DEPARTMENT IN CONSULTATION
18	WITH THE OWNER, THE OWNER IS NOT REQUIRED TO PROVIDE A BOND, AND ANY EXISTING BOND MUST BE RELEASED UNTIL
19	THE REPURPOSED FACILITY REACHES ITS 5TH YEAR OF OPERATION.
20	(8) AN OWNER OF A WIND GENERATION FACILITY IS EXEMPT FROM THE REQUIREMENTS OF SUBSECTION (6) IF:
21	(A) THE OWNER POSTS A BOND WITH A FEDERAL AGENCY, WITH THE DEPARTMENT OF NATURAL RESOURCES AND
22	CONSERVATION FOR THE LEASE OF STATE LAND, OR WITH A TRIBAL, COUNTY, OR LOCAL GOVERNMENT;
23	(B) THE PRIVATE LANDOWNER ON WHOSE LAND THE WIND GENERATION FACILITY IS LOCATED OWNS A 10% OR
24	GREATER SHARE OF THE WIND GENERATION FACILITY, AS DETERMINED BY THE DEPARTMENT; OR
25	(C) THE WIND GENERATION FACILITY COMMENCED COMMERCIAL OPERATION ON OR BEFORE JANUARY 1, 2018,
26	AND HAS LESS THAN 25 MEGAWATTS IN NAMEPLATE CAPACITY.
27	(9) (A) IF THE OWNER OF THE WIND GENERATION FACILITY FAILS TO SUBMIT A DECOMMISSIONING BOND
28	ACCEPTABLE TO THE DEPARTMENT WITHIN THE TIMEFRAME REQUIRED BY THIS SECTION, THE DEPARTMENT MAY ASSESS
29	AN ADMINISTRATIVE PENALTY OF NOT MORE THAN \$1,500, AND AN ADDITIONAL ADMINISTRATIVE PENALTY OF NOT MORE
30	THAN \$1,500 FOR EACH DAY THE FAILURE TO SUBMIT THE DECOMMISSIONING BOND CONTINUES.

1	(B) THE OWNER OF THE WIND GENERATION FACILITY MAY APPEAL THE DEPARTMENT'S PENALTY ASSESSMENT TO
2	THE BOARD WITHIN 20 DAYS AFTER RECEIPT OF WRITTEN NOTICE OF THE PENALTY. THE CONTESTED CASE PROVISIONS
3	OF THE MONTANA ADMINISTRATIVE PROCEDURE ACT, TITLE 2, CHAPTER 4, PART 6, APPLY TO A HEARING BEFORE THE
4	BOARD UNDER THIS SUBSECTION (9).
5	(10) IF THE OWNER OF A WIND GENERATION FACILITY TRANSFERS OWNERSHIP OF THE FACILITY TO A SUCCESSOR
6	OWNER, THE FIRST OWNER'S BOND MUST BE RELEASED AFTER 90 DAYS. THE NEW OWNER SHALL SUBMIT ANY NECESSARY

9	(11) ONCE EVERY 5 YEARS, THE OWNER OF A WIND GENERATION FACILITY MAY APPLY TO THE DEPARTMENT FOR
10	A REDUCTION IN THE AMOUNT OF THE DECOMMISSIONING BOND APPLICABLE TO THE WIND ENERGY FACILITY. THE OWNER'S
11	APPLICATION TO THE DEPARTMENT MUST INCLUDE A DETAILED DESCRIPTION OF ANY MATERIAL CHANGES TO INFORMATION
12	CONSIDERED BY THE DEPARTMENT IN SETTING THE INITIAL AMOUNT OF THE BOND.
13	(12) SUBMITTING A BOND IN ACCORDANCE WITH THIS SECTION DOES NOT ABSOLVE THE OWNER OF A WIND
14	GENERATION FACILITY FROM COMPLYING WITH APPLICABLE REGULATIONS AND REQUIREMENTS FOR:
15	(A) AREAS SUBJECT TO LOCAL ZONING ADOPTED UNDER TITLE 76, CHAPTER 2;
16	(B) MILITARY AFFECTED AREAS UNDER TITLE 10, CHAPTER 1, PART 15; OR
17	(C) AIRPORT AFFECTED AREAS UNDER TITLE 67, CHAPTER 7.
18	
19	NEW SECTION. Section 3. Wind decommissioning account use of existing resources. (1) There
20	is a wind decommissioning account within the state special revenue fund established in 17-2-102. There must
21	be paid into the account:
22	(a) penalties collected in accordance with [section 2(5)] [SECTION 2(9)]; and
23	(b) interest income earned on the account.
24	(2) Funds in the wind decommissioning account are statutorily appropriated, as provided in 17-7-502,
25	to the department.
26	(3) (a) Money in the account may only be used by the department in implementing [sections 1 through
27	5] and rules adopted pursuant to [sections 1 through 5].
28	(b) The department shall administer [sections 1 through 5] using existing resources and money in the
29	account pursuant to subsection (1).
30	(4) The department shall maintain and hold bonds or other surety received by the department as

3 NEW SECTION. Section 4. Release of bond -- use of bond by department. (1) The (A) SUBJECT TO 4 SUBSECTION (1)(B), THE department shall release the bond if it is satisfied that an owner has properly 5 decommissioned a wind generation facility.

6 (B) AT ANY TIME, AN OWNER OF A WIND GENERATION FACILITY MAY PETITION THE DEPARTMENT FOR RELEASE

7 OF THE BOND, AND THE DEPARTMENT SHALL REPLY WITH A DETERMINATION WITHIN 90 DAYS.

8 (2) If the owner of a wind generation facility fails to properly decommission a wind generation facility and 9 has not commenced action to rectify deficiencies within 30 90 days after notification by the department, the 10 department shall cause the bond to be forfeited. The department, with staff, equipment, and material under its 11 control or by contract with others, may take any necessary actions to decommission the wind generation facility. 12

13 NEW SECTION. Section 5. Rulemaking. On or before January 1, 2018, the department shall adopt 14 rules prescribing:

15 (1) standards and procedures for the submission of reasonable bonds with good and sufficient surety 16 by the owners of wind generation facilities;

17 (2) the collection of penalties in accordance with [section 2(5)] [SECTION 2(9)];

18 (3) criteria and the process for releasing a bond in accordance with [section 4];

19 (4) the department's use of a bond in the event that the owner of a wind generation facility fails to 20 decommission a wind generation facility;

- 21 (5) information required by the department to determine bond requirements in accordance with [section 22 2]; and
- 23 (6) any additional requirements to ensure compliance with [sections 1 through 5].

16 (4) There is a statutory appropriation to pay the principal, interest, premiums, and costs of issuing, 17 paying, and securing all bonds, notes, or other obligations, as due, that have been authorized and issued 18 pursuant to the laws of Montana. Agencies that have entered into agreements authorized by the laws of Montana 19 to pay the state treasurer, for deposit in accordance with 17-2-101 through 17-2-107, as determined by the state 20 treasurer, an amount sufficient to pay the principal and interest as due on the bonds or notes have statutory 21 appropriation authority for the payments. 11	NEW SECTION. Section 7. Notification to tribal governments. The secretary of state shall send a
12	copy of [this act] to each tribal government located on the seven Montana reservations and to the Little Shell
13	Chippewa tribe.

15	NEW SECTION. Section 8. Codification instruction. [Sections 1 through 5] are intended to be codified
16	as an integral part of Title 75, and the provisions of Title 75 apply to [sections 1 through 5].
17	
18	NEW SECTION. Section 9. Saving clause. [This act] does not affect rights and duties that matured,
19	penalties that were incurred, or proceedings that were begun before [the effective date of this act].

21	NEW SECTION. Section 10. Effective date. [This act] is effective on passage and approval.
