6	A BILL FOR AN ACT ENTITLED: "AN ACT CLARIFYING THAT VEHICLES TRAVELING ON ROADWAYS WITH
7	TWO OR MORE LANES OF TRAFFIC MOVING IN THE SAME DIRECTION MUST STAY IN THE RIGHT LANE
8	WITH CERTAIN EXCEPTIONS; AND AMENDING SECTION 61-8-321, MCA."

10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:
11	
12	Section 1. Section 61-8-321, MCA, is amended to read:
13	"61-8-321. Drive on right side of roadway exceptions. (1) Upon all roadways of sufficient width, a
14	vehicle must be operated upon the right half of the roadway, except as follows:
15	(a) when overtaking and passing another vehicle proceeding in the same direction under the rules
16	governing the passing movement;
17	(b) when the right half of a roadway is closed to traffic while under construction or repair;
18	(c) upon a roadway divided into three marked lanes for traffic under the rules applicable on a divided
19	roadway;
20	(d) upon a roadway designated by official traffic control devices for one-way traffic;
21	(e) when the operator of a vehicle is complying with the provisions of 61-8-346; or
22	(f) when an obstruction exists that makes it necessary to drive to the left of the center of the roadway:
23	<u>OR</u>
24	(G) WHEN A POLICE VEHICLE OR AUTHORIZED EMERGENCY VEHICLE IS PERFORMING A JOB-RELATED DUTY AS
25	PROVIDED IN 61-8-107.
26	(2) A person operating a vehicle to the left of the center of the roadway for any of the reasons provided
27	in subsection (1) shall yield the right-of-way to all vehicles traveling in the proper direction upon the unobstructed
28	portion of the roadway that are within a distance that constitutes an immediate hazard.
29	(3) A vehicle proceeding at less than the normal speed of traffic at the time and place and under the
30	conditions then existing must be operated in the right-hand lane then available for traffic, or as close as

1 practicable to the right-hand curb or edge of the roadway except when overtaking and passing another vehicle 2 proceeding in the same direction or when preparing for a left turn at an intersection or into a private road or 3 driveway. Upon all roadways having two or more lanes for traffic moving in the same direction, a vehicle must 4 be driven in the right-hand lane except when: 5 (a) overtaking and passing another vehicle proceeding in the same direction; 6 (b) traveling at a speed greater than the traffic flow; 7 (c) moving left to allow traffic to merge; or 8 (d) preparing for a left turn at an intersection or into a private road or driveway when a left turn is legally 9 permitted. 10 (A) EXCEPT AS PROVIDED IN SUBSECTION (3)(B) AND SUBJECT TO SUBSECTION (4), UPON ALL ROADWAYS HAVING 11 TWO OR MORE LANES FOR TRAFFIC MOVING IN THE SAME DIRECTION, A VEHICLE MUST BE DRIVEN IN THE RIGHT-HAND LANE. 12 (B) A VEHICLE BEING OPERATED UPON A ROADWAY HAVING TWO OR MORE LANES FOR TRAFFIC MOVING IN THE 13 SAME DIRECTION IS NOT REQUIRED TO BE DRIVEN IN THE RIGHT-HAND LANE WHEN: 14 (I) OVERTAKING AND PASSING ANOTHER VEHICLE PROCEEDING IN THE SAME DIRECTION; 15 (II) TRAVELING AT A SPEED GREATER THAN THE TRAFFIC FLOW; 16 (III) MOVING LEFT TO ALLOW TRAFFIC TO MERGE: 17 (IV) TRAVELING ON A ROADWAY WITHIN THE OFFICIAL BOUNDARIES OF A CITY OR TOWN, EXCEPT AS PROVIDED IN 18 SUBSECTION (4); 19 (V) PREPARING FOR A LEFT TURN AT AN INTERSECTION OR INTO A PRIVATE ROAD OR DRIVEWAY WHEN A LEFT TURN IS LEGALLY PERMITTED; 20 21 (VI) EXITING ONTO A LEFT-HAND EXIT FROM A CONTROLLED-ACCESS HIGHWAY; 22 (VII) AN OBSTRUCTION OR HAZARDOUS CONDITIONS MAKE IT NECESSARY TO DRIVE IN A LANE OTHER THAN THE 23 RIGHT-HAND LANE; OR 24 (VIII) AUTHORIZED SNOW-REMOVAL EQUIPMENT IS OPERATING ON THE ROADWAY. 25 (4) WHEN TRAVELING UPON AN INTERSTATE HIGHWAY, AS DEFINED IN 60-5-102, WITHIN THE OFFICIAL 26 BOUNDARIES OF A CITY OR TOWN, A VEHICLE MUST BE DRIVEN IN THE RIGHT-HAND LANE UNLESS OTHERWISE DIRECTED 27 OR PERMITTED BY AN OFFICIAL TRAFFIC CONTROL DEVICE."
