BY REQUEST OF THE CODE COMMISSIONER

A BILL FOR AN ACT ENTITLED: "AN ACT REVISING AND CLARIFYING THE MONTANA CODE ANNOTATED; DIRECTING THE CODE COMMISSIONER TO CORRECT ERRONEOUS REFERENCES CONTAINED IN MATERIAL ENACTED BY THE 65TH LEGISLATURE AND PREVIOUS LEGISLATURES; AMENDING SECTIONS 1-5-603, 1-5-610, 1-5-622, 7-6-2527, 15-6-301, 15-6-302, 15-6-311, 15-7-102, 15-70-412, 20-7-102, 20-7-1404, 20-9-306, 32-9-169, 33-2-1112, 45-8-340, 46-23-509, 61-3-332, 61-8-607, 69-8-402, 69-8-412, 77-1-125, 80-7-1007, AND 85-7-1411, MCA."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 1-5-603, MCA, is amended to read:

"1-5-603. Requirements for certain notarial acts -- personal appearance -- identification methods.

(1) A notarial officer who takes an acknowledgment of a record shall determine, from personal knowledge or satisfactory evidence of the identity of the individual, that the individual appearing before the notarial officer and making the acknowledgment has the identity claimed and that the signature on the record is the signature of the individual.

(2) A notarial officer who takes a verification on oath or affirmation of a statement shall determine, from personal knowledge or satisfactory evidence of the identity of the individual, that the individual appearing before the notarial officer and making the verification has the identity claimed and that the signature on the statement verified is the signature of the individual.

(3) A notarial officer who witnesses or attests to a signature shall determine, from personal knowledge or satisfactory evidence of the identity of the individual, that the individual appearing before the notarial officer and signing the record has the identity claimed.

(4) A notarial officer who certifies or attests a copy of a record or an item that was copied shall determine that the copy is a full, true, and accurate transcription or reproduction of the record or the item.

(5) A notarial officer who makes or notes a protest of a negotiable instrument shall determine the matters set forth in ~~30-3-510(1)(b)~~ 30-3-510(2).



1 (6) A notarial officer who administers an oath in conjunction with taking a deposition and certifies or
2 attests to the transcript of the deposition shall certify to the matters set forth by this part, other laws, or the court
3 of jurisdiction.

4 (7) (a) If a notarial act relates to a statement made in or a signature executed on a record, the individual
5 making the statement or executing the signature shall appear physically before the notarial officer or by real-time,
6 two-way video and audio communication technology as authorized in 1-5-615 and 1-5-628.

7 (b) Except as provided in subsection (7)(c), subsection (7)(a) modifies, limits, and supersedes the
8 Electronic Signatures in Global and National Commerce Act, 15 U.S.C. 7001, et seq.

9 (c) Subsection (7)(a) does not modify, limit, or supersede 15 U.S.C. 7001(c) or authorize electronic
10 delivery of any of the notices described in 15 U.S.C. 7003(b).

11 (8) A notarial officer has personal knowledge of the identity of an individual appearing before the notarial
12 officer if the individual is personally known to the notarial officer through dealings sufficient to provide reasonable
13 certainty that the individual has the identity claimed.

14 (9) A notarial officer has satisfactory evidence of the identity of an individual appearing before the notarial
15 officer if the notarial officer can identify the individual:

16 (a) by means of:

17 (i) a passport, driver's license, or government-issued nondriver identification card, which may be current
18 or expired, and if expired may not be expired for more than 3 years before the performance of the notarial act;
19 or

20 (ii) another form of government identification issued to an individual, which:

21 (A) may be current or expired, and if expired may not be expired for more than 3 years before the
22 performance of the notarial act;

23 (B) must contain the signature or a photograph of the individual; and

24 (C) must be satisfactory to the notarial officer; or

25 (b) by verification on oath or affirmation of a credible witness personally appearing before the notarial
26 officer and known to the notarial officer or

27 whom the notarial officer can identify on the basis of a passport, driver's license, or government-issued
28 nondriver identification card, which is current or expired, and if expired may not be expired for more than 3 years
29 before the performance of the notarial act.

30 (10) A notarial officer may require an individual to provide additional information or identification

1 credentials necessary to assure the notarial officer of the identity of the individual."

4 **"1-5-610. Short forms.** The following short-form certificates of notarial acts are sufficient for the
5 purposes indicated if they are completed with the information required by 1-5-609(1) and (2):

14 **Section 3.** Section 1-5-622, MCA, is amended to read:

15 **"1-5-622. Authority to refuse to perform notarial act.** (1) A notarial officer may refuse to perform a
16 notarial act if the notarial officer is not satisfied that:

- 17 (a) the individual executing the record is competent or has the capacity to execute the record; or
- 18 (b) the individual executing the record is ~~not~~ signing knowingly or voluntarily.

19 (2) A notarial officer may refuse to perform a notarial act unless refusal is prohibited by a law other than
20 as provided in this part."

21
22 **Section 4.** Section 7-6-2527, MCA, is amended to read:

23 **"7-6-2527. Taxation -- public and governmental purposes.** A county may impose a property tax levy
24 for any public or governmental purpose not specifically prohibited by law. Public and governmental purposes
25 include but are not limited to:

- 26 (1) district court purposes as provided in 7-6-2511;
- 27 (2) county-owned or county-operated health care facility purposes as provided in 7-6-2512;
- 28 (3) county law enforcement services and maintenance of county detention center purposes as provided
29 in 7-6-2513 and search and rescue units as provided in 7-32-235;
- 30 (4) multijurisdictional service purposes as provided in 7-11-1022;



- 1 (5) transportation services for senior citizens and persons with disabilities as provided in 7-14-111;
2 (6) support for a port authority as provided in 7-14-1132;
3 (7) county road, bridge, and ferry purposes as provided in 7-14-2101, 7-14-2501, 7-14-2502, 7-14-2503,
4 7-14-2801, and 7-14-2807;
5 (8) recreational, educational, and other activities of the elderly as provided in 7-16-101;
6 (9) purposes of county fair activities, parks, cultural facilities, and any county-owned civic center, youth
7 center, recreation center, or recreational complex as provided in 7-16-2102 and 7-16-2109;
8 (10) programs for the operation of licensed day-care centers and homes as provided in 7-16-2108 and
9 7-16-4114;
10 (11) support for a museum, facility for the arts and the humanities, collection of exhibits, or a museum
11 district created under provisions of Title 7, chapter 11, part 10, or former Title 7, chapter 16, part 22;
12 (12) extension work in agriculture and home economics as provided in 7-21-3203;
13 (13) weed control and management purposes as provided in 7-22-2142;
14 (14) insect control programs as provided in 7-22-2306;
15 (15) fire control as provided in 7-33-2209;
16 (16) ambulance service as provided in 7-34-102;
17 (17) public health purposes as provided in 50-2-111 and ~~50-2-114~~;
18 (18) public assistance purposes as provided in 53-3-115;
19 (19) indigent assistance purposes as provided in 53-3-116;
20 (20) developmental disabilities facilities as provided in 53-20-208;
21 (21) mental health services as provided in 53-21-1010;
22 (22) airport purposes as provided in 67-10-402 and 67-11-302;
23 (23) purebred livestock shows and sales as provided in 81-8-504;
24 (24) economic development purposes as provided in 90-5-112;
25 (25) prevention programs, including programs that reduce substance abuse; and
26 (26) forest or grassland hazardous fuels reduction projects in areas near homes and communities where
27 wildland fire is a threat."

29 **Section 5.** Section 15-6-301, MCA, is amended to read:

30 **"15-6-301. Definitions.** As used in this part, the following definitions apply:

- 1 (1) "Annual verification" means the use of a process to:
- 2 (a) verify an applicant's income;
- 3 (b) approve, renew, or deny benefits for the current year based upon the applicant's eligibility; and
- 4 (c) terminate participation based upon death or loss of status as a qualified veteran or veteran's spouse.
- 5 (2) "PCE" means the implicit price deflator for personal consumption expenditures as published quarterly
- 6 in the survey of current business by the bureau of economic analysis of the U.S. department of commerce.
- 7 (3) "PCE inflation factor" for a tax year means the PCE for April of the prior tax year before the tax year
- 8 divided by the PCE for April 2015.
- 9 (4) (a) "Primary residence" is, subject to the provisions of subsection (4)(b), a dwelling:
- 10 (i) in which a taxpayer can demonstrate the taxpayer lived for at least 7 months of the year for which
- 11 benefits are claimed;
- 12 (ii) that is the only residence for which property tax assistance is claimed; and
- 13 (iii) determined using the indicators provided for in the rules authorized by 15-6-302(2).
- 14 (b) A primary residence may include more than one dwelling when the taxpayer resides in one dwelling
- 15 for less than 7 months during the tax year and another dwelling for less than 7 months of the same tax year, but
- 16 lives in the dwellings for more than 7 months of the tax year.
- 17 (5) "Qualified veteran" means a veteran:
- 18 (a) who was killed while on active duty or died as a result of a service-connected disability; or
- 19 (b) if living:
- 20 (i) was honorably discharged from active service in any branch of the armed services; and
- 21 (ii) is currently rated 100% disabled or is paid at the 100% disabled rate by the U.S. department of
- 22 veterans affairs for a service-connected disability, as verified by official documentation from the U.S. department
- 23 of veterans affairs.
- 24 (6) "Qualifying income" means:
- 25 (a) the federal adjusted gross income excluding capital and income losses of an applicant and the
- 26 applicant's spouse as calculated on the Montana income tax return for the prior year;
- 27 (b) for assistance under ~~45-6-305~~ [15-6-311], the federal adjusted gross income excluding capital and
- 28 income losses of an applicant as calculated on the Montana income tax return for the prior tax year; or
- 29 (c) for an applicant who is not required to file a Montana income tax return, the income determined using
- 30 available income information.

1 (7) "Residential real property" means the land and improvements of a taxpayer's primary residence."

Section 6. Section 15-6-302, MCA, is amended to read:

4 **"15-6-302. Property tax assistance -- rulemaking.** (1) The requirements of this section must be met
5 for a taxpayer to qualify for property tax assistance under 15-6-305 or 15-6-311.

6 (2) For the property tax assistance programs provided for in 15-6-305 and 15-6-311, the residential real
7 property must be owned by the applicant or under contract for deed and be the primary residence as defined in
8 15-6-301. The department shall make rules specifying the indicators used for determining whether a residence
9 is a primary residence for purposes of property tax assistance programs.

10 (3) An applicant's qualifying income, as defined in 15-6-301, may not exceed the threshold established
11 in 15-6-305 or 15-6-311 or in rules established pursuant to those sections.

12 (4) (a) A claim for assistance must be submitted on a form prescribed by the department.

13 (b) The form must contain:

14 (i) the qualifying income of the applicant and the applicant's spouse;

15 (ii) an affirmation that the applicant owns and maintains the land and improvements as the primary
16 residence as defined in 15-6-301;

17 (iii) the social security number of the applicant and of the applicant's spouse; and

18 (iv) any other information required by the department that is relevant to the applicant's eligibility.

19 (5) (a) An application must be filed by April 15 of the year for which assistance is first claimed.

20 (b) Once assistance is approved, the applicant remains eligible for property tax assistance in subsequent
21 years through the annual verification process defined in 15-6-301 without the need to reapply.

22 (c) Applicants and participants in the property tax assistance program provided for in {former}
23 15-6-134(1)(c) and the disabled or deceased veterans program provided for in {former} 15-6-211 as those
24 sections existed on December 31, 2014, must be included in the annual verification process and are not required
25 to submit a new application.

26 (d) A taxpayer shall inform the department of any change in eligibility occurring from one year to the next.

27 (6) The department may verify an applicant's and an applicant's spouse's social security number and
28 benefits with the social security administration and the U.S. department of veterans affairs.

29 (7) The department must annually verify an applicant's eligibility, including the applicant's and spouse's
30 income, and approve, renew, or deny benefits for the current year based upon the findings.

1 (8) (a) When providing information for property tax assistance under 15-6-305 or 15-6-311, applicants
 2 are subject to the false swearing penalties established in 45-7-202.

3 (b) The department may investigate the information provided in an application and an applicant's
 4 continued eligibility.

5 (c) The department may request applicant verification of the primary residence.

6 (9) The department may address unusual circumstances of ownership and income that arise in
 7 administering taxpayer assistance programs provided for in 15-6-305 and 15-6-311.

8 (10) A temporary stay in a nursing home or similar facility does not change a taxpayer's primary residence
 9 for the purposes of taxpayer assistance programs provided for in 15-6-305 and 15-6-311.

10 (11) The department shall award property assistance under the property tax assistance program that
 11 provides the greatest benefit to the taxpayer by reviewing applications and eligibility requirements, and notify the
 12 applicant of the department's decision."
 13

14 **Section 7.** Section 15-6-311, MCA, is amended to read:

15 **"15-6-311. Disabled veteran program.** (1) The residential real property of a qualified veteran or a
 16 qualified veteran's spouse is eligible to receive a tax rate reduction as provided in ~~15-6-305~~[15-6-302] and this
 17 section.

18 (2) Property qualifying under subsection (1) and owned by a qualified veteran is taxed at the rate
 19 provided in 15-6-134 multiplied by a percentage figure based on the applicant's qualifying income determined
 20 from the following table:

28 (3) For a surviving spouse who owns property qualifying under subsection (4), the property is taxed at
 29 the rate established by 15-6-134 multiplied by a percentage figure based on the spouse's qualifying income

1 determined from the following table:

5 \$31,171 - \$34,911	20%
6 \$34,912 - \$38,651	30%

8 (4) The property tax exemption under this section remains in effect as long as the qualifying income
 9 requirements are met and the property is the primary residence owned and occupied by the veteran or, if the
 10 veteran is deceased, by the veteran's spouse and the spouse:

- 11 (a) is the owner and occupant of the house;
- 12 (b) is unmarried; and
- 13 (c) has obtained from the U.S. department of veterans affairs a letter indicating that the veteran was
 14 rated 100% disabled or was paid at the 100% disabled rate by the U.S. department of veterans affairs for a
 15 service-connected disability at the time of death or that the veteran died while on active duty or as a result of a
 16 service-connected disability.

17 (5) The qualifying income levels contained in subsections (2) and (3) must be adjusted annually by using
 18 the PCE inflation factor defined in 15-6-301, rounded to the nearest whole dollar amount."

19

20 **Section 8.** Section 15-7-102, MCA, is amended to read:

21 **"15-7-102. Notice of classification, market value, and taxable value to owners -- appeals.** (1) (a)
 22 Except as provided in 15-7-138, the department shall mail or provide electronically to each owner or purchaser
 23 under contract for deed a notice that includes the land classification, market value, and taxable value of the land
 24 and improvements owned or being purchased. A notice must be mailed to the owner only if one or more of the
 25 following changes pertaining to the land or improvements have been made since the last notice:

- 26 (i) change in ownership;
- 27 (ii) change in classification;
- 28 (iii) change in valuation; or
- 29 (iv) addition or subtraction of personal property affixed to the land.

1 (b) The notice must include the following for the taxpayer's informational purposes:

2 (i) a notice of the availability of all the property tax assistance programs available to property taxpayers,
3 including the property tax assistance programs provided for in Title 15, chapter 6, part 3, and the residential
4 property tax credit for the elderly provided for in 15-30-2337 through 15-30-2341;

5 (ii) the total amount of mills levied against the property in the prior year; and

6 (iii) a statement that the notice is not a tax bill.

7 (c) When the department uses an appraisal method that values land and improvements as a unit,
8 including the sales comparison approach for residential condominiums or the income approach for commercial
9 property, the notice must contain a combined appraised value of land and improvements.

10 (d) Any misinformation provided in the information required by subsection (1)(b) does not affect the
11 validity of the notice and may not be used as a basis for a challenge of the legality of the notice.

12 (2) (a) Except as provided in subsection (2)(c), the department shall assign each assessment to the
13 correct owner or purchaser under contract for deed and mail or provide electronically the notice in written or
14 electronic form, adopted by the department, containing sufficient information in a comprehensible manner
15 designed to fully inform the taxpayer as to the classification and appraisal of the property and of changes over
16 the prior tax year.

17 (b) The notice must advise the taxpayer that in order to be eligible for a refund of taxes from an appeal
18 of the classification or appraisal, the taxpayer is required to pay the taxes under protest as provided in 15-1-402.

19 (c) The department is not required to mail or provide electronically the notice to a new owner or
20 purchaser under contract for deed unless the department has received the realty transfer certificate from the clerk
21 and recorder as provided in 15-7-304 and has processed the certificate before the notices required by subsection
22 (2)(a) are mailed or provided electronically. The department shall notify the county tax appeal board of the date
23 of the mailing or the date when the taxpayer is informed the information is available electronically.

24 (3) (a) If the owner of any land and improvements is dissatisfied with the appraisal as it reflects the
25 market value of the property as determined by the department or with the classification of the land or
26 improvements, the owner may request an assessment review by submitting an objection on written or electronic
27 forms provided by the department for that purpose.

28 (i) For property other than class three property described in 15-6-133, class four property described in
29 15-6-134, and class ten property described in 15-6-143, the objection must be submitted within 30 days from the
30 date on the notice.

1 (ii) For class three property described in 15-6-133 and class four property described in 15-6-134, the
2 objection may be made only once each valuation cycle. An objection must be made within 30 days from the date
3 on the assessment notice for a reduction in the appraised value to be considered for both years of the 2-year
4 appraisal cycle. Any reduction in value resulting from an objection made more than 30 days from the date of the
5 assessment notice will be applicable only for the second year of the 2-year reappraisal cycle.

6 (iii) For class ten property described in 15-6-143, the objection may be made at any time but only once
7 each valuation cycle. An objection must be made within 30 days from the date on the assessment notice for a
8 reduction in the appraised value to be considered for all years of the 6-year appraisal cycle. Any reduction in
9 value resulting from an objection made more than 30 days after the date of the assessment notice applies only
10 for the subsequent remaining years of the 6-year reappraisal cycle.

11 (b) If the objection relates to residential or commercial property and the objector agrees to the
12 confidentiality requirements, the department shall provide to the objector, by posted mail or electronically, within
13 8 weeks of submission of the objection, the following information:

14 (i) the methodology and sources of data used by the department in the valuation of the property; and

15 (ii) if the department uses a blend of evaluations developed from various sources, the reasons that the
16 methodology was used.

17 (c) At the request of the objector, and only if the objector signs a written or electronic confidentiality
18 agreement, the department shall provide in written or electronic form:

19 (i) comparable sales data used by the department to value the property; and

20 (ii) sales data used by the department to value residential property in the property taxpayer's market
21 model area.

22 (d) For properties valued using the income approach as one approximation of market value, notice must
23 be provided that the taxpayer will be given a form to acknowledge confidentiality requirements for the receipt of
24 all aggregate model output that the department used in the valuation model for the property.

25 (e) The review must be conducted informally and is not subject to the contested case procedures of the
26 Montana Administrative Procedure Act. As a part of the review, the department may consider the actual selling
27 price of the property and other relevant information presented by the taxpayer in support of the taxpayer's opinion
28 as to the market value of the property. The ~~county tax appeal board~~ [department] shall consider an independent
29 appraisal provided by the taxpayer if the appraisal meets standards set by the Montana board of real estate
30 appraisers and the appraisal was conducted within 6 months of the valuation date. If the department does not

1 use the appraisal provided by the taxpayer in conducting the appeal, the department must provide to the taxpayer
2 the reason for not using the appraisal. The department shall give reasonable notice to the taxpayer of the time
3 and place of the review.

4 (f) After the review, the department shall determine the correct appraisal and classification of the land
5 or improvements and notify the taxpayer of its determination by mail or electronically. The department may not
6 determine an appraised value that is higher than the value that was the subject of the objection unless the reason
7 for an increase was the result of a physical change in the property or caused by an error in the description of the
8 property or data available for the property that is kept by the department and used for calculating the appraised
9 value. In the notification, the department shall state its reasons for revising the classification or appraisal. When
10 the proper appraisal and classification have been determined, the land must be classified and the improvements
11 appraised in the manner ordered by the department.

12 (4) Whether a review as provided in subsection (3) is held or not, the department may not adjust an
13 appraisal or classification upon the taxpayer's objection unless:

14 (a) the taxpayer has submitted an objection on written or electronic forms provided by the department;
15 and

16 (b) the department has provided to the objector by mail or electronically its stated reason in writing for
17 making the adjustment.

18 (5) A taxpayer's written objection to a classification or appraisal and the department's notification to the
19 taxpayer of its determination and the reason for that determination are public records. The department shall make
20 the records available for inspection during regular office hours.

21 (6) If a property owner feels aggrieved by the classification or appraisal made by the department after
22 the review provided for in subsection (3), the property owner has the right to first appeal to the county tax appeal
23 board and then to the state tax appeal board, whose findings are final subject to the right of review in the courts.
24 The appeal to the county tax appeal board, pursuant to 15-15-102, must be filed within 30 days from the date on
25 the notice of the department's determination. A county tax appeal board or the state tax appeal board may
26 consider the actual selling price of the property, independent appraisals of the property, and other relevant
27 information presented by the taxpayer as evidence of the market value of the property. If the county tax appeal
28 board or the state tax appeal board determines that an adjustment should be made, the department shall adjust
29 the base value of the property in accordance with the board's order."
30

1 **Section 9.** Section 15-70-412, MCA, is amended to read:

2 **"15-70-412. Invoice of distributors and aviation fuel dealers.** Each distributor and aviation fuel
3 dealer in this state shall at the time of delivery, except when authorized by the department of transportation, issue
4 to the purchaser an invoice that states the number of gallons of gasoline or special fuel covered by the invoice
5 and any other information the department may require."
6

7 **Section 10.** Section 20-7-102, MCA, is amended to read:

8 **"20-7-102. Accreditation of schools.** (1) The conditions under which each elementary school, each
9 middle school, each junior high school, 7th and 8th grades funded at high school rates, and each high school
10 operates must be reviewed by the superintendent of public instruction to determine compliance with the standards

16 public instruction, the multiplier in subsection (2)(a)(i) must be increased to 3.

17 (4) If the money appropriated for Indian {language} immersion programs is insufficient to provide the
18 amounts in subsections (2) and (3), the office of public instruction shall prorate the payments accordingly.

14 either the value of the insurable improvements or the last-known coverage amount of insurance;

15 (5) fail to provide to the borrower a refund of unearned premiums paid by a borrower or charged to the

17 borrower provides reasonable proof that the borrower has obtained coverage so that the forced placement is no

20 (a) review the psychosexual evaluation report, any statement by a victim, and any statement by the
21 offender;

22 (b) designate the offender as level 1, 2, or 3; and

24 (4) An offender designated as a level 2 offender or given a level designation by another state, the federal
25 government, or the department under subsection (6) that is determined by the court to be similar to level 2 may
26 petition the sentencing court or the district court for the judicial district in which the offender resides to change
27 the offender's designation if the offender has enrolled in and successfully completed the treatment phase of either
28 the prison's sexual offender treatment program or of an equivalent program approved by the department. After
29 considering the petition, the court may change the offender's risk level designation if the court finds by clear and
30 convincing evidence that the offender's risk of committing a repeat sexual offense has changed since the time

1 sentence was imposed. The court shall impose one of the three risk levels specified in this section.

2 (5) If, at the time of sentencing, the sentencing judge did not apply a level designation to a sexual
3 offender who is required to register under this part and who was sentenced prior to October 1, 1997, the
4 department shall designate the offender as level 1, 2, or 3 when the offender is released from confinement.

5 (6) If an offense is covered by 46-23-502(9)(b), the offender registers under 46-23-504(1)(c), and the
6 offender was given a risk level designation after conviction by another state or the federal government, the
7 department of justice may give the offender the risk level designation assigned by the other state or the federal
8 government. All offenders convicted in another state or by the federal government who are not currently under
9 the supervision of the department or the youth court and were not given a risk level designation after conviction
10 shall provide to the department of justice all prior risk assessments and psychosexual evaluations done to
11 evaluate the offender's risk to reoffend. Any offender without a risk assessment or psychosexual evaluation shall,
12 at the offender's expense, undergo a psychosexual evaluation with a sexual offender evaluator who is a member
13 of the Montana sex offender treatment association or has comparable credentials acceptable to the department
14 of labor and industry. The results of the ~~sex offender~~ psychosexual evaluation may be requested by the attorney
15 general or a county attorney for purposes of petitioning a district court to assign a risk level designation.

16 (7) The lack of a fixed residence is a factor that may be considered by the sentencing court or by the

19 a wheelchair design, excluding collegiate or generic specialty plates with a wheelchair design, are treated as

5 through 61-3-468, generic specialty license plates authorized under 61-3-472 through 61-3-481, commemorative
6 centennial license plates authorized under 61-3-448, and special military or veteran license plates authorized
7 under 61-3-458.

8 (4) (a) All license plates must be metal and treated with a reflectorized background material according
9 to specifications prescribed by the department. The word "Montana" must be placed on each license plate and,
10 except for license plates that are 4 inches wide and 7 inches in length, the outline of the state of Montana must
11 be used as a distinctive border on each standard license plate.

12 (b) Plates for semitrailers, travel trailers, pole trailers, trailers with a declared weight of 6,000 pounds or
13 more, and motor vehicles, other than motorcycles and quadricycles, must be 6 inches wide and 12 inches in
14 length.

15 (c) Plates for motorcycles and quadricycles must be 4 inches wide and 7 inches in length.

16 (d) The department shall issue plates that are 4 inches wide and 7 inches in length for trailers with a
17 declared weight of less than 6,000 pounds unless a person registering a trailer with a declared weight of less than
18 6,000 pounds requests plates that are 6 inches wide and 12 inches in length. A person registering a trailer shall
19 pay all applicable fees for the plates chosen.

20 (5) The distinctive registration numbers for standard license plates must begin with a number one or with
21 a letter-number combination, such as "A 1" or "AA 1", or any other similar combination of letters and numbers.
22 Except for special license plates, collegiate license plates, generic specialty license plates, fleet license plates,
23 and standard license plates that are 4 inches wide and 7 inches in length, the distinctive registration number or
24 letter-number combination assigned to the motor vehicle must appear on the plate preceded by the number of
25 the county and appearing in horizontal order on the same horizontal baseline. The county number must be
26 separated from the distinctive registration number by a separation mark unless a letter-number combination is
27 used. The dimensions of the numerals and letters must be determined by the department, and all county and
28 registration numbers must be of equal height.

29 (6) For the use of exempt motor vehicles, trailers, semitrailers, or pole trailers and motor vehicles,
30 trailers, semitrailers, or pole trailers that are exempt from the registration fee as provided in 61-3-321, in addition

1 to the markings provided in this section, standard license plates must bear the following distinctive markings:

2 (a) For motor vehicles, trailers, semitrailers, or pole trailers owned by the state, the department may
3 designate the prefix number for the various state departments. All numbered plates issued to state departments
4 must bear the words "State Owned", and a year number may not be indicated on the plates because these
5 numbered plates are of a permanent nature and will be replaced by the department only when the physical
6 condition of numbered plates requires it.

7 (b) For motor vehicles, trailers, semitrailers, or pole trailers that are owned by the counties,
8 municipalities, and special districts, as defined in 18-8-202, organized under the laws of Montana and not
9 operating for profit, and that are used and operated by officials and employees in the line of duty and for motor
10 vehicles on loan from the United States government or the state of Montana to, or owned by, the civil air patrol
11 and used and operated by officials and employees in the line of duty, there must be placed on the standard
12 license plates assigned, in a position that the department may designate, the letter "X" or the word "EXEMPT".
13 Distinctive registration numbers for plates assigned to motor vehicles, trailers, semitrailers, or pole trailers of each
14 of the counties in the state and those of the municipalities and special districts that obtain plates within each
15 county must begin with number one and be numbered consecutively. Because these standard license plates are
16 of a permanent nature, they are subject to replacement by the department only when the physical condition of
17 the license plates requires it and a year number may not be displayed on the plates.

18 (7) For the purpose of this chapter, the several counties of the state are assigned numbers as follows:

23 Sheridan, 34; Sanders, 35; Judith Basin, 36; Daniels, 37; Glacier, 38; Fallon, 39; Sweet Grass, 40; McCone, 41;
24 Carter, 42; Broadwater, 43; Wheatland, 44; Prairie, 45; Granite, 46; Meagher, 47; Liberty, 48; Park, 49; Garfield,
25 50; Jefferson, 51; Wibaux, 52; Golden Valley, 53; Mineral, 54; Petroleum, 55; Lincoln, 56. Any new counties must
26 be assigned numbers by the department as they are formed, beginning with the number 57.

27 (8) Each type of special license plate approved by the legislature, except collegiate license plates
28 authorized in 61-3-463 and generic specialty license plates authorized in 61-3-472 through 61-3-481, must be
29 a separate series of plates, numbered as provided in subsection (5), except that the county number must be
30 replaced by a design that distinguishes each separate plate series. Unless otherwise specifically stated in this

1 section, the special plates are subject to the same rules and laws as govern the issuance of standard license
2 plates, must be placed or mounted on a motor vehicle, trailer, semitrailer, or pole trailer owned by the person who
3 is eligible to receive them, with the registration decal affixed to the rear license plate of the motor vehicle, trailer,
4 semitrailer, or pole trailer, and must be removed upon sale or other disposition of the motor vehicle, trailer,
5 semitrailer, or pole trailer.

6 (9) (a) A Montana resident who is eligible to receive a special parking permit under 49-4-301 may and
7 a person with a low-speed restricted driver's license operating a low-speed electric vehicle or golf cart as provided
8 in 61-5-122 must, upon written application on a form prescribed by the department, be issued a special license
9 plate with a design or decal bearing a representation of a wheelchair as the symbol of a person with a disability.

10 (b) If the motor vehicle to which the license plate is attached is permanently registered, the owner of the
11 motor vehicle shall provide, upon request of a person authorized to enforce special parking laws or ordinances
12 in this or any state, evidence of continued eligibility to use the license plate in the form of a valid special parking
13 permit issued to or renewed by the vehicle owner under 49-4-304 and 49-4-305.

14 (c) A person with a permanent condition, as provided in 49-4-301(2)(b), who has been issued a special
15 license plate upon written application, as provided in this subsection (9), is not required to reapply upon
16 reregistration of the motor vehicle.

17 (10) The provisions of this section do not apply to a motor vehicle, trailer, semitrailer, or pole trailer that
18 is registered as part of a fleet, as defined in 61-3-712, and that is subject to the provisions of 61-3-711 through
19 61-3-733."

21 **Section 18.** Section 61-8-607, MCA, is amended to read:

22 **"61-8-607. Lamps and other equipment on bicycles and mopeds.** (1) A bicycle or moped when in
23 use at dawn, dusk, or nighttime must be equipped with:

24 (a) a lamp on the front emitting a white light visible from a distance of at least 500 feet to the front. In lieu
25 of a lamp affixed to the bicycle {or moped}, a bicyclist may use a lamp with equal intensity and visibility affixed
26 to the cyclist's helmet and facing forward.

27 (b) facing the rear, either a lamp emitting a red light visible from a distance of at least 500 feet to the rear
28 or a red reflector visible from a distance of at least 500 feet to the rear when illuminated by low-beam motor
29 vehicle headlamps; and

30 (c) reflective material large and reflective enough to be visible from the left and right sides from a

1 distance of at least 500 feet when illuminated by low-beam motor vehicle headlamps.

2 (2) A bicycle or moped must be equipped with a brake enabling the operator to stop the bicycle {or
3 moped} within no more than 25 feet from a speed of 10 miles an hour on dry, level, clean pavement."

5 **Section 19.** Section 69-8-402, MCA, is amended to read:

6 **"69-8-402. Universal system benefits programs.** (1) Universal system benefits programs are
7 established for the state of Montana to ensure continued funding of and new expenditures for energy
8 conservation, renewable resource projects and applications, and low-income energy assistance.

9 (2) (a) Except as provided in subsection (11), beginning January 1, 1999, 2.4% of each utility's annual
10 retail sales revenue in Montana for the calendar year ending December 31, 1995, is established as the initial
11 funding level for universal system benefits programs. To collect this amount of funds on an annualized basis in
12 1999, the commission shall establish rates for utilities subject to its jurisdiction and the governing boards of
13 cooperatives shall establish rates for the cooperatives.

14 ~~(a)~~(b) The recovery of all universal system benefits programs costs imposed pursuant to this section is
15 authorized through the imposition of a universal system benefits charge assessed at the meter for each local
16 utility system customer as provided in this section.

17 ~~(b)~~(c) A utility must receive credit toward annual funding requirements for the utility's internal programs
18 or activities that qualify as universal system benefits programs, including those amortized or nonamortized
19 portions of expenditures for the purchase of power that are for the acquisition or support of renewable energy,
20 conservation-related activities, or low-income energy assistance, and for large customers' programs or activities
21 as provided in subsection (7). The department of revenue shall review claimed credits of the utilities and large
22 customers pursuant to 69-8-414.

23 ~~(c)~~(d) A utility at which the sale of power for final end use occurs is the utility that receives credit for the
24 universal system benefits programs expenditure.

25 ~~(d)~~(e) A customer's utility shall collect universal system benefits funds less any allowable credits.

26 ~~(e)~~(f) For a utility to receive credit for low-income-related expenditures, the activity must have taken place
27 in Montana.

28 ~~(f)~~(g) If a utility's or a large customer's credit for internal activities does not satisfy the annual funding
29 provisions of this subsection (2), then the utility or large customer shall make a payment to the universal system
30 benefits fund established in 69-8-412 for any difference.

1 (3) Cooperative utilities may collectively pool their statewide credits to satisfy their annual funding
2 requirements for universal system benefits programs and low-income energy assistance.

3 (4) A utility's transition plan must describe how the utility proposes to provide for universal system
4 benefits programs, including the methodologies, such as cost-effectiveness and need determination, used to
5 measure the utility's level of contribution to each program.

6 (5) (a) A cooperative utility's minimum annual funding requirement for low-income energy and
7 weatherization assistance is established at 17% of the cooperative utility's annual universal system benefits
8 funding level and is inclusive within the overall universal system benefits funding level.

9 (b) Except as provided in subsection (11), a public utility's minimum annual funding requirement for
10 low-income energy and weatherization assistance is established at 50% of the public utility's annual universal
11 system benefits funding level and is inclusive within the overall universal system benefits funding level.

12 (c) A utility must receive credit toward the utility's low-income energy assistance annual funding
13 requirement for the utility's internal low-income energy assistance programs or activities. Internal programs and
14 activities may include providing low-income energy and weatherization assistance on Indian reservations.

15 (d) If a utility's credit for internal activities does not satisfy its annual funding requirement, then the utility
16 shall make a payment for any difference to the universal low-income energy assistance fund established in
17 69-8-412.

18 (6) An individual customer may not bear a disproportionate share of the local utility's funding
19 requirements, and a sliding scale must be implemented to provide a more equitable distribution of program costs.

20 (7) (a) A large customer:

21 (i) shall pay a universal system benefits programs charge with respect to the large customer's qualifying
22 load equal to the lesser of:

23 (A) \$500,000, less the large customer credits provided for in this subsection (7); or

24 (B) the product of 0.9 mills per kilowatt hour multiplied by the large customer's total kilowatt hour
25 purchases, less large customer credits with respect to that qualifying load provided for in this subsection (7);

26 (ii) must receive credit toward that large customer's universal system benefits charge for internal
27 expenditures and activities that qualify as a universal system benefits programs expenditure, and these internal
28 expenditures must include but not be limited to:

29 (A) expenditures that result in a reduction in the consumption of electrical energy in the large customer's
30 facility; and

1 (B) those amortized or nonamortized portions of expenditures for the purchase of power at retail or
2 wholesale that are for the acquisition or support of renewable energy or conservation-related activities.

3 (b) Large customers making these expenditures must receive a credit against the large customer's
4 universal system benefits charge, except that any of those amounts expended in a calendar year that exceed that
5 large customer's universal system benefits charge for the calendar year must be used as a credit against those
6 charges in future years until the total amount of those expenditures has been credited against that large
7 customer's universal system benefits charges.

8 (8) (a) Except as provided in subsection (11), a public utility shall prepare and submit an annual summary
9 report of the public utility's activities relating to all universal system benefits programs to the commission, the
10 department of revenue, and the energy and telecommunications interim committee provided for in 5-5-230. A
11 cooperative utility shall prepare and submit annual summary reports of activities to the cooperative utility's
12 respective local governing body, the statewide cooperative utility office, and the energy and telecommunications
13 interim committee. The statewide cooperative utility office shall prepare and submit an annual summary report
14 of the activities of individual cooperative utilities, including a summary of the pooling of statewide credits, as
15 provided in subsection (3), to the department of revenue and the energy and telecommunications interim
16 committee. The annual report of a public utility or of the statewide cooperative utility office must include but is not
17 limited to:

18 (i) the types of internal utility and customer programs being used to satisfy the provisions of this chapter;

19 (ii) the level of funding for those programs relative to the annual funding requirements prescribed in
20 subsection (2);

21 (iii) any payments made to the statewide funds in the event that internal funding was below the prescribed
22 annual funding requirements; and

23 (iv) the names of all large customers who either utilized credits to minimize or eliminate their charge
24 pursuant to subsection (7) or received a reimbursement for universal system benefits related to expenditures from
25 the utility during the previous reporting year.

26 (b) Before September 15 of the year preceding a legislative session, the energy and telecommunications
27 interim committee shall:

28 (i) review the universal system benefits programs and, if necessary, submit recommendations regarding
29 these programs to the legislature; and

30 (ii) review annual universal system benefits reports provided by utilities in accordance with subsection

1 (8)(a) and compare those reports with reports provided by large customers to the department of revenue in
 2 accordance with subsection (10)(a) and identify large customers, if any, who are not in compliance with reporting
 3 requirements in accordance with this subsection (8) and subsection (10).

4 (9) A utility or large customer filing for a credit shall develop and maintain appropriate documentation
 5 to support the utility's or the large customer's claim for the credit.

6 (10) (a) A large customer claiming credits for a calendar year shall submit an annual summary report of
 7 its universal system benefits programs activities and expenditures to the department of revenue and to the large
 8 customer's utility. A report must be filed with the department even if a large customer is being reimbursed for a
 9 prior year's project. The annual report of a large customer must identify each qualifying project or expenditure
 10 for which it has claimed a credit and the amount of the credit. Prior approval by the utility is not required, except
 11 as provided in subsection (10)(b).

12 (b) If a large customer claims a credit that the department of revenue disallows in whole or in part, the
 13 large customer is financially responsible for the disallowance. A large customer and the large customer's utility
 14 may mutually agree that credits claimed by the large customer be first approved by the utility. If the utility
 15 approves the large customer credit, the utility may be financially responsible for any subsequent disallowance.

16 (11) A public utility with fewer than 50 customers is exempt from the requirements of this section."

18 **Section 20.** Section 69-8-412, MCA, is amended to read:

19 **"69-8-412. Funds established -- fund administrators designated -- purpose of funds -- department**
 20 **rulemaking authority to administer funds.** (1) If, pursuant to ~~69-8-402(2)(f)~~ 69-8-402(2)(g) or (5)(d), there is
 21 any positive difference between credits and the annual funding requirement, the department of revenue shall
 22 establish one or both of the following funds:

23 (a) a fund to provide for universal system benefits programs other than low-income energy assistance.
 24 The department of environmental quality shall administer this fund.

25 (b) a fund to provide universal low-income energy assistance. The department of public health and
 26 human services shall administer this fund.

27 (2) The purpose of these funds is to fund universal system benefits programs.

28 (3) The department of environmental quality and the department of public health and human services
 29 shall expend the money in each representative fund on universal system benefits programs in the utility service
 30 territory from which the money was received.

1 (4) The department of environmental quality and the department of public health and human services
2 may adopt rules that administer and expend the money in each respective fund based on an annual assessment
3 of identified funding needs in the utility service territory from which the money was received. In assessing the
4 funding needs, the departments shall solicit utility and public comment from the utility service territory from which
5 the money was received. The annual assessment must also take into account existing utility and large customer
6 universal system benefits programs expenditures."

8 **Section 21.** Section 77-1-125, MCA, is amended to read:

9 **"77-1-125. Liability for unauthorized installation or construction of facility or structure on state**
10 **trust land -- penalty.** (1) A person, other than the lessee of the affected state trust land, may not, after
11 September 30, 1997:

12 (a) install or construct a road, pipeline, ditch, utility line, fence, building, or other facility or structure on
13 state trust land without obtaining an easement, lease, license, or other written permission of the department; or

14 (b) disturb state trust land in anticipation of the installation or construction of the facility or structure.

15 (2) A person who violates subsection (1) is liable to the department for a civil penalty in an amount
16 determined by the board. The penalty may be an amount up to three times the full market value of the land
17 disturbed or affected or \$500, whichever is greater.

18 (3) In addition to the penalty provided for in subsection ~~(4)~~ (2), a person who installs or constructs a
19 facility or structure on state trust land without permission is liable for any permanent damage to the state trust land
20 and may be required to remove the facility or structure and to reclaim the disturbed land to the satisfaction of the
21 department or to pay the department's cost of removal and reclamation.

22 (4) If the department allows the facility or structure to remain on state trust land, the department shall
23 also require payment of full market value of any easement, lease, or license required for the facility or structure.

24 (5) The penalties provided in this section do not apply to the lessee of the affected state trust land. The
25 remedies and penalties provided in a state trust easement, lease, or license and the statutes and regulations
26 under which the easement, lease, or license was entered are the exclusive remedies and penalties that may be
27 applied to a lessee.

28 (6) The penalties provided in this section do not apply to persons who have inadvertently installed or
29 constructed pipelines or utility lines within 20 feet of the easement boundaries granted by the state.

30 (7) The penalties provided in this section do not apply to facilities or structures installed on lands

1 acquired by the state through exchange or purchase that were authorized with the permission of the previous
2 landowner or through authority granted by an appropriate government agency."

4 **Section 22.** Section 80-7-1007, MCA, is amended to read:

5 **"80-7-1007. Rulemaking authority.** (1) Unless otherwise provided in Title 81, chapters 2 and 7, or this
6 chapter, each of the departments may adopt rules for the prevention, early detection, and control of invasive
7 species under the departments' jurisdiction, including rules for the:

8 (a) implementation of the invasive species strategic plan adopted pursuant to 80-7-1006;

9 (b) transportation of an invasive species or any agent likely to be a carrier of an invasive species;

10 (c) designation, regulation, and treatment of an invasive species management area under 80-7-1008,
11 including rules pertaining to:

12 (i) the use of quarantine regulations and measures;

13 (ii) the movement of vessels and equipment within, to, or from the area; and

14 (iii) the inspection and cleaning of vessels and equipment moving within, to, or from the area; and

15 (d) manner in which vessels and equipment, including bilges, livewells, bait containers, and other
16 boating-related equipment, traveling in the state must be cleaned to ensure that they are free from the presence
17 of an invasive species.

18 (2) The departments shall adopt rules for the administration of the statewide invasive species
19 management area established in 80-7-1015, including rules specifying the method or methods for preventing the
20 introduction or further introduction of invasive species into the state, and shall adopt rules for:

21 (a) the use of quarantine measures;

22 (b) the movement of vessels and equipment into the state; and

23 (c) the manner in which check stations will be used to inspect, clean, and decontaminate vessels and
24 equipment moving into the state."

25

26 **Section 23.** Section 85-7-1411, MCA, is amended to read:

27 **"85-7-1411. Authority to acquire, construct, maintain, operate, and lease various undertakings.**

28 (1) An irrigation district may:

29 (a) construct, acquire by gift, purchase, or lease, or improve any undertaking, within or outside the
30 irrigation district, and acquire by gift, purchase, or lease land or rights in land or water rights in connection with

1 the undertaking;

2 (b) operate and maintain or enter into a contract for the operation and maintenance of any undertaking
3 and furnish or enter into a contract for the furnishing of services, facilities, and commodities of the undertaking
4 for its own use and for the use of public and private consumers within or outside the territorial boundaries of the
5 irrigation district. However, an irrigation district may not furnish or enter into a contract for the furnishing of
6 electrical energy or capacity except to a qualified purchaser under the Public Utility Regulatory ~~Policy~~ Policies
7 Act of 1978.

8 (c) lease any undertaking to a private or governmental entity.

9 (2) This section may not be construed to permit an irrigation district to condemn any property owned or
10 controlled by a rural electric cooperative or a utility, whether publicly or privately owned. An irrigation district is
11 expressly prohibited from condemning, pursuant to Title 70, chapter 30, property owned or controlled by a rural
12 electric cooperative or utility."

15 to implement 1-11-101(2)(g)(ii) by correcting any clearly inaccurate references to other sections of the Montana
