5	A BILL FOR AN ACT ENTITLED: "AN ACT REVISING LAWS RELATED TO THE ISSUANCE OF FREE ELK
6	HUNTING LICENSES AND PERMITS TO LANDOWNERS WHO OFFER FREE PUBLIC ELK HUNTING;
7	AMENDING SECTION 87-2-513, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 87-2-513, MCA, is amended to read:
12	"87-2-513. Either-sex or antlerless elk <u>license or</u> permit for landowner who offers free public elk
13	hunting terms, conditions, and issuance of permit. (1) In addition to any elk permits offered for sale, the
14	<del>department may, for</del> <u>For</u> wildlife management purposes, <del>issue an either-sex or antlerless elk permit</del> <u>the</u>
15	department may issue, at no cost to a landowner who provides free public elk hunting on the landowner's property
16	and who otherwise meets the conditions of this section. The department may issue elk permits to the public, at
17	regular cost and in the number authorized in subsection (3), for hunting on the property of a landowner who opens
18	property for public elk hunting for wildlife management purposes pursuant to this section, an either-sex or
19	antlerless elk license, permit, or combination thereof as required in that hunting district for the landowner or the
20	landowner's designee to hunt on the landowner's property. A designee may be an immediate family member or
21	an authorized full-time employee of the landowner.
22	(2) To be eligible for a license or permit pursuant to this section, a landowner:
23	(a) must own occupied elk habitat that is large enough, in the department's determination, to
24	accommodate successful public hunting;
25	(b) may not have been issued a Class A-7 landowner license pursuant to 87-2-501(3) during the license
26	year;
27	(c) must have entered into a contractual public elk hunting access agreement with the department in
28	accordance with subsection (7) that allows public access for free public elk hunting on the landowner's property
29	throughout the regular hunting season and that includes public hunting by permitholders using permits that are
30	valid for the hunting district; and

4	(3) Subject to the management provisions provided in 87-1-321 through 87-1-325, not more than 20	%
5	of permits issued pursuant to this section may be issued at no cost to a landowner, an immediate family memb	er
6	of a landowner, or an authorized full-time employee of a landowner. The remaining permits must be issued to th	e
7	public on a first-come, first-served basis.	
8	(3) For every four members of the public allowed to hunt under the contractual public elk hunting acces	ss
9	agreement, the department may issue one license, permit, or combination thereof pursuant to subsection (1). The	<u>1e</u>
10	department may limit the total number of licenses and permits issued under this section.	
11	(4) A license or permit issued pursuant to this section:	
12	(a) is nontransferable and may not be sold <u>or bartered;</u> and	
13	(b) may only be used for hunting conducted on property that is opened to public access pursuant to th	is
14	section.	
15	(5) The department may prioritize distribution of the <u>licenses or</u> permits <u>under subsection (1)</u> accordir	٦g
16	to the areas the department determines are most in need of management.	
17	(6) If the department determines that a landowner or landowner's designee has not abided by the	٦e
18	restrictions and conditions of a license or permit issued pursuant to this section, that landowner or landowner	r's
19	designee is not eligible to receive another <u>license or</u> permit pursuant to this section during any subsequent licens	se
20	year.	
21	(7) (a) The department, through the commission, may authorize the issuance of permits under th	lis
22	<del>section to a landowner who enters into a <u>A</u> contractual public elk hunting access agreement <del>with the departme</del></del>	nt
23	that defines must define the areas that will be open to public elk hunting, the number of public elk hunting day	ys
24	that will be allowed on the property, and other factors that the department and the landowner consider necessa	ry
25	for the proper management of elk on the landowner's property.	
26	(b) The department shall select public hunters eligible to hunt on the landowner's property through	а
27	random drawing of holders of existing licenses or permits in that hunting district."
