8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10	Section 1. Section 7-4-2631, MCA, is amended to read:
11	"7-4-2631. Fees of county clerk. (1) Except as provided in 7-2-2803(4), 7-4-2632, and 7-4-2637, the
12	county clerks shall charge, for the use of their respective counties:
13	(a) for filing and indexing each writ of attachment, execution, certificate of sale, lien, or other instrument
14	required by law to be filed and indexed, \$5;
15	(b) for filing of subdivision and townsite plats, \$25 plus:
16	(i) for each lot up to and including 100, 50 cents;
17	(ii) for each additional lot in excess of 100, 25 cents;
18	(c) for filing certificates of surveys and amendments thereto, \$25 plus 50 cents per tract or lot;
19	(d) for each page of a document required to be filed with a subdivision, townsite plat, or certificate of
20	survey for which a filing fee is not otherwise set by law, \$1;
21	(e) for a copy of a record or paper:
22	(i) for the first page of any document, 50 cents, and 25 cents for each subsequent page; and
23	(ii) for each certification with seal affixed, \$2;
24	(f) for searching an index record of files of the office for each year when required in abstracting or
25	otherwise, 50 cents;
26	(g) for administering an oath with certificate and seal, no charge;
27	(h) for taking and certifying an acknowledgment, with seal affixed, for signature to it, no charge;
28	(i) for filing, indexing, or other services provided for by Title 30, chapter 9A, part 5, the fees prescribed
29	under those sections;
30	(j) for recording each stock subscription and contract, stock certificate, and articles of incorporation for

- 2 (k) for filing a copy of notarial commission and issuing a certificate of official character of such notary
- 3 public, \$2;
- 4 (I) for each certified copy of a birth certificate, \$5 \$10 \$8, and for each certified copy of a death certificate,
- 5 <del>\$3 \$6</del> \$5;
- 6 (m) for electronic storage of minutes of an administrative board, district, or commission pursuant to
- 7 7-1-204, 7-11-1030, 7-13-2350, 7-22-2113, 7-33-2112, or 76-15-324, no charge;
- 8 (n) for filing, recording, or indexing any other instrument not expressly provided for in this section or
- 9 7-4-2632, the same fee provided in this section or 7-4-2632 for a similar service.
- 10 (2) The county clerks shall charge, for the use of their respective counties, the fee as provided in
- 11 7-4-2632 for recording and indexing the following:
- 12 (a) each certificate of location of a quartz or placer mining claim or millsite claim, including a certificate
- 13 that the instrument has been recorded with the seal affixed; and
- 14 (b) each affidavit of annual labor on a mining claim, including a certificate that the instrument has been
- 15 recorded with the seal affixed.
- 16 (3) State agencies submitting documents to be put of record shall pay the fees provided for in this
- 17 section. If a state agency or political subdivision has requested an account with the county clerk, any applicable
- 18 fees must be paid on a periodic basis."
