12	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

14	Section 1. Section 45-5-501, MCA, is amended to read:
15	<b>"45-5-501. Definitions.</b> (1) (a) As used in 45-5-502, 45-5-503, and 45-5-508, the term "consent" means
16	words or overt actions indicating a freely given agreement to have sexual intercourse or sexual contact and is
17	further defined but not limited by the following:
18	(i) an expression of lack of consent through words or conduct means there is no consent or that consent
19	has been withdrawn;
20	(ii) a current or previous dating or social or sexual relationship by itself or the manner of dress of the
21	person involved with the accused in the conduct at issue does not constitute consent; and
22	(iii) lack of consent may be inferred based on all of the surrounding circumstances and must be
23	considered in determining whether a person gave consent.
24	(b) Subject to subsections (1)(c) <del>and (1)(d),</del> <u>through (1)(f),</u> the victim is incapable of consent because
25	the victim is:
26	(i) mentally disordered or incapacitated;
27	(ii) physically helpless;
28	(iii) overcome by deception, coercion, or surprise;
29	(iv) less than 16 years old;
30	(v) incarcerated in an adult or juvenile correctional, detention, or treatment facility or is on probation or

5	(3) As used in 45-5-502 and this section, the following definitions apply:
6	(a) "Parole":
7	(i) in the case of an adult offender, has the meaning provided in 46-1-202; and
8	(ii) in the case of a juvenile offender, means supervision of a youth released from a state youth
9	correctional facility, as defined in 41-5-103, to the supervision of the department of corrections.
10	(b) "Probation" means:
11	(i) in the case of an adult offender, release without imprisonment of a defendant found guilty of a crime
12	and subject to the supervision of a supervising authority; and
13	(ii) in the case of a juvenile offender, supervision of the juvenile by a youth court pursuant to Title 41,

15	(c) (I) "Psychotherapy services" means treatment, diagnosis, or counseling in a professional relationship
16	to assist individuals or groups to alleviate behavioral or mental health disorders, understand unconscious or
17	conscious motivation, resolve emotional, relationship, or attitudinal conflicts, or modify behaviors that interfere
18	with effective emotional, social, or intellectual functioning REGARDLESS OF WHETHER THE INDIVIDUAL PROVIDING THE
19	PSYCHOTHERAPY SERVICES IS LICENSED OR UNLICENSED.
20	(II) THE TERM DOES NOT INCLUDE A PARTNER SURROGATE WORKING WITH A SOCIAL WORKER, A PROFESSIONAL
21	COUNSELOR, OR A LICENSED CLINICAL PROFESSIONAL COUNSELOR AS THOSE PROFESSIONALS ARE LICENSED IN TITLE
22	<u>37, CHAPTER 22 OR 23.</u>
23	(c)(d) "Supervising authority" includes a court, including a youth court, a county, or the department of
24	corrections."

26	Section 2. Section 45-5-502, MCA, is amended to read:
27	"45-5-502. Sexual assault. (1) A person who knowingly subjects another person to any sexual contact
28	without consent commits the offense of sexual assault.
29	(2) (a) On a first conviction for sexual assault, the offender shall be fined an amount not to exceed \$500
30	or be imprisoned in the county jail for a term not to exceed 6 months, or both.

(b) On a second conviction for sexual assault, the offender shall be fined an amount not to exceed
\$1,000 or be imprisoned in the county jail for a term not to exceed 1 year, or both.

3 (c) On a third and subsequent conviction for sexual assault, the offender shall be fined an amount not
4 to exceed \$10,000 or be imprisoned for a term not to exceed 5 years, or both.

5 (3) If the victim is less than 16 years old and the offender is 3 or more years older than the victim or if 6 the offender inflicts bodily injury upon anyone in the course of committing sexual assault, the offender shall be 7 punished by life imprisonment or by imprisonment in the state prison for a term of not less than 4 years, unless 8 the judge makes a written finding that there is good cause to impose a term of less than 4 years and imposes a 9 term of less than 4 years, or more than 100 years and may be fined not more than \$50,000.

(4) An act "in the course of committing sexual assault" includes an attempt to commit the offense or flight
after the attempt or commission.

(5) (a) Subject to subsections (5)(b) and (5)(c), through (5)(e), consent is ineffective under this section
 if the victim is:

(i) incarcerated in an adult or juvenile correctional, detention, or treatment facility or is on probation or
 parole and the perpetrator is an employee, contractor, or volunteer of the supervising authority and has
 supervisory or disciplinary authority over the victim, unless the act is part of a lawful search;

17 (ii) less than 14 years old and the offender is 3 or more years older than the victim;

18 (iii) receiving services from a youth care facility, as defined in 52-2-602, and the perpetrator:

19 (A) has supervisory or disciplinary authority over the victim or is providing treatment to the victim; and
