7	A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING PUBLIC NOTICE FOR CERTAIN CENTERLINE
8	RUMBLE STRIP PROJECTS; AND AMENDING SECTION 60-2-245, MCA."

10	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

12	Section 1. Section 60-2-245, MCA, is amended to read:
13	"60-2-245. Construction projects project impacts notice. (1) (a) After the commission has
14	selected and prioritized a construction project under 60-2-110, the department or the commission shall determine
15	whether the project will have a substantial impact on the public. If the department or the commission determines
16	that the project will have a substantial impact, the department shall ensure that the public, in the area where the
17	project is located and in areas adjacent to the project area, as provided in subsection (3)(a)(i), is notified of the
18	project and is provided with periodic updates on the status of the project as provided in this section.
19	(b) A project with a substantial impact includes but is not limited to:
20	(i) a project for which additional right-of-way is necessary for project completion: and
21	(ii) the INITIAL installation of centerline rumbles RUMBLE strips within 200 yards of a residence RESIDENTIAL
22	BUILDING, AS MEASURED FROM ANY POINT ON A PROSPECTIVE RUMBLE STRIP TO ANY PART OF A RESIDENTIAL BUILDING.
23	(2) (a) The department shall engage the public through informational meetings or other appropriate
24	means at major milestones in phases of the project, from the selection of the project by the commission to project
25	completion. To engage and inform the public, the department shall:
26	(i) place and maintain current information regarding the status of the project in a prominent location on
27	the department's website;
28	(ii) use newspaper, television, and radio formats as appropriate to provide information to the public
29	regarding the status of the project;
30	(iii) investigate the use of other types of media, such as electronic social media, to provide information

1 to the public regarding the status of the project; and

2 (iv) maintain an electronic notification list as provided in subsection (3).

3 (b) For the purposes of this section, phases of a project include but are not limited to survey, design, and 4 right-of-way phases of a project.

- (3) (a) For each proposed project identified under subsection (1), the department shall maintain a list of:
- (i) all local government and tribal government entities within which the project will be located that are likely to be impacted by the project or that are adjacent to the project area; and
- (ii) organizations and associations that represent motorists and commercial motor vehicle companies and operators that regularly conduct business in the project area and any other organizations or entities that represent travelers or those who regularly use highways in the project area for recreational or business purposes.
- (b) The department shall notify the entities identified in subsection (3)(a) when the commission selects a construction project as provided in subsection (1) and shall provide project updates of major milestones in phases of the project through electronic communication to any entity that submits a request to receive updates."
