9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	NEW SECTION. Section 1. Short title. [Sections 1 through 4] may be cited as the "Montana Paycheck
12	<del>Transparency Act".</del>
13	
14	NEW SECTION. Section 1. Paycheck transparency employee protections. (1) An employer may
15	not require as a condition of employment or application for employment that an individual:
16	(a) provide information regarding past wages, benefits, or other salary history;
17	(b) refrain from disclosing, discussing, or sharing information about the amount of the individual's wages,
18	benefits, or other compensation or from inquiring, discussing, or sharing information about another employee's
19	wages, benefits, or other compensation if that other employee voluntarily disclosed the information; or
20	(c) sign a waiver or other document agreeing not to disclose the amount of the employee's own wages,
21	benefits, or other compensation or to inquire about or discuss with others information about another employee's
22	wages, benefits, or other compensation if that other employee voluntarily disclosed the information.
23	(2) Information regarding wages, benefits, or other compensation of a public employee as defined in
24	2-2-102, including state employees as defined in 2-18-701 and officials or appointees of officials described in
25	2-18-103 or 2-18-104, is a public record.

27	<u>NEW SECTION.</u> Section 3. Paycheck transparency unlawful acts of employer. (1) It is unlawful
28	for an employer or an employer's agent to formally or informally discipline or otherwise discriminate against an
29	employee because the employee:
30	(a) has disclosed the employee's wages, benefits, or other compensation or has inquired about or

discussed the wages, benefits, or other compensation of another employee; 1 2 (b) has lodged a complaint or has testified, assisted, or participated in any manner in an informal or 3 formal investigation of prohibited acts or practices; 4 (c) is known by the employer to be about to lodge a complaint, testify, assist, or participate in any manner 5 in an informal or formal investigation of prohibited acts or practices; or (d) has opposed a prohibited act or practice or asserted a right that is protected under [section 2]. 6 7 (2) This section may not be construed to: (a) create an obligation in an employer, other than a public employer under public record laws, or in an 8 employee to disclose wages: 9 10 (b) permit an employee, without written consent of an employer, to disclose proprietary information, trade 11 secret information, or information that is otherwise subject to a legal privilege or protected by law; 12 (c) require an employee to disclose the employee's own wages, benefits, or other compensation; or 13 (d) limit the rights of an employee that are provided under another provision of law or a collective 14 bargaining agreement. 15 16 NEW SECTION. Section 4. Paycheck transparency -- employee notification. (1) An employer shall 17 post a clearly visible notice as provided in subsection (2) in the employer's workplace in a space where 18 employees congregate. 19 (2) The notice, in a font size no smaller than 24 point, must state that an employer is engaged in an 20 unlawful practice if the employer requires as a condition of employment or application for employment that an 21 individual: 22 <del>(a)provide information regarding past wages, benefits, or other salary history;</del> 23 (b) refrain from disclosing, discussing, or sharing information about the amount of the individual's wages, 24 benefits, or other compensation or from inquiring, discussing, or sharing information about another employee's 25 wages, benefits, or other compensation if that other employee voluntarily disclosed the information; or 26 (c) sign a waiver or other document agreeing not to disclose the amount of the employee's own wages, 27 benefits, or other compensation or to inquire about or discuss with others information about another employee's 28 wages, benefits, or other compensation if that other employee voluntarily disclosed the information. 29
