9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	NEW SECTION. Section 1. Transfer of funds grant program. (1) The superintendent of public
12	instruction is directed to transfer \$100,000 out of the state level activities budget (program 06) to the local
13	education activities budget (program 09) of the superintendent's budget for fiscal year 2020.
14	(2) (a) The superintendent of public instruction is directed to use the \$100,000 of funds transferred
15	pursuant to subsection (1) to create and administer a school safety professional development grant program.
16	(b) The superintendent of public instruction shall offer grants to school districts to provide professional
17	development on topics related to school safety. Acceptable uses for the school safety professional development
18	grants include but are not limited to individual training of school employees, improvement of facilities, and
19	programs that promote the protection of students from violence, theft, bullying, exposure to weapons, and the sale
20	or use of illegal substances on school grounds.
21	(3) For purposes of this section, "school safety" means keeping students safe from violence, bullying,
22	harassment, and substance use at schools and school-related activities.

24	COORDINATION SECTION. Section 2. COORDINATION INSTRUCTION. IF BOTH HOUSE BILL NO. 2 AND [THIS
25	ACT] ARE PASSED AND APPROVED AND HOUSE BILL NO. 2 INCLUDES A TRANSFER FOR THE SUPERINTENDENT OF PUBLIC
26	INSTRUCTION TO CREATE AND ADMINISTER A SCHOOL SAFETY PROFESSIONAL GRANT PROGRAM, THEN:
27	(1) [SECTION 1(1) OF THIS ACT] IS VOID; AND
28	(2) IN [SECTION 1(2)(A) OF THIS ACT], THE REFERENCE TO "SUBSECTION (1)" MUST BE CHANGED TO "HOUSE BILL
