The department shall distribute the money proportionally based on the formula distributions of 2016 4th quarter excess oil and natural gas production tax to zone 1 and 2 school districts, not including distributions for infrastructure grants. This money may not be counted against a district's limit of retained oil and natural gas production taxes pursuant to 20-9-310. The trustees of a district receiving a distribution under this section may deposit the money in any budgeted fund of the district."
