

1 HOUSE RESOLUTION NO. 2

2 INTRODUCED BY A. OLSEN

4 A RESOLUTION OF THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA URGING
5 CONGRESS TO PROPOSE, A CONSTITUTIONAL AMENDMENT ABOLISHING CORPORATE PERSONHOOD
6 AND DECLARING THAT MONEY IS NOT FREE SPEECH.

8 WHEREAS, government of, by, and for the people is an American value; and

9 WHEREAS, the people of the United States enacted the Constitution of the United States to ensure
10 self-government and secure the blessings of liberty; and

11 WHEREAS, American voters have passed amendments to the Constitution of the United States
12 expanding self-government and the blessings of liberty to more and more people; and

13 WHEREAS, Montana voters in 2012 overwhelmingly passed Initiative 166, asserting that the people of
14 Montana regard money as property and not as free speech and regard the rights under the United States
15 Constitution as rights of human beings--not rights of corporations, calling for the Montana congressional
16 delegation to propose an amendment to the United States Constitution establishing that corporations are not
17 human beings entitled to constitutional rights, establishing a state policy that corporations are not entitled to
18 constitutional rights because corporations are not human beings, and asserting that there should be a level
19 playing field in campaign spending and that corporate campaign contributions should be limited; and

20 WHEREAS, free and fair elections are essential to democracy and effective representative
21 self-governance; and

22 WHEREAS, persons are rightfully recognized as human beings; and

23 WHEREAS, corporations are not recognized in the United States Constitution, and have never been
24 granted constitutional rights by the people; and

25 WHEREAS, corporations are not human beings or people but are created by human beings or people;
26 and

27 WHEREAS, money is property--not free speech; and

28 WHEREAS, people across the United States are joining to call for an amendment to the United States
29 Constitution to abolish corporate personhood and the doctrine of money as free speech.

1 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF
2 MONTANA:

3 That the 66th House of Representatives of the state of Montana urges Congress to propose an
4 amendment to the United States Constitution stating:

5 "Section 1. The rights extended by the Constitution are the rights of natural persons only. Artificial entities,
6 such as corporations, limited liability companies, and other entities, established by the laws of any State, the
7 United States, or any foreign state shall have no rights under this Constitution and are subject to regulation by
8 the People, through Federal, State, or local law.

9 Section 2. To ensure all citizens have access to the political process, money is not equal to free speech
10 and therefore nonhuman entities are prohibited from making contributions or expenditures for or against a
11 candidate or ballot issue."

12 BE IT FURTHER RESOLVED, that the Secretary of State send copies of this resolution to the individual
13 members of the United States House of Representatives and the United States Senate.
