2 INTRODUCED BY T. RICHMOND

3 BY REQUEST OF THE DEPARTMENT OF ENVIRONMENTAL QUALITY

5 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING LAWS RELATED TO OPENCUT MINING;
6 CLARIFYING EFFECTIVE AND EXPIRATION DATES FOR PERMITS; REQUIRING LANDOWNERS TO ALLOW
7 ACCESS FOR RECLAMATION; EXTENDING APPLICATION DEADLINES FOR WEATHER OR OTHER FIELD
8 CONDITIONS; REVISING THE BONDING PROCESS; ESTABLISHING FEES; AMENDING SECTIONS
9 15-38-106, 15-38-113, 82-4-405, 82-4-424, 82-4-425, 82-4-426, 82-4-427, 82-4-431, 82-4-432, 82-4-433,
10 82-4-434, 82-4-437, AND 82-4-438, MCA; AND PROVIDING AN EFFECTIVE DATE."

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

13

14 **Section 1.** Section 15-38-106, MCA, is amended to read:

15 **"15-38-106. Payment of tax -- records -- collection of taxes -- refunds.** (1) The tax imposed by this
16 chapter must be paid by each person to which the tax applies, on or before the due date of the annual statement
17 established in 15-38-105, on the value of product in the year preceding January 1 of the year in which the tax is
18 paid. The tax must be paid to the department at the time that the statement of yield for the preceding calendar
19 year is filed with the department.

20 (2) The department shall, in accordance with the provisions of 17-2-124, deposit the proceeds from the
21 resource indemnity and ground water assessment tax ~~and money deposited pursuant to 82-4-424(3)~~ in the
22 following order:

23 (a) annually in due course, from the proceeds of the tax to the CERCLA match debt service fund
24 provided in 75-10-622, the amount necessary, as certified by the department of environmental quality, after
25 crediting to the CERCLA match debt service fund amounts transferred from the CERCLA cost recovery account
26 established under 75-10-631, to pay the principal of, premium, if any, and interest during the next fiscal year on
27 bonds or notes issued pursuant to 75-10-623;

28 (b) \$366,000 of the proceeds from the tax in the ground water assessment account established by
29 85-2-905;

30 (c) for the biennium beginning July 1, 2007, \$150,000 of the proceeds from the tax in the water storage

1 state special revenue account established in 85-1-631;

2 (d) 50% of the remaining proceeds from the tax divided equally between the environmental quality
3 protection fund established in 75-10-704 and the hazardous waste/CERCLA special revenue account established
4 in 75-10-621; and

5 (e) all remaining proceeds from the tax in the natural resources projects state special revenue account,
6 established in 15-38-302, for the purpose of making grants to be used for mineral development reclamation
7 projects and renewable resource projects.

8 (3) Each person to whom the tax applies shall keep records in accordance with 15-38-105, and the
9 records are subject to inspection by the department upon reasonable notice during normal business hours.

10 (4) The department shall examine the statement and compute the taxes to be imposed, and the amount
11 computed by the department is the tax imposed, assessed against, and payable by the taxpayer. If the tax found
12 to be due is greater than the amount paid, the excess must be paid by the taxpayer to the department within 30
13 days after written notice of the amount of deficiency is mailed by the department to the taxpayer. If the tax
14 imposed is less than the amount paid, the difference must be applied as a tax credit against tax liability for
15 subsequent years or refunded if requested by the taxpayer."

17 **Section 2.** Section 15-38-113, MCA, is amended to read:

18 **"15-38-113. Exemption from resource indemnity and ground water assessment tax.** The following
19 persons are exempt from the resource indemnity and ground water assessment tax:

20 (1) a person who has paid the license tax on a metal mine under the provisions of Title 15, chapter 37,
21 part 1;

22 (2) a person who has paid the tax on oil and natural gas production under the provisions of Title 15,
23 chapter 36, part 3;

24 (3) a person who holds a permit pursuant to Title 82, chapter 4, part 4, and is subject to the ~~fee~~ fees
25 provided for in 82-4-437(2) and (3); or

26 (4) a county, city, or town that holds a permit pursuant to Title 82, chapter 4, part 4."
27

28 **Section 3.** Section 82-4-405, MCA, is amended to read:

29 **"82-4-405. Inapplicability to government.** (1) Except as provided in subsection (2), the provisions of
30 this part relating to fees or bonds do not apply to the federal government or its agencies, the state of Montana,

1 counties, cities, or towns.

2 (2) Counties, cities, and towns are responsible for the ~~fee~~ fees required pursuant to 82-4-437(2) and (3)."

3

4 **Section 4.** Section 82-4-424, MCA, is amended to read:

5 **"82-4-424. Receipt and expenditure of funds -- disposition of penalties and other money.** (1) The

6 department may receive any federal funds, state funds, or any other funds for the reclamation of affected land.

7 The department may cause the reclamation work to be done by its employees, by employees of other

8 governmental agencies, by soil conservation districts, or through contracts with qualified persons.

9 (2) All penalties and other money paid under the provisions of this part, except ~~annual~~ fees provided for

10 in 82-4-437, must be deposited in the environmental rehabilitation and response account in the state special

11 revenue fund provided for in 75-1-110. Funds held by the department as bond or as a result of bond forfeiture

12 that are no longer needed for reclamation and for which the department is not able to locate a surety or other

13 person who owns the funds after diligent search must be deposited in the environmental rehabilitation and

14 response account in the state special revenue fund.

15 ~~(3) The department shall deposit 85% of proceeds from annual fees into the opencut fund established~~

16 ~~in 82-4-438 and transfer 15% of the proceeds from the fees to the department of revenue for distribution in~~

17 ~~accordance with 15-38-106."~~

18

19 **Section 5.** Section 82-4-425, MCA, is amended to read:

20 **"82-4-425. Inspection of opencut operations.** The department or its ~~accredited~~ representatives may

21 enter upon lands subjected to opencut operations at all reasonable times for the purpose of inspection to

22 determine whether the provisions of this part have been complied with. The department shall attempt to provide

23 reasonable notice to a permitted operator when practicable under the circumstances."

24

25 **Section 6.** Section 82-4-426, MCA, is amended to read:

26 **"82-4-426. Reclamation of land on which bond forfeited.** In keeping with the provisions of this part,

27 the department ~~may~~ or its agents or contractors may enter and reclaim any affected land with respect to which

28 a bond has been forfeited."

29

30 **Section 7.** Section 82-4-427, MCA, is amended to read:



1 **"82-4-427. Hearing -- appeal -- venue.** (1) (a) Subject to subsections (1)(b) and (1)(c), a person whose
2 interests are or may be adversely affected by a final decision of the department to approve or disapprove a permit
3 application and accompanying material or a permit amendment application and accompanying material under
4 this part is entitled to a hearing before the board if a written request stating the reasons for the appeal is
5 submitted to the board within 30 days of the department's decision.

6 (b) If an application was noticed publicly as required by this part, to be eligible to file for an appeal a
7 person must have either submitted comments to the department on an application or submitted comments at a
8 public meeting held under 82-4-432.

9 (c) Subsection (1)(b) does not apply to a person filing for an appeal of an application that was not
10 required to be noticed publicly by this part.

11 (2) An operator may request a hearing before the board on:

12 (a) a final decision of the department director pursuant to 82-4-436(4) by submitting a request for a
13 hearing within 15 days of receipt of notice of the director's decision; and

14 (b) an order of suspension or revocation issued under 82-4-442 by filing a request for hearing within 30
15 days of receipt of the decision.

16 (3) The operator or the landowner may request a hearing before the board on a decision on a bond
17 release application by submitting a written request stating the reasons for the appeal within 30 days of the receipt
18 of the decision.

19 (4) The contested case provisions of the Montana Administrative Procedure Act, Title 2, chapter 4, part
20 6, apply to a hearing held under this section.

21 (5) A petition for judicial review of a board decision made pursuant to this section must be brought in the
22 county in which the permitted activity is proposed to occur or, if mutually agreed upon by both parties in the
23 action, in the first judicial district, Lewis and Clark County. If an activity is proposed to occur in more than one
24 county, the action may be brought in any of the counties in which the activity is proposed to occur.

25 (6) The petition for judicial review must include the party to whom the permit was issued or the applicant
26 unless otherwise agreed to by the permitholder or applicant. All judicial challenges of permits for projects with
27 a project cost, as determined by the court, of more than \$1 million must have precedence over any civil cause
28 of a different nature pending in that court. If the court determines that the challenge was without merit or was for
29 an improper purpose, such as to harass, to cause unnecessary delay, or to impose needless or increased cost
30 in litigation, the court may award attorney fees and costs incurred in defending the action."

- 2 **Section 8.** Section 82-4-431, MCA, is amended to read:
- 3 **"82-4-431. Permit for mining, processing, and reclamation required.** (1) A permit is required for an
- 4 operator who:
- 5 (a) conducts an opencut operation that results in the removal of more than 10,000 cubic yards of
- 6 materials and overburden;
- 7 (b) conducts more than one opencut operation where each of the operations results in the removal of
- 8 less than 10,000 cubic yards of materials and overburden but the operations result in the removal of 10,000 cubic
- 9 yards or more of materials and overburden in the aggregate; or
- 10 (c) removes materials or overburden at a previously mined site where the removal, combined with the
- 11 amount of previously mined materials and overburden, exceeds 10,000 cubic yards.
- 12 (2) Except as provided in or conditioned under subsections (5) and (6), an operator who holds a permit
- 13 under this part may conduct a limited opencut operation without first securing an additional permit or an
- 14 amendment to an existing permit if the limited opencut operation meets the following criteria:
- 15 (a) the area to be disturbed by the limited opencut operation is located more than 1 mile from the
- 16 operator's nearest existing limited opencut operation;
- 17 (b) the total amount of materials and overburden removed does not exceed 10,000 cubic yards and the
- 18 total area from which the materials and overburden are removed does not exceed 5 acres; and
- 19 (c) the operator:
- 20 (i) submits appropriate site and opencut operation information on a limited opencut operation form
- 21 provided by the department; and
- 22 (ii) within 1 year of the department's receipt of the limited opencut operation form, salvages all soil from
- 23 the area to be disturbed, removes the materials, grades the affected land to 3:1 or flatter slopes, blends the
- 24 graded land into the surrounding topography, replaces an appropriate amount of overburden and all soil, and
- 25 reclaims to conditions present prior to mining all access roads used for the operation unless the landowner
- 26 requests in writing that specific roads or portions of the roads remain open. Roads left open at the landowner's
- 27 request must be sized to support the use of the road after opencut operations.
- 28 (iii) at the first seasonal opportunity, seeds or plants all affected land with vegetative species that meet
- 29 the requirements of 82-4-434.
- 30 (3) At the operator's request and with department approval, the operator may have up to 1 additional

1 year to perform the reclamation required by subsection (2)(c), provided the operator does not apply to extend or
2 continue the limited opencut operation pursuant to subsection (4).

3 (4) (a) An operator who commences a limited opencut operation pursuant to subsection (2) may apply
4 for a permit to continue or expand that opencut operation pursuant to the provisions of this subsection (4).

5 (b) The permit application must be complete within 180 days of the department's receipt of the limited
6 opencut operation form.

7 (c) If the complete permit application is acceptable within 1 year of the department's receipt of the limited
8 opencut operation form, the provisions of subsections (2)(c)(ii) and (2)(c)(iii) do not apply and reclamation must
9 be conducted as prescribed in the permit.

10 (d) If the complete permit application is not acceptable within 1 year of the department's receipt of the
11 limited opencut operation form, the application is considered abandoned and void. Starting 3 days after the
12 department notifies the applicant that the application is considered abandoned and void, the applicant has 180
13 days to complete the reclamation provided for in subsections (2)(c)(ii) and (2)(c)(iii).

14 (e) If the permit application is withdrawn by the applicant within 1 year of the department's receipt of the
15 limited opencut operation form, the reclamation provided for in subsections (2)(c)(ii) and (2)(c)(iii) must be
16 completed within 180 days of the date of the withdrawal.

17 (5) The department may refuse to approve an application for issuance of a permit under subsection (1)
18 or may prohibit the operator from conducting an opencut operation under subsection (2) if, at the time of
19 notification by the operator to the department, the operator has a pattern of violations or is in current violation of
20 this part, rules adopted under this part, or provisions of a permit.

21 (6) The department may require an additional bond as a condition for the conduct of an opencut
22 operation under subsection (2).

23 (7) Opencut operations described in subsection (2) may not occur:

24 (a) in ephemeral, intermittent, or perennial streams;

25 (b) in an area where the opencut operation will intercept surface water, ground water, or any slope that
26 is steeper than 3:1; or

27 (c) in any area where mining would be restricted by other laws.

28 (8) Sand and gravel opencut operations must meet applicable local zoning regulations adopted under
29 Title 76, chapter 2.

30 (9) A permit is effective when the department provides written notice to the applicant that the information

1 and materials provided to the department meet the requirements of this part and rules adopted pursuant to this
 2 part.

3 (10) (a) Except as provided in (10)(b), a permit issued under this part expires on the reclamation date
 4 in the plan of operation or after 20 years from the permit issuance date, whichever occurs first.

5 (b) Prior to the expiration of a permit:

6 (i) the operator may file an application to amend the plan of operation to extend the reclamation date
 7 pursuant to 82-4-434(4)(a);

8 (ii) the department may amend the plan of operation pursuant to 82-4-436;

9 (iii) the department may revoke the permit pursuant to 82-4-442; or

10 (iv) the operator and the department may agree to terminate the permit upon mutual written consent.

11 (11) The expiration or termination of a permit issued under this part does not relieve an operator from the
 12 obligation to conduct reclamation as required by the plan of operation from the liability for costs of reclamation
 13 exceeding the amount of the bond."

14

15 **Section 9.** Section 82-4-432, MCA, is amended to read:

16 **"82-4-432. Application for permit -- contents -- issuance -- amendment.** (1) An application for a
 17 permit must be made using forms furnished by the department and must contain the following:

18 (a) the name of the applicant and, if other than the owner of the land, the name and address of the
 19 owner;

20 (b) the type of operation to be conducted;

21 (c) the estimated volume of overburden and materials to be removed;

22 (d) the location of the proposed opencut operation by legal description and county accompanied by a
 23 map showing the location of the proposed operation sufficient to allow the public to locate the proposed site; and

24 (e) a statement that the applicant has the legal right to mine the designated materials in the lands
 25 described.

26 (2) The application must be accompanied by:

27 (a) a bond or security meeting the requirements as set out in this part;

28 (b) a statement from the local governing body having jurisdiction over the area to be mined certifying that
 29 the proposed sand and gravel opencut operation complies with applicable local zoning regulations adopted under
 30 Title 76, chapter 2;

1 (c) a plan of operation that ~~addresses~~ satisfies the requirements of 82-4-434 and rules adopted pursuant
2 to this part related to 82-4-434;

3 (d) written documentation that the landowner has been consulted about the proposed plan of operation;
4 ~~and~~

5 (e) a written agreement between the landowner and the operator allowing the operator access to the site
6 to perform reclamation if the landowner revokes or otherwise terminates the operator's right to mine;

7 ~~(e)(f)~~ a list of surface owners of land located within one-half mile of the boundary of the proposed
8 opencut permit area using the owners of record as shown no more than 60 days prior to the submission of an
9 application in the paper or electronic records of the county clerk and recorder for the county where the proposed
10 opencut operation is located; and

11 (g) documentation of consultation with the state historic preservation office regarding possible
12 archaeological or historical values on the affected land.

13 (3) If, prior to applying for a permit, a person notifies the department of the intention to submit an
14 application and requests that the department examine the area to be mined, the department shall examine the
15 area and make recommendations to the person regarding the proposed opencut operation. The person may
16 request a meeting with the department. The department shall hold a meeting if requested.

17 (4) (a) (i) Except as provided in 75-1-208(4)(b), upon receipt of an application, the department shall,
18 within 5 working days, review the application and notify the person as to whether or not the application is
19 complete. An application is complete if it contains the items listed in subsections (1) and (2). If the department
20 determines that the application is not complete, the department shall notify the applicant in writing and include
21 a detailed identification of information necessary to make the application complete.

22 (ii) The time limit provided in subsection (4)(a)(i) applies to each submittal of the application until the
23 department determines that the application is complete.

24 (b) (i) A determination that an application is complete does not ensure that the application is acceptable
25 and does not limit the department's ability to request additional information or inspect the site during the review
26 process.

27 (ii) Upon determining that an application is complete, the department shall begin reviewing the application
28 for acceptability pursuant to this section.

29 (iii) The department shall accept public comment throughout the review process.

30 (c) The department may declare an application abandoned and void if:

- 1 (i) the applicant fails to respond to the department's written request for more information within 1 year;
2 and
- 3 (ii) the department notifies the applicant of its intent to abandon the application and the applicant fails to
4 provide information within 30 days.
- 5 (d) The department shall notify the applicant when an application is complete and post the complete
6 application on the department's website.
- 7 (5) Within 15 days after the department sends notice of a complete application to the applicant, the
8 applicant shall provide public notice, which must include:
- 9 (a) the name, address, and telephone number of the applicant;
- 10 (b) a description of the acreage, the estimated volume of overburden and materials to be removed, the
11 type of materials to be removed, the facilities, the duration of activities, and the access points of the proposed
12 opencut operation;
- 13 (c) a legal description of the proposed opencut operation and a map, or directions on how to access a
14 map, showing the location of the proposed opencut operation and immediately surrounding property; and
- 15 (d) on a form provided by the department, notification that the application is complete and information
16 on how to request a public meeting pursuant to this section.
- 17 (6) To provide public notice, the applicant shall:
- 18 (a) publish notice at least twice in a newspaper of general circulation in the locality of the proposed
19 opencut operation. A map is not required in the notice if, in addition to the legal description of the proposed
20 opencut operation, the notice provides an address for the map posted on the department's website and
21 instructions for obtaining a paper copy of the map from an applicant. If the notice does not include a map, the
22 applicant shall promptly provide a paper copy to a requestor.
- 23 (b) mail the notice by first-class mail to the board of county commissioners of the county in which the
24 proposed opencut operation is located and to surface owners of land located within one-half mile of the boundary
25 of the proposed opencut permit area using the most current known owners of record as shown in the paper or
26 electronic records of the county clerk and recorder for the county where the proposed opencut operation is
27 located;
- 28 (c) post the notice in at least two prominent locations at the site of the proposed opencut operation,
29 including near a public road if possible; and
- 30 (d) provide the department with the names and addresses of those notified pursuant to subsection (6)(b).

1 (7) (a) Except as provided in subsection (7)(b), the department shall accept requests for a public meeting
2 for 45 days after the department sends notice to the applicant of a complete application. Within this period, unless
3 a public meeting is required pursuant to subsection (9), the department shall notify the applicant as to whether
4 or not the application is acceptable pursuant to subsection (10).

5 (b) If the applicant and the department mutually agree or the applicant submits documentation on a form
6 provided by the department showing that a public meeting will not be required pursuant to subsection (9), the
7 department shall inform the applicant within 30 days of the notice of a complete application as to whether or not
8 the application is acceptable pursuant to subsection (10).

9 (8) If a public meeting is required pursuant to subsection (9), within 30 days from the closing date of the
10 public meeting request period in subsection (7), the department shall:

11 (a) hold a meeting; and

12 (b) notify the applicant as to whether or not the application is acceptable pursuant to subsection (10) or
13 that the application requires an extended review pursuant to 82-4-439.

14 (9) (a) The department shall hold a public meeting in the area of the proposed open-cut operation at the
15 request of:

16 (i) the applicant; or

17 (ii) at least 30% of the property owners or 10 property owners, whichever is greater, notified pursuant to
18 this section. For the purposes of this subsection (9)(a)(ii), multiple property owners of the same parcel are to be
19 counted as a single property owner.

20 (b) To provide notice for a public meeting, the department shall notify by first-class mail or electronically
21 the property owners on the list provided by the applicant pursuant to this section and the board of county
22 commissioners in the county where the proposed open-cut operation is located.

23 (10) (a) An application is acceptable if it complies with the requirements of subsections (1) and (2) and
24 includes a plan of operation that satisfies the requirements of 82-4-434 and rules adopted pursuant to this part
25 related to 82-4-434. If the department determines that the application is not acceptable, the department shall
26 notify the applicant in writing and include a detailed identification of all deficiencies.

27 (b) Within 10 working days of receipt of the applicant's response to the identified deficiencies, the
28 department shall review the responses and notify the applicant as to whether or not the application is acceptable.
29 If the application is unacceptable, the department shall notify the applicant in writing and include a detailed
30 identification of the deficiencies.

1 (c) If the application is acceptable, the department shall issue a permit to the operator that entitles the
2 operator to engage in the opencut operation on the land described in the application.

3 (11) (a) An operator may amend a permit by submitting an amendment application to the department.
4 Upon receipt of the amendment application, the department shall review it in accordance with the requirements
5 and procedures in this section. If the amendment application is acceptable, the department shall issue an
6 amendment to the original permit.

7 (b) An application for an amendment is not subject to the public notice or public meeting requirements
8 of this section or an extended review pursuant to 82-4-439 unless it proposes an increase in permitted acreage
9 of 50% or more of the amount of permitted acreage in the current permit.

10 (c) For amendment applications not subject to the public notice and public meeting requirements of this
11 section, the department shall, within 45 days of notifying the applicant that the application is complete, notify the
12 applicant as to whether or not the application is acceptable pursuant to subsection (10).

13 (12) If weather or other field conditions prevent the department from conducting an adequate site
14 inspection to evaluate a permit or amendment application, the time limits provided in subsections (7) and (11)
15 are suspended until the weather or other field conditions allow for an adequate site inspection.

16 ~~(12)~~(13) The department shall post a copy of an acceptable permit or amendment on its website."
17

18 **Section 10.** Section 82-4-433, MCA, is amended to read:

19 **"82-4-433. Bond.** (1) Before a permit or permit amendment may be issued, a surety bond made payable
20 to the state of Montana and conditioned upon the operator's full compliance with all requirements of this part, the
21 rules adopted under this part, and the permit must be submitted to and approved by the department. The bond
22 must be signed by the applicant as principal and by a good and sufficient corporate surety licensed to do business
23 in the state of Montana. The bond amount must be determined by the department at the cost of reclamation of
24 the affected land by the department. The applicant shall submit a bond that is no less than the amount determined
25 by the department.

26 (2) (a) For opencut operations on federal land within the state, the department may accept a bond
27 payable to the state of Montana and the federal agency administering the land. The bond must provide at least
28 the same amount of financial guarantee as required by this part.

29 (b) The bond must provide that the department may forfeit the bond without the concurrence of the
30 federal land management agency. The bond may provide that the federal land management agency may forfeit

1 the bond without the concurrence of the department. Upon forfeiture by either agency, the bond must be payable
2 to the department and may also be payable to the federal land management agency. If the bond is payable to
3 the department and the federal land management agency, the department, before accepting the bond, shall enter
4 into an agreement or memorandum of understanding with the federal land management agency providing for
5 administration of the bond funds in a manner that will allow the department to provide for compliance with the
6 requirements of this part, the rules adopted under this part, and the permit.

7 (3) In lieu of submitting a surety bond pursuant to subsection (1), the operator may submit cash, a
8 certificate of deposit, a letter of credit in a form acceptable to the department, or a bond with property sureties
9 in an amount equal to that of the required bond on conditions as prescribed in this part. In the discretion of the
10 department, surety bond requirements may be fulfilled by the operator's posting a bond with land and
11 improvements and facilities located on the land as security, in which event a surety may not be required but the
12 department may require that the amount of the bond be adjusted to reimburse the department for foreclosure
13 costs.

14 (4) The bond or other security must be increased or reduced as provided in this part.

15 (5) The bond or security remains in effect until the affected land has been reclaimed as provided under
16 the permit and the department has approved the reclamation and released the bond or security. The bond or
17 security may cover only actual affected land and must be increased or reduced to cover only unreclaimed
18 acreages.

19 (6) If the license of a surety that has issued a bond filed with the department pursuant to this part is
20 suspended or revoked, the operator, within 30 days after receiving notice of the suspension or revocation from
21 the department, shall substitute a good and sufficient bond from another surety licensed to do business in the
22 state or shall submit another type of security pursuant to subsection (3). Upon failure of the operator to make the
23 bond substitution within the 30-day time period, the department shall suspend the permit of the operator to
24 conduct opencut operations upon the land described in the permit until the substitution has been made. If the
25 operator demonstrates in writing that the operator has been pursuing a replacement bond in good faith but
26 additional time is necessary to complete the transaction, the department may grant up to an additional 60 days
27 for the operator to submit a replacement bond before suspending the permit.
