4 A BILL FOR AN ACT ENTITLED: "AN ACT PROVIDING AN EXEMPTION FROM THE REQUIREMENT FOR  
5 A MOTORCYCLE ENDORSEMENT FOR AN AUTOCYCLE ~~AND A THREE-WHEELED MOTORCYCLE~~;  
6 DEFINING "AUTOCYCLE"; AND AMENDING SECTIONS 61-1-101, 61-3-317, 61-5-102, 61-5-112, AND  
7 61-8-102, MCA."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10  
11 **Section 1.** Section 61-1-101, MCA, is amended to read:

12 **"61-1-101. Definitions.** As used in this title, unless the context indicates otherwise, the following  
13 definitions apply:

14 (1) (a) "Authorized agent" means a person who has executed a written agreement with the department  
15 and is specifically authorized by the department to electronically access and update the department's motor  
16 vehicle titling, registration, or driver records, using an approved automated interface, for specific functions or  
17 purposes on behalf of a third party.

18 (b) For purposes of this subsection (1), "person" means an individual, corporation, partnership, limited  
19 partnership, limited liability company, association, joint venture, state agency, local government unit, another state  
20 government, the United States, a political subdivision of this or another state, or any other legal or commercial  
21 entity.

22 (2) "Authorized agent agreement" means the written agreement executed between an authorized agent  
23 and the department that sets the technical and operational program standards, compliance criteria, payment  
24 options, and service expectations by which the authorized agent is required to operate in performing specific  
25 motor vehicle or driver-related record functions.

26 (3) "Autocycle" means a three-wheeled motorcycle that is equipped with safety belts, roll bars or roll  
27 hoops, a steering wheel, and seating that does not require the operator to straddle or sit astride it.

28 ~~(3)~~(4) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the  
29 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the  
30 transportation of persons for compensation.



1           ~~(4)~~(5) (a) "Business entity" means a corporation, association, partnership, limited liability partnership,  
2 limited liability company, or other legal entity recognized under state law.

3           (b) The term does not include an individual.

4           ~~(5)~~(6) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or attached  
5 to an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not limited to  
6 a cab-over, half cab-over, noncab-over, telescopic, and telescopic cab-over.

7           (b) The term does not include a truck canopy cover or topper.

8           ~~(6)~~(7) "CDLIS driver record" means the electronic record of a person's commercial driver's license status  
9 and history stored as part of the commercial driver's license system established under 49 U.S.C. 31309.

10          ~~(7)~~(8) "Certificate of title" means the paper record issued by the department or by the appropriate agency  
11 of another jurisdiction that establishes a verifiable record of ownership between an identified person or persons  
12 and the motor vehicle specifically described in the record and that provides notice of a perfected security interest  
13 in the motor vehicle.

14          ~~(8)~~(9) "Commercial driver's license" means:

15          (a) a driver's license issued under or granted by the laws of this state that authorizes a person to operate  
16 a class of commercial motor vehicle; or

17          (b) the privilege of a person to drive a commercial motor vehicle, whether or not the person holds a valid  
18 commercial driver's license.

19          ~~(9)~~(10) (a) "Commercial motor vehicle" means a motor vehicle or combination of motor vehicles used  
20 in commerce to transport passengers or property if the vehicle:

21           (i) has a gross combination weight rating or a gross combination weight of 26,001 pounds or more,  
22 whichever is greater, inclusive of a towed unit with a gross vehicle weight rating of more than 10,000 pounds;

23           (ii) has a gross vehicle weight rating or a gross vehicle weight of 26,001 pounds or more, whichever is  
24 greater;

25           (iii) is designed to transport at least 16 passengers, including the driver;

26           (iv) is a school bus; or

27           (v) is of any size and is used in the transportation of hazardous materials.

28          (b) The following vehicles are not commercial motor vehicles:

29           (i) an authorized emergency vehicle:

30           (A) equipped with audible and visual signals as required under 61-9-401 and 61-9-402; and

1 (B) operated when responding to or returning from an emergency call or operated in another official  
2 capacity;

3 (ii) a vehicle:

4 (A) controlled and operated by a farmer, family member of the farmer, or person employed by the farmer;

5 (B) used to transport farm products, farm machinery, or farm supplies to or from the farm within Montana  
6 within 150 miles of the farm or, if there is a reciprocity agreement with a state adjoining Montana, within 150 miles  
7 of the farm, including any area within that perimeter that is in the adjoining state; and

8 (C) not used to transport goods for compensation or for hire; or

9 (iii) a vehicle operated for military purposes by active duty military personnel, a member of the military  
10 reserves, a member of the national guard on active duty, including personnel on full-time national guard duty,  
11 personnel in part-time national guard training, and national guard military technicians, or active duty United States  
12 coast guard personnel.

13 (c) For purposes of this subsection ~~(9)~~ (10):

14 (i) "farmer" means a person who operates a farm or who is directly involved in the cultivation of land or  
15 crops or the raising of livestock owned by or under the direct control of that person;

16 (ii) "gross combination weight rating" means the value specified by the manufacturer as the loaded weight  
17 of a combination or articulated vehicle;

18 (iii) "gross vehicle weight rating" means the value specified by the manufacturer as the loaded weight of  
19 a single vehicle; and

20 (iv) "school bus" has the meaning provided in 49 CFR 383.5.

21 ~~(10)~~(11) "Commission" means the state transportation commission.

22 ~~(11)~~(12) "Custom-built motorcycle" means a motorcycle that is equipped with:

23 (a) an engine that was manufactured 20 years prior to the current calendar year and that has been  
24 altered from the manufacturer's original design; or

25 (b) an engine that was manufactured to resemble an engine 20 or more years old and that has been  
26 constructed in whole or in part from nonoriginal materials.

27 ~~(12)~~(13) "Custom vehicle" means a motor vehicle other than a motorcycle that:

28 (a) (i) was manufactured with a model year after 1948 and that is at least 25 years old; or

29 (ii) was built to resemble a vehicle manufactured after 1948 and at least 25 years before the current  
30 calendar year, including a kit vehicle intended to resemble a vehicle manufactured after 1948 and that is at least

1 25 years old; and

2 (b) has been altered from the manufacturer's original design or has a body constructed from nonoriginal  
3 materials.

4 ~~(13)~~(14) "Customer identification number" means:

5 (a) a driver's license or identification card number when the customer is an individual who has been  
6 issued a driver's license or identification card by a state driver licensing authority;

7 (b) a federal employer or tax identification number when the customer is a business entity that has been  
8 issued a federal employer or tax identification number;

9 (c) the identification number assigned by the secretary of state to a business entity authorized to do  
10 business in this state under Title 35 if the customer is a business entity that does not have a federal employer  
11 or tax identification number other than a social security number; or

12 (d) if the customer has not been issued one of the numbers described in subsections ~~(13)(a)~~ through  
13 ~~(13)(c)~~ (14)(a) through (14)(c), a number assigned to the customer by the department when a transaction is  
14 initiated under this title.

15 ~~(14)~~(15) (a) "Dealer" means a person that, for commission or profit, engages in whole or in part in the  
16 business of buying, selling, exchanging, or accepting on consignment new or used motor vehicles, trailers,  
17 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, off-highway vehicles, or special  
18 mobile equipment that is not registered in the name of the person.

19 (b) The term does not include the following:

20 (i) receivers, trustees, administrators, executors, guardians, or other persons appointed by or acting  
21 under a judgment or order of any court of competent jurisdiction;

22 (ii) employees of the persons included in subsection ~~(14)(b)(i)~~ (15)(b)(i) when engaged in the specific  
23 performance of their duties as employees; or

24 (iii) public officers while performing or in the operation of their duties.

25 ~~(15)~~(16) "Declared weight" means the total unladen weight of a vehicle plus the weight of the maximum  
26 load to be carried on the vehicle as stated by the registrant in the application for registration.

27 ~~(16)~~(17) "Department" means the department of justice acting directly or through its duly authorized  
28 officers or agents.

29 ~~(17)~~(18) "Dolly or converter gear" means a device consisting of one or two axles with a fifth wheel and  
30 trailer tongue used to support the forward end of a semitrailer, converting a semitrailer into a trailer.

- 1           ~~(18)~~(19) "Domiciled" means a place where:
- 2           (a) an individual establishes residence;
- 3           (b) a business entity maintains its principal place of business;
- 4           (c) the business entity's registered agent maintains an address; or
- 5           (d) a business entity most frequently uses, dispatches, or controls a motor vehicle, trailer, semitrailer,
- 6 or pole trailer that it owns or leases.
- 7           ~~(19)~~(20) "Downgrade" means the removal of a person's privilege to operate a commercial motor vehicle,
- 8 as maintained by the department on the individual Montana driving record and the CDLIS driver record for that
- 9 person.
- 10          ~~(20)~~(21) "Driver" means a person who drives or is in actual physical control of a vehicle.
- 11          ~~(21)~~(22) "Driver's license" means a license or permit to operate a motor vehicle issued under or granted
- 12 by the laws of this state, including:
- 13          (a) any temporary license or learner license;
- 14          (b) the privilege of any person to drive a motor vehicle, whether or not the person holds a valid license;
- 15          (c) any nonresident's driving privilege;
- 16          (d) a motorcycle endorsement; or
- 17          (e) a commercial driver's license.
- 18          ~~(22)~~(23) "Electric personal assistive mobility device" means a device that has two nontandem wheels,
- 19 is self-balancing, and is designed to transport only one person with an electric propulsion system that limits the
- 20 maximum speed of the device to 12 1/2 miles an hour.
- 21          ~~(23)~~(24) "For hire" means an action performed for remuneration of any kind, whether paid or promised,
- 22 either directly or indirectly, or received or obtained through leasing, brokering, or buy-and-sell arrangements from
- 23 which a remuneration is obtained or derived for transportation service.
- 24          ~~(24)~~(25) (a) "Golf cart" means a motor vehicle that is designed for use on a golf course to carry a person
- 25 or persons and golf equipment and that has an average speed of less than 15 miles per hour.
- 26          (b) Except as provided in 61-3-201, a golf cart is exempt from titling, registration, and mandatory liability
- 27 insurance requirements under this title.
- 28          ~~(25)~~(26) "Gross vehicle weight" means the weight of a vehicle without load plus the weight of any load
- 29 on the vehicle.
- 30          ~~(26)~~(27) "Hazardous material" means:

1 (a) any material that has been designated as hazardous under 49 U.S.C. 5103 and is required to be  
2 placarded under 49 CFR, part 172; or

3 (b) any quantity of a material listed as a select agent or toxin in 42 CFR, part 73.

4 ~~(27)~~(28) "Highway" or "public highway" means the entire width between the boundary lines of every  
5 publicly maintained way when any part of the publicly maintained way is open to the use of the public for purposes  
6 of vehicular travel.

7 ~~(28)~~(29) "Highway patrol officer" means a state officer authorized to direct or regulate traffic or to make  
8 arrests for violations of traffic regulations.

9 ~~(29)~~(30) "Implement of husbandry" means a vehicle that is designed for agricultural purposes and  
10 exclusively used by the owner of the vehicle in the conduct of the owner's agricultural operations.

11 ~~(30)~~(31) "Kit vehicle" is a motor vehicle assembled from a manufactured kit either as:

12 (a) a complete kit, consisting of a prefabricated body and chassis, to construct a new motor vehicle; or

13 (b) a kit with a prefabricated body to be mounted to an existing motor vehicle chassis and drivetrain,  
14 commonly referred to as a donor vehicle.

15 ~~(31)~~(32) "Light vehicle" means a motor vehicle commonly referred to as an automobile, van, sport utility  
16 vehicle, or truck having a manufacturer's rated capacity of 1 ton or less.

17 ~~(32)~~(33) "Low-speed electric vehicle" means a motor vehicle, on or by which a person may be  
18 transported, that:

19 (a) has four wheels;

20 (b) has a maximum speed of at least 20 miles an hour and no greater than 40 miles an hour as certified  
21 by the manufacturer;

22 (c) is propelled by its own power, using an electric motor or other device that transforms stored electrical  
23 energy into the motion of the vehicle;

24 (d) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the power  
25 grid or from renewable electrical energy sources;

26 (e) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;

27 (f) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle  
28 identification number as provided in 49 CFR, part 565; and

29 (g) is equipped as provided in 61-9-432.

30 ~~(33)~~(34) "Low-speed restricted driver's license" means a license limited to the operation of a low-speed

1 electric vehicle or a golf cart issued under or granted by the laws of this state, including:

2 (a) a temporary license or learner license;

3 (b) the privilege of a person to drive a low-speed electric vehicle or golf cart under the authority of  
4 61-5-122, whether or not the person holds a valid driver's license; and

5 (c) a nonresident's similarly restricted driving privilege.

6 ~~(34)~~(35) "Manufactured home" has the meaning provided in 15-24-201.

7 ~~(35)~~(36) "Manufacturer" includes any person engaged in the manufacture of motor vehicles, trailers,  
8 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, or off-highway vehicles as a regular  
9 business.

10 ~~(36)~~(37) "Manufacturer's certificate of origin" means the original paper record produced and issued by  
11 the manufacturer of a vehicle or, if in a medium authorized by the department, an electronic record created and  
12 transmitted by the manufacturer of a vehicle to the manufacturer's agent or a licensed dealer. The record must  
13 establish the origin of the vehicle specifically described in the record and, upon assignment, transfers of  
14 ownership of the vehicle to the person or persons named in the certificate.

15 ~~(37)~~(38) (a) "Medium-speed electric vehicle" is a motor vehicle, on or by which a person may be  
16 transported, that:

17 (i) has a maximum speed of 45 miles an hour as certified by the manufacturer;

18 (ii) is propelled by its own power, using an electric motor or other device that transforms stored electrical  
19 energy into the motion of the vehicle;

20 (iii) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the power  
21 grid or from renewable electrical energy sources;

22 (iv) is fully enclosed and includes at least one door for entry;

23 (v) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;

24 (vi) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle  
25 identification number as provided in 49 CFR, part 565;

26 (vii) bears a sticker, affixed by the manufacturer or dealer, on the left side of the rear window that  
27 indicates the vehicle's maximum speed rating; and

28 (viii) as certified by the manufacturer, is equipped as provided in 61-9-432.

29 (b) A medium-speed electric vehicle must be treated as a light vehicle for purposes of titling and  
30 registration under Title 61, chapter 3.

- 1 (c) A medium-speed electric vehicle may not have a gross vehicle weight in excess of 5,000 pounds.
- 2 ~~(38)~~(39) "Mobile home" or "housetrailer" has the meaning provided in 15-24-201.
- 3 ~~(39)~~(40) "Montana resident" means:
- 4 (a) an individual who resides in Montana as determined under 1-1-215; or
- 5 (b) for the purposes of chapter 3, a business entity that maintains a principal place of business or a
- 6 registered agent in this state.
- 7 ~~(40)~~(41) (a) "Motorboat" means a vessel, including a personal watercraft or pontoon, propelled by any
- 8 machinery, motor, or engine of any description, whether or not the machinery, motor, or engine is the principal
- 9 source of propulsion. The term includes boats temporarily equipped with detachable motors or engines.
- 10 (b) The term does not include a vessel that has a valid marine document issued by the U.S. coast guard
- 11 or any successor federal agency.
- 12 ~~(41)~~(42) (a) "Motor carrier" means a person or corporation or its lessees, trustees, or receivers appointed
- 13 by a court that are operating motor vehicles on a public highway in this state for the transportation of property for
- 14 hire on a commercial basis.
- 15 (b) The term does not include motor carriers regulated under Title 69, chapter 12.
- 16 ~~(42)~~(43) (a) "Motorcycle" means a motor vehicle that has a seat or saddle for the use of the operator and
- 17 that is designated to travel on not more than three wheels in contact with the ground. A motorcycle may carry one
- 18 or more attachments and a seat for the conveyance of a passenger.
- 19 (b) A motorcycle designed for use on highways is a motor vehicle unless otherwise prescribed.
- 20 (c) A motorcycle designed for off-road recreational use is an off-highway vehicle unless it has been
- 21 modified to meet the equipment standards specified in chapter 9 and has been registered for highway use.
- 22 (d) The term includes an autocycle.
- 23 ~~(43)~~(e) The term does not include a tractor, a bicycle or a moped as defined in 61-8-102, a motorized
- 24 nonstandard vehicle, or a two- or three-wheeled all-terrain vehicle that is used exclusively on private property.
- 25 ~~(43)~~(44) (a) "Motor-driven cycle" means a motorcycle, including a motor scooter, with a motor that
- 26 produces 5 horsepower or less.
- 27 (b) The term does not include a bicycle or a moped, as defined in 61-8-102, or a motorized nonstandard
- 28 vehicle.
- 29 ~~(44)~~(45) "Motor home" means a motor vehicle:
- 30 (a) designed to provide temporary living quarters, built as an integral part of or permanently attached to

1 a self-propelled motor vehicle chassis or van;

2 (b) containing permanently installed independent life support systems that meet the ANSIA/A119.2  
3 standard; and

4 (c) providing at least four of the following types of facilities:

5 (i) cooking, refrigeration, or icebox;

6 (ii) self-contained toilet;

7 (iii) heating or air conditioning, or both;

8 (iv) potable water supply, including a faucet and sink; or

9 (v) separate 110-volt or 125-volt electrical power supply or a liquefied petroleum gas supply, or both.

10 ~~(45)(46)~~ (a) "Motorized nonstandard vehicle" means a vehicle, on or by which a person may be  
11 transported, that:

12 (i) is propelled by its own power, using an internal combustion engine or an electric motor;

13 (ii) has a wheelbase of less than 40 inches and a wheel diameter of less than 10 inches; and

14 (iii) does not display a manufacturer's certification in accordance with 49 CFR, part 567, or have a  
15 17-character vehicle identification number assigned by the manufacturer in accordance with 49 CFR, part 565.

16 (b) The term includes but is not limited to a motorized skateboard and a vehicle commonly known as a  
17 "pocket rocket".

18 (c) The term does not include a moped as defined in 61-8-102, an electric personal assistive mobility  
19 device, or a motorized wheelchair or other low-powered, mechanically propelled vehicle designed specifically for  
20 use by a physically disabled person.

21 ~~(46)(47)~~ (a) "Motor vehicle" means:

22 (i) a vehicle propelled by its own power and designed or used to transport persons or property on the  
23 highways of the state;

24 (ii) a quadricycle if it is equipped for use on the highways as prescribed in chapter 9; or

25 (iii) a golf cart only if it is equipped for use on the highways as prescribed in chapter 9 and is operated  
26 pursuant to 61-8-391 or by a person with a low-speed restricted driver's license.

27 (b) The term does not include a bicycle or a moped as defined in 61-8-102, an electric personal assistive  
28 mobility device, a motorized nonstandard vehicle, or a motorized wheelchair or other low-powered, mechanically  
29 propelled vehicle that is designed specifically for use by a physically disabled person and that is used as a means  
30 of mobility for that person.

1           ~~(47)~~(48) "New motor vehicle" means a motor vehicle, regardless of the mileage of the vehicle, the legal  
2 or equitable title to which has never been transferred by a manufacturer, distributor, or dealer to another person  
3 as the result of a retail sale.

4           ~~(48)~~(49) "Nonresident" means a person who is not a Montana resident.

5           ~~(49)~~(50) (a) "Not used for general transportation purposes" means the operation of a motor vehicle  
6 registered as a collector's item, a custom vehicle, a street rod, or a custom-built motorcycle to or from a car or  
7 motorcycle club activity or event or an exhibit, show, cruise night, or parade, or for other occasional transportation  
8 activity.

9           (b) The term does not include operation of a motor vehicle for routine or ordinary household  
10 maintenance, employment, education, or other similar purposes.

11           ~~(50)~~(51) (a) "Off-highway vehicle" means a self-propelled vehicle designed for recreation or cross-country  
12 travel on public lands, trails, easements, lakes, rivers, or streams. The term includes but is not limited to  
13 motorcycles, quadricycles, dune buggies, amphibious vehicles, air cushion vehicles, and any other means of land  
14 transportation deriving motive power from any source other than muscle or wind.

15           (b) The term does not include:

16           (i) vehicles designed primarily for travel on, over, or in the water;

17           (ii) snowmobiles; or

18           (iii) motor vehicles designed to transport persons or property on the highways unless the vehicle is used  
19 for off-road recreation on public lands.

20           ~~(51)~~(52) "Operator" means a person who is in actual physical control of a motor vehicle.

21           ~~(52)~~(53) "Owner" means a person who holds the legal title to a vehicle. If a vehicle is the subject of an  
22 agreement for the conditional sale of the vehicle with the right of purchase upon performance of the conditions  
23 stated in the agreement and with an immediate right of possession vested in the conditional vendee, or in the  
24 event a vehicle is subject to a lease, contract, or other legal arrangement vesting right of possession or control,  
25 for security or otherwise, or in the event a mortgagor of a vehicle is entitled to possession, then the owner is the  
26 person in whom is vested the right of possession or control.

27           ~~(53)~~(54) "Person" means an individual, corporation, partnership, association, firm, or other legal entity.

28           ~~(54)~~(55) "Personal watercraft" means a vessel that uses an outboard motor or an inboard engine  
29 powering a water jet pump as its primary source of propulsion and that is designed to be operated by a person  
30 sitting, standing, or kneeling on the vessel rather than by the conventional method of sitting or standing in the

1 vessel.

2 ~~(55)~~(56) "Pole trailer" means a vehicle without power designed to be drawn by another vehicle and  
3 attached to the towing vehicle by means of a reach or pole or by being boomed or otherwise secured to the  
4 towing vehicle and ordinarily used for transporting long or irregularly shaped loads such as poles, pipes, or  
5 structural members capable generally of sustaining themselves as beams between the supporting connections.

6 ~~(56)~~(57) "Police officer" means an officer authorized to direct or regulate traffic or to make arrests for  
7 violations of traffic regulations.

8 ~~(57)~~(58) (a) "Quadricycle" means a four-wheeled motor vehicle, designed for on-road or off-road use,  
9 having a seat or saddle on which the operator sits.

10 (b) The term does not include golf carts.

11 ~~(58)~~(59) "Railroad" means a carrier of persons or property on cars, other than streetcars, operated on  
12 stationary rails.

13 ~~(59)~~(60) (a) "Railroad train" or "train" means a steam engine or electric or other motor, with or without cars  
14 coupled to the engine, that is operated on rails.

15 (b) The term does not include streetcars.

16 ~~(60)~~(61) "Recreational vehicle" includes a motor home, travel trailer, or camper.

17 ~~(61)~~(62) "Registration" or "register" means the act or process of creating an electronic record, maintained  
18 by the department, of the assignment of a license plate or a set of license plates to and the issuance of a  
19 registration decal for a specific vehicle, the ownership of which has been established or is presumed in  
20 department records.

21 ~~(62)~~(63) "Registration decal" means an adhesive sticker produced by the department and issued by the  
22 department, its authorized agent, or a county treasurer to the owner of a motor vehicle, trailer, semitrailer, pole  
23 trailer, motorboat, sailboat, personal watercraft, or snowmobile as proof of payment of all fees imposed for the  
24 registration period indicated on the sticker as recorded by the department under 61-3-101.

25 ~~(63)~~(64) "Registration receipt" means a paper record that is produced and issued or, if authorized by the  
26 department, an electronic record that is transmitted by the department, its authorized agent, or a county treasurer  
27 to the owner of a vehicle that identifies a vehicle, based on information maintained in the electronic record of title  
28 for the vehicle, and that provides evidence of the payment of all fees required to be paid for the registration of the  
29 vehicle for the registration period indicated in the receipt.

30 ~~(64)~~(65) "Retail sale" means the sale of a motor vehicle, trailer, semitrailer, pole trailer, travel trailer,

1 motorboat, snowmobile, off-highway vehicle, or special mobile equipment by a dealer to a person for purposes  
2 other than resale.

17 for carrying property and for being drawn by a motor vehicle and constructed so that no part of its weight rests

19 (b) The term does not include a mobile home or a manufactured home, as defined in 15-1-101.

20 ~~(83)~~(84) "Transaction summary receipt" means an electronic record produced and issued by the

1 has a grace period of 40 calendar days from the date of purchase to make application for a certificate of title and  
 2 pay the registration fees, fees in lieu of tax and other fees required by this chapter, and local option taxes, if

 4 and highways of this state during this period unless a temporary registration permit has been issued for and is

 13 **"61-5-102. Drivers to be licensed -- penalty.** (1) (a) Except as provided in 61-5-104, a person may not  
 14 drive a motor vehicle upon a highway in this state unless the person has a valid Montana driver's license. A  
 15 person may not receive a Montana driver's license until the person surrenders to the department all valid driver's  
 16 licenses issued by any other jurisdiction. A person may not have in the person's possession or under the person's  
 17 control more than one valid Montana driver's license at any time.

18 (b) Except as provided in subsection (1)(c), the penalty for a violation of this section is a fine of not more  
 19 than \$500.

20 (c) A person who is eligible to hold a driver's license and has obtained a valid driver's license but has

 5 (ii) the passengers or type or types of cargo being transported.

6 (3) A low-speed restricted driver's license is not valid for the operation of a motor vehicle other than a  
 7 low-speed electric vehicle or a golf cart.

8 (4) When a city or town requires a licensed driver to obtain a local driving license or permit, a license or  
 9 permit may not be issued unless the applicant presents a state driver's license valid under the provisions of this  
 10 chapter."

13 **"61-5-112. Types and classes of commercial driver's licenses -- classification -- rulemaking --**  
 14 **reciprocity agreements.** (1) The department shall adopt rules that it considers necessary for the safety and  
 15 welfare of the traveling public governing the classification of commercial driver's licenses and related  
 16 endorsements and the examination of commercial driver's license applicants and renewal applicants. The rules  
 17 must:

18 (a) subject to the exceptions provided in this section, comport with the licensing standards and  
 19 requirements of 49 CFR, part 383, the medical qualifications of 49 CFR, part 391, and the security threat  
 20 assessment provisions of 49 CFR, part 1572;

21 (b) allow for the issuance of a type 2 (intrastate only) commercial driver's license in accordance with  
 22 medical qualification and visual acuity standards prescribed by the department;

23 (c) allow for the issuance of a type 2 commercial driver's license to a person who is 18 years of age or  
 24 older;

25 (d) allow for issuance of a seasonal commercial driver's license based on standards established by the  
 26 department for the waiver of the knowledge and road or skills test for a qualified person employed in farm-related  
 27 service industries who has a good driving record and sufficient prior driving experience;

28 (e) prescribe the operational and seasonal restrictions for a seasonal commercial driver's license;

29 (f) prescribe the requirements for the medical statement that must be submitted in order for a person to  
 30 be qualified for a type 2 commercial driver's license;

1 (g) prescribe the minimum standards for certification of a third-party commercial driver testing program  
2 and any test waiver under 61-5-118; and

3 (h) allow for the issuance of a commercial learner's permit.

4 (2) The department is authorized to enter into reciprocal agreements with adjacent states that would  
5 allow certain drivers of vehicles transporting farm products, farm machinery, or farm supplies within 150 miles  
6 of a farm to operate without a commercial driver's license because the vehicles are not considered commercial  
7 motor vehicles as provided in 61-1-101~~(9)(b)(ii)~~(10)(b)(ii)."

9 **Section 5.** Section 61-8-102, MCA, is amended to read:

10 **"61-8-102. Uniformity of interpretation -- definitions.** (1) Interpretation of this chapter in this state must  
11 be as consistent as possible with the interpretation of similar laws in other states.

12 (2) As used in this chapter, unless the context requires otherwise, the following definitions apply:

13 (a) "Authorized emergency vehicle" means a vehicle of a governmental fire agency organized under Title  
14 7, chapter 33, an ambulance, or an emergency vehicle designated or authorized by the department.

15 (b) "Bicycle" means a vehicle propelled solely by human power on which any person may ride,  
16 irrespective of the number of wheels, except scooters, wheelchairs, and similar devices. The term includes an  
17 electrically assisted bicycle.

18 (c) "Bicycle trailer" means a device with one or more wheels that is designed to be towed by a bicycle.

19 (d) "Business district" means the territory contiguous to and including a highway when within any 600  
20 feet along a highway there are buildings in use for business or industrial purposes, including but not limited to  
21 hotels, banks, office buildings, railroad stations, and public buildings that occupy at least 300 feet of frontage on  
22 one side or 300 feet collectively on both sides of the highway.

23 (e) "Controlled-access highway" means a highway, street, or roadway in respect to which owners or  
24 occupants of abutting lands and other persons have no legal right of access to or from the highway, street, or  
25 roadway except at the points and in the manner as determined by the public authority having jurisdiction over the  
26 highway, street, or roadway.

27 (f) "Crosswalk" means:

28 (i) that part of a roadway at an intersection included within the connections of the lateral lines of the  
29 sidewalks on opposite sides of the highway measured from the curbs or, in the absence of curbs, from the edges  
30 of the traversable roadway; or

1 (ii) any portion of a roadway at an intersection or elsewhere distinctly indicated for pedestrians crossing  
2 by lines or other markings on the surface.

3 (g) "Electrically assisted bicycle" means a vehicle on which a person may ride that has two tandem  
4 wheels and an electric motor capable of propelling the vehicle and a rider who weighs 170 pounds no faster than  
5 20 miles an hour on a paved, level surface.

6 (h) "Flag person" means a person who directs, controls, or alters the normal flow of vehicular traffic on  
7 a street or highway as a result of a vehicular traffic hazard then present on that street or highway. This person,  
8 except a uniformed traffic enforcement officer exercising the officer's duty as a result of a planned vehicular traffic  
9 hazard, must be equipped as required by the rules of the department of transportation.

10 (i) "Highway" has the meaning provided in 61-1-101, but includes ways that have been or are later  
11 dedicated to public use.

12 (j) "Ignition interlock device" means ignition equipment that:

13 (i) analyzes the breath to determine blood alcohol concentration;

14 (ii) is approved by the department pursuant to 61-8-441; and

15 (iii) is designed to prevent a motor vehicle from being operated by a person who has consumed a specific  
16 amount of an alcoholic beverage.

17 (k) (i) "Intersection" means the area embraced within the prolongation or connection of the lateral curb  
18 lines or if there are no curb lines then the lateral boundary lines of the roadways of two highways that join one  
19 another at or approximately at right angles or the area within which vehicles traveling on different highways joining  
20 at any other angle may come in conflict.

21 (ii) When a highway includes two roadways 30 feet or more apart, then every crossing of each roadway  
22 of the divided highway by an intersecting highway must be regarded as a separate intersection. If the intersecting  
23 highways also include two roadways 30 feet or more apart, then every crossing of two roadways of the highways  
24 must be regarded as a separate intersection.

25 (l) "Laned roadway" means a roadway that is divided into two or more clearly marked lanes for vehicular  
26 traffic.

27 (m) "Local authorities" means every county, municipal, and other local board or body having authority  
28 to enact laws relating to traffic under the constitution and laws of this state.

29 (n) "Moped" means a vehicle equipped with two or three wheels, foot pedals to permit muscular  
30 propulsion, and an independent power source providing a maximum of 2 brake horsepower. The power source

1 may not be capable of propelling the device, unassisted, at a speed exceeding 30 miles an hour on a level  
2 surface. The device must be equipped with a power drive system that functions directly or automatically only and  
3 does not require clutching or shifting by the operator after the drive system is engaged.

4 (o) "Noncommercial motor vehicle" or "noncommercial vehicle" means any motor vehicle or combination  
5 of motor vehicles that is not included in the definition of commercial motor vehicle in 61-1-101 and includes but  
6 is not limited to the vehicles listed in 61-1-101~~(9)(b)~~(10)(b).

7 (p) "Official traffic control devices" means all signs, signals, markings, and devices not inconsistent with  
8 this title that are placed or erected by authority of a public body or official having jurisdiction for the purpose of  
9 regulating, warning, or guiding traffic.

10 (q) "Pedestrian" means any person on foot or any person in a manually or mechanically propelled  
11 wheelchair or other low-powered, mechanically propelled vehicle designed specifically for use by a physically  
12 disabled person.

13 (r) "Police vehicle" means a vehicle used in the service of any law enforcement agency.

14 (s) "Private road" or "driveway" means a way or place in private ownership and used for vehicular travel  
15 by the owner and those having express or implied permission from the owner, but not by other persons.

16 (t) "Residence district" means the territory contiguous to and including a highway not comprising a  
17 business district when the property on the highway for a distance of 300 feet or more is primarily improved with  
18 residences or residences and buildings in use for business.

19 (u) "Right-of-way" means the privilege of the immediate use of the roadway.

20 (v) "Roadway" means the portion of a highway that is improved, designed, or ordinarily used for vehicular  
21 travel, including the paved shoulder.

22 (w) "School bus" has the meaning provided in 20-10-101.

23 (x) "Sidewalk" means the portion of a street that is between the curb lines or the lateral lines of a  
24 roadway and the adjacent property lines and that is intended for use by pedestrians.

25 (y) "Traffic control signal" means a device, whether manually, electrically, or mechanically operated, by  
26 which traffic is alternately directed to stop and to proceed.

27 (z) "Urban district" means the territory contiguous to and including any street that is built up with  
28 structures devoted to business, industry, or dwelling houses situated at intervals of less than 100 feet for a  
29 distance of one-fourth mile or more."
