A BILL FOR AN ACT ENTITLED: "AN ACT IMPLEMENTING THE PROVISIONS OF THE GENERAL APPROPRIATIONS ACT; GENERALLY REVISING LAWS RELATED TO THE STATE BUDGET; ~~TRANSFERRING FUNDS; PROVIDING LEGISLATIVE INTENT; PROVIDING APPROPRIATIONS;~~ AND PROVIDING AN EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

~~NEW SECTION. Section 1. Transfer of funds. By August 15, 2019, the state treasurer shall transfer \$100 from the general fund to the state special revenue fund established in 1-11-301.~~

NEW SECTION. SECTION 1. APPROPRIATION -- LEGISLATIVE INTENT. (1) FOR THE FISCAL YEAR BEGINNING JULY 1, 2020, THERE IS APPROPRIATED \$1,128,404 TO THE DEPARTMENT OF JUSTICE FROM THE STATE SPECIAL REVENUE ACCOUNT ESTABLISHED IN 44-1-504 TO FUND A DRUG INTERDICTION TEAM WITHIN THE MONTANA HIGHWAY PATROL.

(2) IT IS THE INTENT OF THE LEGISLATURE THAT THE FUNDING IN SUBSECTION (1) BE USED TO FUND SIX PERMANENT FTE IN THE MONTANA HIGHWAY PATROL, INCLUDING FOUR TROOPERS, ONE SUPERVISOR, AND ONE INTERDICTION AGENT FROM THE DIVISION OF CRIMINAL INVESTIGATION.

(3) IT IS THE INTENT OF THE LEGISLATURE THAT \$732,710 OF THE FUNDING IN SUBSECTION (1) BE INCLUDED IN THE BASE BUDGET OF THE MONTANA HIGHWAY PATROL FOR THE BIENNIUM BEGINNING JULY 1, 2021.
