16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

17
18 NEW SECTION. **Section 1. Purpose -- rule of construction.** (1) This code shall be liberally construed
19 and applied to promote its underlying purposes and policies.

- 20 (2) The underlying purposes and policies of this code are to:
- 21 (a) simplify and clarify the law concerning the affairs of decedents, missing persons, protected persons,
 - 22 minors, and incapacitated persons;
 - 23 (b) discover and make effective the intent of a decedent in distribution of the decedent's property;
 - 24 (c) promote a speedy and efficient system for liquidating the estate of the decedent and making
 - 25 distribution to the decedent's successors;
 - 26 (d) facilitate use and enforcement of certain trusts; and
 - 27 (e) make uniform the law among the various jurisdictions.

28
29 NEW SECTION. **Section 2. Severability.** If any provision of this code or the application of this code
30 to any person or circumstances is held invalid, the invalidity may not affect other provisions or applications of the

1 code which can be given effect without the invalid provision or application, and to this end the provisions of this
2 code are declared to be severable.

4 **Section 3.** Section 72-1-103, MCA, is amended to read:

5 **"72-1-103. General definitions.** Subject to additional definitions contained in the subsequent chapters
6 that are applicable to specific chapters, parts, or sections and unless the context otherwise requires, in chapters
7 1 through 6, the following definitions apply:

8 (1) "Agent" includes an attorney-in-fact under a durable or nondurable power of attorney, an individual
9 authorized to make decisions concerning another's health care, and an individual authorized to make decisions
10 for another under a natural death act.

11 (2) "Application" means a written request to the clerk for an order of informal probate or appointment
12 under chapter 3, part 2.

13 (3) "Beneficiary", as it relates to:

14 (a) a trust beneficiary, includes a person who has any present or future interest, vested or contingent,
15 and also includes the owner of an interest by assignment or other transfer;

16 (b) a charitable trust, includes any person entitled to enforce the trust;

17 (c) a beneficiary of a beneficiary designation, refers to a beneficiary of:

18 (i) an account with POD designation or a security registered in beneficiary form (TOD); or

19 (ii) any other nonprobate transfer at death; and

20 (d) a beneficiary designated in a governing instrument, includes a grantee of a deed, a devisee, a trust
21 beneficiary, a beneficiary of a beneficiary designation, a donee, and a person in whose favor a power of attorney
22 or a power held in any individual, fiduciary, or representative capacity is exercised.

23 (4) "Beneficiary designation" refers to a governing instrument naming a beneficiary of:

24 (a) an account with POD designation or a security registered in beneficiary form (TOD); or

25 (b) any other nonprobate transfer at death.

26 (5) "Child" includes an individual entitled to take as a child under chapters 1 through 5 by intestate
27 succession from the parent whose relationship is involved and excludes a person who is only a stepchild, a foster
28 child, a grandchild, or any more remote descendant.

29 (6) (a) "Claims", in respect to estates of decedents and protected persons, includes liabilities of the
30 decedent or protected person, whether arising in contract, in tort, or otherwise, and liabilities of the estate that

1 arise at or after the death of the decedent or after the appointment of a conservator, including funeral expenses
2 and expenses of administration.

3 (b) The term does not include estate taxes or demands or disputes regarding title of a decedent or
4 protected person to specific assets alleged to be included in the estate.

5 (7) "Clerk" or "clerk of court" means the clerk of the district court.

6 (8) "Conservator" means a person who is appointed by a court to manage the estate of a protected
7 person.

8 (9) "Court" means the district court in this state having jurisdiction in matters relating to the affairs of
9 decedents.

10 (10) "Descendant" of an individual means all of the individual's descendants of all generations, with the
11 relationship of parent and child at each generation being determined by the definition of child and parent
12 contained in this section code.

13 (11) "Devise" when used as a noun means a testamentary disposition of real or personal property and
14 when used as a verb means to dispose of real or personal property by will.

15 (12) "Devisee" means a person designated in a will to receive a devise. For purposes of chapter 3, in the
16 case of a devise to an existing trust or trustee or to a trustee or trust described by will, the trust or trustee is the
17 devisee and the beneficiaries are not devisees.

18 (13) "Disability" means cause for a protective order as described by 72-5-409.

19 (14) "Distributee" means any person who has received property of a decedent from the decedent's
20 personal representative other than as a creditor or purchaser. A testamentary trustee is a distributee only to the
21 extent of distributed assets or increment to distributed assets remaining in the trustee's hands. A beneficiary of
22 a testamentary trust to whom the trustee has distributed property received from a personal representative is a
23 distributee of the personal representative. For purposes of this provision, "testamentary trustee" includes a trustee
24 to whom assets are transferred by will, to the extent of the devised assets.

25 (15) "Estate" includes the property of the decedent, trust, or other person whose affairs are subject to
26 chapters 1 through 5 as originally constituted and as it exists from time to time during administration.

27 (16) "Exempt property" means that property of a decedent's estate that is described in 72-2-413.

28 (17) "Fiduciary" includes a personal representative, guardian, conservator, and trustee.

29 (18) "Foreign personal representative" means a personal representative appointed by another jurisdiction.

30 (19) "Formal proceedings" means proceedings conducted before a judge with notice to interested

1 persons.

2 (20) "Governing instrument" means a deed; will; trust; insurance or annuity policy; account with POD
3 designation; security registered in beneficiary form (TOD); pension, profit-sharing, retirement, or similar benefit
4 plan; instrument creating or exercising a power of appointment or a power of attorney; or dispositive, appointive,
5 or nominative instrument of any similar type.

6 (21) "Guardian" means a person who has qualified as a guardian of a minor or incapacitated person
7 pursuant to testamentary or court appointment but excludes one who is merely a guardian ad litem.

8 (22) "Heirs", except as controlled by 72-2-721, means persons, including the surviving spouse and the
9 state, who are entitled under the statutes of intestate succession to the property of a decedent.

10 (23) "Incapacitated person" has the meaning provided in 72-5-101.

11 (24) "Informal proceedings" means proceedings conducted without notice to interested persons by the
12 clerk of court for probate of a will or appointment of a personal representative.

13 (25) "Interested person" includes heirs, devisees, children, spouses, creditors, beneficiaries, and any
14 others having a property right in or claim against a trust estate or the estate of a decedent, ward, or protected
15 person. The term also includes persons having priority for appointment as personal representative and other
16 fiduciaries representing interested persons. The meaning as it relates to particular persons may vary from time
17 to time and must be determined according to the particular purposes of and matter involved in any proceeding.

18 (26) "Issue" of a person means a descendant.

19 (27) "Joint tenants with the right of survivorship" includes co-owners of property held under circumstances
20 that entitle one or more to the whole of the property on the death of the other or others but excludes forms of
21 co-ownership registration in which the underlying ownership of each party is in proportion to that party's
22 contribution.

23 (28) "Lease" includes an oil, gas, coal, or other mineral lease.

24 (29) "Letters" includes letters testamentary, letters of guardianship, letters of administration, and letters
25 of conservatorship.

26 (30) "Minor" means a person who is under 18 years of age.

27 (31) "Mortgage" means any conveyance, agreement, or arrangement in which property is used as
28 security.

29 (32) "Nonresident decedent" means a decedent who was domiciled in another jurisdiction at the time of
30 death.

1 (33) "Organization" means a corporation, business trust, estate, trust, partnership, joint venture,
2 association, government or governmental subdivision or agency, or any other legal or commercial entity.

3 (34) "Parent" includes any person entitled to take, or who would be entitled to take if the child died without
4 a will, as a parent under chapters 1 through 5 by intestate succession from the child whose relationship is in
5 question and excludes any person who is only a stepparent, foster parent, or grandparent.

6 (35) "Payor" means a trustee, insurer, business entity, employer, government, governmental agency or
7 subdivision, or any other person authorized or obligated by law or a governing instrument to make payments.

8 (36) "Person" means an individual, a corporation, an organization, or other legal entity.

9 (37) "Personal representative" includes executor, administrator, successor personal representative,
10 special administrator, and persons who perform substantially the same function under the law governing their
11 status. "General personal representative" excludes special administrator.

12 (38) "Petition" means a written request to the court for an order after notice.

13 (39) "Proceeding" includes action at law and suit in equity.

14 (40) "Property" includes both real and personal property or any interest in that property and means
15 anything that may be the subject of ownership.

16 (41) "Protected person" has the meaning provided in 72-5-101.

17 (42) "Protective proceeding" has the meaning provided in 72-5-101.

18 (43) "Record" means information that is inscribed on a tangible medium or that is stored in an electronic
19 or other medium and is retrievable in perceivable form.

20 ~~(43)~~(44) "Security" includes any note; stock; treasury stock; bond; debenture; evidence of indebtedness;
21 certificate of interest or participation in an oil, gas, or mining title or lease or in payments out of production under
22 such a title or lease; collateral trust certificate; transferable share; voting trust certificate; in general, any interest
23 or instrument commonly known as a security; any certificate of interest or participation; or any temporary or
24 interim certificate, receipt, or certificate of deposit for or any warrant or right to subscribe to or purchase any of
25 the foregoing.

26 ~~(44)~~(45) "Settlement", in reference to a decedent's estate, includes the full process of administration,
27 distribution, and closing.

28 (46) "Sign" means, with present intent to authenticate or adopt a record other than a will:

29 (a) to execute or adopt a tangible symbol; or

30 (b) to attach to or logically associate with the record an electronic symbol, sound, or process.

- 1 ~~(45)~~(47) "Special administrator" means a personal representative as described by chapter 3, part 7.
- 2 ~~(46)~~(48) "State" means a state of the United States, the District of Columbia, the Commonwealth of
3 Puerto Rico, or any territory or insular possession subject to the jurisdiction of the United States.
- 4 ~~(47)~~(49) "Successor personal representative" means a personal representative, other than a special
5 administrator, who is appointed to succeed a previously appointed personal representative.
- 6 ~~(48)~~(50) "Successors" means persons, other than creditors, who are entitled to property of a decedent
7 under the decedent's will or chapters 1 through 5.
- 8 ~~(49)~~(51) "Supervised administration" refers to the proceedings described in chapter 3, part 4.
- 9 ~~(50)~~(52) "Survive" means that an individual has neither predeceased an event, including the death of
10 another individual, nor is considered to have predeceased an event under 72-2-114 or 72-2-712. The term
11 includes its derivatives, such as "survives", "survived", "survivor", and "surviving".
- 12 ~~(51)~~(53) "Testacy proceeding" means a proceeding to establish a will or determine intestacy.
- 13 ~~(52)~~(54) "Testator" includes an individual of either sex.
- 14 ~~(53)~~(55) "Trust" includes an express trust, private or charitable, with additions to the trust, wherever and
15 however created. The term also includes a trust created or determined by judgment or decree under which the
16 trust is to be administered in the manner of an express trust. The term excludes other constructive trusts and
17 excludes resulting trusts; conservatorships; personal representatives; trust accounts as defined in 72-6-111 and
18 Title 72, chapter 6, parts 2 and 3; custodial arrangements pursuant to chapter 26; business trusts providing for
19 certificates to be issued to beneficiaries; common trust funds; voting trusts; security arrangements; liquidation
20 trusts; trusts for the primary purpose of paying debts, dividends, interest, salaries, wages, profits, pensions, or
21 employee benefits of any kind; and any arrangement under which a person is nominee or escrowee for another.
- 22 ~~(54)~~(56) "Trustee" includes an original, additional, or successor trustee, whether or not appointed or
23 confirmed by court.
- 24 ~~(55)~~(57) "Ward" means an individual described in 72-5-101.
- 25 ~~(56)~~(58) "Will" includes codicil and any testamentary instrument that merely appoints an executor,
26 revokes or revises another will, nominates a guardian, or expressly excludes or limits the right of an individual
27 or class to succeed to property of the decedent passing by intestate succession."

28

29 **Section 4.** Section 72-1-201, MCA, is amended to read:

30 **"72-1-201. Territorial application.** Except as otherwise provided in this code, this code applies to:

- 1 (1) the affairs and estates of decedents, missing persons, and persons to be protected in this state;
- 2 (2) the property of nonresidents located in this state or property coming into the control of a fiduciary who
- 3 is subject to the laws of this state; ~~and~~
- 4 (3) incapacitated persons and minors in this state; and
- 5 (4) survivorship and related accounts in this state."

6

7 **Section 5.** Section 72-1-208, MCA, is amended to read:

8 **"72-1-208. Jury trial.** (1) If duly demanded, a party is entitled to trial by jury in a formal testacy

9 proceeding, ~~a formal proceeding for determination of heirship, and any other proceeding as may be provided for~~

10 ~~by law~~ and any proceeding in which any controverted question of fact arises as to which any party has a

11 constitutional right to trial by jury.

12 (2) If there is no right to trial by jury under subsection (1) or the right is waived, the court in its discretion

13 may call a jury to decide any issue of fact, in which case the verdict is advisory only."

14

15 **Section 6.** Section 72-1-302, MCA, is amended to read:

16 **"72-1-302. Waiver of notice.** A person, including a guardian ad litem, conservator, or other fiduciary,

17 may waive notice by a writing signed by the person or the person's attorney and filed in the proceeding. A person

18 for whom a guardianship or other protective order is sought, a ward, or a protected person may not waive notice."

19

20 **Section 7.** Section 72-1-303, MCA, is amended to read:

21 **"72-1-303. Pleadings -- when orders or notice binding one binds another -- representation.** In

22 formal proceedings involving trusts or estates of decedents, minors, protected persons, or incapacitated persons

23 and in judicially supervised settlements, the following apply:

- 24 (1) Interests to be affected must be described in pleadings that give reasonable information to owners
- 25 by name or class, by reference to the instrument creating the interests, or in other appropriate manner.
- 26 (2) Persons are bound by orders binding others in the following cases:
 - 27 (a) Orders binding the sole holder or all coholders of a power of revocation or a presently exercisable
 - 28 general power of appointment, including one in the form of a power of amendment, bind other persons to the
 - 29 extent their interests, as objects, takers in default, or otherwise, are subject to the power.
 - 30 (b) (i) To the extent there is no conflict of interest between them or among persons represented, orders

1 binding a:

2 (A) conservator bind the person whose estate the conservator controls;

3 (B) guardian bind the ward if a conservator of the ward's estate has not been appointed;

4 (C) trustee bind beneficiaries of the trust in proceedings to probate a will establishing or adding to a trust,
5 to review the acts or accounts of a prior fiduciary, and in proceedings involving creditors or other third parties;

6 **and**

7 (D) personal representative bind persons interested in the undistributed assets of a decedent's estate
8 in actions or proceedings by or against the estate; and

9 (E) a sole holder or all co-holders of a general testamentary power of appointment binds other persons
10 to the extent their interests as objects, takers in default, or otherwise are subject to the power.

11 (ii) If there is no conflict of interest and a conservator or guardian has not been appointed, a parent may
12 represent the parent's minor child.

13 (c) An unborn or unascertained person who is not otherwise represented is bound by an order to the
14 extent the person's interest is adequately represented by another party having a substantially identical interest
15 in the proceeding.

16 (3) Notice is required as follows:

17 (a) Notice as prescribed by 72-1-301 must be given to every interested person or to one who can bind
18 an interested person as described in subsection (2)(a) or (2)(b). Notice may be given both to a person and to
19 another who may bind the person.

20 (b) Notice is given to unborn or unascertained persons, who are not represented under subsection (2)(a)
21 or (2)(b), by giving notice to all known persons whose interests in the proceedings are substantially identical to
22 those of the unborn or unascertained persons.

23 (4) At any point in a proceeding, a court may appoint a guardian ad litem to represent the interest of a
24 minor, an incapacitated, unborn, or unascertained person, or a person whose identity or address is unknown if
25 the court determines that representation of the interest otherwise would be inadequate. If not precluded by conflict
26 of interests, a guardian ad litem may be appointed to represent several persons or interests. The court shall set
27 out its reasons for appointing a guardian ad litem as a part of the record of the proceeding."
28

29 **Section 8.** Section 72-2-112, MCA, is amended to read:

30 **"72-2-112. Share of spouse.** The intestate share of a decedent's surviving spouse is:

- 1 (1) the entire intestate estate if:
- 2 (a) no descendant or parent of the decedent survives the decedent; or
- 3 (b) all of the decedent's surviving descendants are also descendants of the surviving spouse and there
- 4 is no other descendant of the surviving spouse who survives the decedent;
- 5 (2) the first ~~\$200,000~~ \$300,000, plus three-fourths of any balance of the intestate estate, if no descendant
- 6 of the decedent survives the decedent but a parent of the decedent survives the decedent;
- 7 (3) the first ~~\$150,000~~ \$225,000, plus one-half of any balance of the intestate estate, if all of the
- 8 decedent's surviving descendants are also descendants of the surviving spouse and the surviving spouse has
- 9 one or more surviving descendants who are not descendants of the decedent;
- 10 (4) the first ~~\$100,000~~ \$150,000, plus one-half of any balance of the intestate estate, if one or more of
- 11 the decedent's surviving descendants are not descendants of the surviving spouse."

12

13 **Section 9.** Section 72-2-114, MCA, is amended to read:

14 **"72-2-114. Requirement that heir survive decedent for 120 hours.** An individual who fails to survive

15 the decedent by 120 hours is ~~considered~~ deemed to have predeceased the decedent for purposes of homestead

16 allowance, exempt property, and intestate succession, and the decedent's heirs are determined accordingly. If

17 it is not established by clear and convincing evidence that an individual who would otherwise be an heir survived

18 the decedent by 120 hours, it is ~~considered~~ deemed that the individual failed to survive for the required period.

19 This section is not to be applied if its application would result in a taking of intestate estate by the state under

20 72-2-115."

21

22 **Section 10.** Section 72-2-116, MCA, is amended to read:

23 **"72-2-116. Representation.** (1) As used in this section, the following definitions apply:

24 (a) "Deceased descendant", "deceased parent", or "deceased grandparent" means a descendant,

25 parent, or grandparent who either predeceased the decedent or is ~~considered~~ deemed to have predeceased the

26 decedent under 72-2-114.

27 (b) "Surviving descendant" means a descendant who neither predeceased the decedent nor is

28 ~~considered~~ deemed to have predeceased the decedent under 72-2-114.

29 (2) (a) If, under 72-2-113(1)(a), a decedent's intestate estate or a part of the intestate estate passes by

30 representation to the decedent's descendants, the estate or part of the estate is divided into as many equal

1 shares as there are:

2 (i) surviving descendants in the generation nearest to the decedent that contains one or more surviving
3 descendants; and

4 (ii) deceased descendants in the same generation who left surviving descendants, if any.

5 (b) Each surviving descendant in the nearest generation is allocated one share. The share of each
6 deceased descendant in the same generation as the surviving descendant is divided in the same manner, with
7 the subdivision repeating at each succeeding generation until the property is fully allocated among surviving
8 descendants.

9 (3) (a) If, under 72-2-113(1)(c) or (1)(d), a decedent's intestate estate or a part of the intestate estate
10 passes by representation to the descendants of the decedent's deceased parents or either of them or to the
11 descendants of the decedent's deceased paternal or maternal grandparents or either of them, the estate or part
12 of the estate is divided into as many equal shares as there are:

13 (i) surviving descendants in the generation nearest the deceased parents or either of them or nearest
14 the deceased grandparents or either of them that contains one or more surviving descendants; and

15 (ii) deceased descendants in the same generation who left surviving descendants, if any.

16 (b) Each surviving descendant in the nearest generation is allocated one share. The share of each
17 deceased descendant in the same generation as the surviving descendant is divided in the same manner, with
18 the subdivision repeating at each succeeding generation until the property is fully allocated among surviving
19 descendants."

20

21 **Section 11.** Section 72-2-118, MCA, is amended to read:

22 **"72-2-118. Afterborn heirs.** An individual in gestation at a particular time is treated as living at that time
23 if the individual lives 120 hours or more after birth. If it is not established by clear and convincing evidence that
24 an individual in gestation at the decedent's death lived 120 hours after birth, it is deemed that the individual failed
25 to survive for the required period."

26

27 NEW SECTION. **Section 12. Parent barred from inheriting in certain circumstances.** (1) A parent
28 is barred from inheriting from or through a child of the parent if:

29 (a) the parent's parental rights were terminated and the parent-child relationship was not judicially
30 reestablished; or

1 (b) the child died before reaching 18 years of age and there is clear and convincing evidence that
 2 immediately before the child's death the parental rights of the parent could have been terminated under law of
 3 this state other than this code on the basis of nonsupport, abandonment, abuse, neglect, or other actions or
 4 inactions of the parent toward the child.

5 (2) For the purpose of intestate succession from or through the deceased child, a parent who is barred
 6 from inheriting under this section is treated as if the parent predeceased the child.

7

8 **NEW SECTION. Section 13. Definitions.** In [sections 13 through 19]:

9 (1) "Adoptee" means an individual who is adopted.

10 (2) "Assisted reproduction" means a method of causing pregnancy other than sexual intercourse.

11 (3) "Divorce" includes an annulment, dissolution, and declaration of invalidity of a marriage.

12 (4) "Functioned as a parent of the child" means behaving toward a child in a manner consistent with being
 13 the child's parent and performing functions that are customarily performed by a parent, including fulfilling parental
 14 responsibilities toward the child, recognizing or holding out the child as the individual's child, materially
 15 participating in the child's upbringing, and residing with the child in the same household as a regular member of
 16 that household.

17 (5) "Genetic father" means the man whose sperm fertilized the egg of a child's genetic mother. If the
 18 father-child relationship is established under the presumption of paternity under 40-6-105, the term means only
 19 the man for whom that relationship is established.

20 (6) "Genetic mother" means the woman whose egg was fertilized by the sperm of a child's genetic father.

21 (7) "Genetic parent" means a child's genetic father or genetic mother.

22 (8) "Incapacity" means the inability of an individual to function as a parent of a child because of the
 23 individual's physical or mental condition.

24 (9) "Relative" means a grandparent or a descendant of a grandparent.

25

26 **NEW SECTION. Section 14. Effect of parent-child relationship.** Except as otherwise provided in
 27 [section 17(2) through (5)], if a parent-child relationship exists or is established under [sections 13 through 19],
 28 the parent is a parent of the child and the child is a child of the parent for the purpose of intestate succession.

29

30 **NEW SECTION. Section 15. No distinction based on marital status.** Except as otherwise provided

1 in [sections 12, 17, 18, or 19], a parent-child relationship exists between a child and the child's genetic parents,
2 regardless of the parents' marital status.

3
4 **NEW SECTION. Section 16. Adoptee and adoptee's adoptive parent or parents.** (1) A parent-child
5 relationship exists between an adoptee and the adoptee's adoptive parent or parents.

6 (2) For purposes of subsection (1):

7 (a) an individual who is in the process of being adopted by a married couple when one of the spouses
8 dies is treated as adopted by the deceased spouse if the adoption is subsequently granted to the decedent's
9 surviving spouse; and

10 (b) a child of a genetic parent who is in the process of being adopted by a genetic parent's spouse when
11 the spouse dies is treated as adopted by the deceased spouse if the genetic parent survives the deceased
12 spouse by 120 hours.

13 (3) If, after a parent-child relationship is established between a child of assisted reproduction and a parent
14 under [section 18] or between a gestational child and a parent under [section 19], the child is in the process of
15 being adopted by the parent's spouse when that spouse dies, the child is treated as adopted by the deceased
16 spouse for the purpose of subsection (2)(b).

17
18 **NEW SECTION. Section 17. Adoptee and adoptee's genetic parents.** (1) Except as otherwise
19 provided in subsections (2) through (5), a parent-child relationship does not exist between an adoptee and the
20 adoptee's genetic parents.

21 (2) A parent-child relationship exists between an individual who is adopted by the spouse of either genetic
22 parent and:

23 (a) the genetic parent whose spouse adopted the individual; and

24 (b) the other genetic parent, but only for the purpose of the right of the adoptee or a descendant of the
25 adoptee to inherit from or through the other genetic parent.

26 (3) A parent-child relationship exists between both genetic parents and an individual who is adopted by
27 a relative of a genetic parent, or by the spouse or surviving spouse of a relative of a genetic parent, but only for
28 the purpose of the right of the adoptee or a descendant of the adoptee to inherit from or through either genetic
29 parent.

30 (4) A parent-child relationship exists between both genetic parents and an individual who is adopted after

1 the death of both genetic parents, but only for the purpose of the right of the adoptee or a descendant of the
2 adoptee to inherit through either genetic parent.

3 (5) If, after a parent-child relationship is established between a child of assisted reproduction and a parent
4 or parents under [section 18] or between a gestational child and a parent or parents under [section 19], the child
5 is adopted by another or others, the child's parent or parents under [sections 18 or 19] are treated as the child's
6 genetic parent or parents for the purpose of this section.

7
8 **NEW SECTION. Section 18. Child conceived by assisted reproduction other than child born to**
9 **gestational carrier.** (1) In this section:

10 (a) "Birth mother" means a woman, other than a gestational carrier under [section 19], who gives birth
11 to a child of assisted reproduction. The term is not limited to a woman who is the child's genetic mother.

12 (b) "Child of assisted reproduction" means a child conceived by means of assisted reproduction by a
13 woman other than a gestational carrier under [section 19].

14 (c) "Third-party donor" means an individual who produces eggs or sperm used for assisted reproduction,
15 whether or not for consideration. The term does not include:

16 (i) a husband who provides sperm, or a wife who provides eggs, that are used for assisted reproduction
17 by the wife;

18 (ii) the birth mother of a child of assisted reproduction; or

19 (iii) an individual who has been determined under subsection (5) or (6) to have a parent-child relationship
20 with a child of assisted reproduction.

21 (2) A parent-child relationship does not exist between a child of assisted reproduction and a third-party
22 donor.

23 (3) A parent-child relationship exists between a child of assisted reproduction and the child's birth mother.

24 (4) Except as otherwise provided in subsections (9) and (10), a parent-child relationship exists between
25 a child of assisted reproduction and the husband of the child's birth mother if the husband provided the sperm
26 that the birth mother used during his lifetime for assisted reproduction.

27 (5) A birth certificate identifying an individual other than the birth mother as the other parent of a child of
28 assisted reproduction presumptively establishes a parent-child relationship between the child and that individual.

29 (6) Except as otherwise provided in subsections (7), (9), and (10), and unless a parent-child relationship
30 is established under subsection (4) or (5), a parent-child relationship exists between a child of assisted

1 reproduction and an individual other than the birth mother who consented to assisted reproduction by the birth
2 mother with intent to be treated as the other parent of the child. Consent to assisted reproduction by the birth
3 mother with intent to be treated as the other parent of the child is established if the individual:

4 (a) before or after the child's birth, signed a record that, considering all the facts and circumstances,
5 evidences the individual's consent; or

6 (b) in the absence of a signed record under subsection (6)(a):

7 (i) functioned as a parent of the child no later than 2 years after the child's birth;

8 (ii) intended to function as a parent of the child no later than 2 years after the child's birth but was
9 prevented from carrying out that intent by death, incapacity, or other circumstances; or

10 (iii) intended to be treated as a parent of a posthumously conceived child, if that intent is established by
11 clear and convincing evidence.

12 (7) For the purpose of subsection (6)(a), neither an individual who signed a record more than 2 years
13 after the birth of the child, nor a relative of that individual who is not also a relative of the birth mother, inherits
14 from or through the child unless the individual functioned as a parent of the child before the child reached 18
15 years of age.

16 (8) For the purpose of subsection (6)(b), the following rules apply:

17 (a) If the birth mother is married and no divorce proceeding is pending, in the absence of clear and
18 convincing evidence to the contrary, her spouse satisfies subsection (6)(b)(i) or (ii).

19 (b) If the birth mother is a surviving spouse and at her deceased spouse's death no divorce proceeding
20 was pending, in the absence of clear and convincing evidence to the contrary, her deceased spouse satisfies
21 subsection (6)(b)(ii) or (iii).

22 (9) If a married couple is divorced before placement of eggs, sperm, or embryos, a child resulting from
23 the assisted reproduction is not a child of the birth mother's former spouse, unless the former spouse consented
24 in a record that if assisted reproduction were to occur after divorce, the child would be treated as the former
25 spouse's child.

26 (10) If, in a record, an individual withdraws consent to assisted reproduction before placement of eggs,
27 sperm, or embryos, a child resulting from the assisted reproduction is not a child of that individual, unless the
28 individual subsequently satisfies subsection (6).

29 (11) If, under this section, an individual is a parent of a child of assisted reproduction who is conceived
30 after the individual's death, the child is treated as in gestation at the individual's death for purposes of 72-2-118

1 if the child is:

2 (a) in utero not later than 36 months after the individual's death; or

3 (b) born not later than 45 months after the individual's death.

4

5 **NEW SECTION. Section 19. Child born to gestational carrier.** (1) In this section:

6 (a) "Gestational agreement" means an enforceable or unenforceable agreement for assisted reproduction
7 in which a woman agrees to carry a child to birth for an intended parent, intended parents, or an individual
8 described in subsection (5).

9 (b) "Gestational carrier" means a woman who is not an intended parent who gives birth to a child under
10 a gestational agreement. The term is not limited to a woman who is the child's genetic mother.

11 (c) "Gestational child" means a child born to a gestational carrier under a gestational agreement.

12 (d) "Intended parent" means an individual who entered into a gestational agreement providing that the
13 individual will be the parent of a child born to a gestational carrier by means of assisted reproduction. The term
14 is not limited to an individual who has a genetic relationship with the child.

15 (2) A parent-child relationship is conclusively established by a court order designating the parent or
16 parents of a gestational child.

17 (3) A parent-child relationship between a gestational child and the child's gestational carrier does not exist
18 unless the gestational carrier is:

19 (a) designated as a parent of the child in a court order described in subsection (2); or

20 (b) the child's genetic mother and a parent-child relationship does not exist under this section with an
21 individual other than the gestational carrier.

22 (4) In the absence of a court order under subsection (2), a parent-child relationship exists between a
23 gestational child and an intended parent who:

24 (a) functioned as a parent of the child no later than 2 years after the child's birth; or

25 (b) died while the gestational carrier was pregnant if:

26 (i) there were two intended parents and the other intended parent functioned as a parent of the child no
27 later than 2 years after the child's birth;

28 (ii) there were two intended parents, the other intended parent also died while the gestational carrier was
29 pregnant, and a relative of either deceased intended parent or the spouse or surviving spouse of a relative of
30 either deceased intended parent functioned as a parent of the child no later than 2 years after the child's birth;

1 or

2 (iii) there was no other intended parent and a relative of or the spouse or surviving spouse of a relative
3 of the deceased intended parent functioned as a parent of the child no later than 2 years after the child's birth.

4 (5) In the absence of a court order under subsection (2), a parent-child relationship exists between a
5 gestational child and an individual whose sperm or eggs were used after the individual's death or incapacity to
6 conceive a child under a gestational agreement entered into after the individual's death or incapacity if the
7 individual intended to be treated as the parent of the child. The individual's intent may be shown by:

8 (a) a record signed by the individual which considering all the facts and circumstances evidences the
9 individual's intent; or

10 (b) other facts and circumstances establishing the individual's intent by clear and convincing evidence.

11 (6) Except as otherwise provided in subsection (7), and unless there is clear and convincing evidence
12 of a contrary intent, an individual is deemed to have intended to be treated as the parent of a gestational child
13 for purposes of subsection (5)(b) if:

14 (a) the individual, before death or incapacity, deposited the sperm or eggs that were used to conceive
15 the child;

16 (b) when the individual deposited the sperm or eggs, the individual was married and no divorce
17 proceeding was pending; and

18 (c) the individual's spouse or surviving spouse functioned as a parent of the child no later than 2 years
19 after the child's birth.

20 (7) The presumption under subsection (6) does not apply if there is:

21 (a) a court order under subsection (2); or

22 (b) a signed record that satisfies subsection (5)(a).

23 (8) If, under this section, an individual is a parent of a gestational child who is conceived after the
24 individual's death, the child is treated as in gestation at the individual's death for purposes of 72-2-118 if the child
25 is:

26 (a) in utero not later than 36 months after the individual's death; or

27 (b) born not later than 45 months after the individual's death.

28 (9) This section does not affect law of this state other than this code regarding the enforceability or validity
29 of a gestational agreement.

30

1 NEW SECTION. **Section 20. Definitions.** In [sections 20 through 29]:

2 (1) As used in sections other than [section 24], "decedent's nonprobate transfers to others" means the
3 amounts that are included in the augmented estate under [section 24].

4 (2) "Fractional interest in property held in joint tenancy with the right of survivorship," whether the
5 fractional interest is unilaterally severable or not, means the fraction, the numerator of which is one and the
6 denominator of which, if the decedent was a joint tenant, is one plus the number of joint tenants who survive the
7 decedent and which, if the decedent was not a joint tenant, is the number of joint tenants.

8 (3) "Marriage," as it relates to a transfer by the decedent during marriage, means any marriage of the
9 decedent to the decedent's surviving spouse.

10 (4) "Nonadverse party" means a person who does not have a substantial beneficial interest in the trust
11 or other property arrangement that would be adversely affected by the exercise or nonexercise of the power that
12 person possesses respecting the trust or other property arrangement. A person having a general power of
13 appointment over property is deemed to have a beneficial interest in the property.

14 (5) "Power" or "power of appointment" includes a power to designate the beneficiary of a beneficiary
15 designation.

16 (6) "Presently exercisable general power of appointment" means a power of appointment under which,
17 at the time in question, the decedent, whether or not the decedent then had the capacity to exercise the power,
18 held a power to create a present or future interest in the decedent, the decedent's creditors, the decedent's
19 estate, or creditors of the decedent's estate, and includes a power to revoke or invade the principal of a trust or
20 other property arrangement.

21 (7) "Property" includes values subject to a beneficiary designation.

22 (8) "Right to income" includes a right to payments under a commercial or private annuity, an annuity trust,
23 a unitrust, or a similar arrangement.

24 (9) "Transfer," as it relates to a transfer by or of the decedent, includes:

25 (a) an exercise or release of a presently exercisable general power of appointment held by the decedent;

26 (b) a lapse at death of a presently exercisable general power of appointment held by the decedent; and

27 (c) an exercise, release, or lapse of a general power of appointment that the decedent created in the
28 decedent and of a power described in [section 24(2)(b)] that the decedent conferred on a nonadverse party.

29

30 NEW SECTION. **Section 21. Elective share.** (1) The surviving spouse of a decedent who dies

1 domiciled in this state has a right of election, under the limitations and conditions stated in [sections 20 through
2 29], to take an elective-share amount equal to 50% of the value of the marital-property portion of the augmented
3 estate.

4 (2) If the sum of the amounts described in [sections 26 and 28(1)(a)], and that part of the elective-share
5 amount payable from the decedent's net probate estate and nonprobate transfers to others under [section 28(3)
6 and (4)] is less than \$75,000, the surviving spouse is entitled to a supplemental elective-share amount equal to
7 \$75,000, minus the sum of the amounts described in those sections. The supplemental elective-share amount
8 is payable from the decedent's net probate estate and from recipients of the decedent's nonprobate transfers to
9 others in the order of priority set forth in [section 28(3) and (4)].

10 (3) If the right of election is exercised by or on behalf of the surviving spouse, the surviving spouse's
11 homestead allowance, exempt property, and family allowance, if any, are not charged against but are in addition
12 to the elective-share and supplemental elective-share amounts.

13 (4) The right, if any, of the surviving spouse of a decedent who dies domiciled outside this state to take
14 an elective share in property in this state is governed by the law of the decedent's domicile at death.

15
16 **NEW SECTION. Section 22. Composition of the augmented estate.** (1) Subject to [section 27], the
17 value of the augmented estate, to the extent provided in [sections 23, 24, 25, and 26], consists of the sum of the
18 values of all property, whether real or personal; movable or immovable, tangible or intangible, wherever situated,
19 that constitute:

- 20 (a) the decedent's net probate estate;
- 21 (b) the decedent's nonprobate transfers to others;
- 22 (c) the decedent's nonprobate transfers to the surviving spouse; and
- 23 (d) the surviving spouse's property and nonprobate transfers to others.

24 (2) The value of the marital-property portion of the augmented estate consists of the sum of the values
25 of the four components of the augmented estate as determined under subsection (1) multiplied by the following
26 percentage:

27 If the decedent and the spouse	The percentage is:

30 1 year but less than 2 years	6%

16 NEW SECTION. **Section 23. Decedent's net probate estate.** The value of the augmented estate
 17 includes the value of the decedent's probate estate, reduced by funeral and administration expenses, homestead
 18 allowance, family allowances, exempt property, and enforceable claims.

19

20 NEW SECTION. **Section 24. Decedents's nonprobate transfers to others.** The value of the
 21 augmented estate includes the value of the decedent's nonprobate transfers to others, not included under [section
 22 23], of any of the following types, in the amount provided respectively for each type of transfer:

23 (1) Property owned or owned in substance by the decedent immediately before death that passed outside
 24 probate at the decedent's death. Property included under this category consists of:

25 (a) Property over which the decedent alone, immediately before death, held a presently exercisable
 26 general power of appointment. The amount included is the value of the property subject to the power, to the
 27 extent the property passed at the decedent's death, by exercise, release, lapse, in default, or otherwise, to or for
 28 the benefit of any person other than the decedent's estate or surviving spouse.

29 (b) The decedent's fractional interest in property held by the decedent in joint tenancy with the right of
 30 survivorship. The amount included is the value of the decedent's fractional interest, to the extent the fractional

1 interest passed by right of survivorship at the decedent's death to a surviving joint tenant other than the
2 decedent's surviving spouse.

3 (c) The decedent's ownership interest in property or accounts held in POD, TOD, or co-ownership
4 registration with the right of survivorship. The amount included is the value of the decedent's ownership interest,
5 to the extent the decedent's ownership interest passed at the decedent's death to or for the benefit of any person
6 other than the decedent's estate or surviving spouse.

7 (2) Property transferred in any of the following forms by the decedent during marriage:

8 (a) Any irrevocable transfer in which the decedent retained the right to the possession or enjoyment of,
9 or to the income from, the property if and to the extent the decedent's right terminated at or continued beyond
10 the decedent's death. The amount included is the value of the fraction of the property to which the decedent's
11 right related, to the extent the fraction of the property passed outside probate to or for the benefit of any person
12 other than the decedent's estate or surviving spouse.

13 (b) Any transfer in which the decedent created a power over income or property, exercisable by the
14 decedent alone or in conjunction with any other person, or exercisable by a nonadverse party, to or for the benefit
15 of the decedent, creditors of the decedent, the decedent's estate, or creditors of the decedent's estate. The
16 amount included with respect to a power over property is the value of the property subject to the power, and the
17 amount included with respect to a power over income is the value of the property that produces or produced the
18 income, to the extent the power in either case was exercisable at the decedent's death to or for the benefit of any
19 person other than the decedent's surviving spouse or to the extent the property passed at the decedent's death,
20 by exercise, release, lapse, in default, or otherwise, to or for the benefit of any person other than the decedent's
21 estate or surviving spouse. If the power is a power over both income and property and the preceding sentence
22 produces different amounts, the amount included is the greater amount.

23 (3) Property that passed during marriage and during the 2 year period next preceding the decedent's
24 death as a result of a transfer by the decedent if the transfer was of any of the following types:

25 (a) Any property that passed as a result of the termination of a right or interest in, or power over, property
26 that would have been included in the augmented estate under subsection (1)(a), (1)(b), or (1)(c), or under
27 subsection (2), if the right, interest, or power had not terminated until the decedent's death. The amount included
28 is the value of the property that would have been included under those subsections if the property were valued
29 at the time the right, interest, or power terminated, and is included only to the extent the property passed upon
30 termination to or for the benefit of any person other than the decedent or the decedent's estate, spouse, or

1 surviving spouse. As used in this subsection (3)(a), "termination," with respect to a right or interest in property,
 2 occurs when the right or interest terminated by the terms of the governing instrument or the decedent transferred
 3 or relinquished the right or interest, and, with respect to a power over property, occurs when the power terminated
 4 by exercise, release, lapse, default, or otherwise, but, with respect to a power described in subsection (1)(a),
 5 "termination" occurs when the power terminated by exercise or release, but not otherwise.

6 (b) Any transfer of property, to the extent not otherwise included in the augmented estate, made to or for
 7 the benefit of a person other than the decedent's surviving spouse. The amount included is the value of the
 8 transferred property to the extent the transfers to any one donee in either of the 2 years exceeded the amount
 9 excludable from taxable gifts under 26 U.S.C. 2503(b) or its successor on the date next preceding the date of the
 10 decedent's death.

11
 12 **NEW SECTION. Section 25. Decedent's nonprobate transfers to surviving spouse.** Excluding
 13 property passing to the surviving spouse under the federal social security system, the value of the augmented
 14 estate includes the value of the decedent's nonprobate transfers to the decedent's surviving spouse, which
 15 consist of all property that passed outside probate at the decedent's death from the decedent to the surviving
 16 spouse by reason of the decedent's death, including:

17 (1) the decedent's fractional interest in property held as a joint tenant with the right of survivorship, to the
 18 extent that the decedent's fractional interest passed to the surviving spouse as surviving joint tenant;

19 (2) the decedent's ownership interest in property or accounts held in co-ownership registration with the
 20 right of survivorship, to the extent the decedent's ownership interest passed to the surviving spouse as surviving
 21 co-owner; and

22 (3) all other property that would have been included in the augmented estate under [section 24(1) or (2)]
 23 had it passed to or for the benefit of a person other than the decedent's spouse, surviving spouse, the decedent,
 24 or the decedent's creditors, estate, or estate creditors.

25
 26 **NEW SECTION. Section 26. Surviving spouse's property and nonprobate transfers to others.** (1)
 27 Except to the extent included in the augmented estate under [sections 23 or 25], the value of the augmented
 28 estate includes the value of:

29 (a) property that was owned by the decedent's surviving spouse at the decedent's death, including:

30 (i) the surviving spouse's fractional interest in property held in joint tenancy with the right of survivorship;

1 (ii) the surviving spouse's ownership interest in property or accounts held in co-ownership registration
2 with the right of survivorship; and

3 (iii) property that passed to the surviving spouse by reason of the decedent's death, but not including the
4 spouse's right to homestead allowance, family allowance, exempt property, or payments under the federal social
5 security system; and

6 (b) property that would have been included in the surviving spouse's nonprobate transfers to others, other
7 than the spouse's fractional and ownership interests included under subsection (1)(a)(i) or (1)(a)(ii), had the
8 spouse been the decedent.

9 (2) Property included under this section is valued at the decedent's death, taking the fact that the
10 decedent predeceased the spouse into account, but, for purposes of subsection (1)(a)(i) and (1)(a)(ii), the values
11 of the spouse's fractional and ownership interests are determined immediately before the decedent's death if the
12 decedent was then a joint tenant or a co-owner of the property or accounts.

13 (3) The value of property included under this section is reduced by enforceable claims against the
14 surviving spouse.

15
16 **NEW SECTION. Section 27. Exclusions, valuation, and overlapping application.** (1) The value of
17 any property is excluded from the decedent's nonprobate transfers to others:

18 (a) to the extent the decedent received adequate and full consideration in money or money's worth for
19 a transfer of the property;

20 (b) if the property was transferred with the written joinder of, or if the transfer was consented to in writing
21 before or after the transfer by, the surviving spouse; or

22 (c) if the property is life insurance or accident insurance payable to persons other than the decedent's
23 surviving spouse or the decedent's estate.

24 (2) The value of property:

25 (a) included in the augmented estate under [sections 24, 25, or 26] is reduced in each category by
26 enforceable claims against the included property; and

27 (b) includes the commuted value of any present or future interest and the commuted value of amounts
28 payable under any trust, life insurance settlement option, annuity contract, public or private pension, disability
29 compensation, death benefit or retirement plan, or any similar arrangement, exclusive of the federal social
30 security system. The commuted value of life and term interests in income, annuity, or unitrust amount must be

1 determined in accordance with U.S. treasury regulations for internal revenue purposes in effect at the time of the
2 decedent's death.

3 (3) In case of overlapping application to the same property of [sections 24, 25, or 26], the property is
4 included in the augmented estate under the provision yielding the greatest value, and under only one overlapping
5 provision if they all yield the same value.

6

7 **NEW SECTION. Section 28. Sources from which elective share payable.** (1) In a proceeding for an
8 elective share, the following are applied first to satisfy the elective-share amount and to reduce or eliminate any
9 contributions due from the decedent's probate estate and recipients of the decedent's nonprobate transfers to
10 others:

11 (a) amounts included in the augmented estate under [section 23] which pass or have passed to the
12 surviving spouse by testate or intestate succession and amounts included in the augmented estate under [section
13 25];

14 (b) amounts included in the augmented estate that would have passed to the spouse but were
15 disclaimed; and

16 (c) the marital-property portion of amounts included in the augmented estate under [section 26].

17 (2) The marital-property portion under subsection (1)(b) is computed by multiplying the value of the
18 amounts included in the augmented estate under [section 26] by the percentage of the augmented estate set forth
19 in the schedule in [section 22(2)] appropriate to the length of time the spouse and the decedent were married to
20 each other.

21 (3) If, after the application of subsection (1), the elective-share amount is not fully satisfied, or the
22 surviving spouse is entitled to a supplemental elective-share amount, amounts included in the decedent's net
23 probate estate, other than assets passing to the surviving spouse by testate or intestate succession, and in the
24 decedent's nonprobate transfers to others under [section 24(1) and (2)] are applied first to satisfy the unsatisfied
25 balance of the elective-share amount or the supplemental elective-share amount. The decedent's net probate
26 estate and that portion of the decedent's nonprobate transfers to others are so applied that liability for the
27 unsatisfied balance of the elective-share amount or for the supplemental elective-
28 share amount is apportioned among the recipients of the decedent's net probate estate and of that portion of the
29 decedent's nonprobate transfers to others in proportion to the value of their interests.

30 (4) If, after the application of subsections (1) and (3), the elective-share or supplemental elective-share

1 amount is not fully satisfied, the remaining portion of the decedent's nonprobate transfers to others is so applied
2 that liability for the unsatisfied balance of the elective-share or supplemental elective-share amount is apportioned
3 among the recipients of the remaining portion of the decedent's nonprobate transfers to others in proportion to
4 the value of their interests therein.

5 (5) The unsatisfied balance of the elective-share or supplemental elective-share amount as determined
6 under subsection (3) or (4) is treated as a general pecuniary devise for purposes of 72-3-913.

7

8 **NEW SECTION. Section 29. Effect of premarital or marital agreement right to elect and of other**
9 **rights.** (1) In this section, "agreement" includes a subsequent agreement that affirms, modifies, or waives an
10 earlier agreement.

11 (2) The right of election of a surviving spouse and the rights of the surviving spouse to homestead
12 allowance, exempt property, and family allowance, or any of them, may be affirmed, modified, or waived wholly
13 or partially, only by a written agreement signed by the surviving spouse, before or after the marriage. The
14 agreement is enforceable without consideration.

15 (3) An agreement under subsection (2) is not enforceable if the surviving spouse proves that:

16 (a) the agreement was involuntary or the result of duress;

22 under subsection (5).

23 (4) A surviving spouse had access to independent legal representation if:

24 (a) before signing an agreement, the surviving spouse had a reasonable time to:

25 (i) decide whether to retain a lawyer to provide independent legal representation; and

26 (ii) locate a lawyer to provide independent legal representation, obtain the lawyer's advice, and consider
27 the advice provided; and

28 (b) the other spouse was represented by a lawyer and the surviving spouse had the financial ability to
29 retain a lawyer or the other spouse agreed to pay the reasonable fees and expenses of independent legal
30 representation.

- 1 (5) A surviving spouse had adequate financial disclosure under this section if the surviving spouse:
- 2 (a) received a reasonably accurate description and good-faith estimate of the value of the property,
- 3 liabilities, and income of the other spouse;
- 4 (b) expressly waived, in a separate signed record, the right to financial disclosure beyond the disclosure
- 5 provided; or

18 does not specifically refer to a child of assisted reproduction or a gestational child does not apply to a child of

12 (a) "Disposition or appointment of property" includes a transfer of an item of property or any other benefit
13 to a beneficiary designated in a governing instrument.

14 (b) "Governing instrument" means a governing instrument executed by the decedent.

15 (c) "Revocable", with respect to a disposition, appointment, provision, or nomination, means one under
16 which the decedent, at the time of or immediately before death, was alone empowered, by law or under the
17 governing instrument, to cancel the designation in favor of the killer, whether or not the decedent was then
18 empowered to designate the decedent in place of the decedent's killer and whether or not the decedent then had
19 capacity to exercise the power.

20 (2) An individual who feloniously and intentionally kills the decedent forfeits all benefits under this chapter
21 with respect to the decedent's estate, including an intestate share, an elective share, an omitted spouse's or
22 child's share, a homestead allowance, exempt property, and a family allowance. If the decedent died intestate,
23 the decedent's intestate estate passes as if the killer disclaimed the killer's intestate share.

24 (3) The felonious and intentional killing of the decedent:

25 (a) revokes any revocable:

26 (i) disposition or appointment of property made by the decedent to the killer in a governing instrument;

27 (ii) provision in a governing instrument conferring a general or nongeneral power of appointment on the
28 killer; and

29 (iii) nomination of the killer in a governing instrument, nominating or appointing the killer to serve in any
30 fiduciary or representative capacity, including a personal representative, executor, trustee, or agent; and

1 (b) severs the interests of the decedent and killer in property held by them at the time of the killing as
2 joint tenants with the right of survivorship and transforms the interests of the decedent and killer into tenancies
3 in common.

4 (4) A severance under subsection (3)(b) does not affect any third-party interest in property acquired for
5 value and in good faith reliance on an apparent title by survivorship in the killer unless a writing declaring the
6 severance has been noted, registered, filed, or recorded in records appropriate to the kind and location of the
7 property, which records are relied upon, in the ordinary course of transactions involving such property, as
8 evidence of ownership.

9 (5) Provisions of a governing instrument are given effect as if the killer disclaimed all provisions revoked
10 by this section or, in the case of a revoked nomination in a fiduciary or representative capacity, as if the killer
11 predeceased the decedent.

12 (6) A wrongful acquisition of property or interest by a killer not covered by this section must be treated
13 in accordance with the principle that a killer cannot profit from the killer's wrong.

29 suspicious or questionable as to the beneficiary's participation in a homicide. A payor or other third party is only
30 liable for actions taken 2 or more business days after the actual receipt by the payor or other third party of written

1 notice. The payor or other third party may be liable for actions taken pursuant to the governing instrument only
2 if the form of the service is that described in subsection (8)(b).

3 (b) The written notice must indicate the name of the decedent, the name of the person asserting an
4 interest, the nature of the payment or item of property or other benefit, and a statement that a claim of forfeiture
5 or revocation is being made under this section. Written notice of a claimed forfeiture or revocation under
6 subsection (8)(a) must be mailed to the payor's or other third party's main office or home by certified mail, return
7 receipt requested, or served upon the payor or other third party in the same manner as a summons in a civil
8 action. Notice to a sales representative of the payor or other third party does not constitute notice to the payor
9 or other third party. Upon receipt of written notice of a claimed forfeiture or revocation under this section, a payor
10 or other third party may pay any amount owed or transfer or deposit any item of property held by it to or with the
11 court having jurisdiction of the probate proceedings relating to the decedent's estate or, if no proceedings have
12 been commenced, to or with the court having jurisdiction of probate proceedings relating to decedents' estates
13 located in the county of the decedent's residence. In addition to the actions available under this section, the payor
14 or other third party may take any action authorized by law or the governing instrument. If probate proceedings
15 have not been commenced, the payor or other third party shall file with the court a copy of the written notice
16 received by the payor or other third party, with the payment of funds or transfer or deposit of property. The court
17 may not charge a filing fee to the payor or other third party for the payment to the court of amounts owed or
18 transferred to or deposited with the court or any item of property. The court shall hold the funds or item of property
19 and, upon its determination under this section, shall order disbursement in accordance with the determination.
20 A filing fee, if any, may be charged upon disbursement either to the recipient or against the funds or property on
21 deposit with the court, in the discretion of the court. Payments, transfers, or deposits made to or with the court
22 discharge the payor or other third party from all claims for the value of amounts paid to or items of property
23 transferred to or deposited with the court.

24 (9) (a) A bona fide purchaser who purchases property or who receives a payment or other item of
25 property in partial or full satisfaction of a legally enforceable obligation is neither obligated under this section to
26 return the payment, item of property, or benefit nor liable under this section for the amount of the payment or the
27 value of the item of property or benefit. However, a person who, not for value, receives a payment, item of
28 property, or other benefit to which the person is not entitled under this section is obligated to return the payment,
29 item of property, or benefit, or is personally liable for the amount of the payment or the value of the item of
30 property or benefit, to the person who is entitled to it under this section.

1 (b) If this section or any part of this section is preempted by federal law, ~~other than the federal Employee~~
 2 ~~Retirement Income Security Act of 1974, as amended,~~ with respect to a payment, an item of property, or any
 3 other benefit covered by this section, a person who, not for value, receives the payment, item of property, or other
 4 benefit to which the person is not entitled under this section is obligated to return the payment, item of property,
 5 or benefit, or is personally liable for the amount of the payment or the value of the item of property or benefit, to
 6 the person who would have been entitled to it were this section or part of this section not preempted.

7 (10) For the purposes of this section, a felonious and intentional killing includes a deliberate homicide
 8 as defined in 45-5-102 and a mitigated deliberate homicide as defined in 45-5-103."
 9

10 **Section 44.** Section 72-2-814, MCA, is amended to read:

11 **"72-2-814. Revocation of probate and nonprobate transfers by divorce -- no revocation by other**
 12 **changes of circumstances.** (1) As used in this section, the following definitions apply:

13 (a) "Disposition or appointment of property" includes a transfer of an item of property or any other benefit
 14 to a beneficiary designated in a governing instrument.

15 (b) "Divorce or annulment" means any divorce, annulment, or dissolution or declaration of invalidity of
 16 a marriage that would exclude the spouse as a surviving spouse within the meaning of 72-2-812. A decree of
 17 separation that does not terminate the status of husband and wife is not a divorce for purposes of this section.

18 (c) "Divorced individual" includes an individual whose marriage has been annulled.

19 (d) "Governing instrument" means a governing instrument executed by the divorced individual before
 20 the divorce or annulment of the individual's marriage to the individual's former spouse.

21 (e) "Relative of the divorced individual's former spouse" means an individual who is related to the
 22 divorced individual's former spouse by blood, adoption, or affinity and who, after the divorce or annulment, is not
 23 related to the divorced individual by blood, adoption, or affinity.

24 (f) "Revocable", with respect to a disposition, appointment, provision, or nomination, means one under
 25 which the divorced individual, at the time of the divorce or annulment, was alone empowered, by law or under
 26 the governing instrument, to cancel the designation in favor of the individual's former spouse or former spouse's
 27 relative, whether or not the divorced individual was then empowered to designate the divorced individual in place
 28 of the individual's former spouse or in place of the former spouse's relative and whether or not the divorced
 29 individual then had the capacity to exercise the power.

30 (2) Except as to a retirement system established in Title 19 or as provided by the express terms of a

1 governing instrument, a court order, or a contract relating to the division of the marital estate made between the
2 divorced individuals before or after the marriage, divorce, or annulment, the divorce or annulment of a marriage:

3 (a) revokes any revocable:

4 (i) disposition or appointment of property made by a divorced individual to the individual's former spouse
5 in a governing instrument and any disposition or appointment created by law or in a governing instrument to a
6 relative of the divorced individual's former spouse;

7 (ii) provision in a governing instrument conferring a general or nongeneral power of appointment on the
8 divorced individual's former spouse or on a relative of the divorced individual's former spouse; and

9 (iii) nomination in a governing instrument that nominates a divorced individual's former spouse or a
10 relative of the divorced individual's former spouse to serve in any fiduciary or representative capacity, including
11 a personal representative, executor, trustee, conservator, agent, or guardian; and

12 (b) severs the interests of the former spouses in property held by them at the time of the divorce or
13 annulment as joint tenants with the right of survivorship and transforms the interests of the former spouses into
14 tenancies in common.

15 (3) A severance under subsection (2)(b) does not affect any third-party interest in property acquired for
16 value and in good faith reliance on an apparent title by survivorship in the survivor of the former spouses unless
17 a writing declaring the severance has been noted, registered, filed, or recorded in records appropriate to the kind
18 and location of the property, which records are relied upon, in the ordinary course of transactions involving such
19 property, as evidence of ownership.

20 (4) Provisions of a governing instrument are given effect as if the former spouse and relatives of the
21 former spouse disclaimed all provisions revoked by this section or, in the case of a revoked nomination in a
22 fiduciary or representative capacity, as if the former spouse and relatives of the former spouse died immediately
23 before the divorce or annulment.

24 (5) Provisions revoked solely by this section are revived by the divorced individual's remarriage to the
25 former spouse or by a nullification of the divorce or annulment.

26 (6) No change of circumstances other than as described in this section and in 72-2-813 effects a
27 revocation.

28 (7) (a) A payor or other third party is not liable for having made a payment or transferred an item of
29 property or any other benefit to a beneficiary designated in a governing instrument affected by a divorce,
30 annulment, or remarriage, or for having taken any other action in good faith reliance on the validity of the

1 governing instrument, before the payor or other third party received written notice of the divorce, annulment, or
2 remarriage. A payor or other third party does not have a duty or obligation to inquire as to the continued marital
3 relationship between the decedent and a beneficiary or to seek any evidence with respect to a marital
4 relationship. A payor or other third party is only liable for actions taken 2 or more business days after the actual
5 receipt by the payor or other third party of written notice. The payor or other third party may be liable for actions
6 taken pursuant to the governing instrument only if the form of service is that described in subsection (7)(b).

7 (b) The written notice must indicate the name of the decedent, the name of the person asserting an
8 interest, the nature of the payment or item of property or other benefit, and a statement that a dissolution,
9 annulment, or remarriage of the decedent and the designated beneficiary occurred. Written notice of the divorce,
10 annulment, or remarriage under subsection (7)(a) must be mailed to the payor's or other third party's main office
11 or home by registered or certified mail, return receipt requested, or served upon the payor or other third party in
12 the same manner as a summons in a civil action. Upon receipt of written notice of the divorce, annulment, or
13 remarriage, a payor or other third party may pay any amount owed or transfer or deposit any item of property held
14 by it to or with the court having jurisdiction of the probate proceedings relating to the decedent's estate or, if no
15 proceedings have been commenced, to or with the court having jurisdiction of probate proceedings relating to
16 decedents' estates located in the county of the decedent's residence. In addition to the actions available under
17 this section, the payor or other third party may take any action authorized by law or the governing instrument. If
18 probate proceedings have not been commenced, the payor or other third party shall file with the court a copy of
19 the written notice received by the payor or other third party, with the payment of funds or transfer or deposit of
20 property. The court may not charge a filing fee to the payor or other third party for the payment to the court of
21 amounts owed or transferred to or deposited with the court or any item of property. The court shall hold the funds
22 or item of property and, upon its determination under this section, shall order disbursement or transfer in
23 accordance with the determination. A filing fee, if any, may, in the discretion of the court, be charged upon
24 disbursement either to the recipient or against the funds or property on deposit with the court. Payments,
25 transfers, or deposits made to or with the court discharge the payor or other third party from all claims for the
26 value of amounts paid to or items of property transferred to or deposited with the court.

27 (8) (a) A bona fide purchaser who purchases property from a former spouse, relative of a former spouse,
28 or any other person or who receives from a former spouse, relative of a former spouse, or any other person for
29 value and without notice a payment or other item of property in partial or full satisfaction of a legally enforceable
30 obligation is neither obligated under this section to return the payment, item of property, or benefit nor liable under

1 this section for the amount of the payment or the value of the item of property or benefit. However, a former
 2 spouse, relative of a former spouse, or other person who, not for value, received a payment, item of property, or
 3 other benefit to which that person is not entitled under this section is obligated to return the payment, item of
 4 property, or benefit, or is personally liable for the amount of the payment or the value of the item of property or
 5 benefit, to the person who is entitled to it under this section.

6 (b) If this section or any part of this section is preempted by federal law, ~~other than the federal Employee~~
 7 ~~Retirement Income Security Act of 1974, as amended~~, with respect to a payment, an item of property, or any
 8 other benefit covered by this section, a former spouse, relative of the former spouse, or any other person who,
 9 not for value, received a payment, item of property, or other benefit to which that person is not entitled under this
 10 section is obligated to return that payment, item of property, or benefit, or is personally liable for the amount of
 11 the payment or the value of the item of property or benefit, to the person who would have been entitled to it were
 12 this section or part of this section not preempted.

13 (9) The provisions of this section apply to testate and intestate estates, and in the event of a conflict
 14 between the provisions of this section and those provided in chapters 1 through 5 and chapter 16, part 6, of this
 15 title, the provisions of this section control. This subsection does not apply if a divorced individual designates a
 16 former spouse as personal representative of the estate subsequent to the divorce."
 17

18 NEW SECTION. **Section 45. Reformation to correct mistakes.** The court may reform the terms of
 19 a governing instrument, even if unambiguous, to conform the terms to the transferor's intention if it is proved by
 20 clear and convincing evidence what the transferor's intention was and that the terms of the governing instrument
 21 were affected by a mistake of fact or law, whether in expression or inducement.
 22

23 NEW SECTION. **Section 46. Modification to achieve transferor's tax objectives.** To achieve the
 24 transferor's tax objectives, the court may modify the terms of a governing instrument in a manner that is not
 25 contrary to the transferor's probable intention. The court may provide that the modification has retroactive effect.
 26

27 NEW SECTION. **Section 47. Short title.** [Sections 47 through 63] may be cited as the "Uniform
 28 Disclaimer of Property Interests Act".
 29

30 NEW SECTION. **Section 48. Definitions.** As used in [sections 47 through 63] the following definitions

1 apply:

2 (1) "Disclaimant" means the person to whom a disclaimed interest or power would have passed had the
3 disclaimer not been made.

4 (2) "Disclaimed interest" means the interest that would have passed to the disclaimant had the disclaimer
5 not been made.

6 (3) "Disclaimer" means the refusal to accept an interest in or power over property.

7 (4) "Fiduciary" means a personal representative, trustee, agent acting under a power of attorney, or other
8 person authorized to act as a fiduciary with respect to the property of another person.

9 (5) "Jointly held property" means property held in the name of two or more persons under an arrangement
10 in which all holders have concurrent interests and under which the last surviving holder is entitled to the whole
11 of the property.

12 (6) "Person" means an individual, corporation, business trust, estate, trust, partnership, limited liability
13 company, association, joint venture, government; governmental subdivision, agency, or instrumentality; public
14 corporation, or any other legal or commercial entity.

15 (7) "State" means a state of the United States, the District of Columbia, Puerto Rico, the United States
16 Virgin Islands, or any territory or insular possession subject to the jurisdiction of the United States. The term
17 includes an Indian tribe or band, or Alaskan native village, recognized by federal law or formally acknowledged
18 by a state.

19 (8) "Trust" means:

20 (a) an express trust, charitable or noncharitable, with additions thereto, whenever and however created;
21 and

22 (b) a trust created pursuant to a statute, judgment, or decree which requires the trust to be administered
23 in the manner of an express trust.

24
25 **NEW SECTION. Section 49. Scope.** [Sections 47 through 63] applies to disclaimers of any interest in
26 or power over property, whenever created.

27
28 **NEW SECTION. Section 50. [Sections 47 through 63] supplemented by other law.** (1) Unless
29 displaced by a provision of [sections 47 through 63], the principles of law and equity supplement [sections 47
30 through 63].

1 (2) [Sections 47 through 63] do not limit any right of a person to waive, release, disclaim, or renounce
 2 an interest in or power over property under a law other than [sections 47 through 63].

3
 4 **NEW SECTION. Section 51. Power to disclaim -- general requirements -- when revocable.** (1) A
 5 person may disclaim, in whole or part, any interest in or power over property, including a power of appointment.
 6 A person may disclaim the interest or power even if its creator imposed a spendthrift provision or similar
 7 restriction on transfer or a restriction or limitation on the right to disclaim.

8 (2) Except to the extent a fiduciary's right to disclaim is expressly restricted or limited by another statute
 9 of this state or by the instrument creating the fiduciary relationship, a fiduciary may disclaim, in whole or part, any
 10 interest in or power over property, including a power of appointment, whether acting in a personal or
 11 representative capacity. A fiduciary may disclaim the interest or power even if its creator imposed a spendthrift
 12 provision or similar restriction on transfer or a restriction or limitation on the right to disclaim or an instrument other
 13 than the instrument that created the fiduciary relationship imposed a restriction or limitation on the right to
 14 disclaim.

15 (3) To be effective, a disclaimer must be in a writing or other record, declare the disclaimer, describe the
 16 interest or power disclaimed, be signed by the person making the disclaimer, and be delivered or filed in the
 17 manner provided in [section 58]. In this subsection:

18 (a) "record" means information that is inscribed on a tangible medium or that is stored in an electronic
 19 or other medium and is retrievable in perceivable form; and

20 (b) "signed" means, with present intent to authenticate or adopt a record, to:

21 (i) execute or adopt a tangible symbol; or

22 (ii) attach to or logically associate with the record an electronic sound, symbol, or process.

23 (4) A partial disclaimer may be expressed as a fraction, percentage, monetary amount, term of years,
 24 limitation of a power, or any other interest or estate in the property.

25 (5) A disclaimer becomes irrevocable when it is delivered or filed pursuant to [section 58] or when it
 26 becomes effective as provided in [sections 52 through 57], whichever occurs later.

27 (6) A disclaimer made under [sections 47 through 63] is not a transfer, assignment, or release.

28

29 **NEW SECTION. Section 52. Disclaimer of interest in property.** (1) In this section:

30 (a) "Future interest" means an interest that takes effect in possession or enjoyment, if at all, later than

1 the time of its creation.

2 (b) "Time of distribution" means the time when a disclaimed interest would have taken effect in
3 possession or enjoyment.

4 (2) Except for a disclaimer governed by [section 53 or 54], the following rules apply to a disclaimer of an
5 interest in property:

6 (a) The disclaimer takes effect as of the time the instrument creating the interest becomes irrevocable,
7 or, if the interest arose under the law of intestate succession, as of the time of the intestate's death.

8 (b) The disclaimed interest passes according to any provision in the instrument creating the interest
9 providing for the disposition of the interest, should it be disclaimed, or of disclaimed interests in general.

10 (c) If the instrument does not contain a provision described in subsection (2)(b), the following rules apply:

11 (i) If the disclaimant is not an individual, the disclaimed interest passes as if the disclaimant did not exist.

12 (ii) If the disclaimant is an individual, except as otherwise provided in subsections (2)(c)(iii) and (2)(c)(iv),
13 the disclaimed interest passes as if the disclaimant had died immediately before the time of distribution.

14 (iii) If by law or under the instrument, the descendants of the disclaimant would share in the disclaimed
15 interest by any method of representation had the disclaimant died before the time of distribution, the disclaimed
16 interest passes only to the descendants of the disclaimant who survive the time of distribution.

17 (iv) If the disclaimed interest would pass to the disclaimant's estate had the disclaimant died before the
18 time of distribution, the disclaimed interest instead passes by representation to the descendants of the disclaimant
19 who survive the time of distribution. If no descendant of the disclaimant survives the time of distribution, the
20 disclaimed interest passes to those persons, including the state but excluding the disclaimant, and in such shares
21 as would succeed to the transferor's intestate estate under the intestate succession law of the transferor's
22 domicile had the transferor died at the time of distribution. However, if the transferor's surviving spouse is living
23 but is remarried at the time of distribution, the transferor is deemed to have died unmarried at the time of
24 distribution.

25 (d) Upon the disclaimer of a preceding interest, a future interest held by a person other than the
26 disclaimant takes effect as if the disclaimant had died or ceased to exist immediately before the time of
27 distribution, but a future interest held by the disclaimant is not accelerated in possession or enjoyment.

28

29 **NEW SECTION. Section 53. Disclaimer of rights of survivorship in jointly held property.** (1) Upon
30 the death of a holder of jointly held property, a surviving holder may disclaim, in whole or part, the greater of:

1 (a) a fractional share of the property determined by dividing the number one by the number of joint
2 holders alive immediately before the death of the holder to whose death the disclaimer relates; or

3 (b) all of the property except that part of the value of the entire interest attributable to the contribution
4 furnished by the disclaimant.

5 (2) A disclaimer under subsection (1) takes effect as of the death of the holder of jointly held property to
6 whose death the disclaimer relates.

7 (3) An interest in jointly held property disclaimed by a surviving holder of the property passes as if the
8 disclaimant predeceased the holder to whose death the disclaimer relates.

9

10 **NEW SECTION. Section 54. Disclaimer of interest by trustee.** If a trustee disclaims an interest in
11 property that otherwise would have become trust property, the interest does not become trust property.

12

13 **NEW SECTION. Section 55. Disclaimer of power of appointment or other power not held in**
14 **fiduciary capacity.** If a holder disclaims a power of appointment or other power not held in a fiduciary capacity,
15 the following rules apply:

16 (1) If the holder has not exercised the power, the disclaimer takes effect as of the time the instrument
17 creating the power becomes irrevocable.

18 (2) If the holder has exercised the power and the disclaimer is of a power other than a presently
19 exercisable general power of appointment, the disclaimer takes effect immediately after the last exercise of the
20 power.

21 (3) The instrument creating the power is construed as if the power expired when the disclaimer became
22 effective.

23

24 **NEW SECTION. Section 56. Disclaimer by appointee, object, or taker in default of exercise of**
25 **power of appointment.** (1) A disclaimer of an interest in property by an appointee of a power of appointment
26 takes effect as of the time the instrument by which the holder exercises the power becomes irrevocable.

27 (2) A disclaimer of an interest in property by an object or taker in default of an exercise of a power of
28 appointment takes effect as of the time the instrument creating the power becomes irrevocable.

29

30 **NEW SECTION. Section 57. Disclaimer of power held in fiduciary capacity.** (1) If a fiduciary disclaims

1 a power held in a fiduciary capacity which has not been exercised, the disclaimer takes effect as of the time the
2 instrument creating the power becomes irrevocable.

3 (2) If a fiduciary disclaims a power held in a fiduciary capacity which has been exercised, the disclaimer
4 takes effect immediately after the last exercise of the power.

5 (3) A disclaimer under this section is effective as to another fiduciary if the disclaimer so provides and
6 the fiduciary disclaiming has the authority to bind the estate, trust, or other person for whom the fiduciary is acting.

7
8 **NEW SECTION. Section 58. Delivery or filing.** (1) In this section, "beneficiary designation" means an
9 instrument, other than an instrument creating a trust, naming the beneficiary of:

10 (a) an annuity or insurance policy;

11 (b) an account with a designation for payment on death;

12 (c) a security registered in beneficiary form;

13 (d) a pension, profit-sharing, retirement, or other employment-related benefit plan; or

14 (e) any other nonprobate transfer at death.

15 (2) Subject to subsections (3) through (12), delivery of a disclaimer may be effected by personal delivery,
16 first-class mail, or any other method likely to result in its receipt.

17 (3) In the case of an interest created under the law of intestate succession or an interest created by will,
18 other than an interest in a testamentary trust:

19 (a) a disclaimer must be delivered to the personal representative of the decedent's estate; or

20 (b) if no personal representative is then serving, it must be filed with a court having jurisdiction to appoint
21 the personal representative.

22 (4) In the case of an interest in a testamentary trust:

23 (a) a disclaimer must be delivered to the trustee then serving, or if no trustee is then serving, to the
24 personal representative of the decedent's estate; or

25 (b) if no personal representative is then serving, it must be filed with a court having jurisdiction to enforce
26 the trust.

27 (5) In the case of an interest in an inter vivos trust:

28 (a) a disclaimer must be delivered to the trustee then serving;

29 (b) if no trustee is then serving, it must be filed with a court having jurisdiction to enforce the trust; or

30 (c) if the disclaimer is made before the time the instrument creating the trust becomes irrevocable, it must

1 be delivered to the settlor of a revocable trust or the transferor of the interest.

2 (6) In the case of an interest created by a beneficiary designation which is disclaimed before the
3 designation becomes irrevocable, the disclaimer must be delivered to the person making the beneficiary
4 designation.

5 (7) In the case of an interest created by a beneficiary designation which is disclaimed after the
6 designation becomes irrevocable:

7 (a) the disclaimer of an interest in personal property must be delivered to the person obligated to
8 distribute the interest; and

9 (b) the disclaimer of an interest in real property must be recorded in the office of the county recorder of
10 the county where the real property that is the subject of the disclaimer is located.

11 (8) In the case of a disclaimer by a surviving holder of jointly held property, the disclaimer must be
12 delivered to the person to whom the disclaimed interest passes.

13 (9) In the case of a disclaimer by an object or taker in default of exercise of a power of appointment at
14 any time after the power was created:

15 (a) the disclaimer must be delivered to the holder of the power or to the fiduciary acting under the
16 instrument that created the power; or

17 (b) if no fiduciary is then serving, it must be filed with a court having authority to appoint the fiduciary.

18 (10) In the case of a disclaimer by an appointee of a nonfiduciary power of appointment:

19 (a) the disclaimer must be delivered to the holder, the personal representative of the holder's estate or
20 to the fiduciary under the instrument that created the power; or

21 (b) if no fiduciary is then serving, it must be filed with a court having authority to appoint the fiduciary.

22 (11) In the case of a disclaimer by a fiduciary of a power over a trust or estate, the disclaimer must be
23 delivered as provided in subsection (3), (4), or (5), as if the power disclaimed were an interest in property.

24 (12) In the case of a disclaimer of a power by an agent, the disclaimer must be delivered to the principal
25 or the principal's representative.

26
27 **NEW SECTION. Section 59. When disclaimer barred or limited.** (1) A disclaimer is barred by a
28 written waiver of the right to disclaim.

29 (2) A disclaimer of an interest in property is barred if any of the following events occur before the
30 disclaimer becomes effective:

1 (a) the disclaimant accepts the interest sought to be disclaimed;

2 (b) the disclaimant voluntarily assigns, conveys, encumbers, pledges, or transfers the interest sought to
3 be disclaimed or contracts to do so; or

4 (c) a judicial sale of the interest sought to be disclaimed occurs.

5 (3) A disclaimer, in whole or part, of the future exercise of a power held in a fiduciary capacity is not
6 barred by its previous exercise.

7 (4) A disclaimer, in whole or part, of the future exercise of a power not held in a fiduciary capacity is not
8 barred by its previous exercise unless the power is exercisable in favor of the disclaimant.

9 (5) A disclaimer is barred or limited if so provided by law other than [sections 47 through 63].

10 (6) A disclaimer of a power over property which is barred by this section is ineffective. A disclaimer of
11 an interest in property which is barred by this section takes effect as a transfer of the interest disclaimed to the
12 persons who would have taken the interest under [sections 47 through 63] had the disclaimer not been barred.

13
14 **NEW SECTION. Section 60. Tax qualified disclaimer.** Notwithstanding any other provision of [sections
15 47 through 63], if as a result of a disclaimer or transfer the disclaimed or transferred interest is treated pursuant

 11 provided by comparable provisions of the laws relating to commercial transactions and laws simplifying transfers
 12 of securities by fiduciaries."

 2 renounce the right to all or any part of the compensation. A written renunciation of fee may be filed with the court."

9 liabilities under this section abate as necessary to satisfy the liability, as if all of the trust instruments were a single
10 will and the interests were devised under it.

11 (5) A provision made in one instrument may direct the apportionment of the liability among the nonprobate
12 transferees taking under that or any other governing instrument. If a provision in one instrument conflicts with
13 a provision in another, the later one prevails.

14 (6) Upon due notice to a nonprobate transferee, the liability imposed by this section is enforceable in
15 proceedings in this state, whether or not the transferee is located in this state.

16 (7) A proceeding under this section may not be commenced unless the personal representative of the
17 decedent's estate has received a written demand for the proceeding from the surviving spouse or a child, to the
18 extent that statutory allowances are affected, or a creditor. If the personal representative declines or fails to
19 commence a proceeding after demand, a person making demand may commence the proceeding in the name
20 of the decedent's estate, at the expense of the person making the demand and not of the estate. A personal
21 representative who declines in good faith to commence a requested proceeding incurs no personal liability for
22 declining.

23 (8) A proceeding under this section must be commenced within 1 year after the decedent's death, but
24 a proceeding on behalf of a creditor whose claim was allowed after proceedings challenging disallowance of the
25 claim may be commenced within 60 days after final allowance of the claim.

4 received becomes liable for the amount of the trustee's liability attributable to assets received by the beneficiary.

7 **"72-6-213. Alteration of rights.** (1) Rights at death under 72-6-212 are determined by the terms of the
8 account at the death of a party.

9 NEW SECTION. Section 95. Applicability. [Sections 93 through 110] applies to a transfer on death
10 deed made before, on, or after [the effective date of this act] by a transferor dying on or after [the effective date
11 of this act].

12

13 NEW SECTION. Section 96. Nonexclusivity. [Section 93 through 110] does not affect any method of
14 transferring property otherwise permitted under the law of this state.

15

16 NEW SECTION. Section 97. Transfer on death deed authorized. An individual may transfer property
17 to one or more beneficiaries effective at the transferor's death by a transfer on death deed.

18

19 NEW SECTION. Section 98. Transfer on death deed revocable. A transfer on death deed is
20 revocable even if the deed or another instrument contains a contrary provision.

22 NEW SECTION. Section 99. Transfer on death deed nontestamentary. A transfer on death deed
23 is nontestamentary.

25 NEW SECTION. Section 100. Capacity of transferor. The capacity required to make or revoke a
26 transfer on death deed is the same as the capacity required to make a will.

28 NEW SECTION. Section 101. Requirements. A transfer on death deed:

29 (1) except as otherwise provided in subsection (2), must contain the essential elements and formalities
30 of a properly recordable inter vivos deed;

- 23 (3) After a transfer on death deed is recorded, it may not be revoked by a revocatory act on the deed.
- 24 (4) This section does not limit the effect of an inter vivos transfer of the property, which revokes any prior
 25 transfer on death deed to the property.

 27 **NEW SECTION. Section 104. Effect of transfer on death deed during transferor's life.** During a
 28 transferor's life, a transfer on death deed does not:

- 29 (1) affect an interest or right of the transferor or any other owner, including the right to transfer or
 30 encumber the property;

- 1 (2) affect an interest or right of a transferee, even if the transferee has actual or constructive notice of the
2 deed;
- 3 (3) affect an interest or right of a secured or unsecured creditor or future creditor of the transferor, even
4 if the creditor has actual or constructive notice of the deed;
- 5 (4) affect the transferor's or designated beneficiary's eligibility for any form of public assistance;
- 6 (5) create a legal or equitable interest in favor of the designated beneficiary; or
- 7 (6) subject the property to claims or process of a creditor of the designated beneficiary.

9 **NEW SECTION. Section 105. Effect of transfer on death deed at transferor's death.** (1) Except as
10 otherwise provided in the transfer on death deed, in [section 91], or in this section, and subject to chapter 2, part
11 2, of this title, on the death of the transferor, the following rules apply to property that is the subject of a transfer
12 on death deed and owned by the transferor at death:

13 (a) Subject to subsection (1)(b), the interest in the property is transferred to the designated beneficiary
14 in accordance with the deed.

15 (b) The interest of a designated beneficiary is contingent on the designated beneficiary surviving the
16 transferor. The interest of a designated beneficiary that fails to survive the transferor lapses.

17 (c) Subject to subsection (1)(d), concurrent interests are transferred to the beneficiaries in equal and
18 undivided shares with no right of survivorship.

19 (d) If the transferor has identified two or more designated beneficiaries to receive concurrent interests
20 in the property, the share of one which lapses or fails for any reason is transferred to the other, or to the others
21 in proportion to the interest of each in the remaining part of the property held concurrently.

22 (2) Subject to Title 70, chapter 21, a beneficiary takes the property subject to all conveyances,
23 encumbrances, assignments, contracts, mortgages, liens, and other interests to which the property is subject at
24 the transferor's death. For purposes of this subsection and Title 70, chapter 21, the recording of the transfer on
25 death deed is deemed to have occurred at the transferor's death.

26 (3) If a transferor is a joint owner and is:

27 (a) survived by one or more other joint owners, the property that is the subject of a transfer on death deed
28 belongs to the surviving joint owner or owners with right of survivorship; or

29 (b) the last surviving joint owner, the transfer on death deed is effective.

30 (4) A transfer on death deed transfers property without covenant or warranty of title even if the deed

1 contains a contrary provision.

3 NEW SECTION. **Section 106. Disclaimer.** A beneficiary may disclaim all or part of the beneficiary's
4 interest as provided by [sections 47 through 63], the Uniform Disclaimer of Property Interests Act.

5

6 NEW SECTION. **Section 107. Liability for creditor claims and statutory allowances.** A beneficiary
7 of a transfer on death deed is liable for an allowed claim against the transferor's probate estate and statutory
8 allowances to a surviving spouse and children to the extent provided in [section 91].

9

10 NEW SECTION. **Section 108. Optional form of transfer on death deed.** The following form may be
11 used to create a transfer on death deed. The other sections of [sections 93 through 110] govern the effect of this
12 or any other instrument used to create a transfer on death deed:

18 COMMON QUESTIONS ABOUT THE USE OF THIS FORM

19 What does the Transfer on Death (TOD) deed do? When you die, this deed transfers the described property,
20 subject to any liens or mortgages (or other encumbrances) on the property at your death. Probate is not required.

21 The TOD deed has no effect until you die. You can revoke it at any time. You are also free to transfer the
22 property to someone else during your lifetime. If you do not own any interest in the property when you die, this
23 deed will have no effect.

24 How do I make a TOD deed? Complete this form. Have it acknowledged before a notary public or other individual
25 authorized by law to take acknowledgments. Record the form in each county where any part of the property is
26 located. The form has no effect unless it is acknowledged and recorded before your death.

27 Is the "legal description" of the property necessary? Yes.

28 How do I find the "legal description" of the property? This information may be on the deed you received when you
29 became an owner of the property. This information may also be available in the office of the county clerk and
30 recorder for the county where the property is located. If you are not absolutely sure, consult a lawyer.



1 Can I change my mind before I record the TOD deed? Yes. If you have not yet recorded the deed and want to
2 change your mind, simply tear up or otherwise destroy the deed.

3 How do I "record" the TOD deed? Take the completed and acknowledged form to the office of the county clerk
4 and recorder of the county where the property is located. Follow the instructions given by the county clerk and
5 recorder to make the form part of the official property records. If the property is in more than one county, you
6 should record the deed in each county.

7 Can I later revoke the TOD deed if I change my mind? Yes. You can revoke the TOD deed. No one, including
8 the beneficiaries, can prevent you from revoking the deed.

9 How do I revoke the TOD deed after it is recorded? There are three ways to revoke a recorded TOD deed:

10 (1) Complete and acknowledge a revocation form, and record it in each county where the property is

18 Do I need to tell the beneficiaries about the TOD deed? No, but it is recommended. Secrecy can cause later
19 complications and might make it easier for others to commit fraud.
