A BILL FOR AN ACT ENTITLED: "AN ACT IMPLEMENTING THE AMERICAN RESCUE PLAN ACT;
PROVIDING APPROPRIATIONS OF FEDERAL FUNDS AND OTHER FUNDS AVAILABLE BECAUSE OF
THE RECEIPT OF FEDERAL FUNDS FOR THE FISCAL YEAR ENDING JUNE 30, 2021; ALLOWING
APPROPRIATIONS TO CONTINUE INTO THE 2023 BIENNIAL AND 2025 BIENNIUMS; PROVIDING
CONDITIONS AND RESTRICTIONS ON THE USE OF FUNDS; CREATING ADVISORY COMMISSIONS
RELATED TO INFRASTRUCTURE, COMMUNICATIONS, ECONOMIC TRANSFORMATION AND
STABILIZATION, AND HEALTH; PROVIDING DEADLINES AND OTHER CONDITIONS RELATED TO THE
GRANT PROCESS; REQUIRING THE USE OF MATCHING FUNDS FOR CERTAIN GRANTS; PROVIDING
FOR AN OUTREACH TEAM TO ASSIST LOCAL GOVERNMENTS IN THE GRANT PROCESS; PROVIDING
FOR FUNDING FOR STATE CAPITAL PROJECTS AND GRANTS FOR WATER AND WASTEWATER
PROJECTS; PROVIDING MINIMUM ALLOCATION GRANTS TO LOCAL GOVERNMENTS FOR
QUALIFYING PROJECTS; PROVIDING FOR A GRANT PROCESS FOR COMMUNICATIONS AND
ECONOMIC TRANSFORMATION AND STABILIZATION PROJECTS; PROVIDING GRANTS TO REGIONAL
WATER AUTHORITIES; REQUIRING PERFORMANCE MEASURES AND REPORTING ON PROJECTS;
PROVIDING COORDINATION INSTRUCTIONS TO FUND QUALIFYING LONG-RANGE PROJECTS WITH
FEDERAL FUNDS; PROVIDING THE EXECUTIVE THE AUTHORITY TO MODIFY AND REPORT
MODIFICATIONS TO APPROPRIATIONS AND PARAMETERS OF PROGRAMS TO THE LEGISLATIVE
FINANCE COMMITTEE; PROVIDING FOR A REDUCTION TO GRANT AWARDS TO LOCAL
GOVERNMENTS BASED ON HEALTH REGULATIONS THAT ARE MORE STRICT THAN THOSE OF THE
STATE; AMENDING SECTION 2-17-603, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

2 **NEW SECTION. Section 1. Infrastructure advisory commission.** (1) There is an American Rescue

3 Plan infrastructure advisory commission.

4 (2) The commission consists of nine members, who must be appointed as follows:

5 (a) three senators, two from the majority party and one from the minority party, appointed by the senate
6 president;

7 (b) three representatives, two from the majority party and one from the minority party, appointed by the
8 speaker of the house; and

9 (c) three members appointed by the governor.

10 (3) The commission shall review applications for funding for state capital projects and state and local
11 government water and wastewater projects and shall provide recommendations to the executive on which
12 projects should be funded. Projects approved by the 67th legislature for funding in House Bill No. 5, 6, 7, 11, or
13 14 are not submitted to the commission.

14 (4) Appointed members of the commission must be compensated and receive travel expenses as
15 provided for in 2-15-124 for each day in attendance at commission meetings or in the performance of any duty
16 or service as a commission member.

17

18 **NEW SECTION. Section 2. Appropriations for capital projects and water and wastewater**

19 **projects -- matching funds.** (1) There are federal funds received pursuant to the American Rescue Plan Act of
20 2021, Public Law 117-2, appropriated to the office of budget and program planning for state infrastructure
21 projects and local infrastructure grants as follows:

25 (2) For any water or wastewater grant awarded to a local government with these funds, a local
26 government must provide matching funds.

27 (3) For the purposes of [this act], "local government" means ~~any tribe, city, town, county, consolidated~~
28 ~~city-county, or school district~~ a city, county, or other political subdivision or local government body of the state,

1 including an authority as defined in 75-6-304, or a tribal government.

2 (4) For the purposes of [this act], " state infrastructure projects" includes projects for state-owned
3 buildings and facilities as well as within the Montana university system, including community colleges in the
4 state.

5 (5) References to "ARPA Section" mean references to section 9901 of the American Rescue Plan Act
6 of 2021, Public Law 117-2, which amends Title VI of the Social Security Act to include section 602 or section
7 604.

8
9 **NEW SECTION. Section 3. Eligibility -- submission deadline -- priority -- approval of**
10 **recommendations.** (1) State and local governments shall submit grant requests and supporting materials,
11 including the amount of matching funds available, to the applicable agency by July 1, 2021, in order to be
12 eligible for funding under [section 2]. The agency will review grant applications, rank projects, and issue a list of
13 recommended projects to the advisory commission by August 15, 2021.

14 (2) The applicable agency shall submit a list of recommended state capital projects to the advisory
15 commission by August 15, 2021.

16 (3) The advisory commission shall review the lists of recommended projects and issue a final list of
17 recommended projects to the executive by September 1, 2021.

18 (4) In preparing recommendations, for capital projects, preference must be given to projects that carry
19 out critical capital projects directly enabling work, education, and health monitoring, including remote options, in
20 response to the public health emergency with respect to COVID-19. For local government grants, preference
21 may also be given to projects that provide a higher match rate.

22 (5) The recommendations of the advisory commission must be considered by the governor and
23 reviewed to comply with the American Rescue Plan Act and all applicable guidance. The governor may modify
24 recommendations and shall provide the final list of approved projects to the legislative finance committee by
25 October 15, 2021. If it is later determined that a project cannot be completed, the governor may authorize
26 another project and provide a report to the legislative finance committee. If it is determined at any time that a
27 project is identified not to be eligible based on federal guidance or regulation and, if completed, would result in
28 a reduction in funds from the American Rescue Plan Act or require the state to repay or refund money to the

1 federal government pursuant to the American Rescue Plan Act, the governor may authorize another project and
2 provide a report to the legislative finance committee.

3
4 NEW SECTION. SECTION 4. MINIMUM ALLOCATION GRANTS TO LOCAL GOVERNMENTS. (1) THE AMOUNT OF
5 \$150 MILLION OF THE CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS APPROPRIATED IN [SECTION 2] MUST BE USED TO
6 PROVIDE MINIMUM ALLOCATION GRANTS TO LOCAL GOVERNMENTS FOR INFRASTRUCTURE PROJECTS.

7 (2) THE AMOUNT A LOCAL GOVERNMENT IS ELIGIBLE TO RECEIVE IN GRANTS UNDER THIS SECTION IS IN THE
8 SAME PROPORTION AND USING THE SAME RATIOS PROVIDED FOR IN 15-70-101(2)(B), (2)(C), AND (3).

9 (3) (A) TO RECEIVE A GRANT UNDER THIS SECTION, A LOCAL GOVERNMENT SHALL SUBMIT AN APPLICATION FOR
10 A QUALIFYING INFRASTRUCTURE PROJECT AND PLEDGE MATCHING FUNDS.

11 (B) A QUALIFYING PROJECT IS A PROJECT THAT COMPLIES WITH THE USES AUTHORIZED FOR THE CORONAVIRUS
12 STATE FISCAL RECOVERY FUNDS.

13 (C) THE LOCAL GOVERNMENT SHALL PLEDGE THE GREATER OF:

14 (I) ONE-TO-ONE MATCHING FUNDS; OR

15 (II) 25% OF THE AMOUNT THAT THE LOCAL GOVERNMENT RECEIVED IN CORONAVIRUS LOCAL FISCAL RECOVERY
16 FUNDS PROVIDED FOR IN THE AMERICAN RESCUE PLAN ACT.

17 (D) A LOCAL GOVERNMENT MAY USE CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS AS MATCHING FUNDS.

18 (4) GRANT FUNDS NOT CLAIMED BY JANUARY 1, 2023, ARE TRANSFERRED TO THE COMPETITIVE GRANT
19 PROGRAM ADMINISTERED BY THE APPROPRIATE AGENCY FOR DISTRIBUTION THROUGH THE COMPETITIVE GRANT
20 PROGRAM.

21
22 NEW SECTION. SECTION 5. GRANTS TO REGIONAL WATER AUTHORITIES -- MATCHING FUNDS -- USES. (1)
23 OF THE APPROPRIATION MADE IN [SECTION 2] OF CORONAVIRUS STATE FISCAL RECOVERY FUNDS, \$10 MILLION IS
24 ALLOCATED TO THE DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION TO PROVIDE EACH REGIONAL WATER
25 AUTHORITY A GRANT OF \$2.5 MILLION.

26 (2) FOR A GRANT UNDER THIS SECTION, A REGIONAL WATER AUTHORITY MUST PROVIDE ONE-TO-ONE MATCHING
27 FUNDS TO BE COMPRISED OF LOANS SECURED BY COAL SEVERANCE TAX BONDS MADE PURSUANT TO HOUSE BILL NO. 8.

28 (3) THE REGIONAL WATER AUTHORITY MUST USE GRANT FUNDS AND LOANS SECURED BY BONDS TO SERVE AS

1 MATCHING FUNDS FOR FEDERAL GRANTS.

2
3 NEW SECTION. Section 6. Outreach team -- grant application and engineering assistance. (1)

4 The department of commerce shall assemble an outreach team to notify local governments, with an emphasis
5 on rural local governments, of the funding opportunities provided for in this bill related to communications,
6 economic TRANSFORMATION AND stabilization, and infrastructure projects.

7 (2) The outreach team shall also assist local governments in the application process and offer
8 engineering assistance.

9 (3) The department may hire modified FTE or contract to create the outreach team.

10 (4) There must be an appropriation of administrative funds.

11
12 NEW SECTION. Section 7. Communications advisory commission. (1) There is an American

13 Rescue Plan communications advisory commission.

14 (2) The commission consists of nine members, who must be appointed as follows:

15 (a) three senators, two from the majority party and one from the minority party, appointed by the senate
16 president;

17 (b) three representatives, two from the majority party and one from the minority party, appointed by the
18 speaker of the house; and

19 (c) three members, appointed by the governor.

20 (3) The commission shall review applications for funding for grants for communications projects and
21 provide recommendations to the executive on which projects should be funded.

22 (4) Appointed members of the commission shall be compensated and receive travel expenses as
23 provided for in 2-15-124 for each day in attendance at commission meetings or in the performance of any duty
24 or service as a commission member.

25
26 NEW SECTION. Section 8. Appropriations for communications project grants. (1) There are
27 federal funds received pursuant to the American Rescue Plan Act of 2021, Public Law 117-2, appropriated to
28 the office of budget and program planning and allocated to the governor for the fiscal year beginning July 1,

1 2020, for communications project grants as follows. Appropriation authority is intended to be allocated to the
2 following items. Appropriations are authorized to continue through the biennium beginning July 1, 2023.

4 250,000,000	9901, 602

5 (2) Communication projects are those related to broadband, cell towers, or public safety.

6 (3) For any grant awarded with these funds, a local government or private entity must provide matching
7 funds.

8 (4) References to "ARPA Section" mean references to section 9901 of the American Rescue Plan Act
9 of 2021, Public Law 117-2, which amends Title VI of the Social Security Act to include section 602 or section
10 604.

11
12 **NEW SECTION. Section 9. Eligibility -- submission deadline -- preference -- approval of**

13 **recommendations.** (1) Local governments and private entities shall submit grant requests and supporting
14 materials, including the amount of matching funds available, to the applicable state agency by July 1, 2021, in
15 order to be eligible for funding under [section ~~6-7~~ 8]. The agency will review grant applications, rank projects,
16 and issue a list of recommended projects to the advisory commission by August 15, 2021.

17 (2) The advisory commission shall review the lists of recommended projects and issue a final list of
18 recommended projects to the executive by September 1, 2021.

19 (3) In preparing recommendations, preference must be given to projects that provide broadband access
20 to underserved and high needs areas. Preference may also be given to projects that provide a higher match
21 rate.

22 (4) The recommendations of the advisory commission must be considered by the governor and
23 reviewed to comply with the American Rescue Plan Act and all applicable guidance. The governor may modify
24 recommendations and shall provide the final list of approved projects to the legislative finance committee by
25 October 15, 2021. If it is later determined that a project cannot be completed, the governor may authorize
26 another project and provide a report to the legislative finance committee. If at any time it is determined that a
27 project is identified not to be eligible based on federal guidance or regulation and, if completed, would result in
28 a reduction in funds from the American Rescue Plan Act or require the state to repay or refund money to the

1 federal government pursuant to the American Rescue Plan Act, the governor may authorize another project and
2 provide a report to the legislative finance committee.

3

4 **NEW SECTION. Section 10. Economic TRANSFORMATION AND stabilization ADVISORY commission.**

5 (1) There is an American Rescue Plan economic TRANSFORMATION AND stabilization advisory commission.

6 (2) The commission consists of nine members, who must be appointed as follows:

7 (a) three senators, two from the majority party and one from the minority party, appointed by the senate
8 president;

9 (b) three representatives, two from the majority party and one from the minority party, appointed by the
10 speaker of the house; and

11 (c) three members appointed by the governor.

12 (3) The commission shall review applications for funding for economic TRANSFORMATION AND
13 stabilization projects and provide a list of recommendations to the executive.

14 (4) Appointed members of the commission must be compensated and receive travel expenses as
15 provided for in 2-15-124 for each day in attendance at commission meetings or in the performance of any duty
16 or service as a commission member.

17 (5) THE ECONOMIC TRANSFORMATION AND STABILIZATION ADVISORY COMMISSION SHALL REQUIRE APPLICANTS
18 TO DISCLOSE WHETHER THEY RECEIVED MONEY ADMINISTERED BY THE STATE FROM THE CORONAVIRUS AID, RELIEF,
19 AND ECONOMIC SECURITY ACT OF 2020 (CARES ACT) OR THE CORONAVIRUS RESPONSE AND RELIEF SUPPLEMENTAL
20 APPROPRIATIONS ACT OF 2020 (CRRSA) AND, IF SO, THE AMOUNT RECEIVED AND THE BASIS AND PURPOSE OF THE
21 AWARD. IN MAKING ITS RECOMMENDATIONS, THE ADVISORY COMMISSION SHALL TAKE INTO ACCOUNT THE FACT THAT THE
22 APPLICANT HAS ALREADY BENEFITED FROM FEDERAL ASSISTANCE PROVIDED IN RESPONSE TO COVID-19, BUT A
23 PREVIOUS CARES ACT OR CRRSA AWARD MAY NOT PRECLUDE CONSIDERATION OF AN APPLICATION.

24

25 **NEW SECTION. Section 11. Appropriations for economic TRANSFORMATION AND stabilization**
26 **grants.** There are federal funds received pursuant to the American Rescue Plan Act of 2021, Public Law 117-2,
27 appropriated to the office of budget and program planning and allocated to the governor for the fiscal year
28 beginning July 1, 2020, for economic TRANSFORMATION AND stabilization grants or loans as follows.

1 Appropriation authority is intended to be allocated to the following items. Appropriations are authorized to
2 continue through the biennium beginning July 1, 2023.

6 **NEW SECTION. Section 12. Eligibility -- submission deadline -- preference -- approval of**
7 **recommendations.** (1) Businesses shall submit grant requests and supporting materials to the applicable state
8 agency by July 1, 2021, in order to be eligible for funding under [section 9 ~~10~~ 11]. The agency will review grant
9 applications, rank grant applications, and issue a list of recommended grants to the ADVISORY commission
10 ESTABLISHED IN [SECTION 8 10] by August 15, 2021.

11 (2) The advisory commission shall review the lists of recommended grants and other proposed uses of
12 the funds and issue a final list of recommended grants and uses of funds to the executive by September 1,
13 2021.

14 (3) THE ADVISORY COMMISSION SHALL PROVIDE OVERSIGHT AND RECOMMENDATIONS ON FUNDS
15 APPROPRIATED PURSUANT TO [SECTION 44 13 THROUGH 44 16].

16 ~~(3)~~(4) The recommendations of the advisory commission must be considered by the governor and
17 reviewed to comply with the American Rescue Plan Act and all applicable guidance. The governor may modify
18 recommendations and shall provide the final list of approved projects to the legislative finance committee by
19 October 15, 2021. If it is later determined that a project cannot be completed, the governor may authorize
20 another project and provide a report to the legislative finance committee. If at any time it is determined that a
21 project is identified not to be eligible based on federal guidance or regulation and, if completed, would result in
22 a reduction in funds from the American Rescue Plan Act or require the state to repay or refund money to the
23 federal government pursuant to the American Rescue Plan Act, the governor may authorize another project and
24 provide a report to the legislative finance committee.

2 following items. Appropriations are authorized to continue through the biennium beginning July 1, 2023.

8 (2) Grants and other uses of funds must be targeted to industries with workforce shortages and
9 promoting high-demand, high-wage jobs, and short-term training to be delivered in the private sector.

10 (3) For Emergency Rental Assistance, funds may be used to pay rent or rental arrears to any place
11 where someone pays on a periodic basis for shelter, including but not limited to nursing homes, senior assisted
12 living, group homes, low-income housing, workforce housing, transitional housing, and correctional facilities.

13 (4) The ~~economic stabilization~~ ADVISORY commission ESTABLISHED IN [SECTION 8 10] shall provide
14 oversight to the department on the use of funds in this section.

15 (5) The department of commerce or applicable agency is encouraged to use existing programs, where
16 feasible, to implement the programs provided for in this section.

17
18 **NEW SECTION. Section 14. State Small Business Credit Initiative insert.** There is appropriated to
19 the department of commerce up to \$65 million in federal funds received pursuant to section 3301 of the
20 American Rescue Plan Act of 2021, Public Law 117-2, for the State Small Business Credit Initiative. Funds are
21 to be distributed in accordance with department of treasury guidelines and as detailed in the department of
22 commerce application specific to the program. The appropriation is for the fiscal year beginning July 1, 2020,
23 and is authorized to continue through the biennium beginning July 1, 2031.

24
25 **NEW SECTION. Section 15. Appropriations to department of labor and industry.** (1) There are
26 federal funds received pursuant to the American Rescue Plan Act of 2021, Public Law 117-2, appropriated to
27 the department of labor and industry for the fiscal year beginning July 1, 2020, that are authorized to continue
28 through the biennium beginning July 1, 2023. Appropriation authority is intended to be allocated to the following

23 president;

24 (b) three representatives, two from the majority party and one from the minority party, appointed by the
25 speaker of the house; and

26 (c) three members appointed by the governor.

27 (3) The commission shall recommend how funds allocated to the department of public health and
28 human services are to be used.

1 (4) Appointed members of the commission must be compensated and receive travel expenses as
2 provided for in 2-15-124 for each day in attendance at commissions meetings or in the performance of any duty
3 or service as a commission member.
4

5 **NEW SECTION. Section 18. Deadlines -- meetings -- recommendations -- approval.** (1) The
6 committee shall meet on or before June 1, 2021, and shall report its recommendations to the director of the
7 department of public health and human services on or before June 15, 2021.

8 (2) The recommendations of the advisory commission must be considered by the executive. The
9 department shall provide reports to the commission on implementation.
10

11 **NEW SECTION. Section 19. Appropriations to department of public health and human**
12 **services.** (1) There are federal funds received pursuant to the American Rescue Plan Act of 2021, Public Law
13 117-2, appropriated to the department of public health and human services for the fiscal year beginning July 1,
14 2020, and continuing into the biennium beginning July 1, 2021. Appropriations are authorized to continue
15 through the biennium beginning July 1, 2023. Appropriation authority is intended to be allocated to the following
16 items. References to "ARPA Section" mean references to sections in the American Rescue Plan Act of 2021,
17 Public Law 117-2.

22 (2) For SNAP, the appropriation is to be used for the 15% benefit extension, for administration, and for
23 contracted private sector workforce training.

24 (3) For Rapid Retraining Jobs Training, funding is appropriated to the department of health and human
25 services for contracted private sector workforce training. This training is to prioritize short-term training for high-
26 demand occupations. The department will use pay-for-performance contracts and require quarterly reporting
27 that follows up on individual job placements for 1 full year after training.

28 (4) For SAMHSA, it is the intent of the legislature that the executive consider use of the SAMHSA funds

1 above for the purposes of the HEART fund and for suicide prevention, including the use of the Utah model for
2 suicide prevention that includes social media outreach, and for potential use in the department of corrections.

3 (5) For Child Care Stabilization block grants provided for in section 2201 of the American Rescue Plan
