A BILL FOR AN ACT ENTITLED: "AN ACT IMPLEMENTING THE AMERICAN RESCUE PLAN ACT; PROVIDING APPROPRIATIONS OF FEDERAL FUNDS AND OTHER FUNDS AVAILABLE BECAUSE OF THE RECEIPT OF FEDERAL FUNDS FOR THE FISCAL YEAR ENDING JUNE 30, 2021; ALLOWING APPROPRIATIONS TO CONTINUE INTO THE 2023 BIENNIUM AND 2025 BIENNIUMS; PROVIDING CONDITIONS AND RESTRICTIONS ON THE USE OF FUNDS; CREATING ADVISORY COMMISSIONS RELATED TO INFRASTRUCTURE, COMMUNICATIONS, ECONOMIC TRANSFORMATION AND STABILIZATION, AND HEALTH; PROVIDING DEADLINES AND OTHER CONDITIONS RELATED TO THE GRANT PROCESS; REQUIRING THE USE OF MATCHING FUNDS FOR CERTAIN GRANTS; PROVIDING FOR AN OUTREACH TEAM TO ASSIST LOCAL GOVERNMENTS IN THE GRANT PROCESS; PROVIDING FOR FUNDING FOR STATE CAPITAL PROJECTS AND GRANTS FOR WATER AND WASTEWATER PROJECTS; PROVIDING MINIMUM ALLOCATION GRANTS TO LOCAL GOVERNMENTS FOR QUALIFYING PROJECTS; PROVIDING FOR A GRANT PROCESS FOR COMMUNICATIONS AND ECONOMIC TRANSFORMATION AND STABILIZATION PROJECTS; PROVIDING GRANTS TO REGIONAL WATER AUTHORITIES; REQUIRING PERFORMANCE MEASURES AND REPORTING ON PROJECTS; PROVIDING COORDINATION INSTRUCTIONS TO FUND QUALIFYING LONG-RANGE PROJECTS WITH FEDERAL FUNDS; PROVIDING THE EXECUTIVE THE AUTHORITY TO MODIFY AND REPORT MODIFICATIONS TO APPROPRIATIONS AND PARAMETERS OF PROGRAMS TO THE LEGISLATIVE FINANCE COMMITTEE; PROVIDING FOR A REDUCTION TO GRANT AWARDS TO LOCAL GOVERNMENTS BASED ON HEALTH REGULATIONS THAT ARE MORE STRICT THAN THOSE OF THE STATE; AMENDING SECTION 2-17-603, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

2 **NEW SECTION. Section 1. Infrastructure advisory commission.** (1) There is an American Rescue

3 Plan infrastructure advisory commission.

4 (2) The commission consists of nine members, who must be appointed as follows:

5 (a) three senators, two from the majority party and one from the minority party, appointed by the senate
6 president;

7 (b) three representatives, two from the majority party and one from the minority party, appointed by the
8 speaker of the house; and

9 (c) three members appointed by the governor.

10 (3) The commission shall review applications for funding for state capital projects and state and local
11 government water and wastewater projects and shall provide recommendations to the executive on which
12 projects should be funded. Projects approved by the 67th legislature for funding in House Bill No. 5, 6, 7, 11, or
13 14 are not submitted to the commission.

14 (4) Appointed members of the commission must be compensated and receive travel expenses as
15 provided for in 2-15-124 for each day in attendance at commission meetings or in the performance of any duty
16 or service as a commission member.

17

18 **NEW SECTION. Section 2. Appropriations for capital projects and water and wastewater
19 projects -- matching funds.** (1) There are federal funds received pursuant to the American Rescue Plan Act of

20 2021, Public Law 117-2, appropriated to the office of budget and program planning for state infrastructure
21 projects and local infrastructure grants as follows:

25 (2) For any water or wastewater grant awarded to a local government with these funds, a local
26 government must provide matching funds.

27 (3) For the purposes of [this act], "local government" means any tribe, city, town, county, consolidated
28 city-county, or school district.

1 (4) For the purposes of [this act], " state infrastructure projects" includes projects for state-owned
2 buildings and facilities as well as within the Montana university system, including community colleges in the
3 state.

4 (5) References to "ARPA Section" mean references to section 9901 of the American Rescue Plan Act
5 of 2021, Public Law 117-2, which amends Title VI of the Social Security Act to include section 602 or section
6 604.

7
8 **NEW SECTION. Section 3. Eligibility -- submission deadline -- priority -- approval of**
9 **recommendations.** (1) State and local governments shall submit grant requests and supporting materials,
10 including the amount of matching funds available, to the applicable agency by July 1, 2021, in order to be
11 eligible for funding under [section 2]. The agency will review grant applications, rank projects, and issue a list of
12 recommended projects to the advisory commission by August 15, 2021.

13 (2) The applicable agency shall submit a list of recommended state capital projects to the advisory
14 commission by August 15, 2021.

15 (3) The advisory commission shall review the lists of recommended projects and issue a final list of
16 recommended projects to the executive by September 1, 2021.

17 (4) In preparing recommendations, for capital projects, preference must be given to projects that carry
18 out critical capital projects directly enabling work, education, and health monitoring, including remote options, in
19 response to the public health emergency with respect to COVID-19. For local government grants, preference
20 may also be given to projects that provide a higher match rate.

21 (5) The recommendations of the advisory commission must be considered by the governor and
22 reviewed to comply with the American Rescue Plan Act and all applicable guidance. The governor may modify
23 recommendations and shall provide the final list of approved projects to the legislative finance committee by
24 October 15, 2021. If it is later determined that a project cannot be completed, the governor may authorize
25 another project and provide a report to the legislative finance committee. If it is determined at any time that a
26 project is identified not to be eligible based on federal guidance or regulation and, if completed, would result in
27 a reduction in funds from the American Rescue Plan Act or require the state to repay or refund money to the
28 federal government pursuant to the American Rescue Plan Act, the governor may authorize another project and

1 provide a report to the legislative finance committee.

2

3 NEW SECTION. SECTION 4. MINIMUM ALLOCATION GRANTS TO LOCAL GOVERNMENTS. (1) THE AMOUNT OF
4 \$150 MILLION OF THE CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS APPROPRIATED IN [SECTION 2] MUST BE USED TO
5 PROVIDE MINIMUM ALLOCATION GRANTS TO LOCAL GOVERNMENTS FOR INFRASTRUCTURE PROJECTS.

6 (2) THE AMOUNT A LOCAL GOVERNMENT IS ELIGIBLE TO RECEIVE IN GRANTS UNDER THIS SECTION IS IN THE
7 SAME PROPORTION AND USING THE SAME RATIOS PROVIDED FOR IN 15-70-101(2)(B), (2)(C), AND (3).

8 (3) (A) TO RECEIVE A GRANT UNDER THIS SECTION, A LOCAL GOVERNMENT SHALL SUBMIT AN APPLICATION FOR
9 A QUALIFYING INFRASTRUCTURE PROJECT AND PLEDGE MATCHING FUNDS.

10 (B) A QUALIFYING PROJECT IS A PROJECT THAT COMPLIES WITH THE USES AUTHORIZED FOR THE CORONAVIRUS
11 STATE FISCAL RECOVERY FUNDS.

12 (C) THE LOCAL GOVERNMENT SHALL PLEDGE THE GREATER OF:

13 (I) ONE-TO-ONE MATCHING FUNDS; OR

14 (II) 25% OF THE AMOUNT THAT THE LOCAL GOVERNMENT RECEIVED IN CORONAVIRUS LOCAL FISCAL RECOVERY
15 FUNDS PROVIDED FOR IN THE AMERICAN RESCUE PLAN ACT.

16 (D) A LOCAL GOVERNMENT MAY USE CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS AS MATCHING FUNDS.

17 (4) GRANT FUNDS NOT CLAIMED BY JANUARY 1, 2023, ARE TRANSFERRED TO THE COMPETITIVE GRANT
18 PROGRAM ADMINISTERED BY THE APPROPRIATE AGENCY FOR DISTRIBUTION THROUGH THE COMPETITIVE GRANT
19 PROGRAM.

20

21 NEW SECTION. SECTION 5. GRANTS TO REGIONAL WATER AUTHORITIES -- MATCHING FUNDS -- USES. (1)
22 OF THE APPROPRIATION MADE IN [SECTION 2] OF CORONAVIRUS STATE FISCAL RECOVERY FUNDS, \$10 MILLION IS
23 ALLOCATED TO THE DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION TO PROVIDE EACH REGIONAL WATER
24 AUTHORITY A GRANT OF \$2.5 MILLION.

25 (2) FOR A GRANT UNDER THIS SECTION, A REGIONAL WATER AUTHORITY MUST PROVIDE ONE-TO-ONE MATCHING
26 FUNDS TO BE COMPRISED OF LOANS SECURED BY COAL SEVERANCE TAX BONDS MADE PURSUANT TO HOUSE BILL NO. 8.

27 (3) THE REGIONAL WATER AUTHORITY MUST USE GRANT FUNDS AND LOANS SECURED BY BONDS TO SERVE AS
28 MATCHING FUNDS FOR FEDERAL GRANTS.

NEW SECTION. Section 6. Outreach team -- grant application and engineering assistance. (1)

The department of commerce shall assemble an outreach team to notify local governments, with an emphasis on rural local governments, of the funding opportunities provided for in this bill related to communications, economic TRANSFORMATION AND stabilization, and infrastructure projects.

(2) The outreach team shall also assist local governments in the application process and offer engineering assistance.

(3) The department may hire modified FTE or contract to create the outreach team.

(4) There must be an appropriation of administrative funds.

NEW SECTION. Section 7. Communications advisory commission. (1) There is an American

Rescue Plan communications advisory commission.

(2) The commission consists of nine members, who must be appointed as follows:

(a) three senators, two from the majority party and one from the minority party, appointed by the senate president;

(b) three representatives, two from the majority party and one from the minority party, appointed by the speaker of the house; and

(c) three members, appointed by the governor.

(3) The commission shall review applications for funding for grants for communications projects and provide recommendations to the executive on which projects should be funded.

(4) Appointed members of the commission shall be compensated and receive travel expenses as provided for in 2-15-124 for each day in attendance at commission meetings or in the performance of any duty or service as a commission member.

NEW SECTION. Section 8. Appropriations for communications project grants. (1) There are

federal funds received pursuant to the American Rescue Plan Act of 2021, Public Law 117-2, appropriated to the office of budget and program planning and allocated to the governor for the fiscal year beginning July 1, 2020, for communications project grants as follows. Appropriation authority is intended to be allocated to the

1 following items. Appropriations are authorized to continue through the biennium beginning July 1, 2023.

4 (2) Communication projects are those related to broadband, cell towers, or public safety.

5 (3) For any grant awarded with these funds, a local government or private entity must provide matching
6 funds.

7 (4) References to "ARPA Section" mean references to section 9901 of the American Rescue Plan Act
8 of 2021, Public Law 117-2, which amends Title VI of the Social Security Act to include section 602 or section
9 604.

10
11 **NEW SECTION. Section 9. Eligibility -- submission deadline -- preference -- approval of**

12 **recommendations.** (1) Local governments and private entities shall submit grant requests and supporting
13 materials, including the amount of matching funds available, to the applicable state agency by July 1, 2021, in
14 order to be eligible for funding under [section ~~6-7~~ 8]. The agency will review grant applications, rank projects,
15 and issue a list of recommended projects to the advisory commission by August 15, 2021.

16 (2) The advisory commission shall review the lists of recommended projects and issue a final list of
17 recommended projects to the executive by September 1, 2021.

18 (3) In preparing recommendations, preference must be given to projects that provide broadband access
19 to underserved and high needs areas. Preference may also be given to projects that provide a higher match
20 rate.

21 (4) The recommendations of the advisory commission must be considered by the governor and
22 reviewed to comply with the American Rescue Plan Act and all applicable guidance. The governor may modify
23 recommendations and shall provide the final list of approved projects to the legislative finance committee by
24 October 15, 2021. If it is later determined that a project cannot be completed, the governor may authorize
25 another project and provide a report to the legislative finance committee. If at any time it is determined that a
26 project is identified not to be eligible based on federal guidance or regulation and, if completed, would result in
27 a reduction in funds from the American Rescue Plan Act or require the state to repay or refund money to the
28 federal government pursuant to the American Rescue Plan Act, the governor may authorize another project and

1 provide a report to the legislative finance committee.

2

3 **NEW SECTION. Section 10. Economic TRANSFORMATION AND stabilization ADVISORY commission.**

6 (a) three senators, two from the majority party and one from the minority party, appointed by the senate
7 president;

8 (b) three representatives, two from the majority party and one from the minority party, appointed by the
9 speaker of the house; and

10 (c) three members appointed by the governor.

11 (3) The commission shall review applications for funding for economic TRANSFORMATION AND
12 stabilization projects and provide a list of recommendations to the executive.

13 (4) Appointed members of the commission must be compensated and receive travel expenses as
14 provided for in 2-15-124 for each day in attendance at commission meetings or in the performance of any duty
15 or service as a commission member.

16 (5) THE ECONOMIC TRANSFORMATION AND STABILIZATION ADVISORY COMMISSION SHALL REQUIRE APPLICANTS
17 TO DISCLOSE WHETHER THEY RECEIVED MONEY ADMINISTERED BY THE STATE FROM THE CORONAVIRUS AID, RELIEF,
18 AND ECONOMIC SECURITY ACT OF 2020 (CARES ACT) OR THE CORONAVIRUS RESPONSE AND RELIEF SUPPLEMENTAL
19 APPROPRIATIONS ACT OF 2020 (CRRSA) AND, IF SO, THE AMOUNT RECEIVED AND THE BASIS AND PURPOSE OF THE
20 AWARD. IN MAKING ITS RECOMMENDATIONS, THE ADVISORY COMMISSION SHALL TAKE INTO ACCOUNT THE FACT THAT THE
21 APPLICANT HAS ALREADY BENEFITED FROM FEDERAL ASSISTANCE PROVIDED IN RESPONSE TO COVID-19, BUT A
22 PREVIOUS CARES ACT OR CRRSA AWARD MAY NOT PRECLUDE CONSIDERATION OF AN APPLICATION.

24 **NEW SECTION. Section 11. Appropriations for economic TRANSFORMATION AND stabilization**
25 **grants.** There are federal funds received pursuant to the American Rescue Plan Act of 2021, Public Law 117-2,
26 appropriated to the office of budget and program planning and allocated to the governor for the fiscal year
27 beginning July 1, 2020, for economic TRANSFORMATION AND stabilization grants or loans as follows.
28 Appropriation authority is intended to be allocated to the following items. Appropriations are authorized to

1 continue through the biennium beginning July 1, 2023.

5 **NEW SECTION. Section 12. Eligibility -- submission deadline -- preference -- approval of**
