9	Section 1. Section 2-15-3402, MCA, is amended to read:
10	"2-15-3402. Fish and wildlife commission. (1) There is a fish and wildlife commission.
11	(2) The commission consists of five seven members. At least one member must be experienced in
12	the breeding and management of domestic livestock. The governor shall appoint one member from each of the
13	following districts:
14	(a) District No. 1, consisting of Lincoln, Flathead, Sanders, Lake, Mineral, Missoula, Powell, Ravalli,
15	Granite, and Lewis and Clark Counties;
16	(b) District No. 2, consisting of Deer Lodge, Silver Bow, Beaverhead, Madison, Jefferson, Broadwater
17	Gallatin, Park, and Sweet Grass Counties;
18	(c) District No. 3, consisting of Glacier, Toole, Liberty, Hill, Pondera, Teton, Chouteau, Cascade,
19	Judith Basin, Fergus, Blaine, Meagher, and Wheatland Counties;
20	(d) District No. 4, consisting of Phillips, Valley, Daniels, Sheridan, Roosevelt, Petroleum, Garfield,
21	McCone, Richland, Dawson, and Wibaux Counties;
22	(e) District No. 5, consisting of Golden Valley, Musselshell, Stillwater, Carbon, Yellowstone, Big Horn,
23	Treasure, Rosebud, Custer, Powder River, Carter, Fallon, and Prairie Counties. administrative regions of the
24	department of fish, wildlife, and parks, which are headquartered in the following locations:
25	(a) Kalispell;
26	(b) Missoula;
27	(c) Bozeman;

3	(g) Miles City.
4	(3) Appointments must be made without regard to political affiliation and must be made solely for the
5	wise management of fish, wildlife, and related recreational resources of this state. A person may not be
6	appointed to the commission unless the person is informed or interested and experienced in the subject of fish,
7	wildlife, and recreation and the requirements for the conservation and protection of fish, wildlife, and
8	recreational resources.
9	(4) A vacancy occurring on the commission must be filled by the governor in the same manner and

(5) The fish and wildlife commission is designated as a quasi-judicial board for purposes of 2-15-124. Notwithstanding the provisions of 2-15-124(1), the governor is not required to appoint an attorney to serve as a member of the commission."
