Description of fiscal impact: The creation of a new community college would require state funding.

FISCAL ANALYSIS

Assumptions:

1. There will be no fiscal impact in FY 2022 or FY 2023 since proposed community college would begin operation in FY 2024
2. Utilizing average state support per resident student from FY 2021 projected community college budgets (as a starting point) multiplied by projected resident student FTE, the FY 2024 impact is \$1,201,476 and \$1,255,780 in FY 2025. (177 FTE x \$6,788 = \$1,201,476 and 185 FTE x \$6,788 = \$1,255,780).
3. This fiscal note uses the enrollment projections provided by the Bitterroot Valley Community College trustees to the September Board of Regents meeting.
