- 1. In accordance with 3-1-1004, MCA, the members of the Judicial Nomination Commission are entitled to travel expenses, paid at state allowed rates, while engaged in judicial nomination duties.
- 2. The Judicial Nomination Commission incurred \$2,083 of travel expenses in FY 2020. This bill repeals the Judicial Nomination Commission which would provide an estimated savings to the Judicial Branch of \$2,083 per year.
